

(57) Abstract: A system and method is provided for authenticating access in a mobile wireless network. The system and method comprise exchanging an extensible authentication protocol (EAP) packet with an access terminal over a high rate packet data radio link and a signaling interface through a radio access network, encapsulating the EAP packet in an authentication authorization and accounting (AAA) packet, and sending the AAA packet to an authentication server for authentication.
