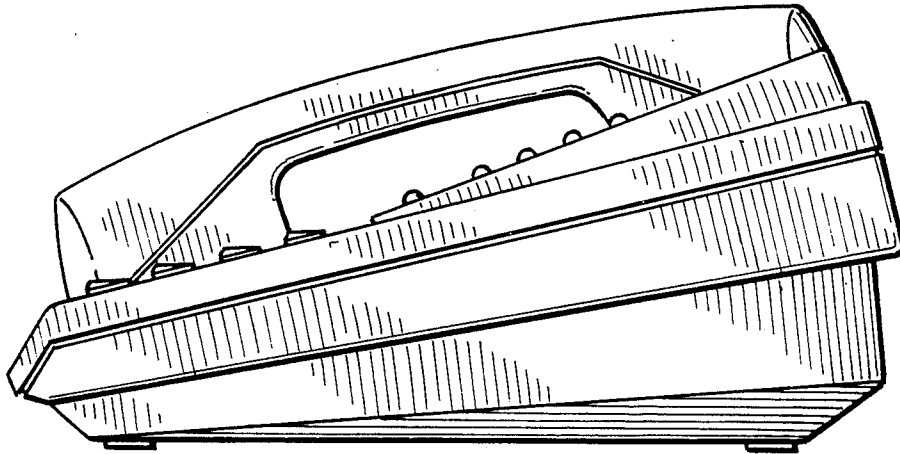

The ornamental design for a telephone set, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of a telephone set showing our new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIGS. 5 and 6 are respectively right and left side elevational views thereof; and  
FIG. 7 is a front, top and right side perspective view thereof.



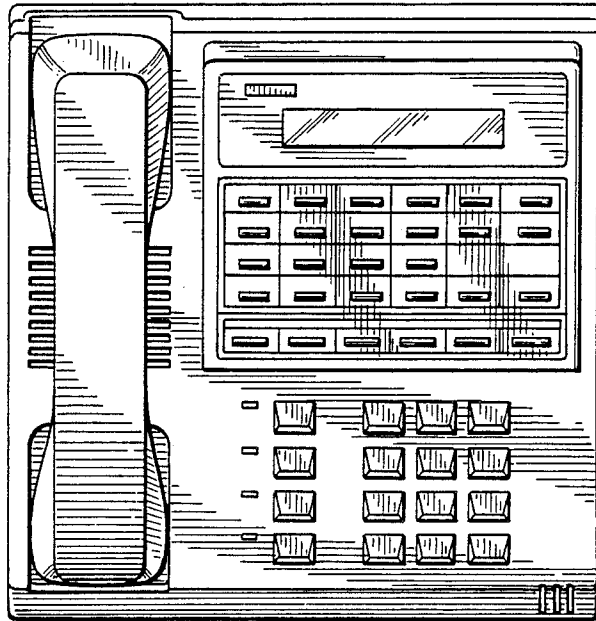

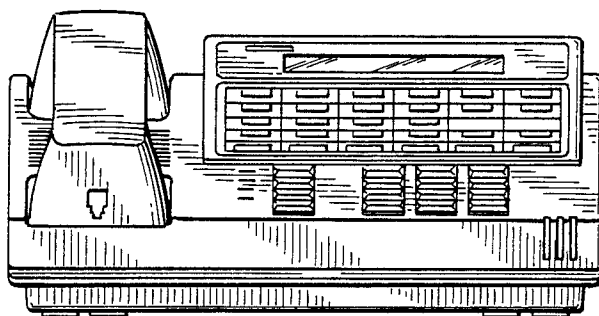

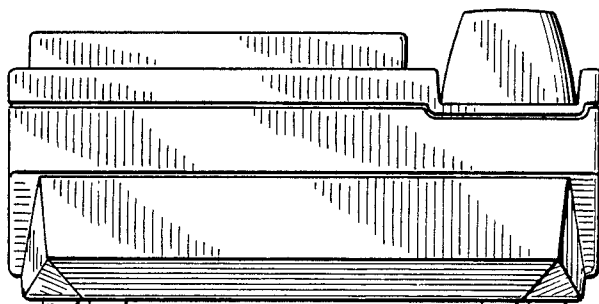
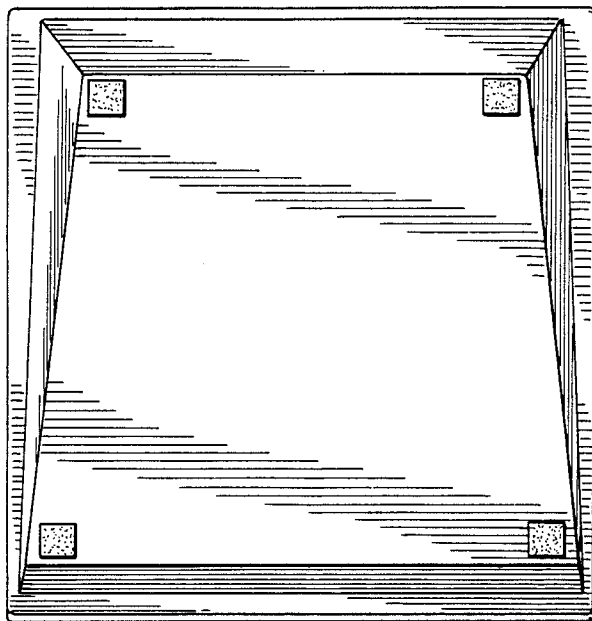

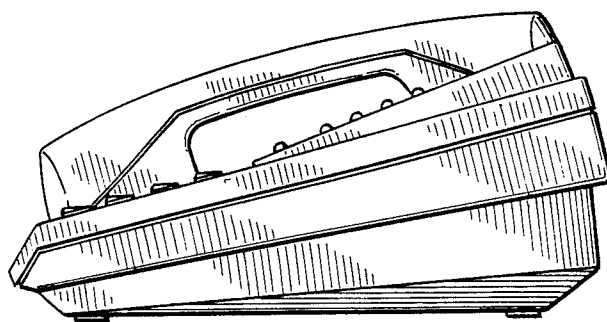

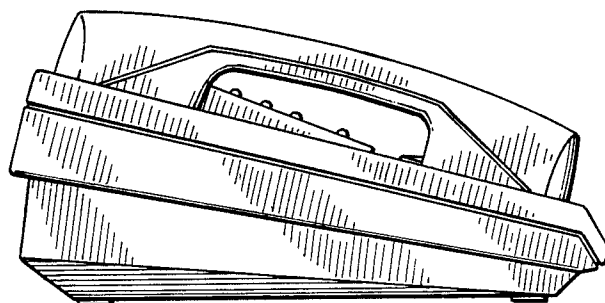
