FIG. 10 is a front elevation view thereof;

FIG. 11 is a rear elevation view thereof;

FIG. 12 is a top plan view thereof;

FIG. 13 is a bottom plan view thereof;

FIG. 14 is a right side elevation view thereof, with the left side elevation view being a mirror image thereof;

FIG. 15 is a partial section view thereof, taken along the line 15-15 in FIG. 14; and,

FIG. 16 is a top front perspective view thereof, shown in use. The broken, dash-dash lines shown in the drawings illustrate portions of the letter board that form no part of the claimed design.

The letter board is shown with a symbolic break in its length indicated with dash-dot-dash lines. The appearance of any portion of the article between the break lines forms no part of the claimed design.

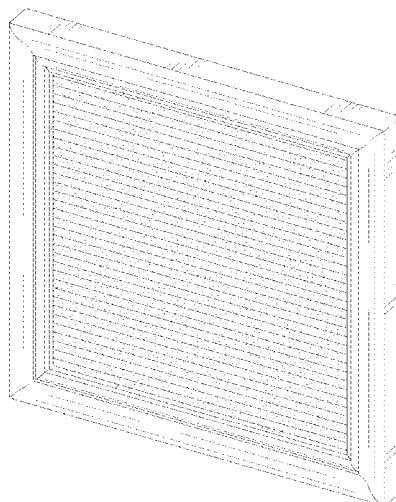

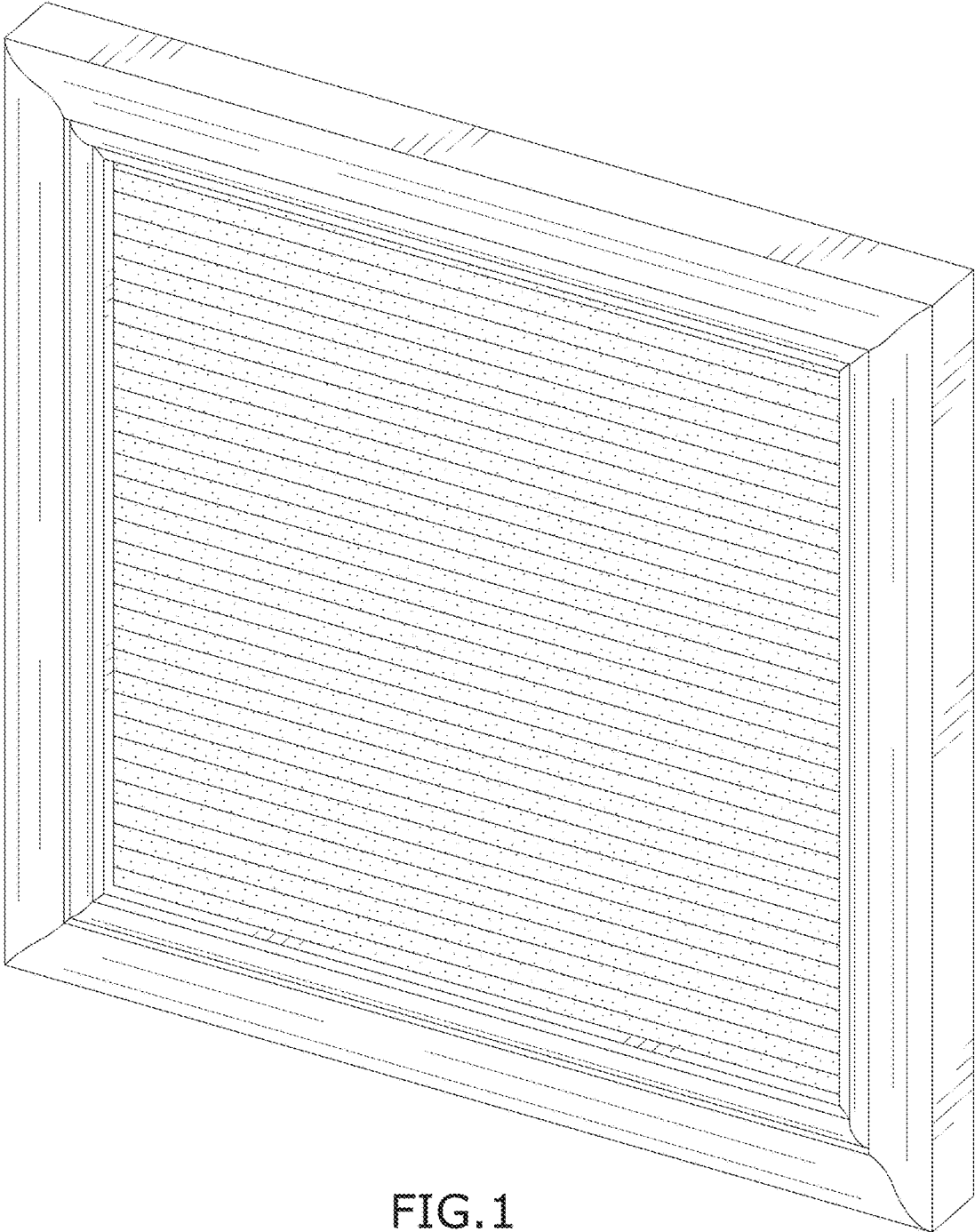

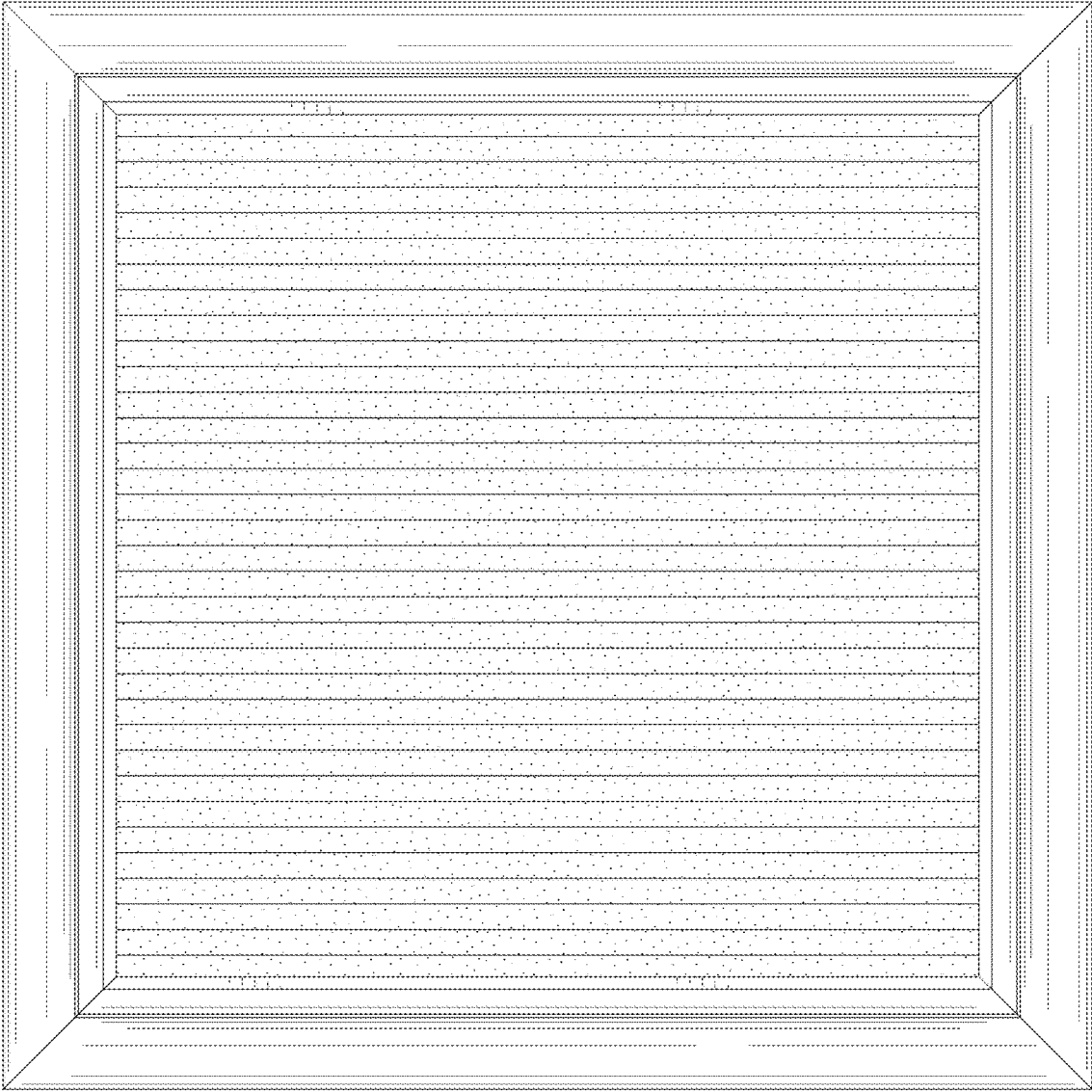

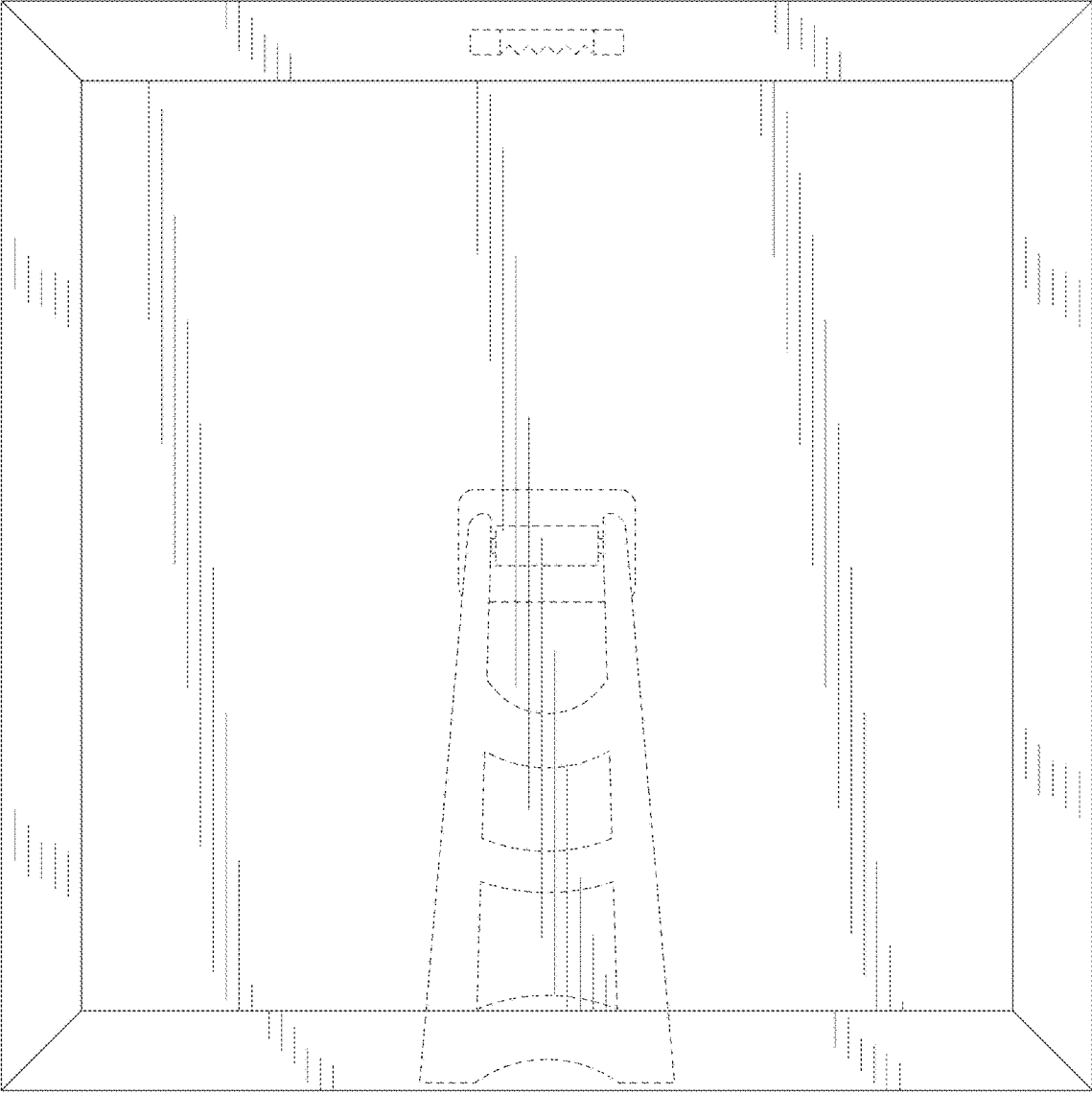

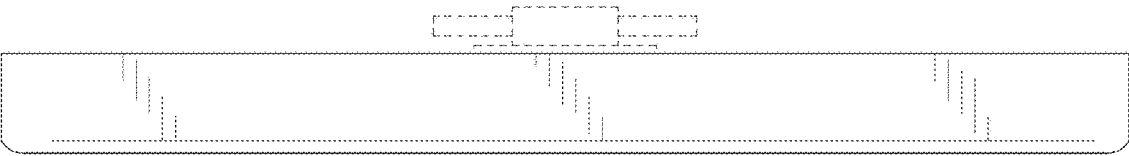

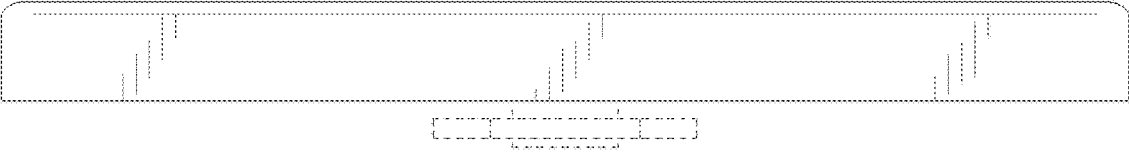

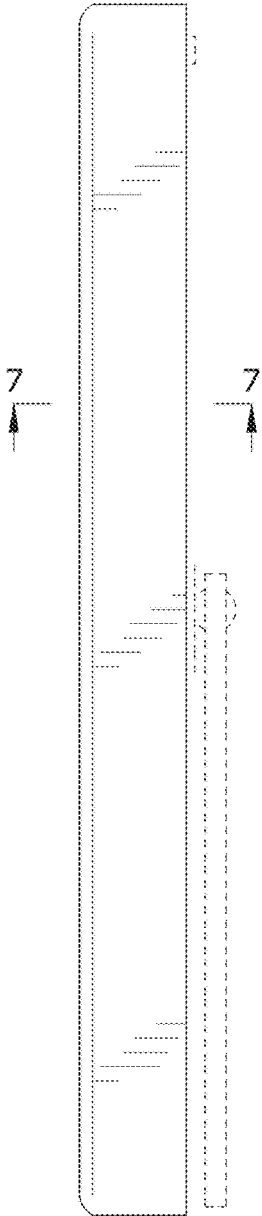

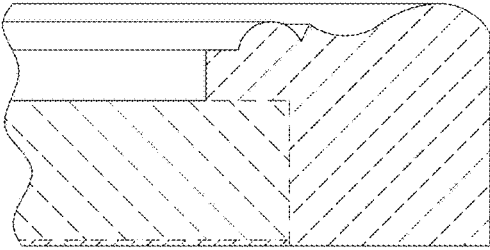

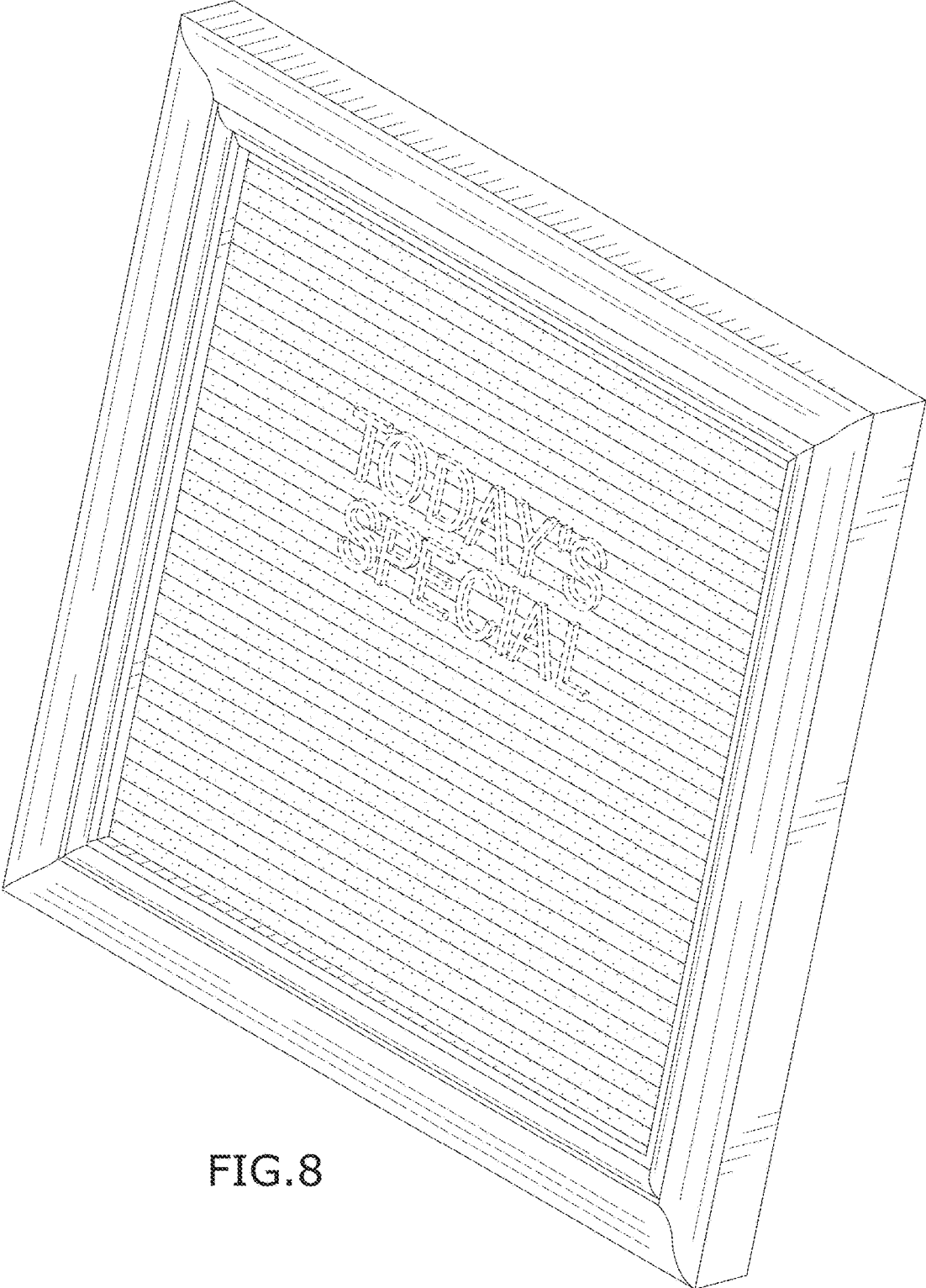

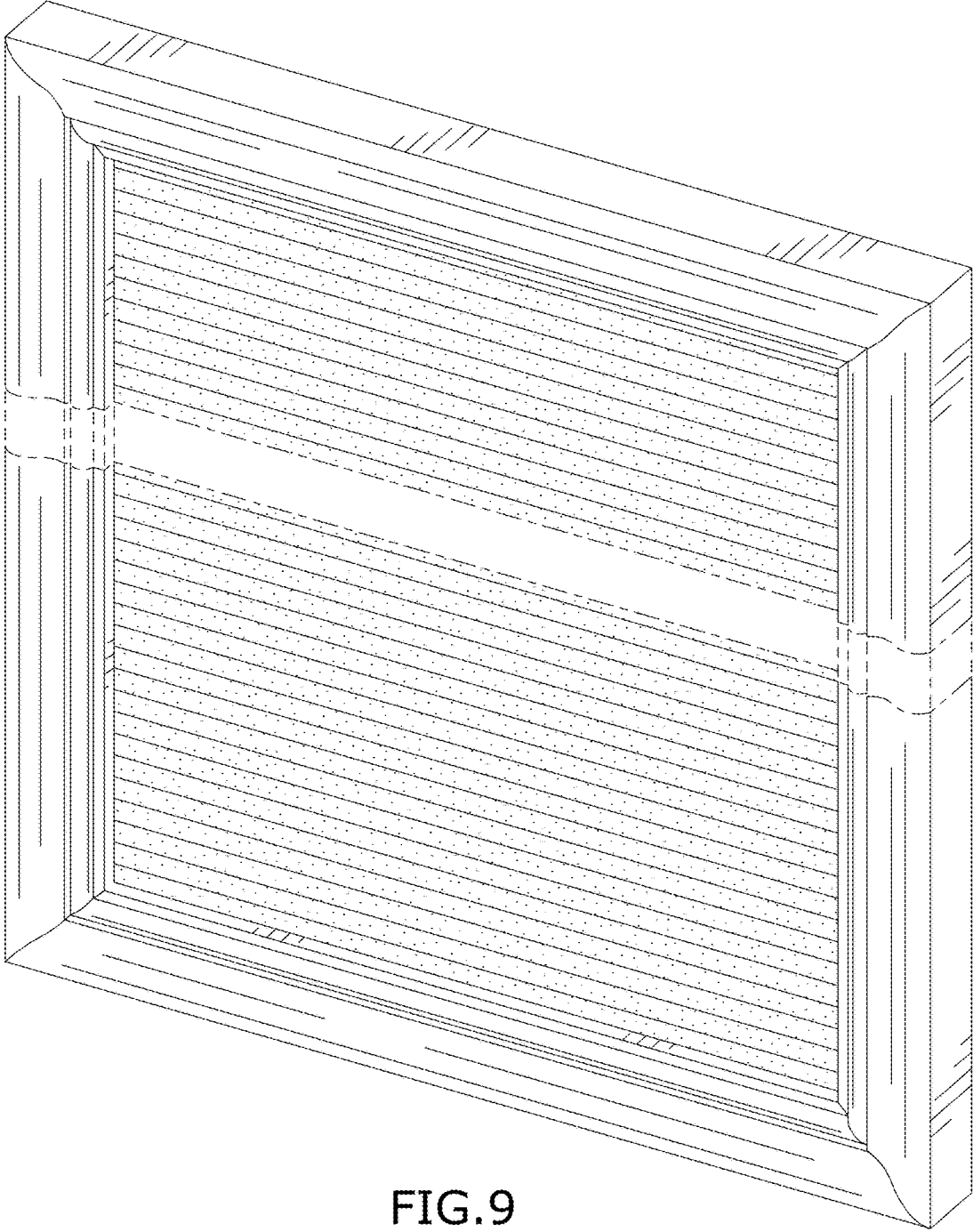

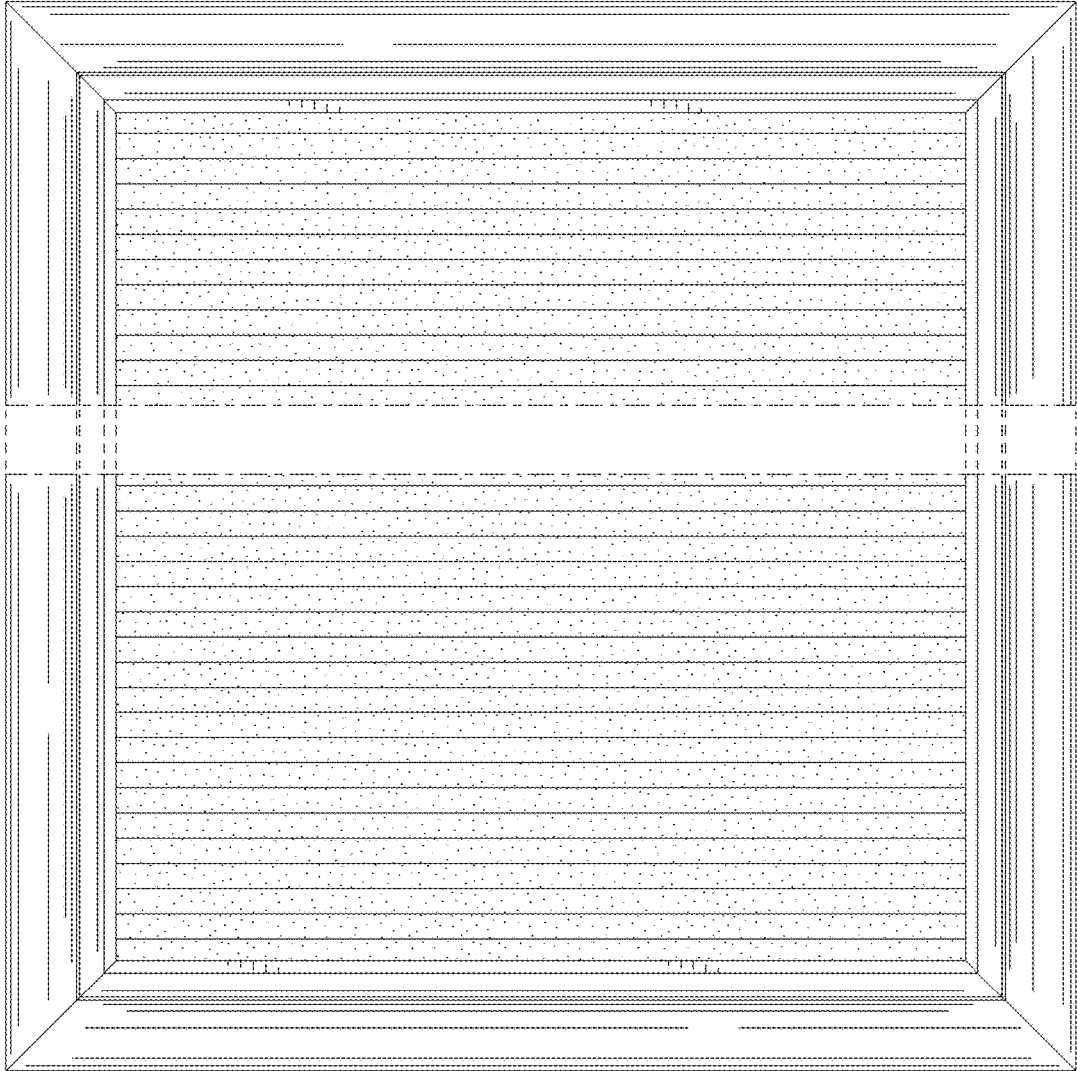

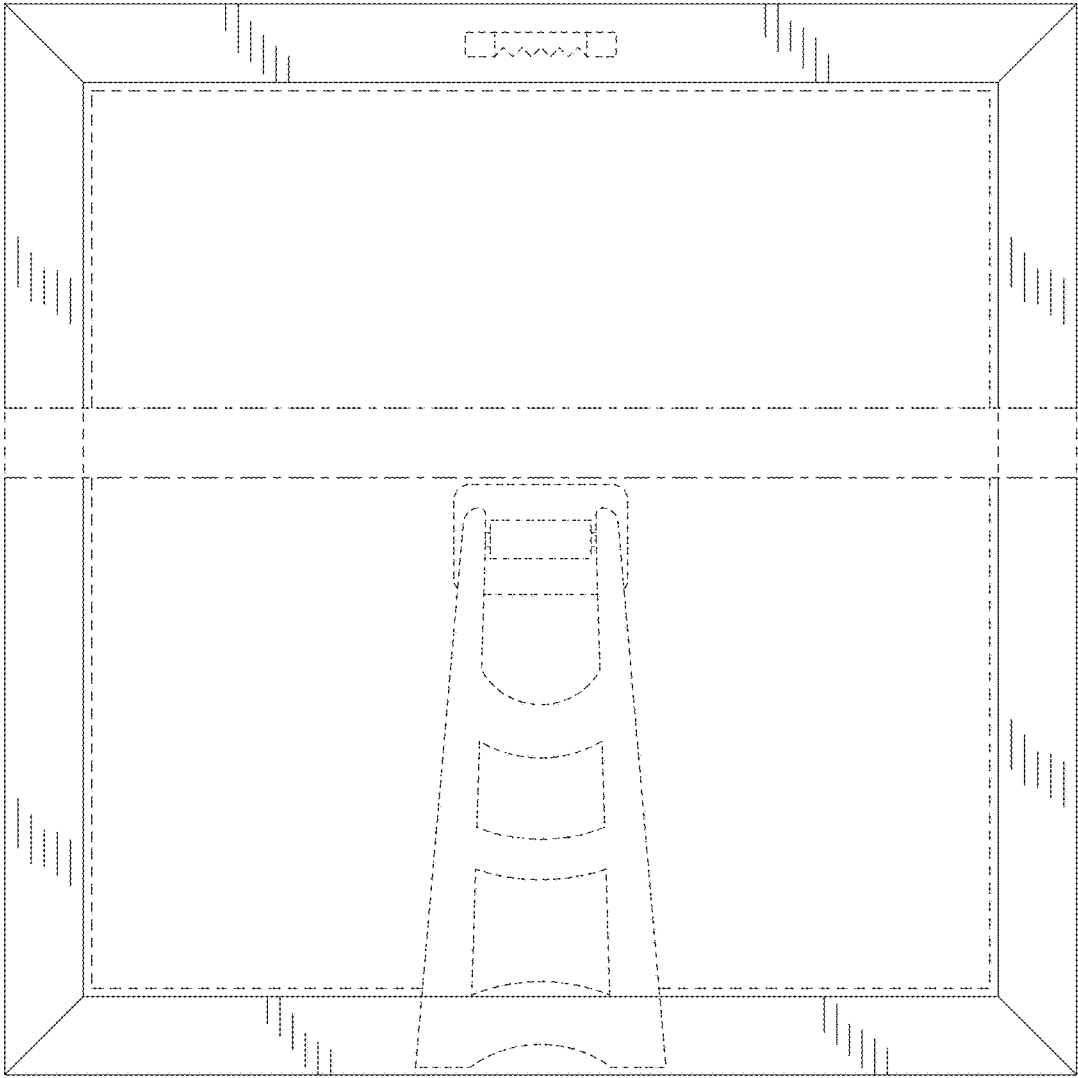

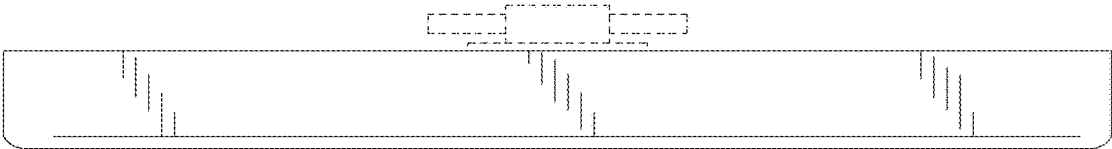

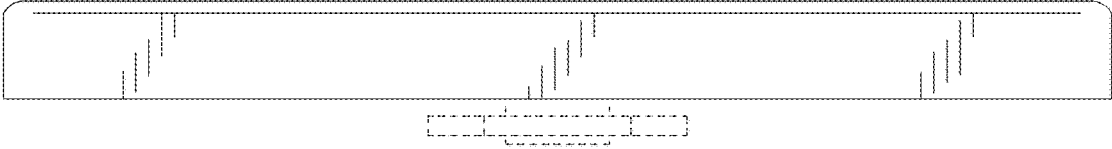

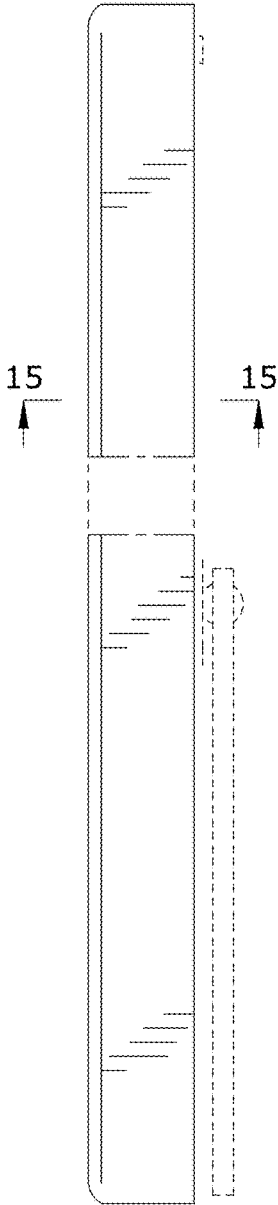

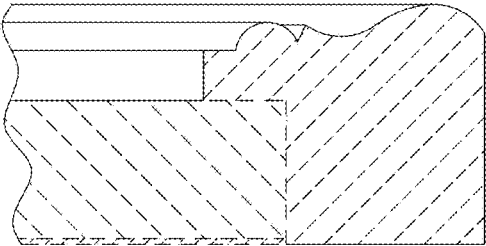

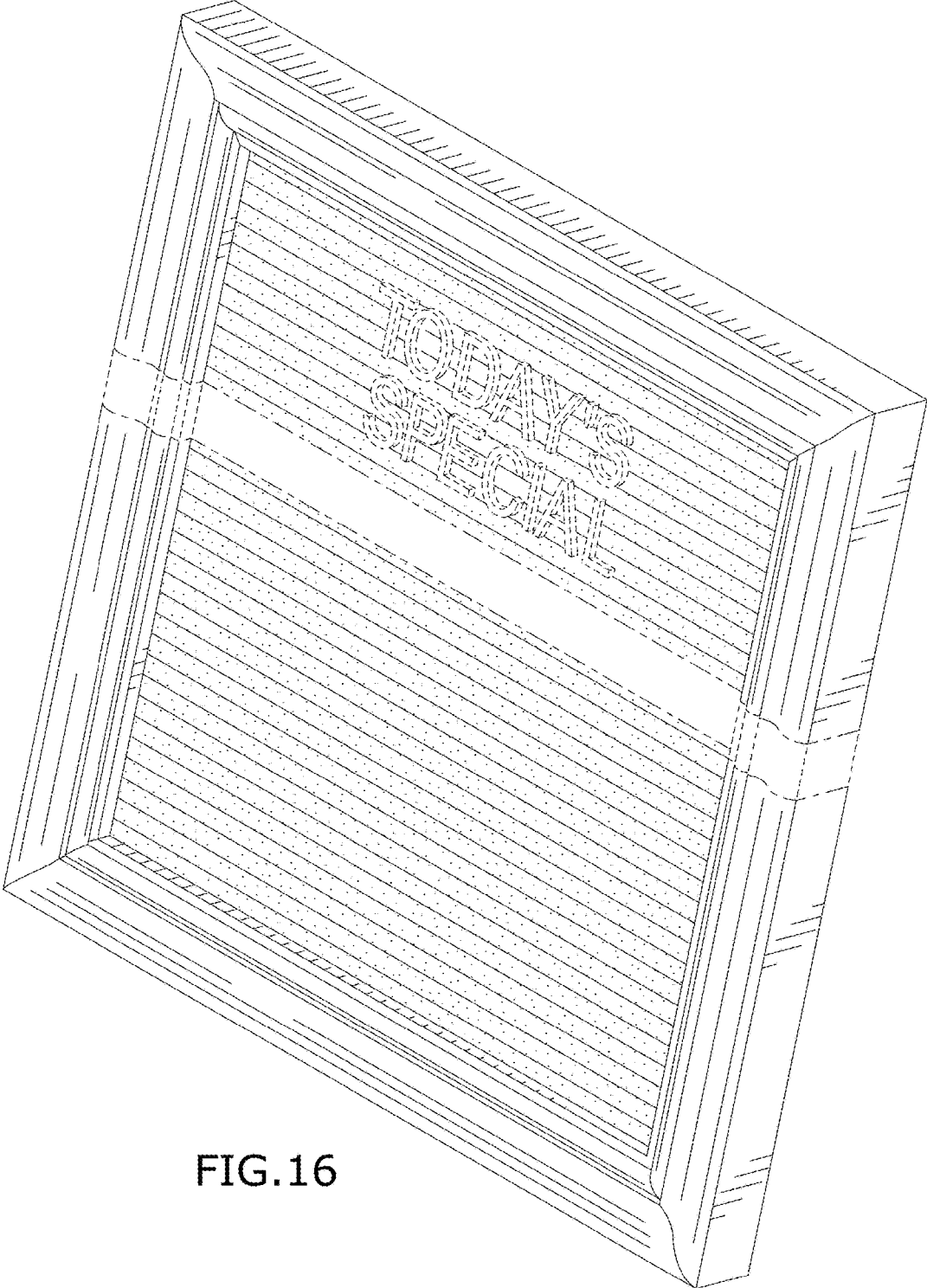
