The portions shown in broken lines in FIGS. 1 through 14 are for purposes of illustration only and forms no part of the instant design.

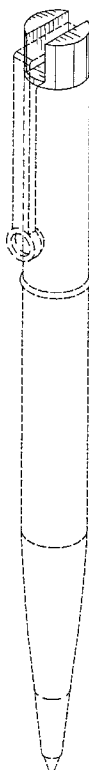

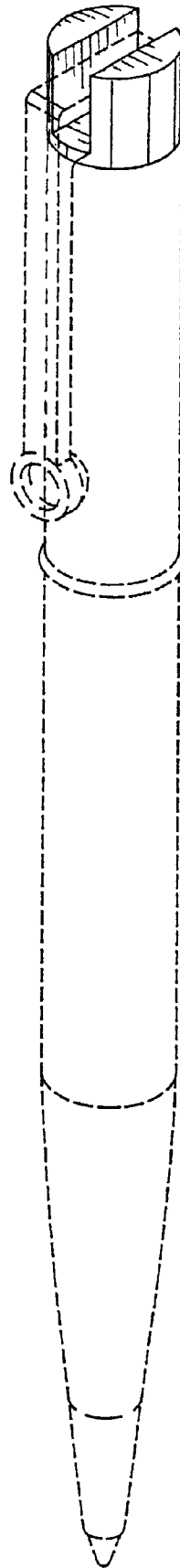

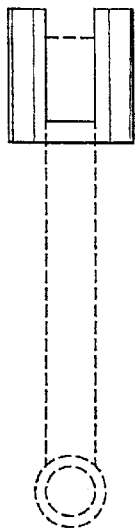

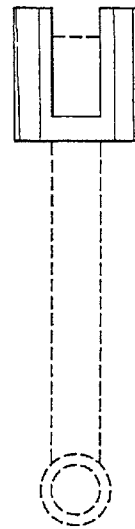

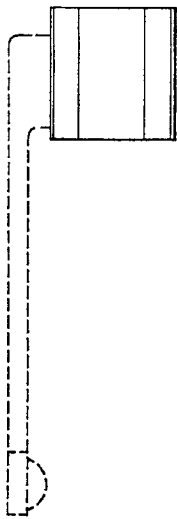

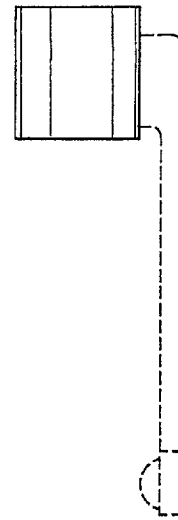

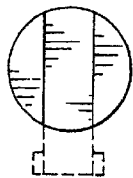

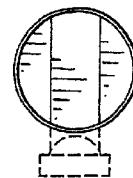

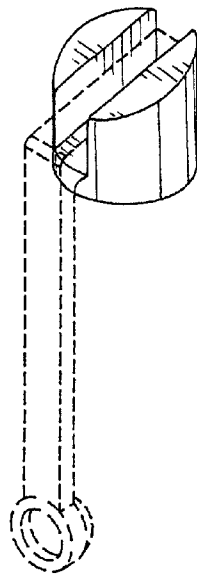

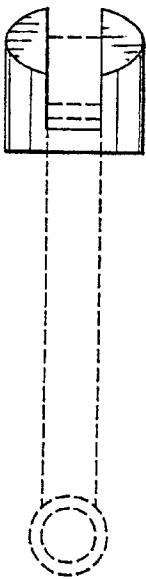

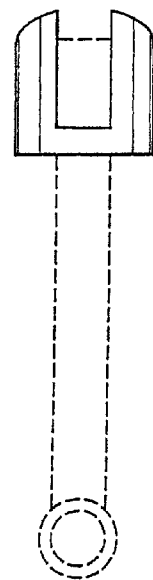

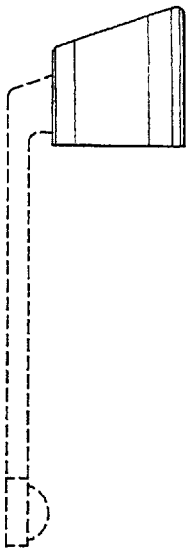

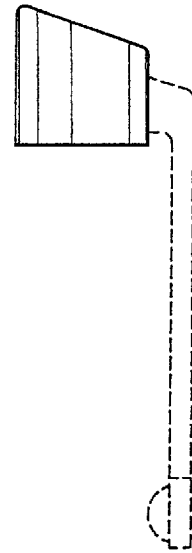

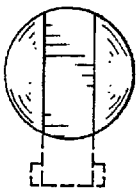

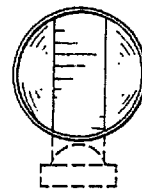

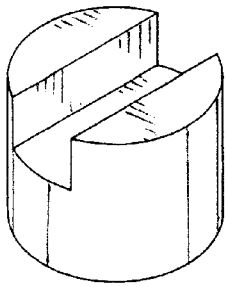

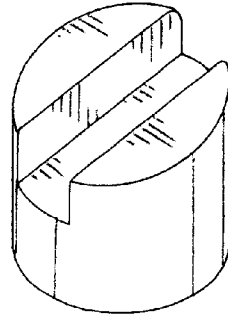

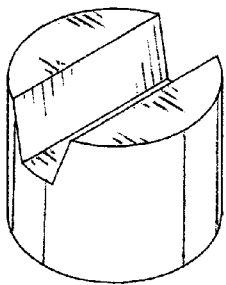

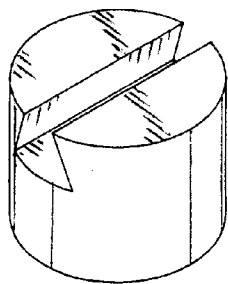
