(57) **CLAIM**

We claim the ornamental design for a label book, as shown and described.

**DESCRIPTION**

FIG. 1 is a right side, top perspective view of a first embodiment of a label book with a pull tab protruding from the bottom edge of the cover of the label book and showing our new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a back elevation view thereof;

FIG. 4 is a left side view thereof;

FIG. 5 is a right side view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a right side, top perspective view thereof showing the first embodiment of a label book with the pull tab removed;

FIG. 9 is a right side, top perspective view of a second embodiment of a label book with an aperture on the first page of the label book showing a length of string horizontally mounted between the bottle and the label book with a stylized, ornamental bow or knot in the string showing our new design;

FIG. 10 is a front elevation view thereof;

FIG. 11 is a back elevation view thereof;

FIG. 12 is a left side view thereof;

FIG. 13 is a right side view thereof;

FIG. 14 is a top plan view thereof;

FIG. 15 is a bottom plan view thereof; and,


FIG. 16 is a right side, top perspective view thereof showing the second embodiment of a label book open and the interior pages thereof.

The bottle is shown in broken lines and forms no part of the claimed design.

The lettering in FIGS. 8 and 16 is shown in broken lines and forms no part of the claimed design.

The broken lines on the cover of the label in the first embodiment represent perforations and is part of the claimed design.




























