DESCRIPTION

FIG. 1 is a left front perspective view of a writing instrument showing our new design; FIG. 2 is a front elevational view; FIG. 3 is a left side elevational view; FIG. 4 is a rear elevational view; FIG. 5 is a right side elevational view in an exploded condition; FIG. 6 is a top plan view; and, FIG. 7 is a bottom plan view thereof.

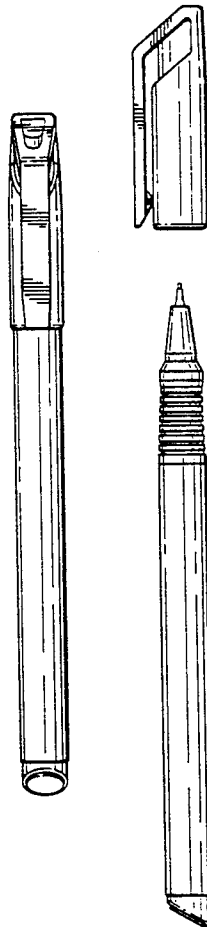

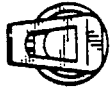

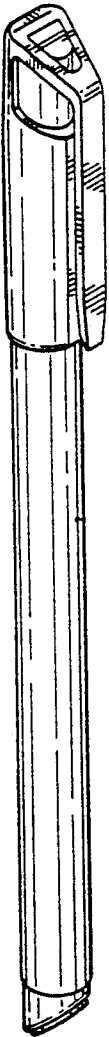
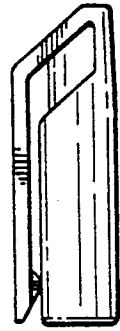

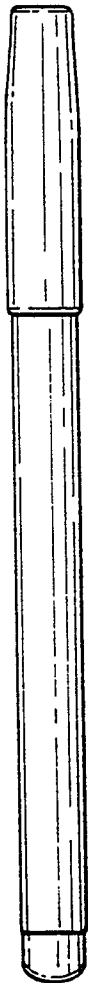
