The ornamental design for a vertically-mountable letter tray, as shown and described.

### DESCRIPTION

FIG. 1 is a front elevational view of a vertically-mountable letter tray showing my new design;

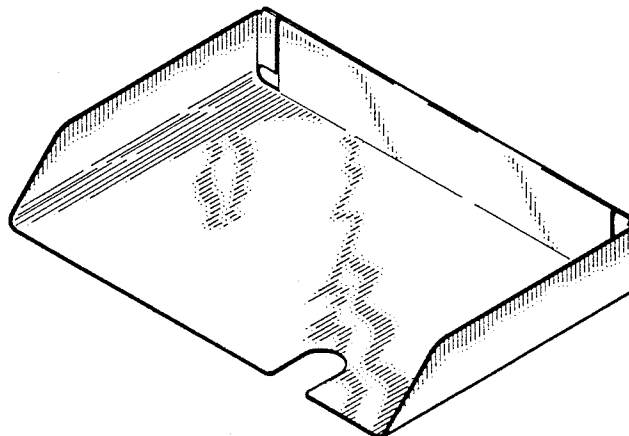
FIG. 2 is a rear elevational view;

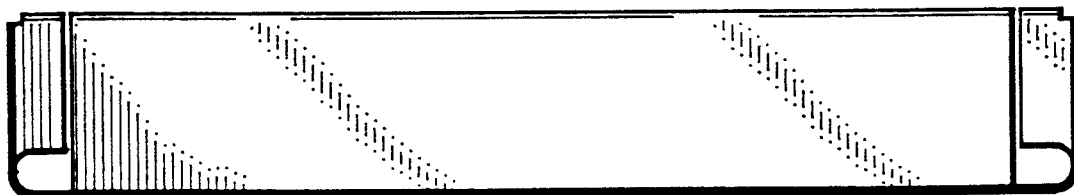

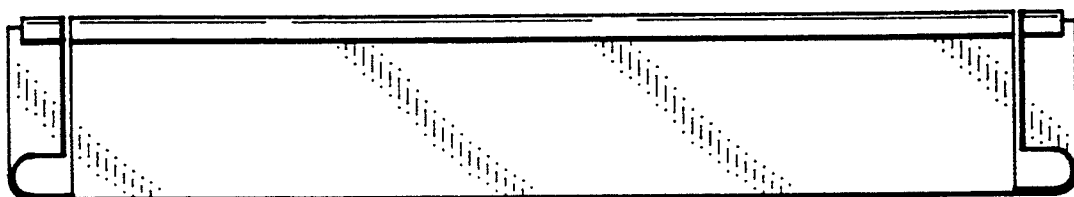

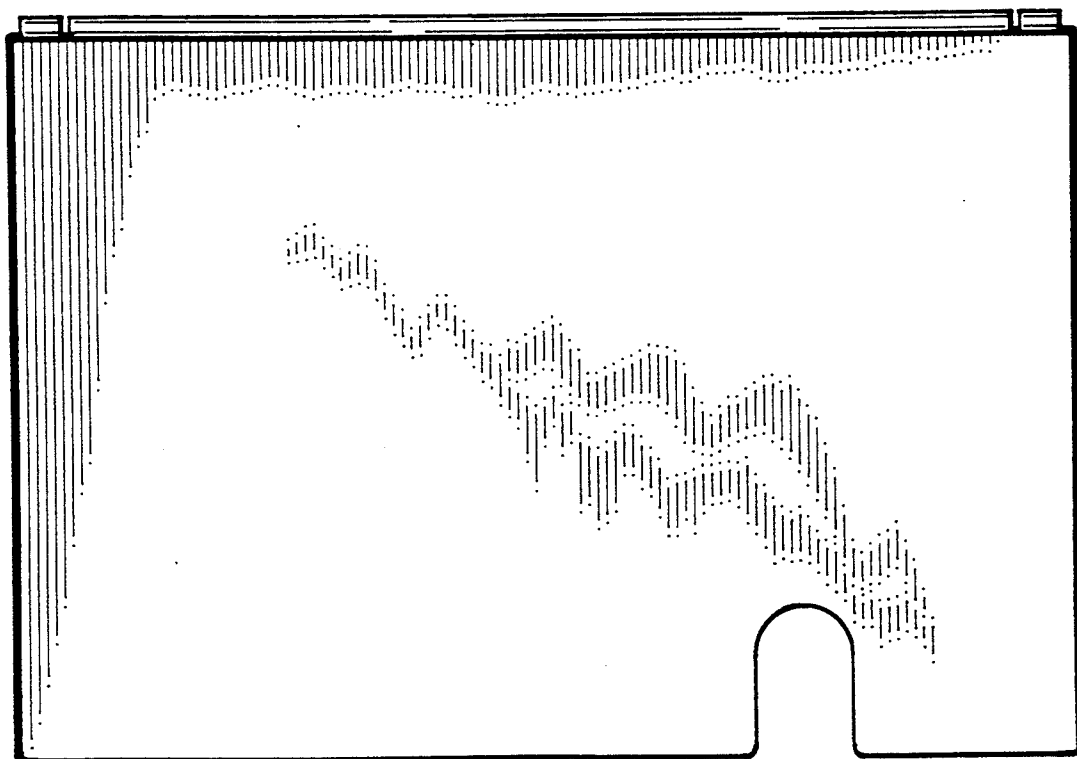

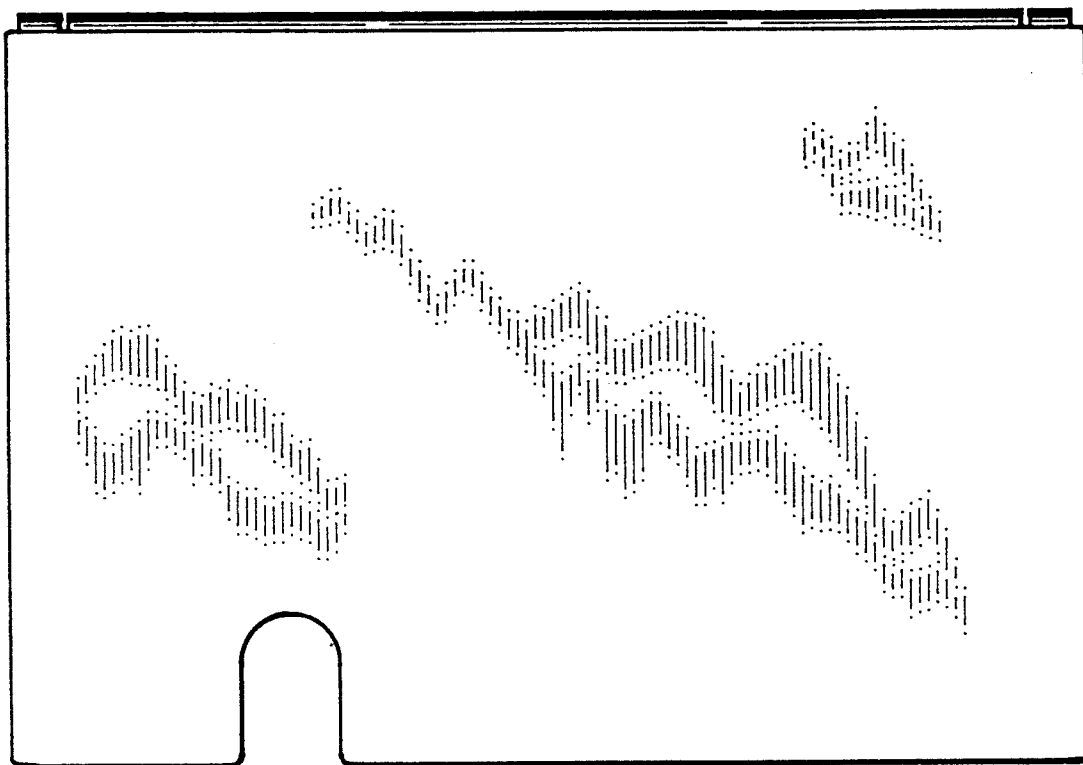
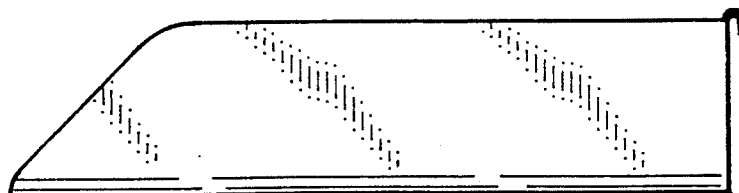

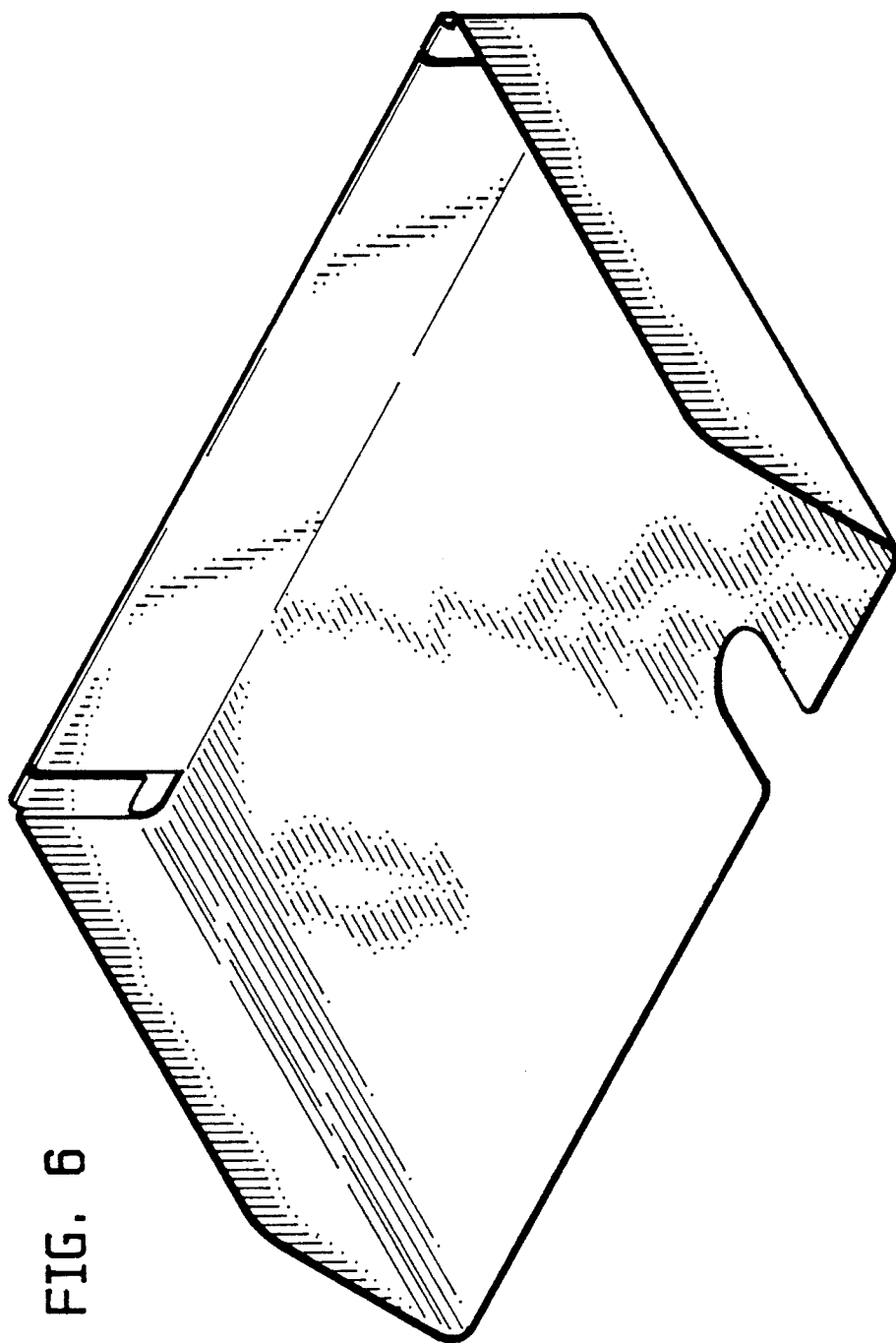
