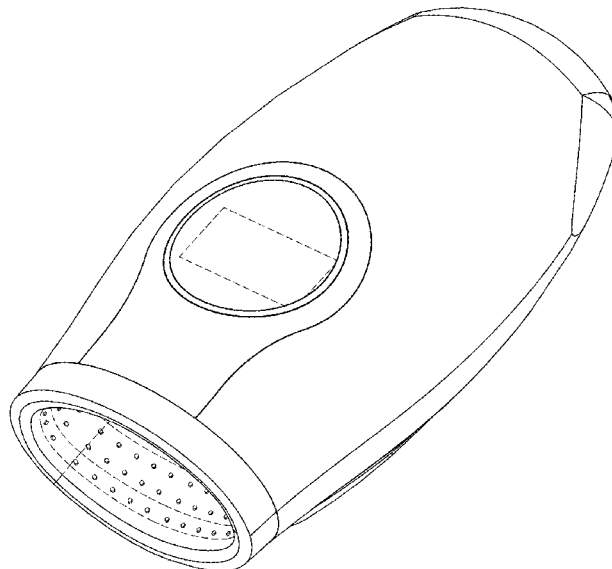
The ornamental design for a “hand massager,” as shown and described.

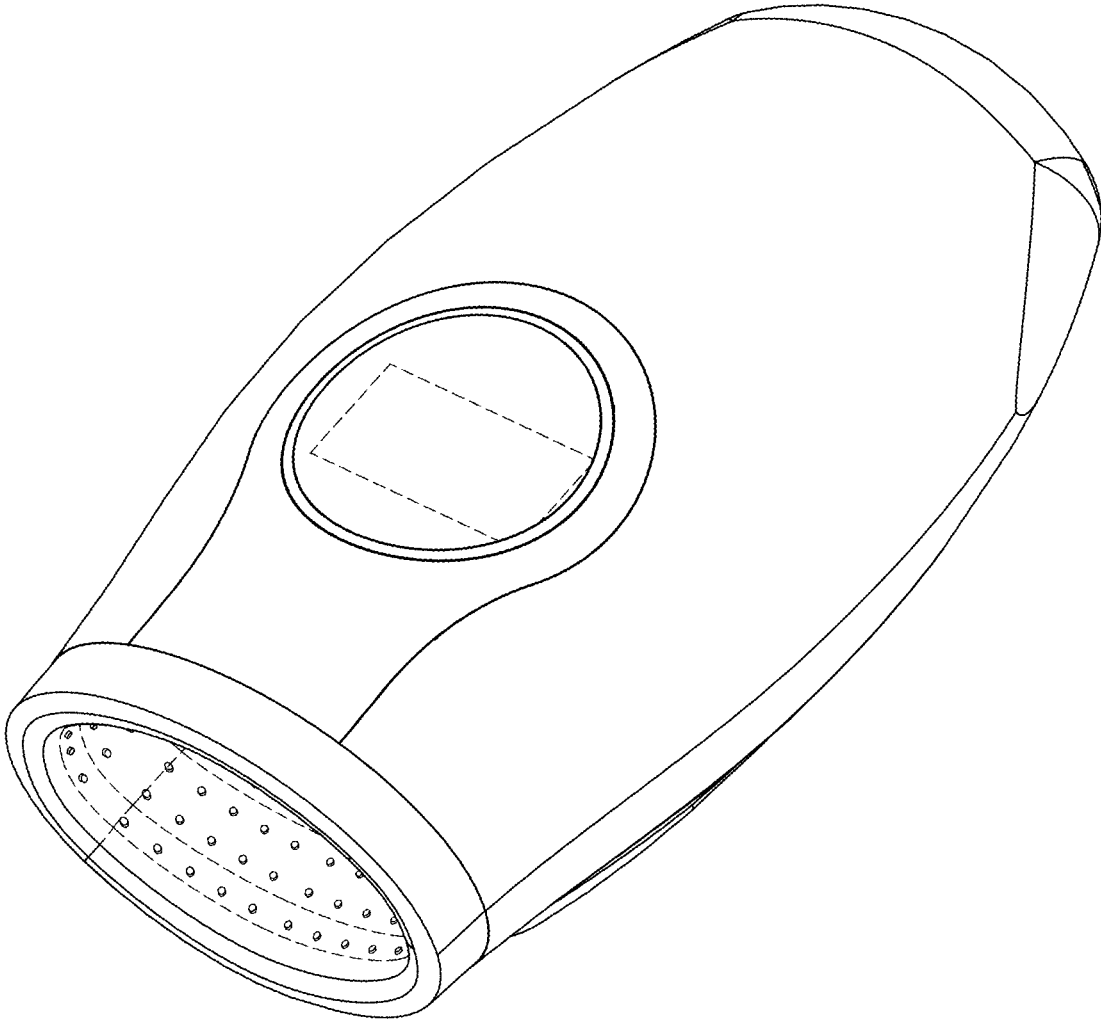

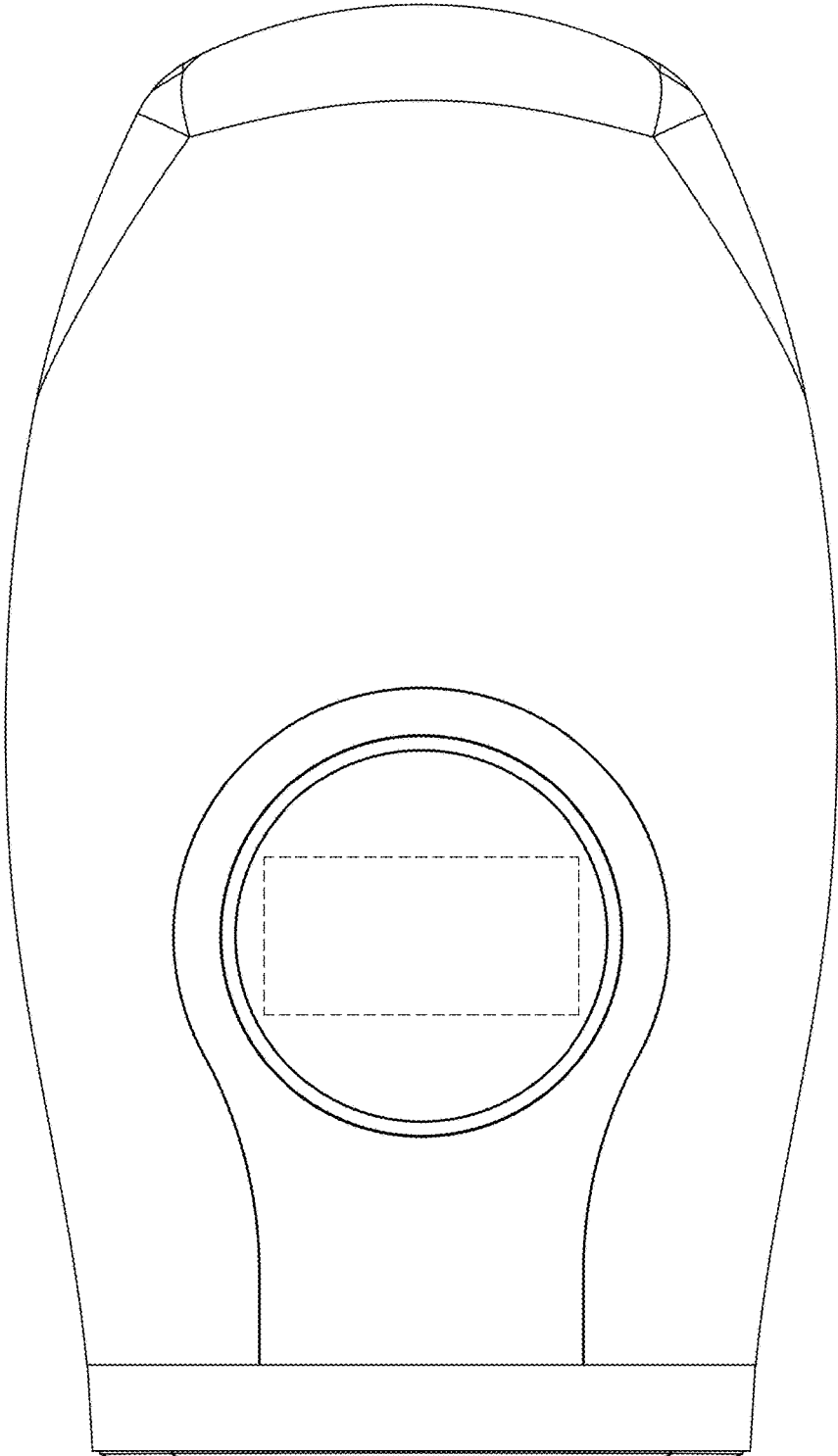

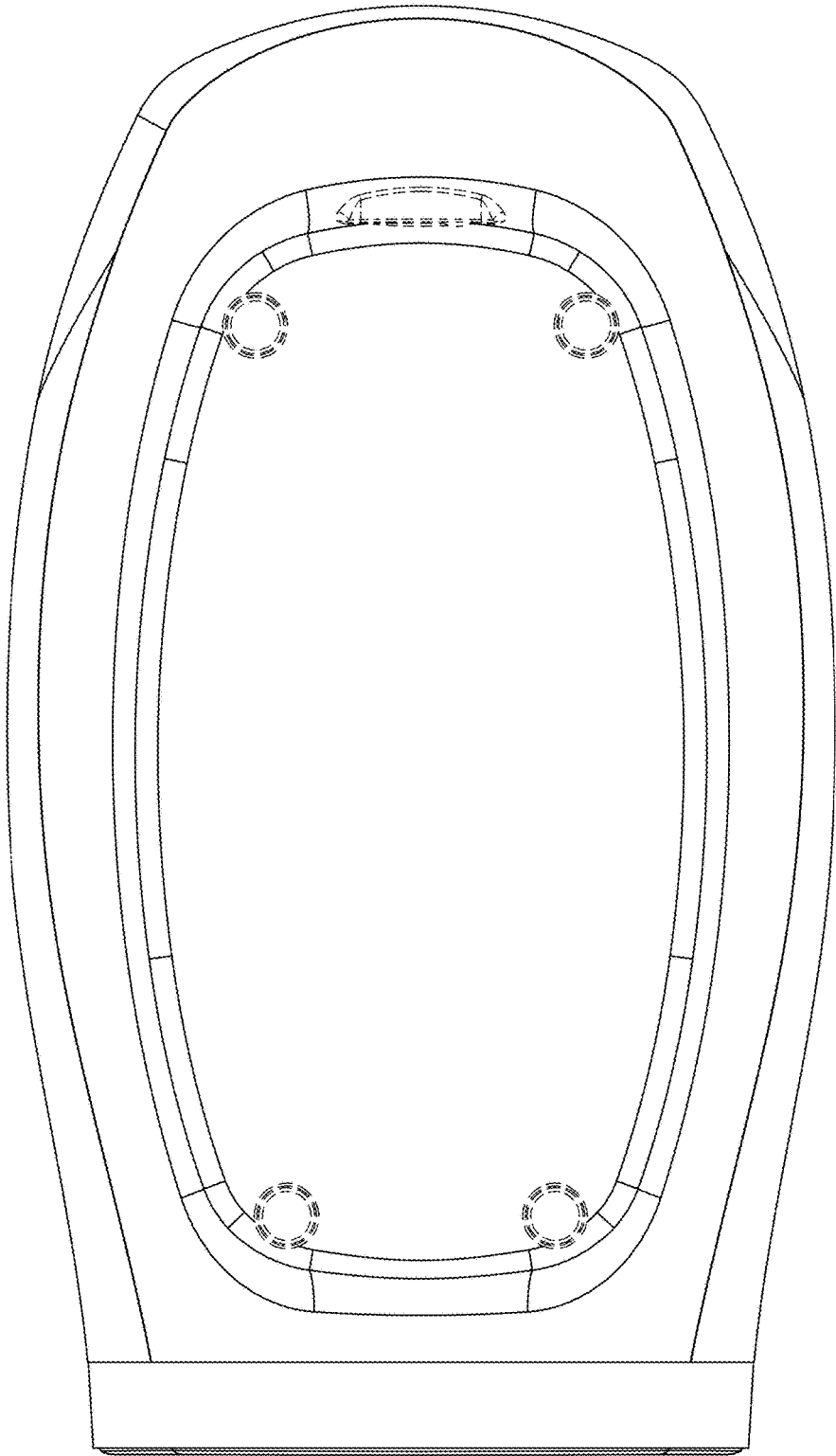

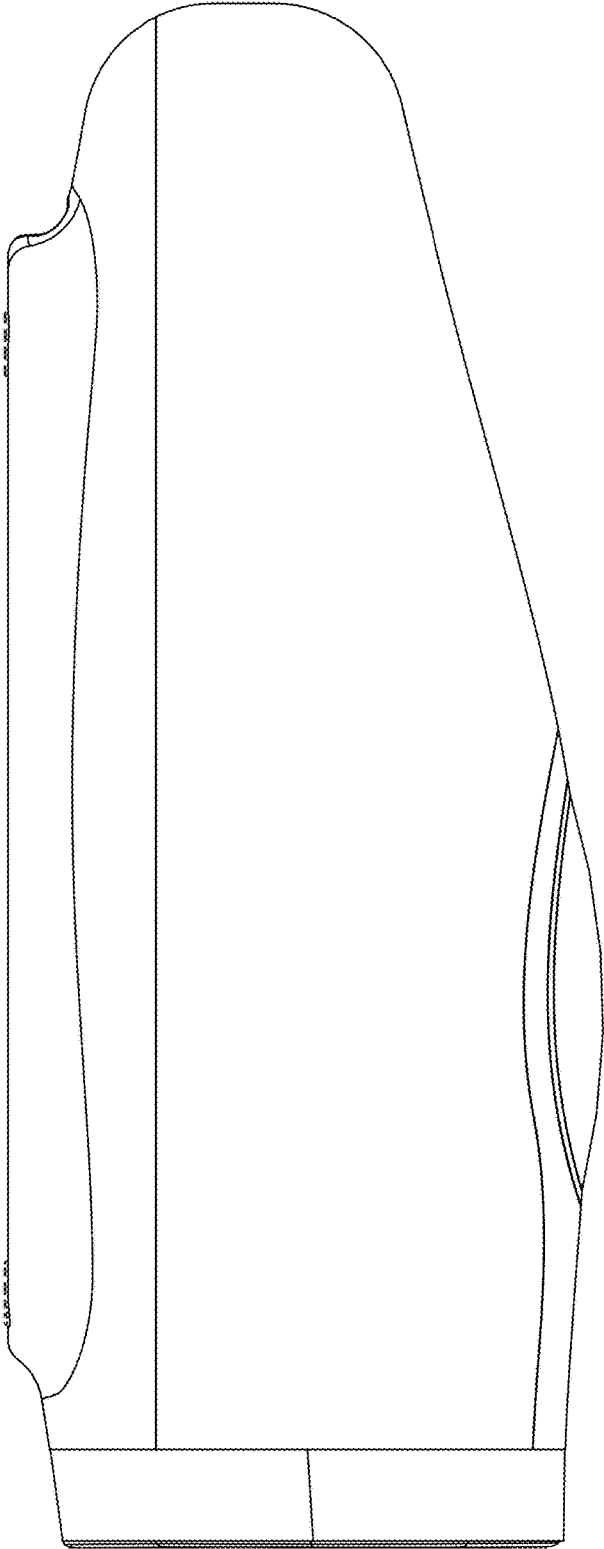

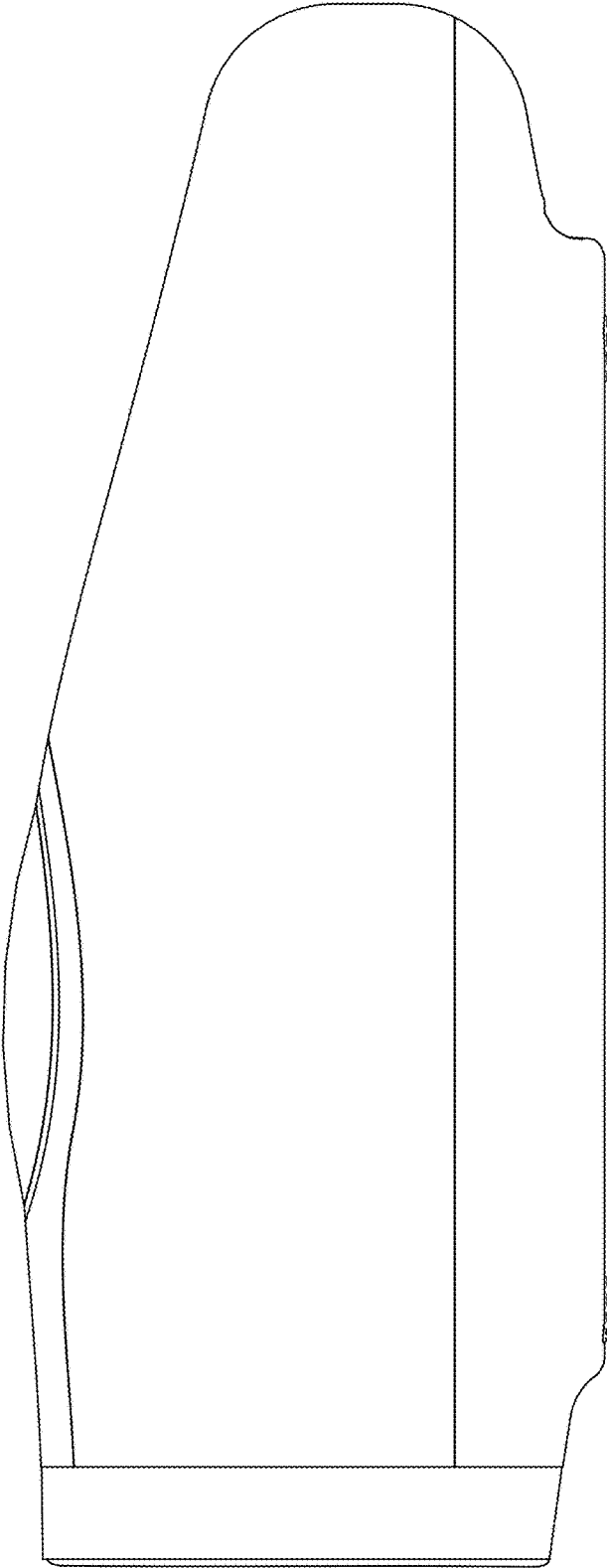

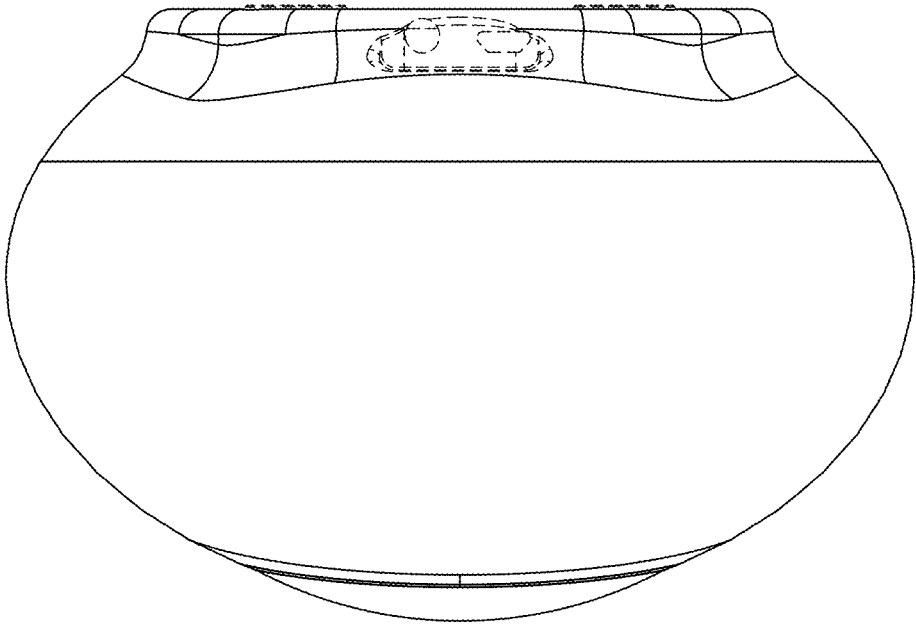

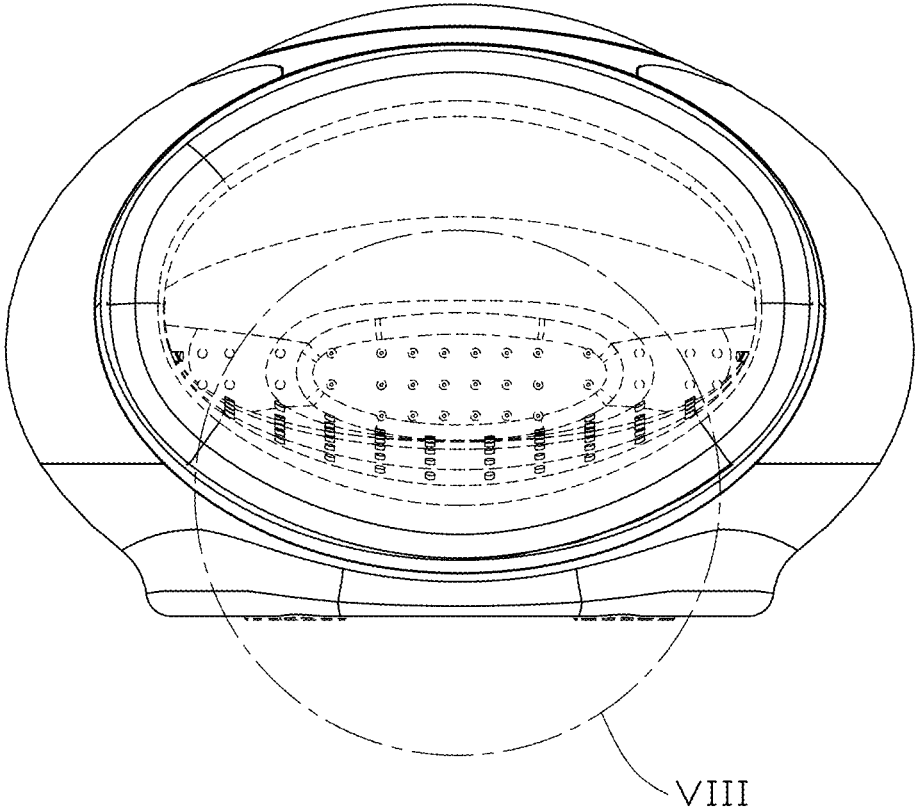

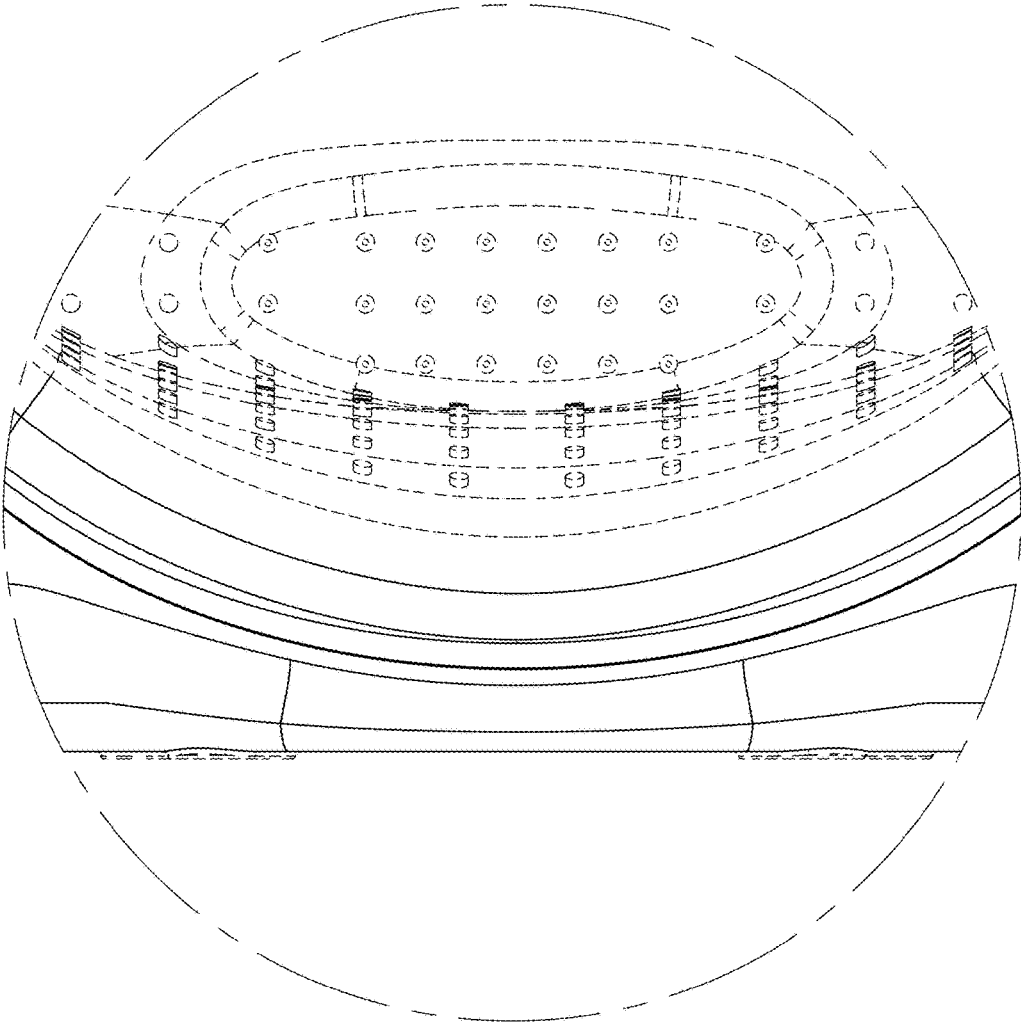
