FIG. 6 is a front view of FIG. 1; and,

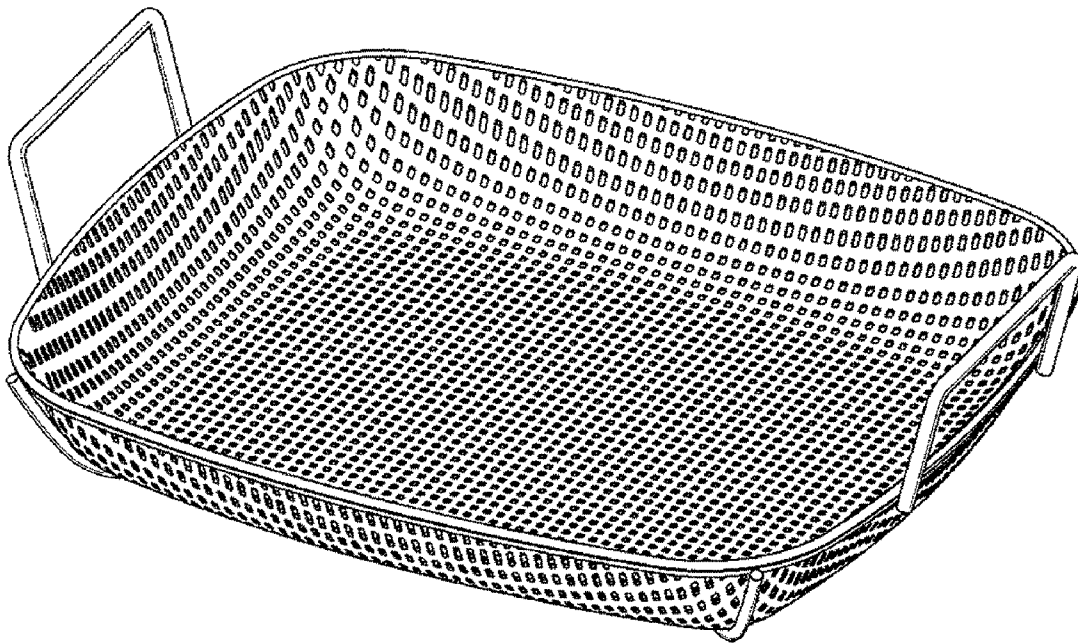
FIG. 7 is a rear view of FIG. 1.

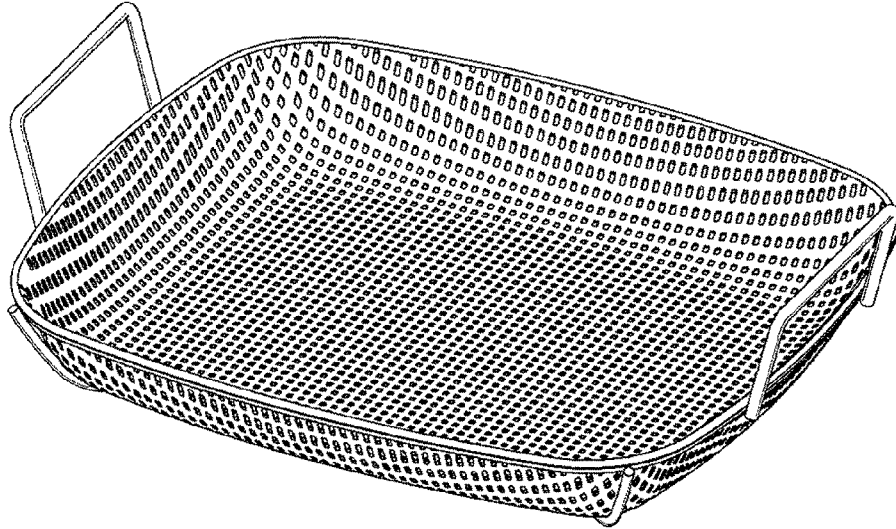

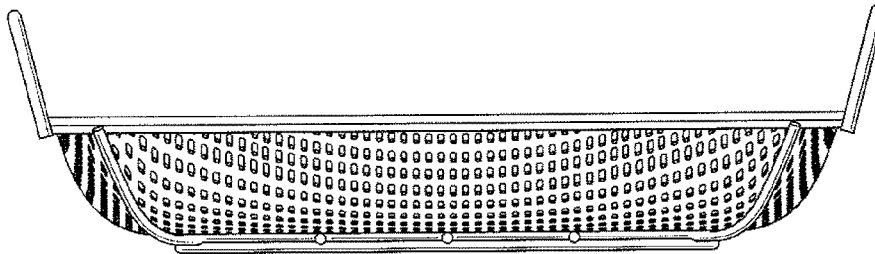

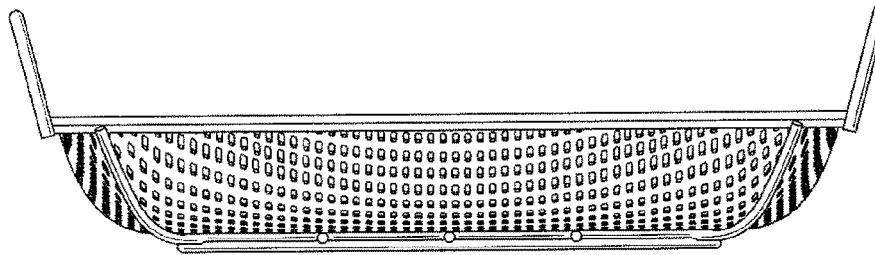

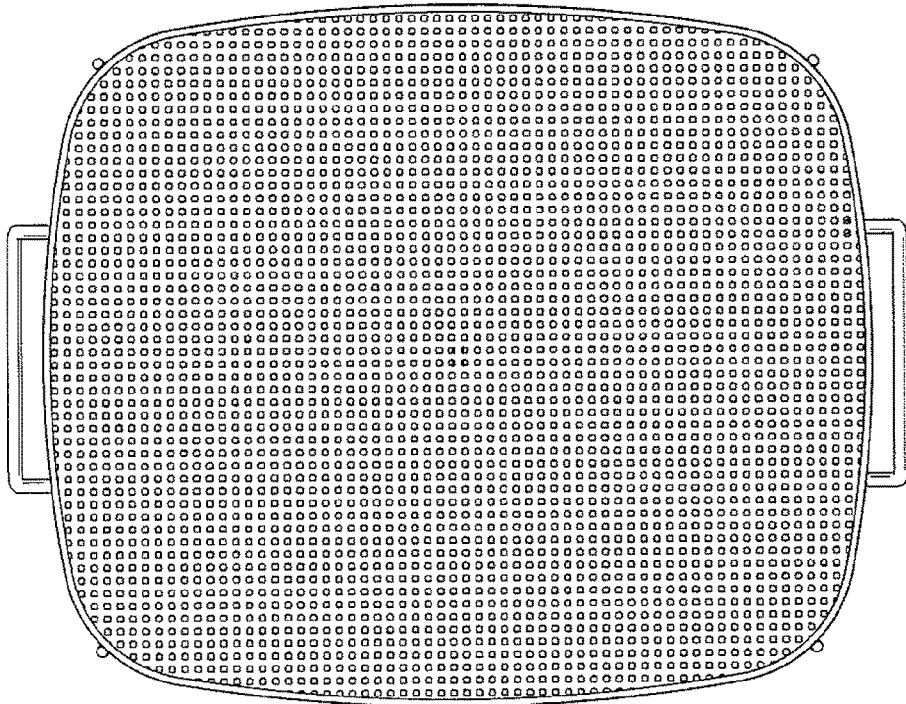

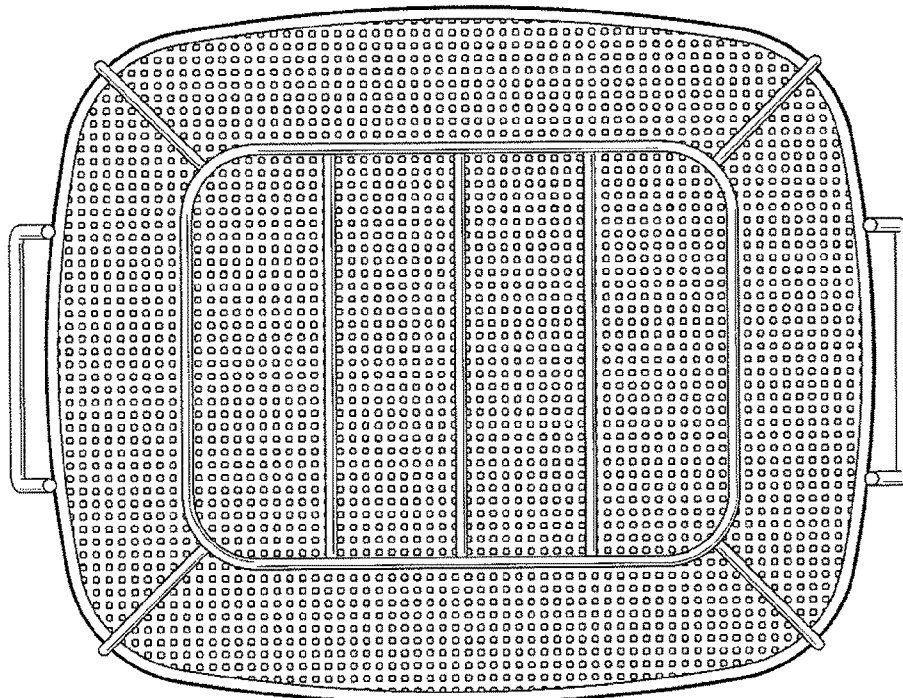

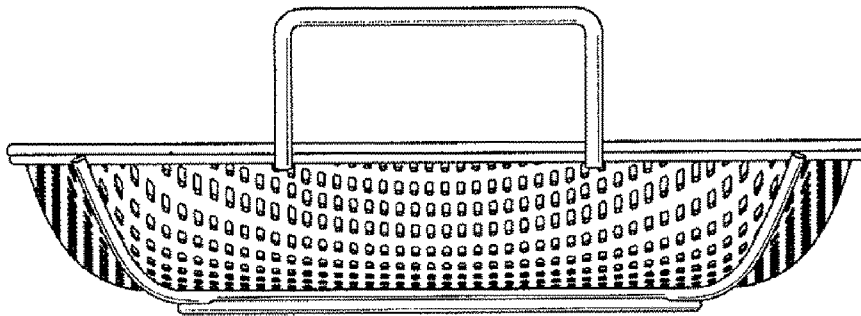

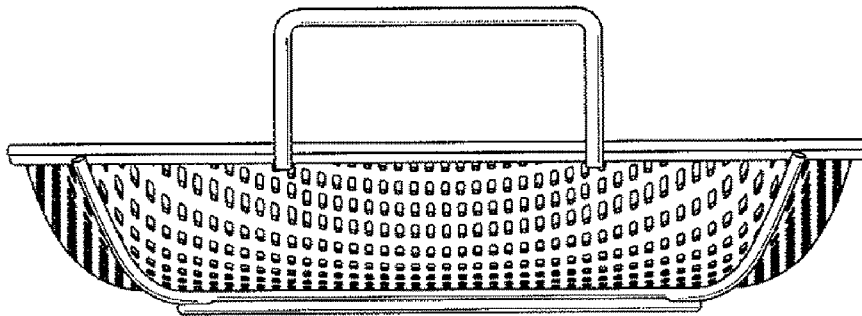
