**1.3** is a rear elevational view thereof;

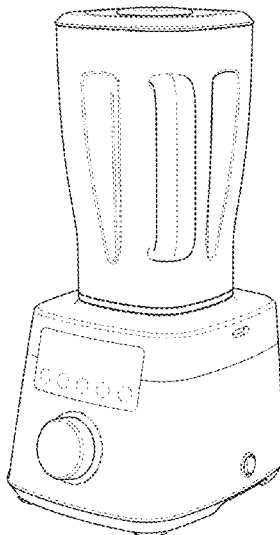
**1.4** is a left side elevational view thereof;

**1.5** is a right side elevational view thereof;

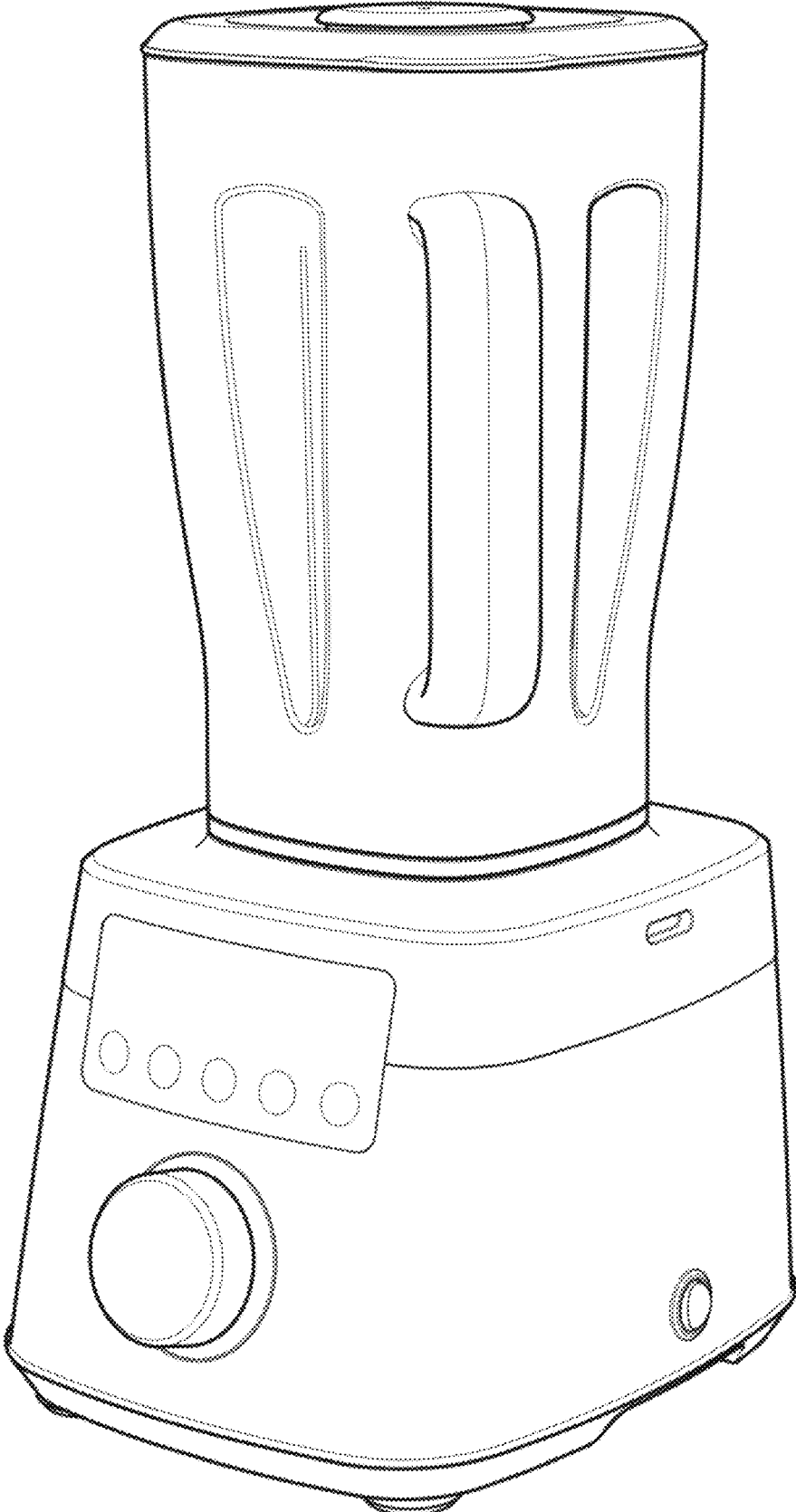
**1.6** is a top plan view thereof; and

**1.7** is a bottom plan view thereof.

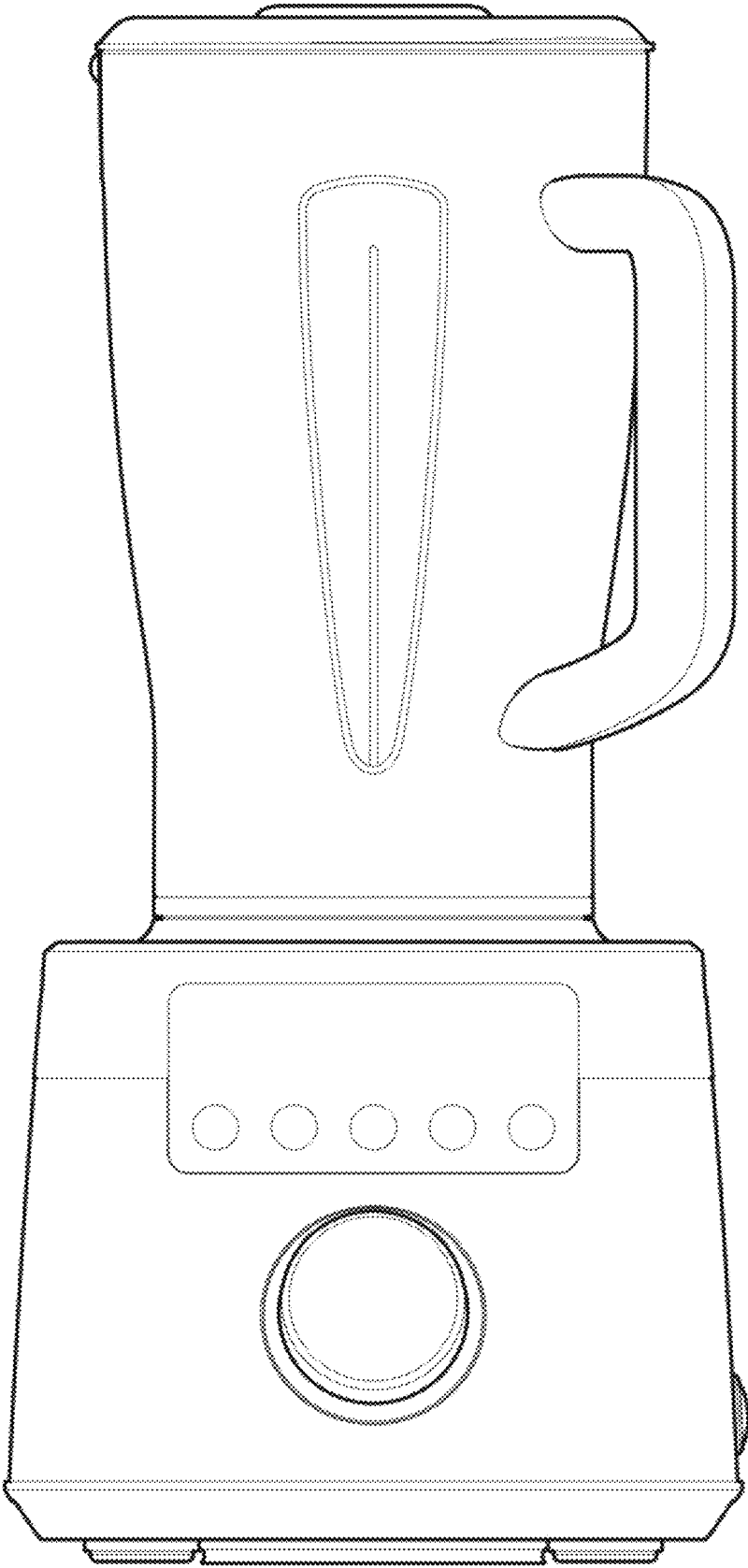

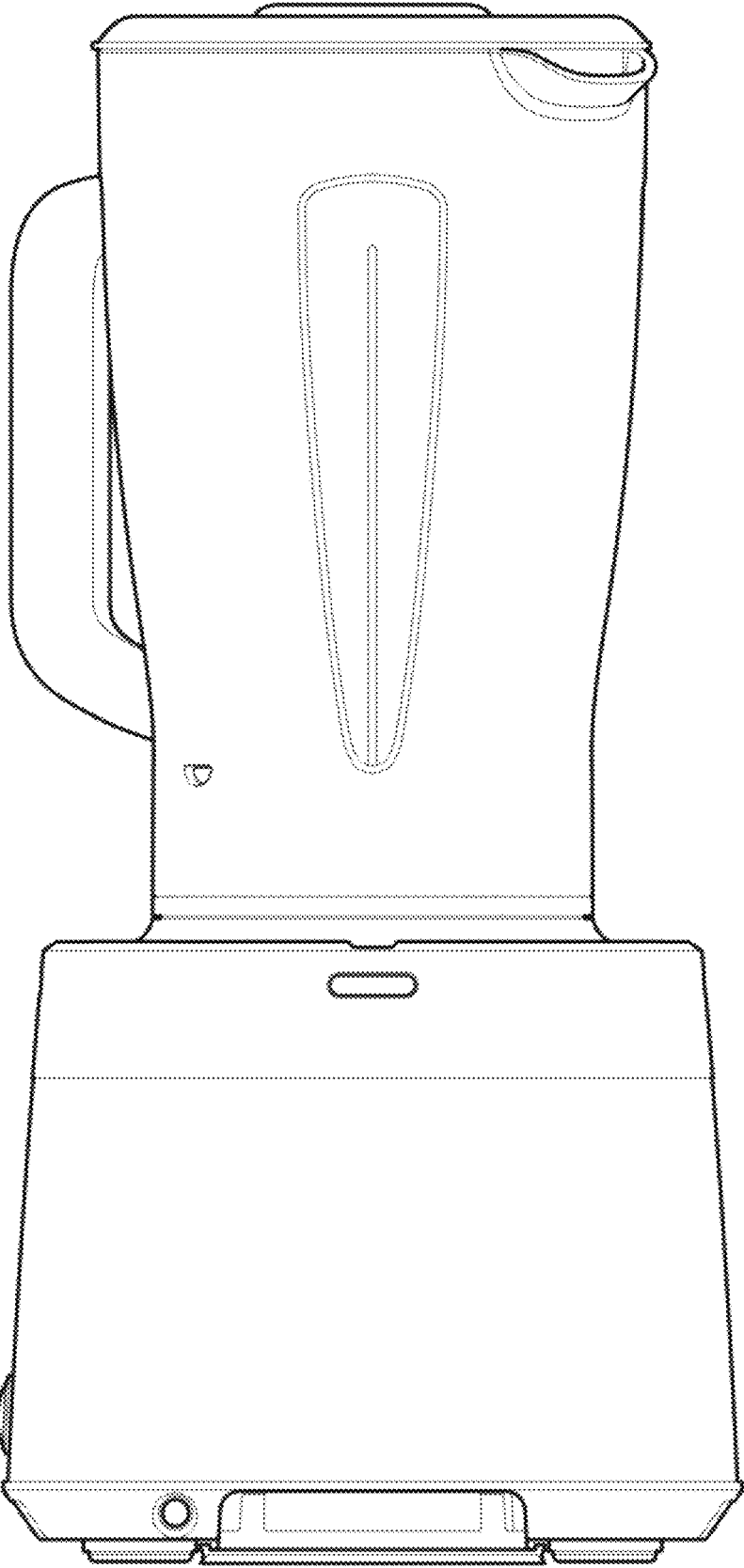

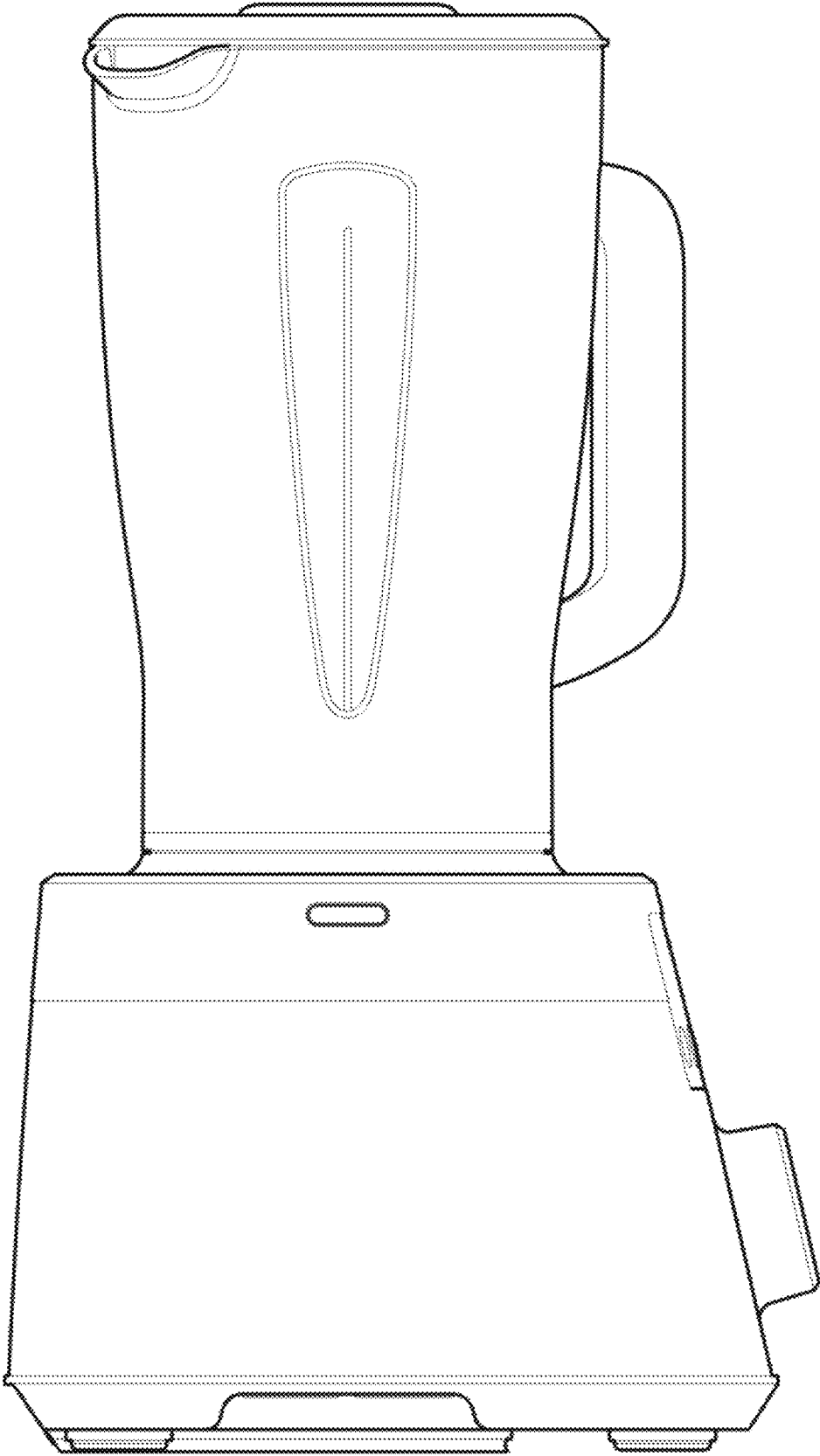

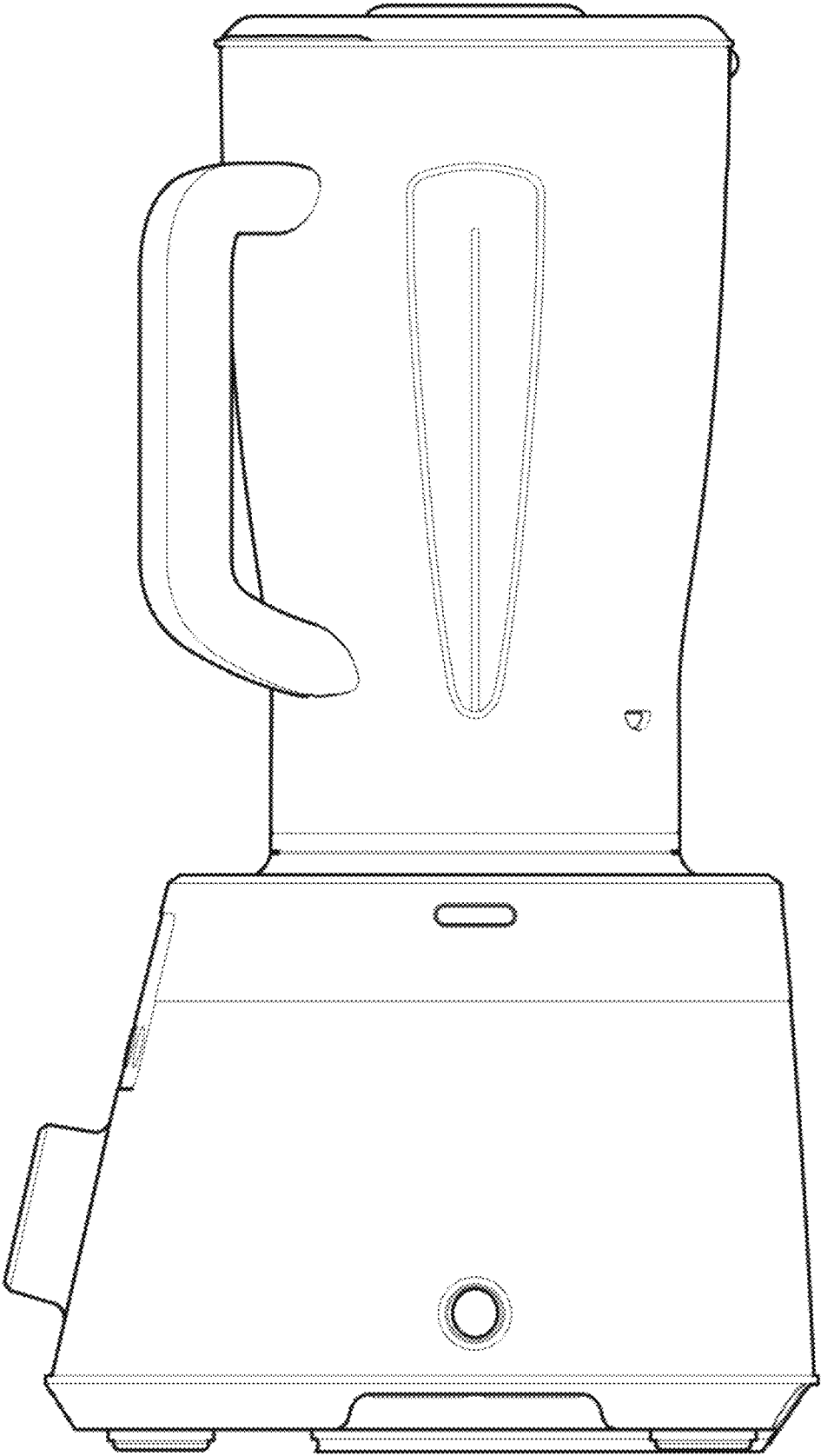

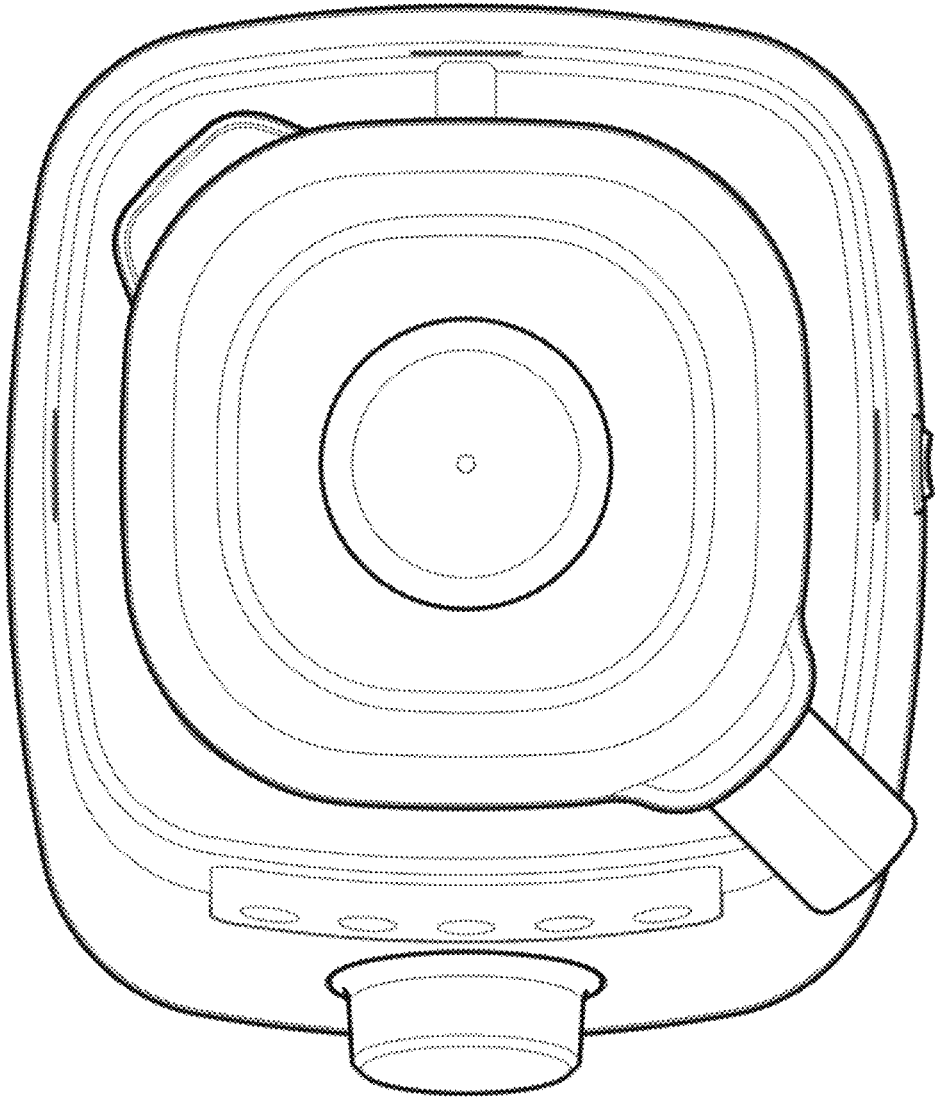
