The ornamental design for a printer machine user interface screen with icon, as shown and described.

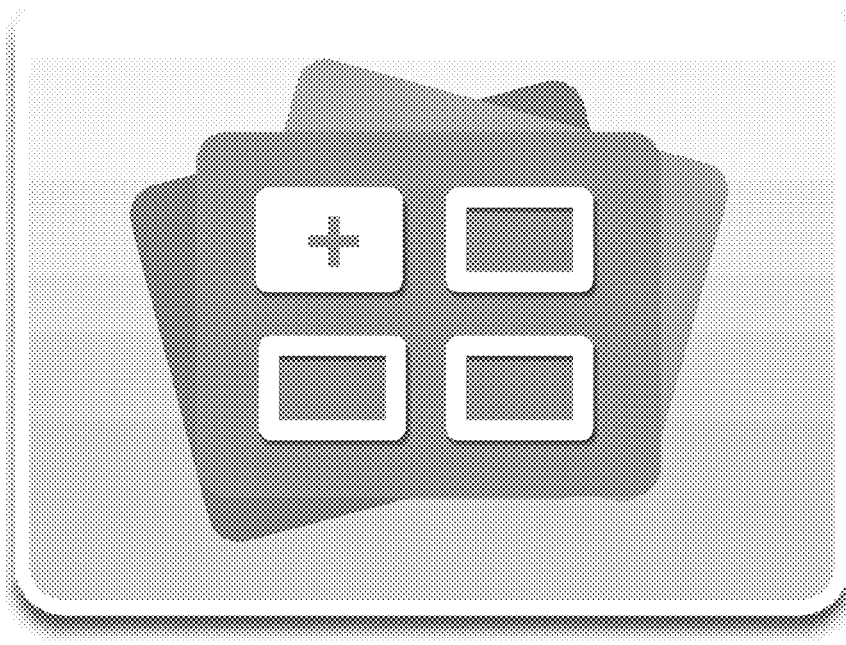
DESCRIPTION

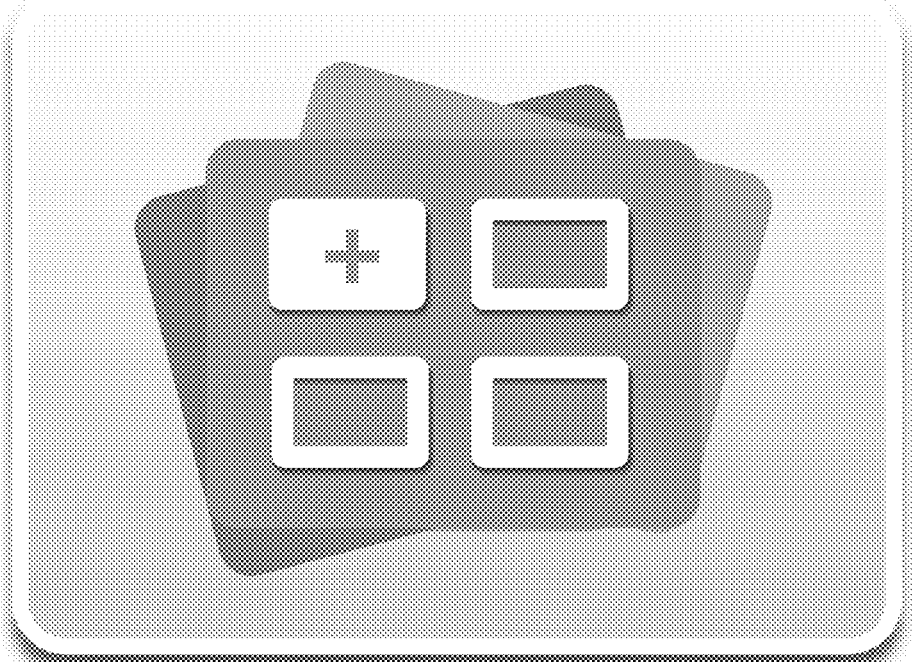

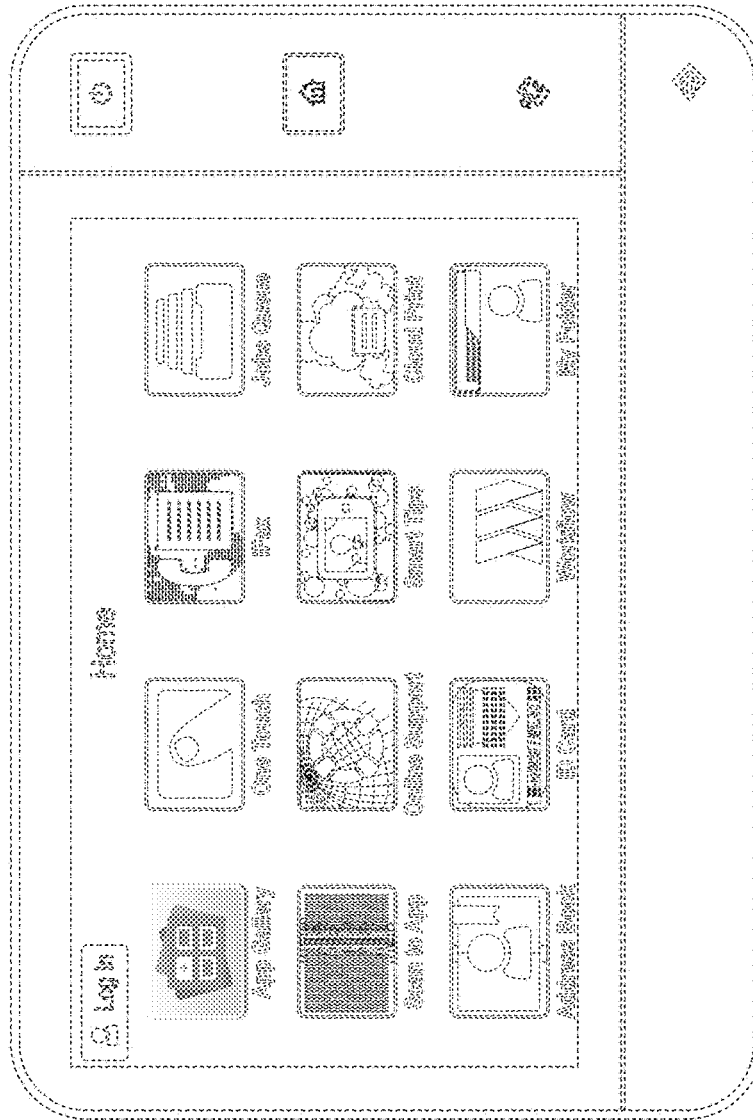
