FIG. 3 is a third sequential image thereof;

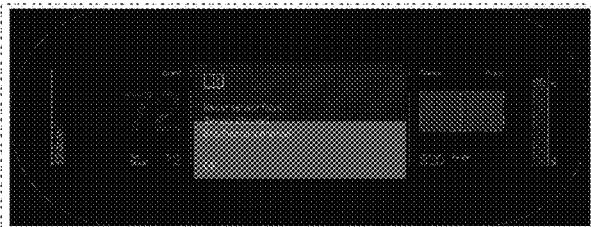
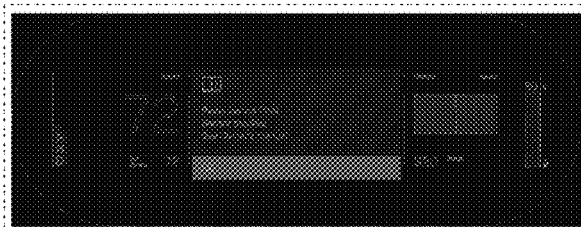
FIG. 4 is a fourth sequential image thereof; and,

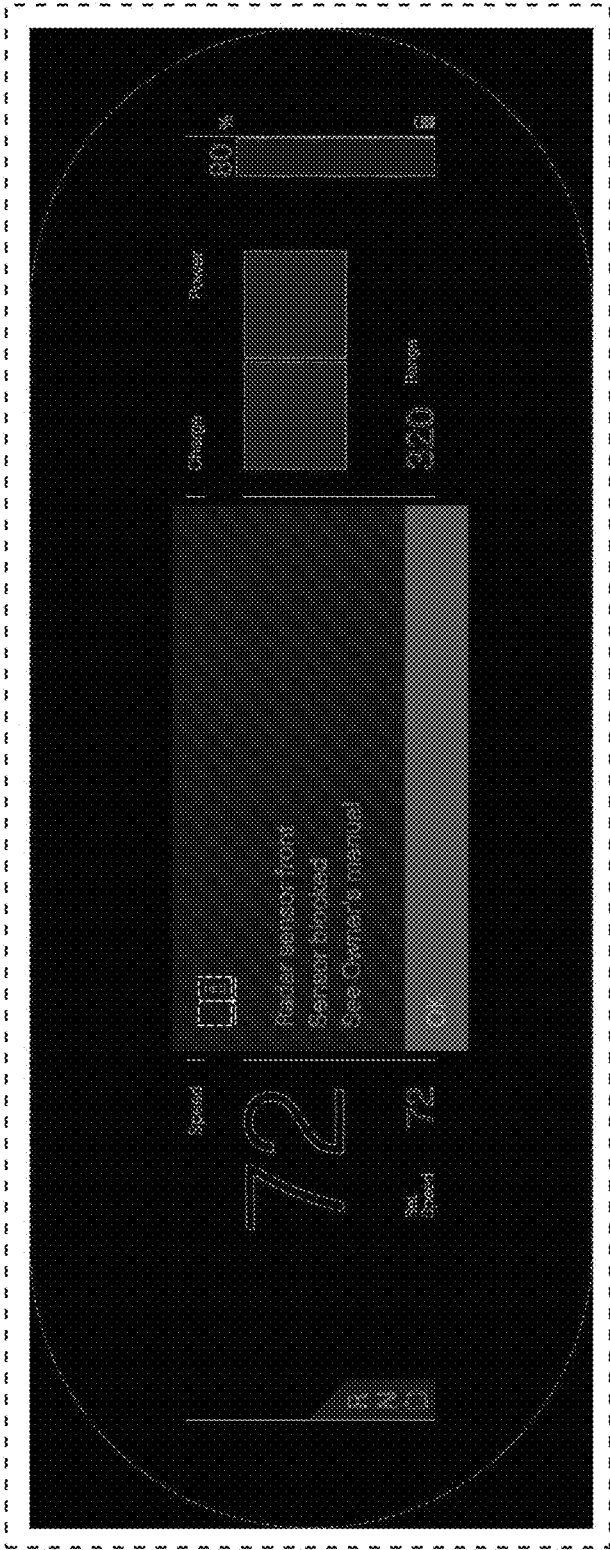

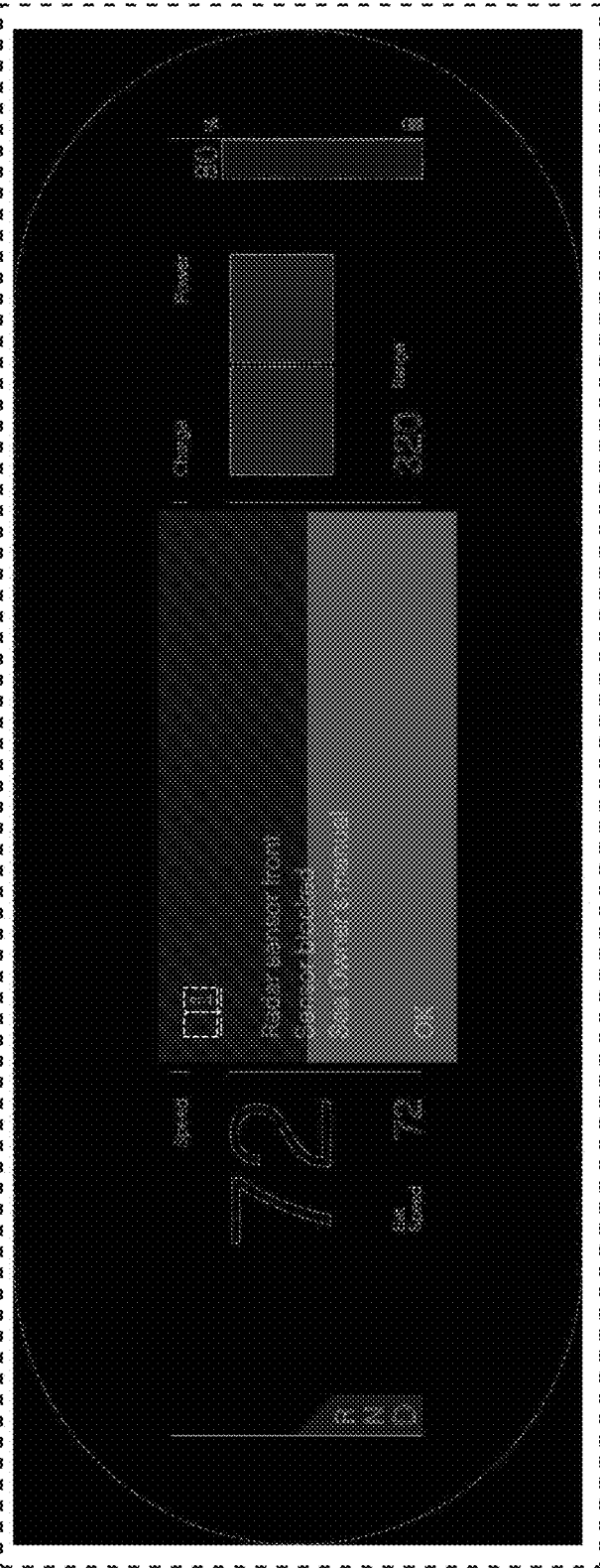

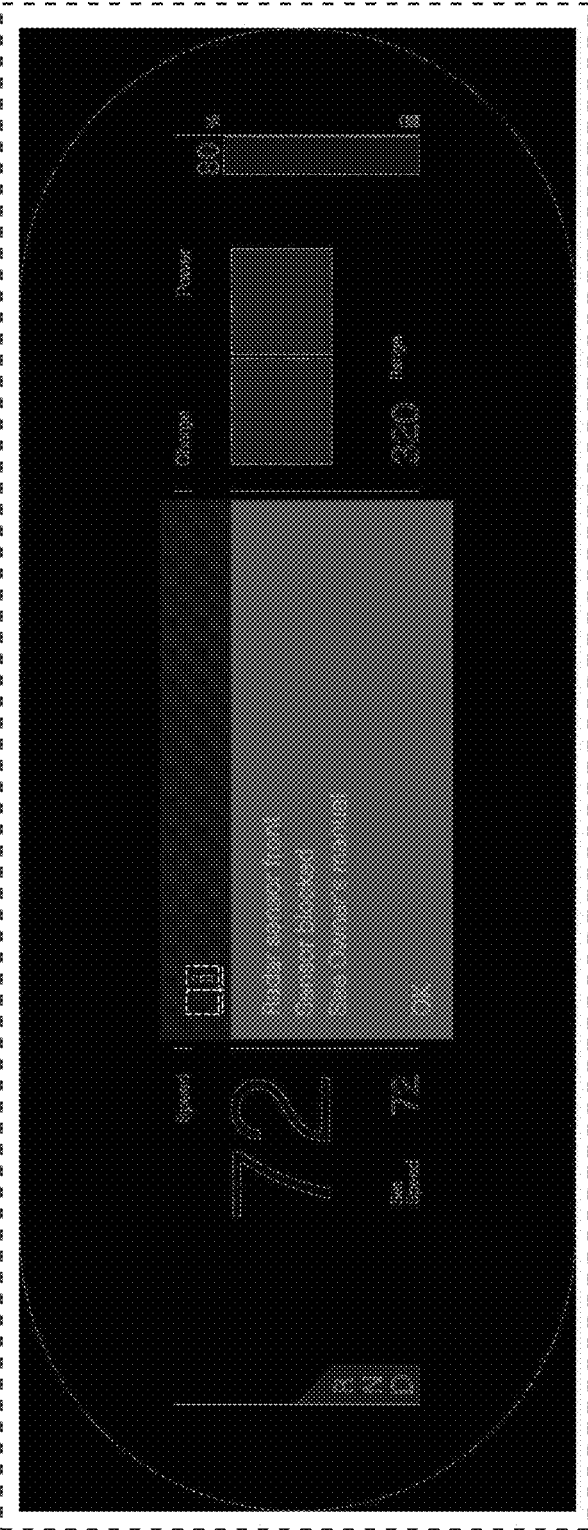

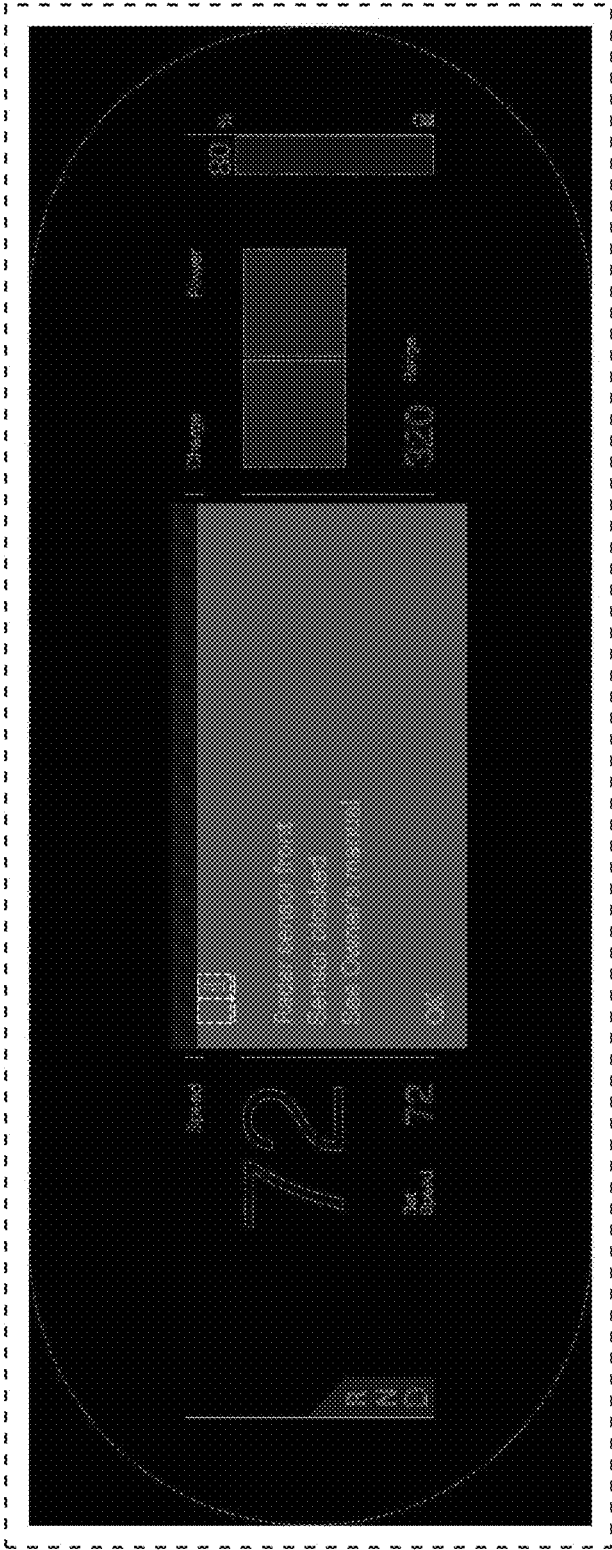

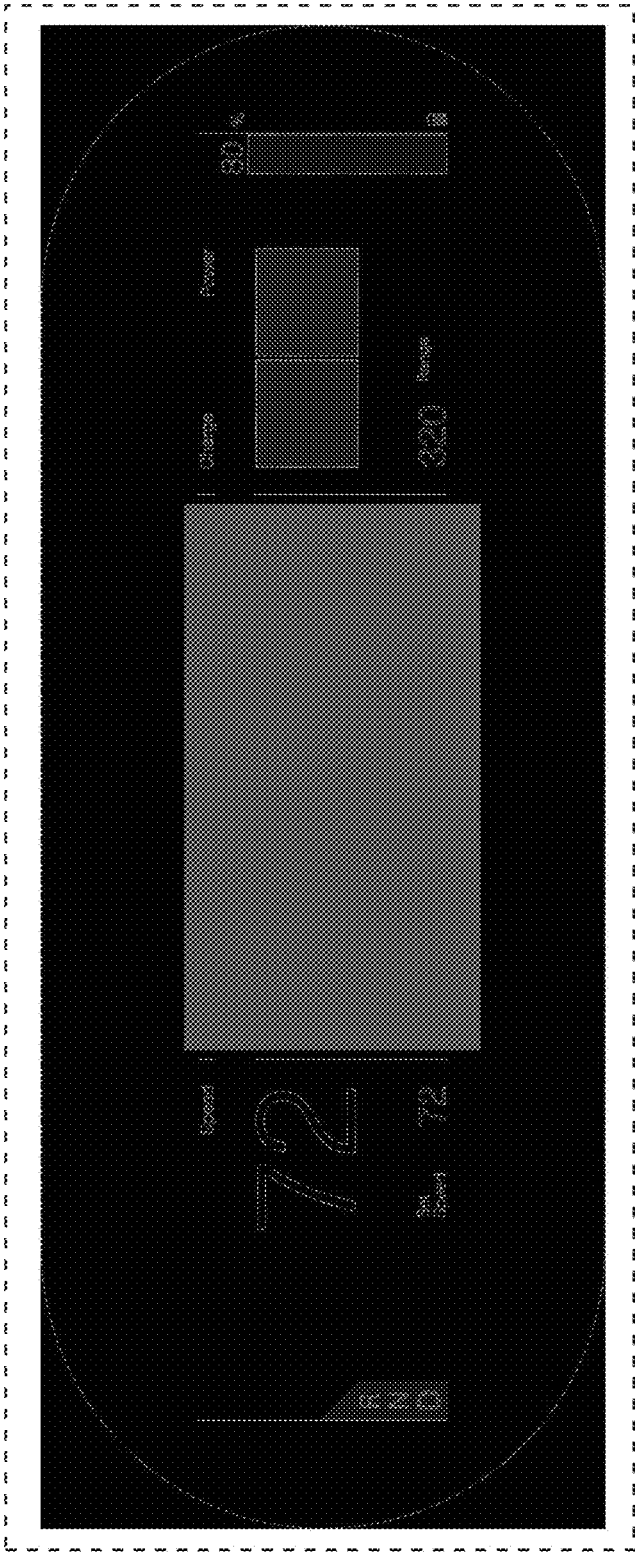
