(57) **CLAIM**

The ornamental design for a towel with a detachable pocket, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a towel with a detachable pocket showing the new design, with the pocket attached to the towel;
 FIG. 2 is a rear elevation view thereof;
 FIG. 3 is a front elevation view thereof, with the detachable pocket separated from the towel;
 FIG. 4 is a rear elevation view thereof, with the detachable pocket separated from the towel;
 FIG. 5 is a front perspective view thereof, with the detachable pocket open and attached to the towel;
 FIG. 6 is a front elevation view of an alternative embodiment of the towel with a detachable pocket of FIG. 1;
 FIG. 7 is a rear elevation view of the alternative embodiment of FIG. 6;
 FIG. 8 is a front elevation view of the alternative embodiment of FIG. 6, with the detachable pocket separated from the towel;
 FIG. 9 is a rear elevation view of the alternative embodiment of FIG. 6, with the detachable pocket separated from the towel;
 FIG. 10 is a front elevation view of another alternative embodiment of the towel with a detachable pocket of FIG. 1;
 FIG. 11 is a rear elevation view of the alternative embodiment of FIG. 10;
 FIG. 12 is a front elevation view of the alternative embodiment of FIG. 10, with the detachable pocket separated from the towel;
 FIG. 13 is a rear elevation view of the alternative embodiment of FIG. 10, with the detachable pocket separated from the towel;
 FIG. 14 is a front perspective view of the alternative embodiment of FIG. 10, with the detachable pocket open and attached to the towel;
 FIG. 15 is a front elevation view of another alternative embodiment of the towel with a detachable pocket of FIG. 1;

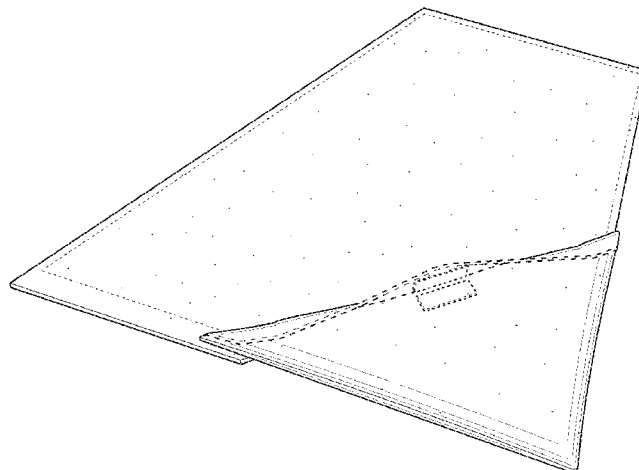


FIG. 16 is a rear elevation view of the alternative embodiment of FIG. 15;

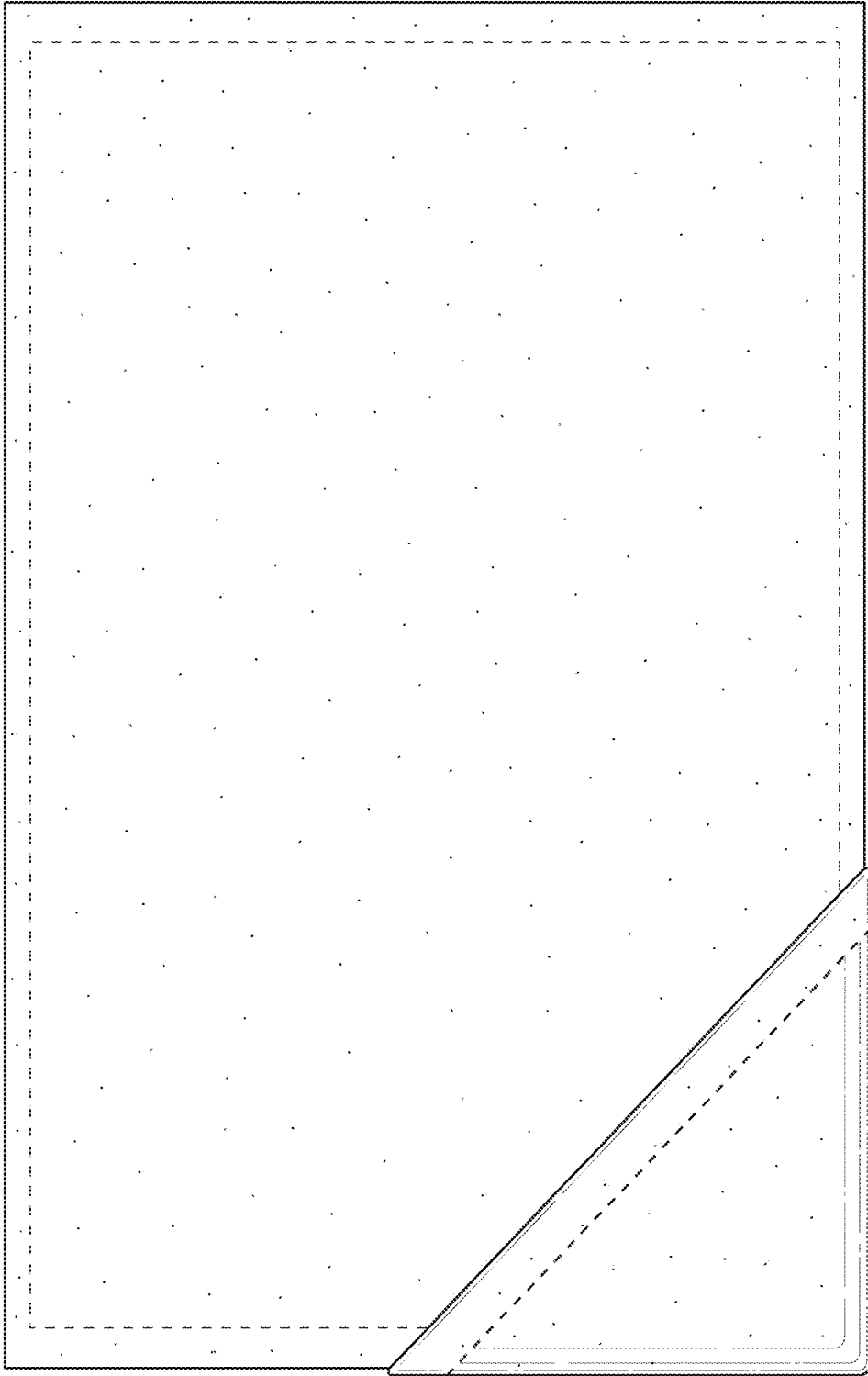

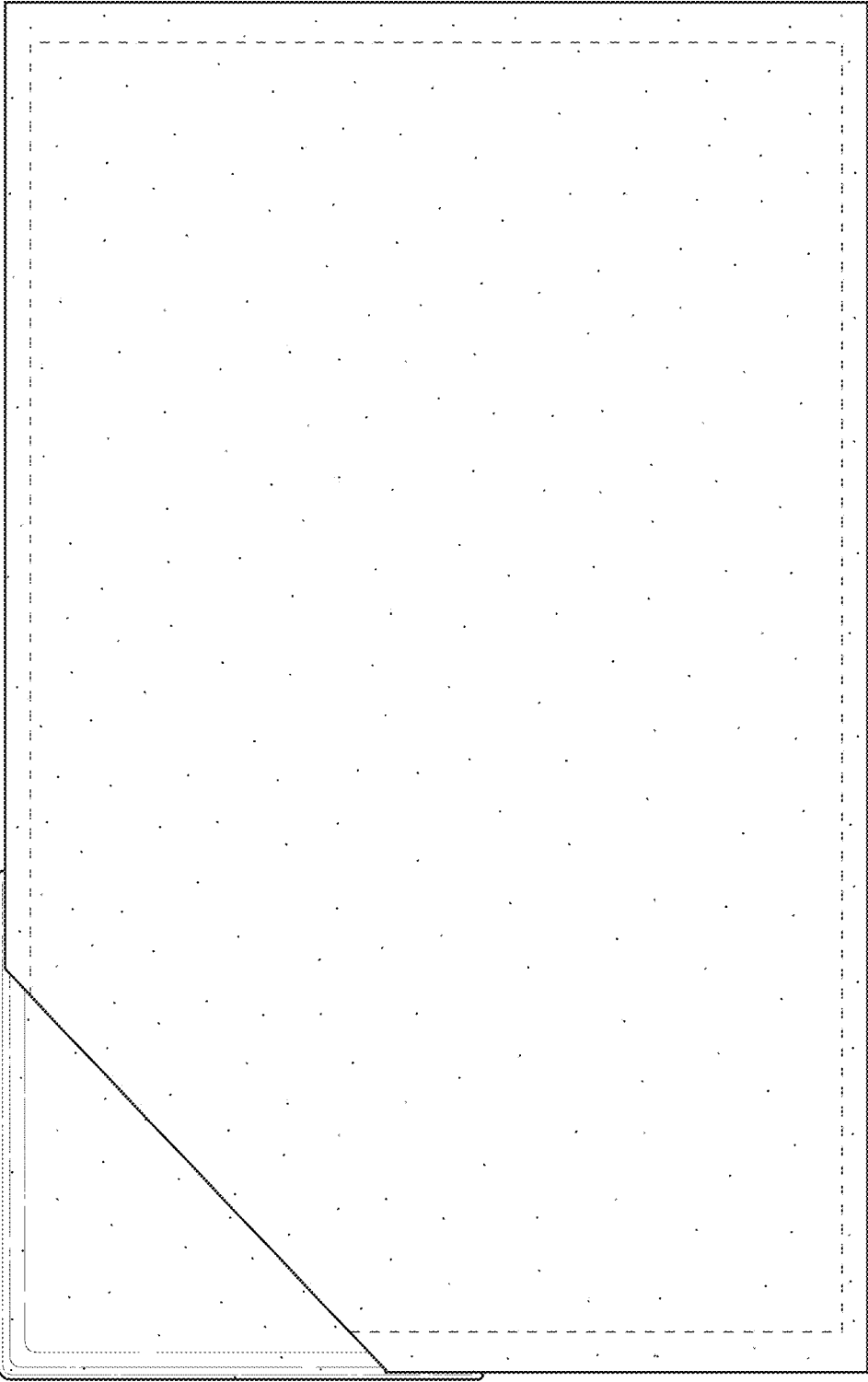

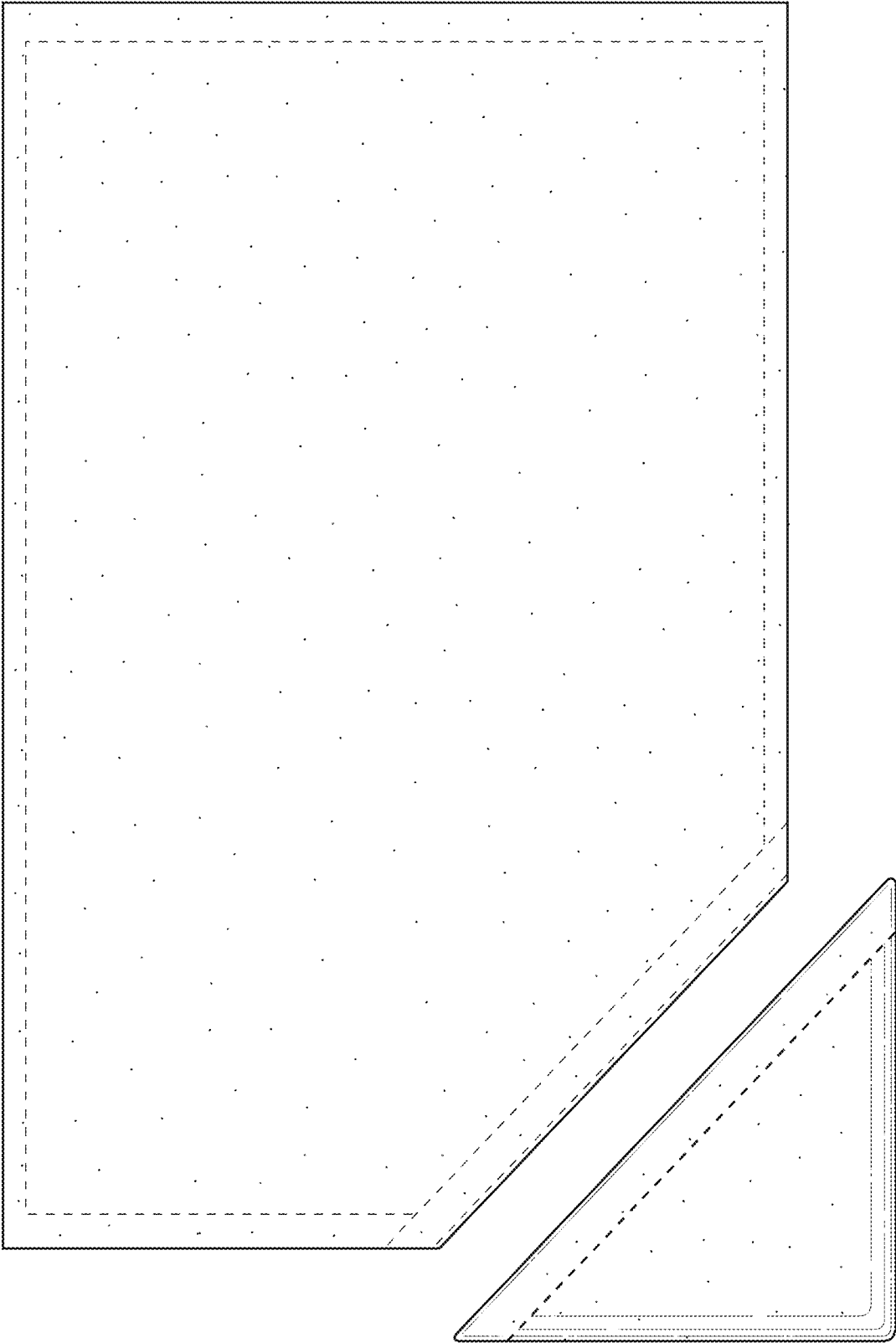

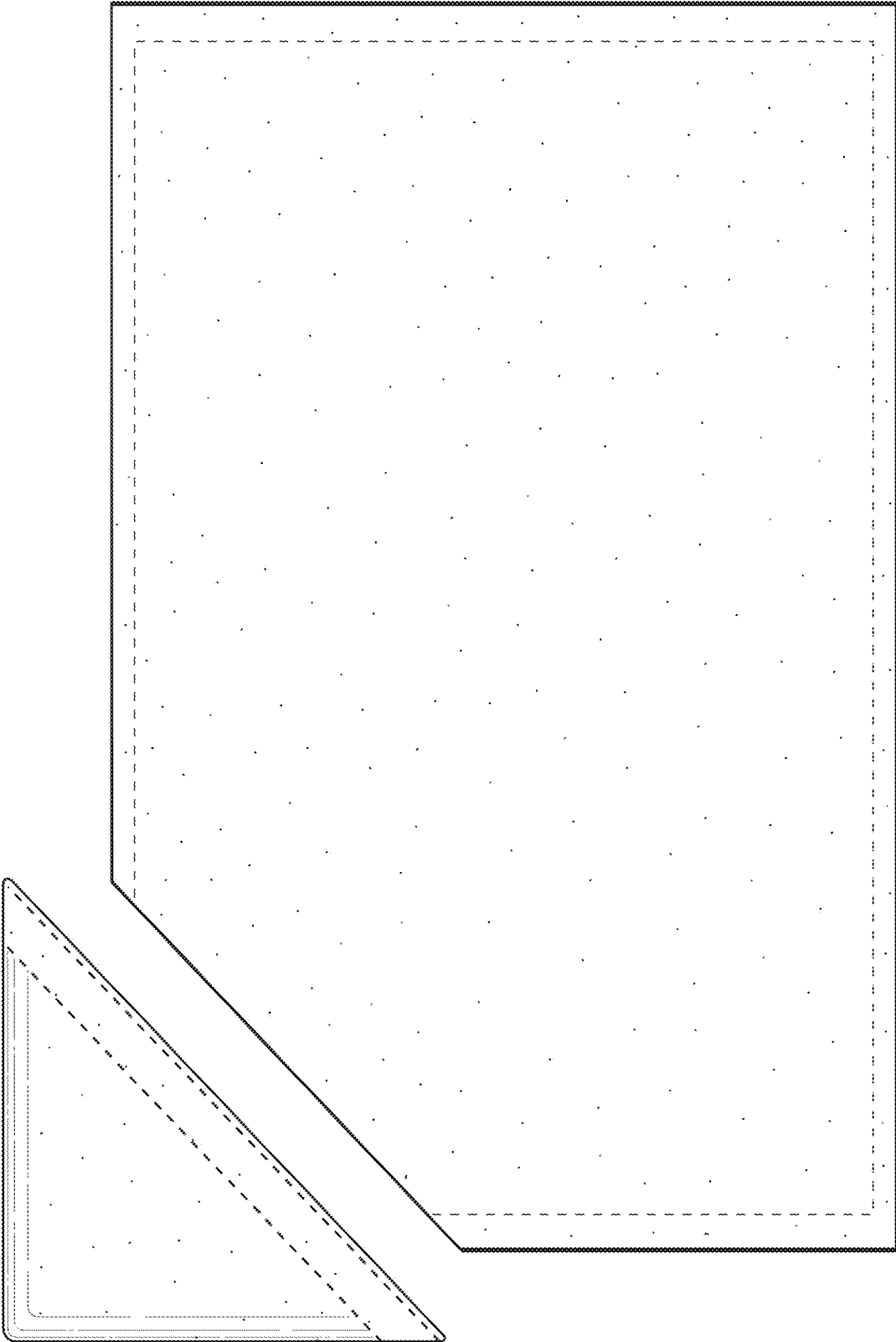

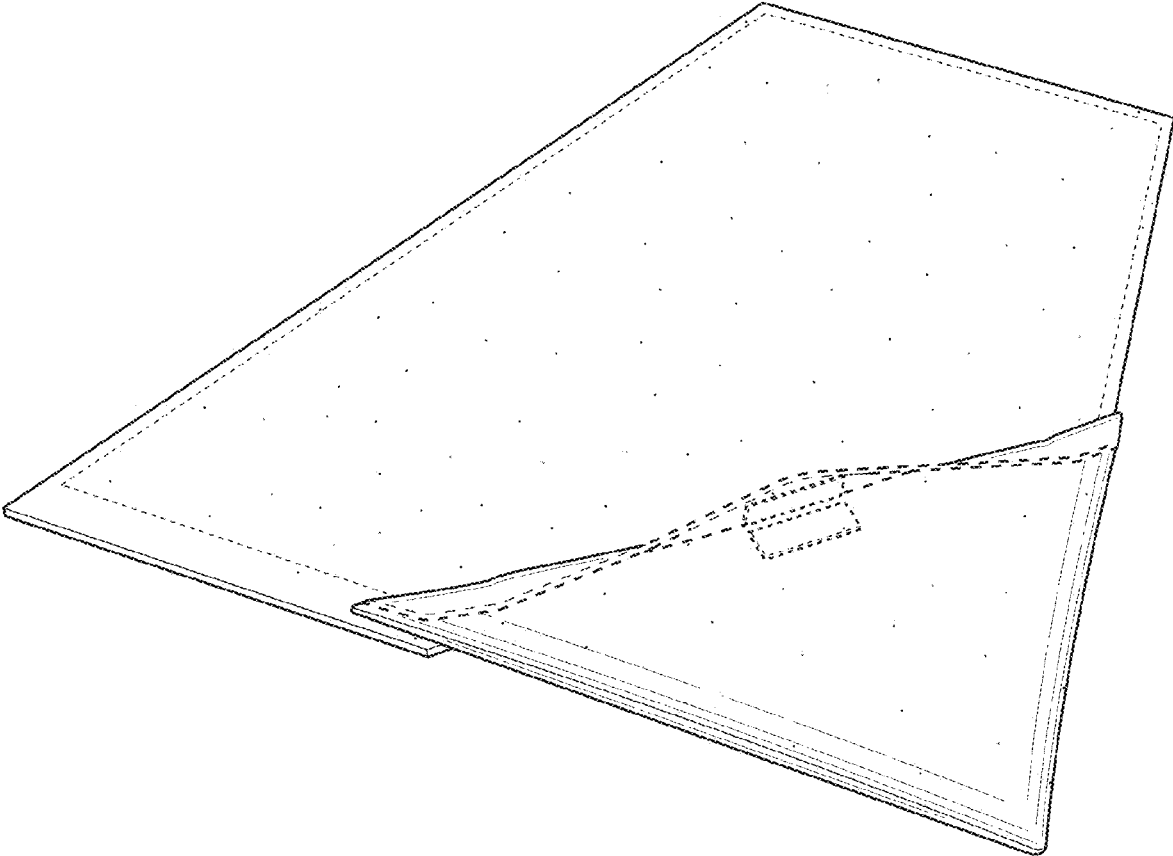

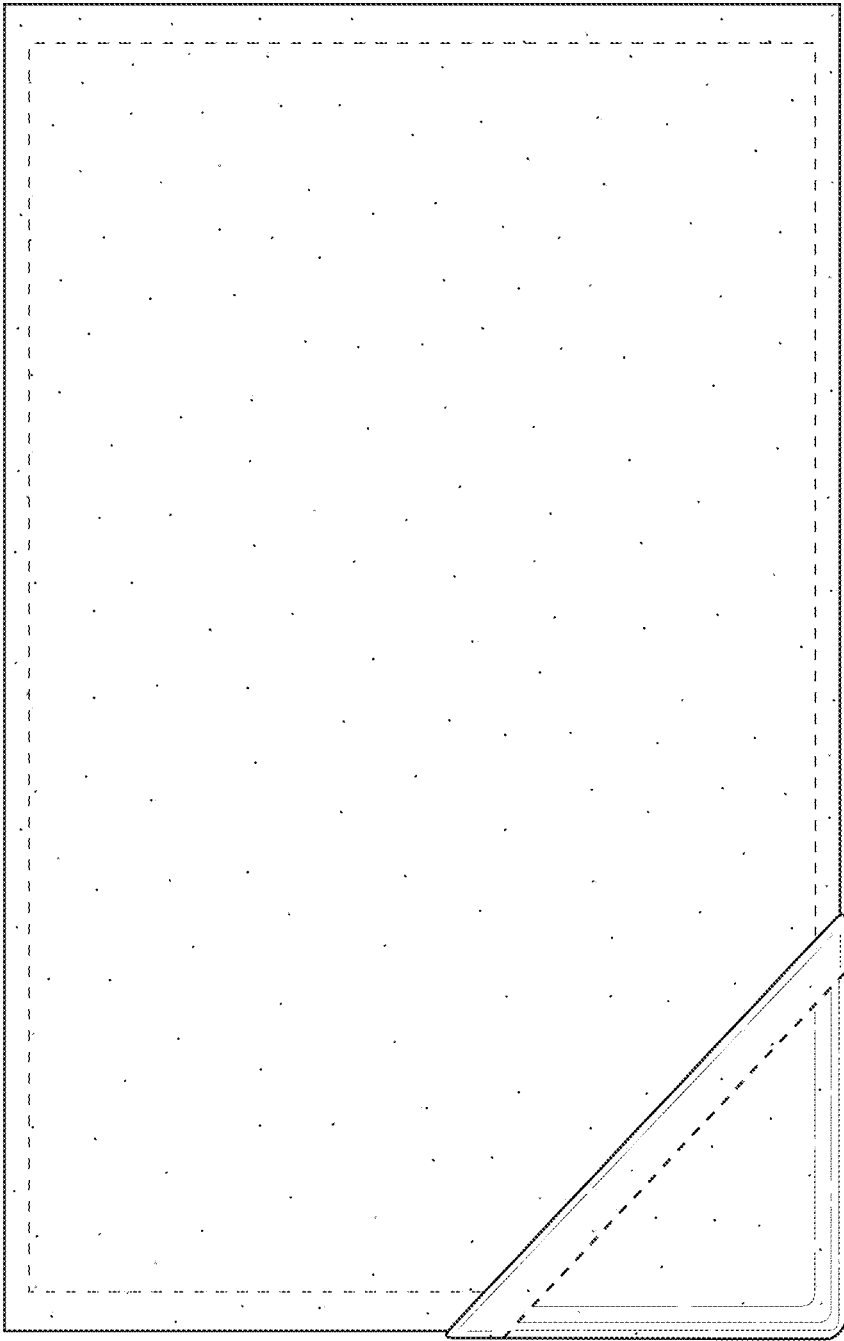

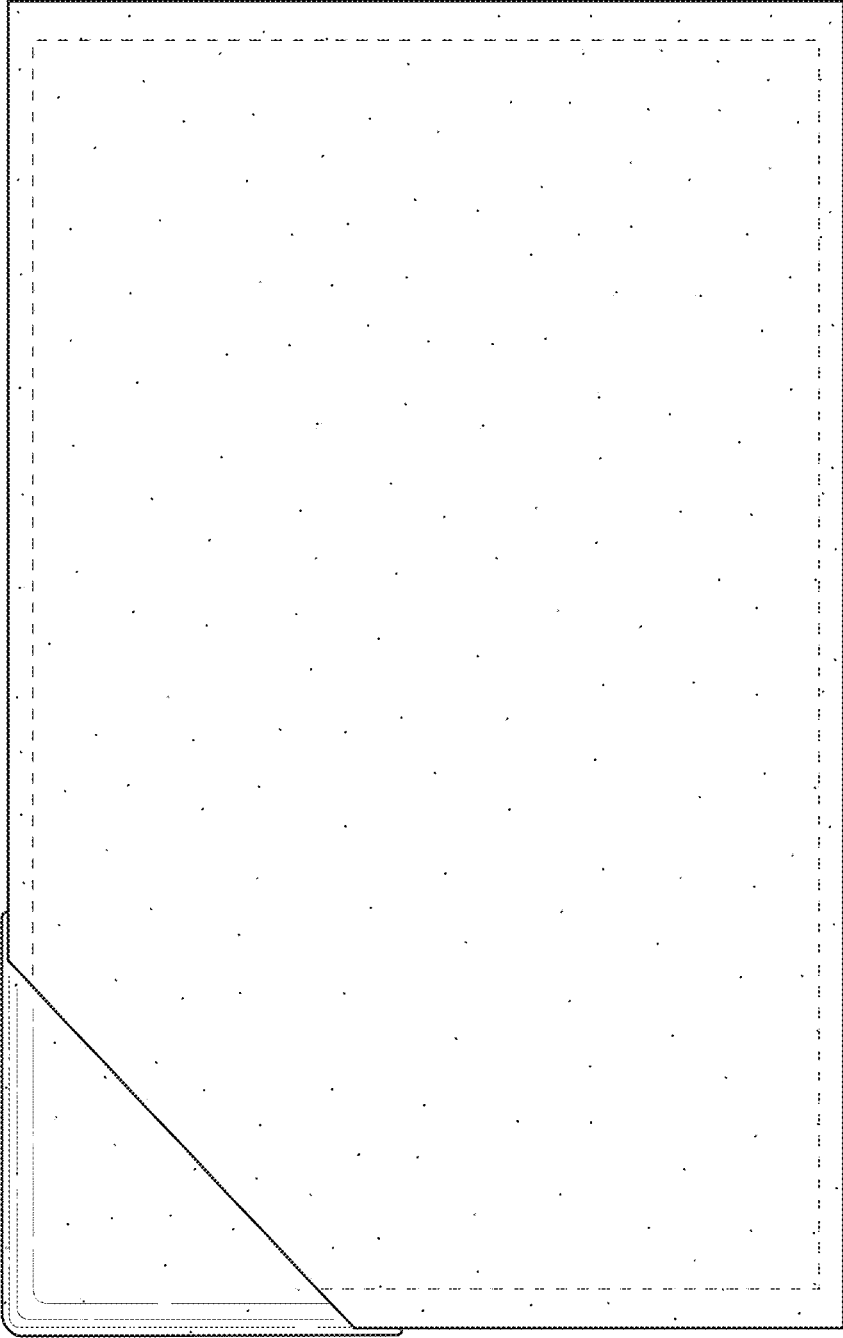

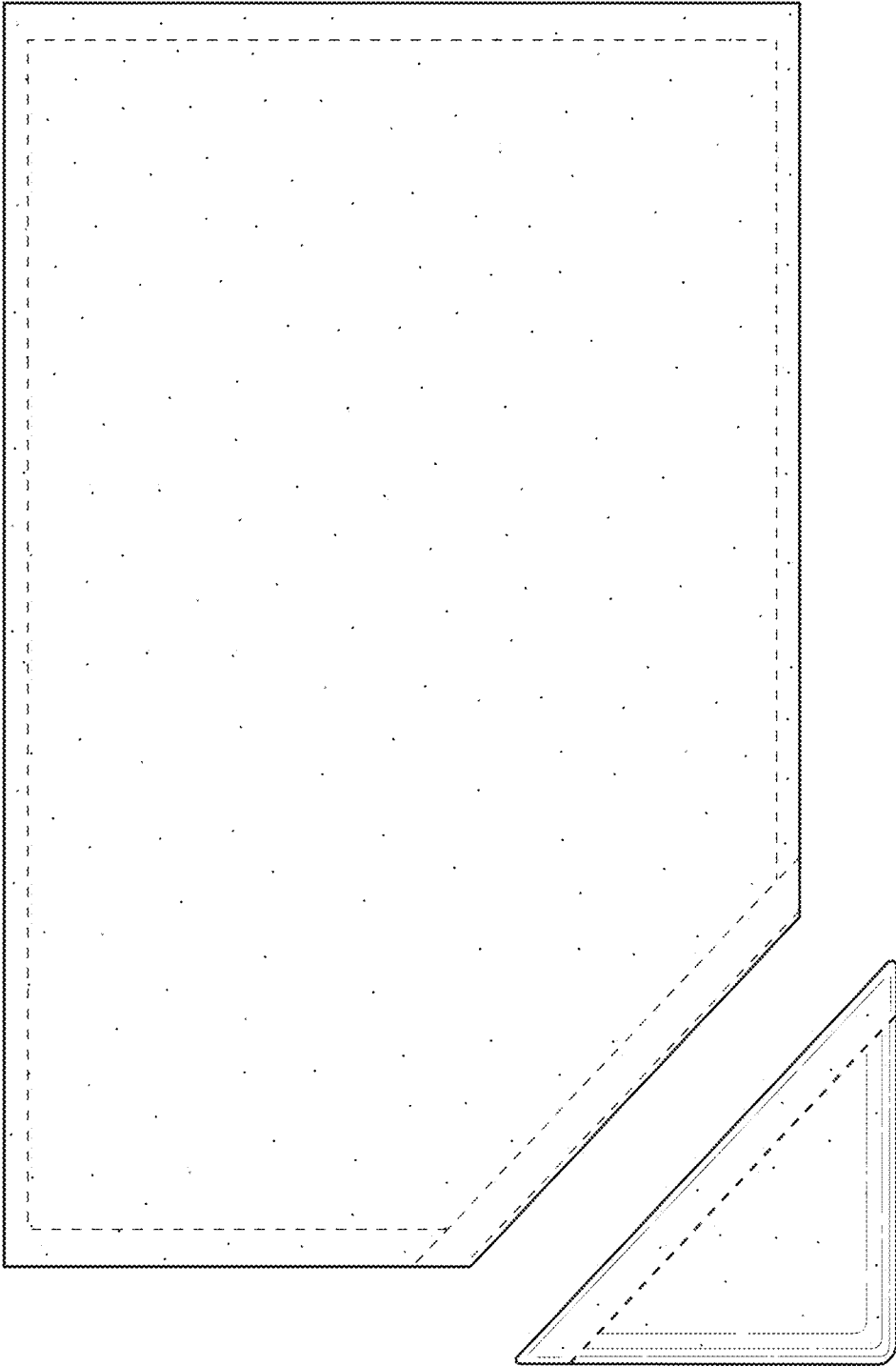

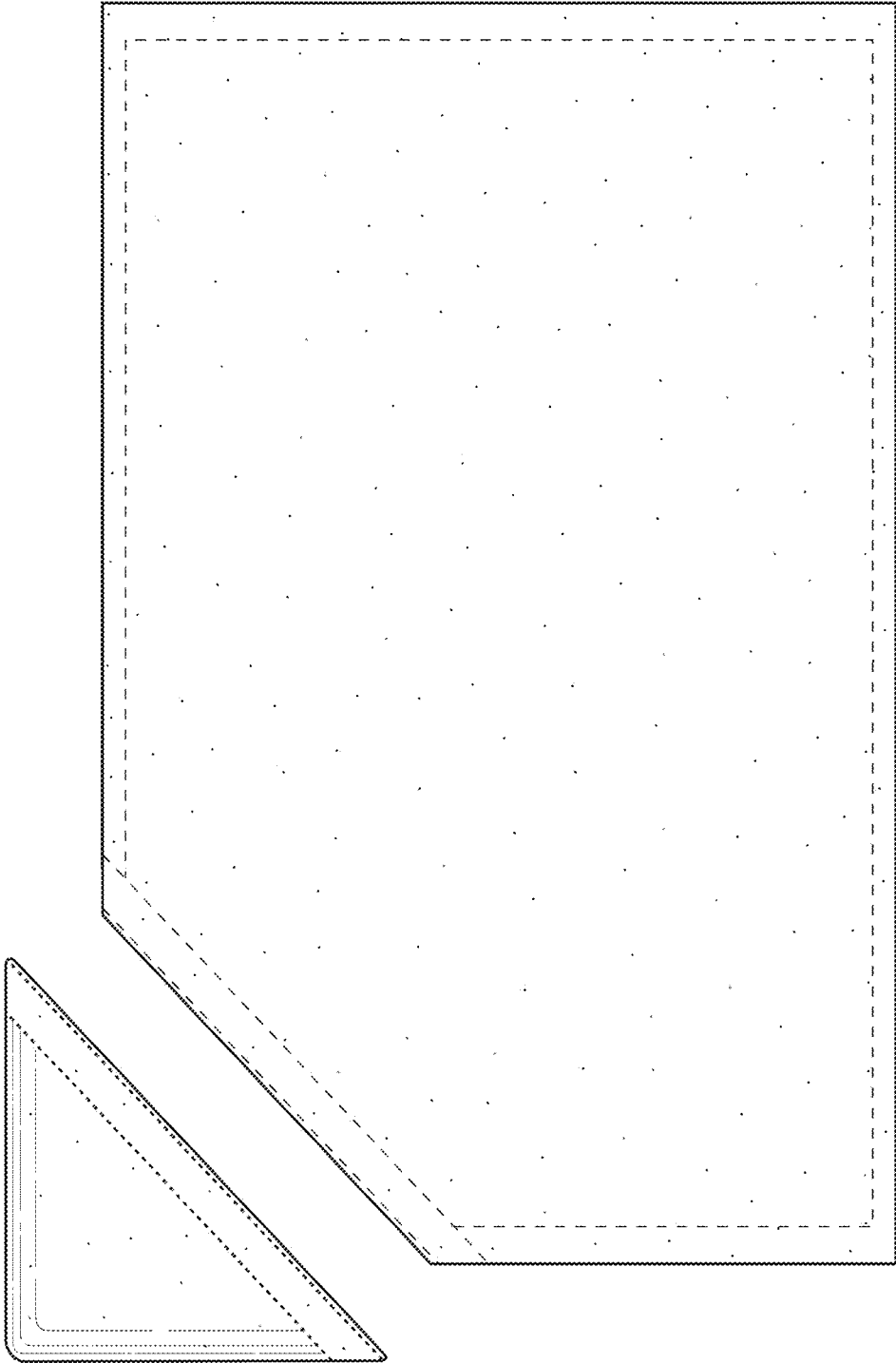

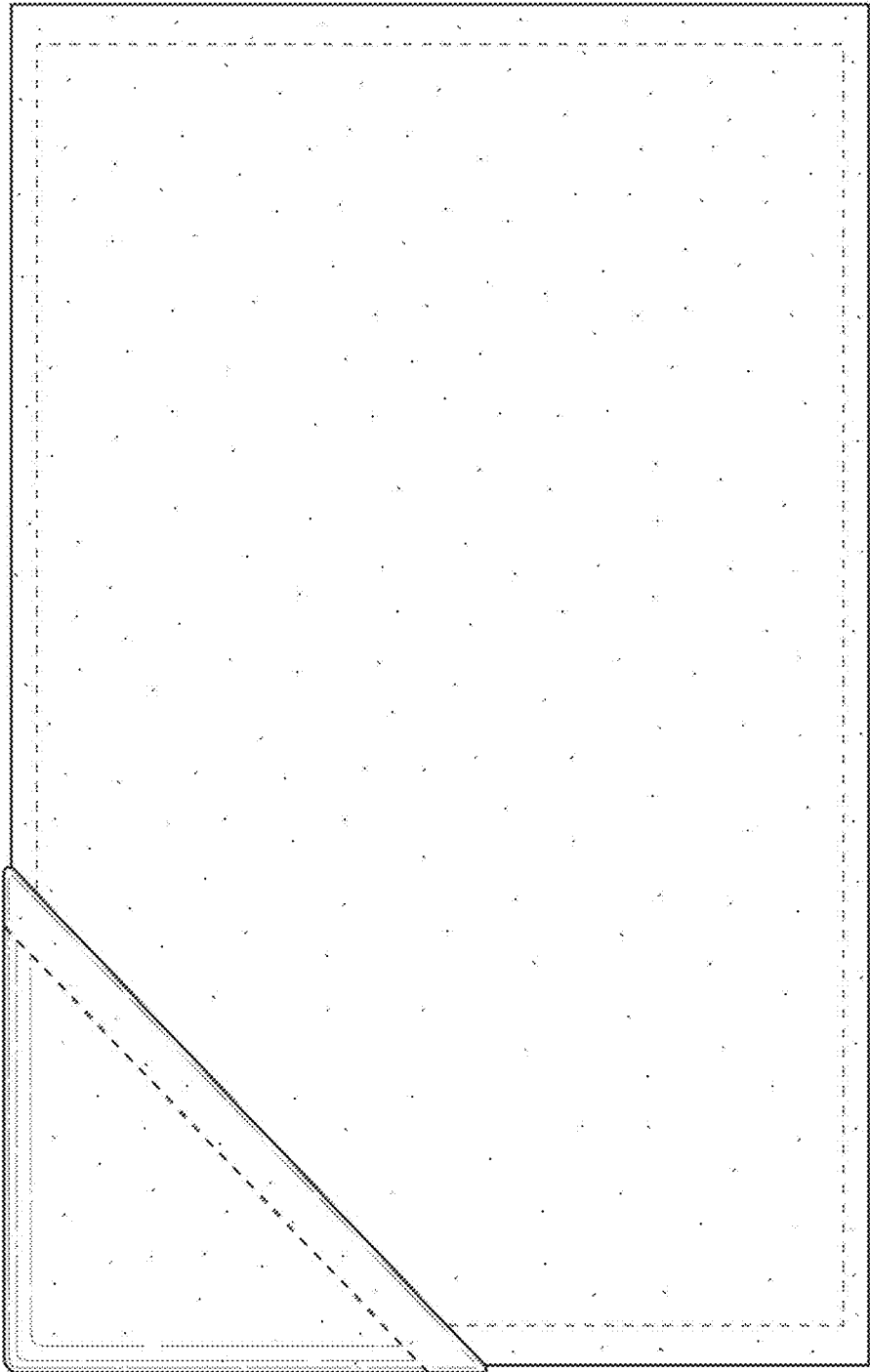

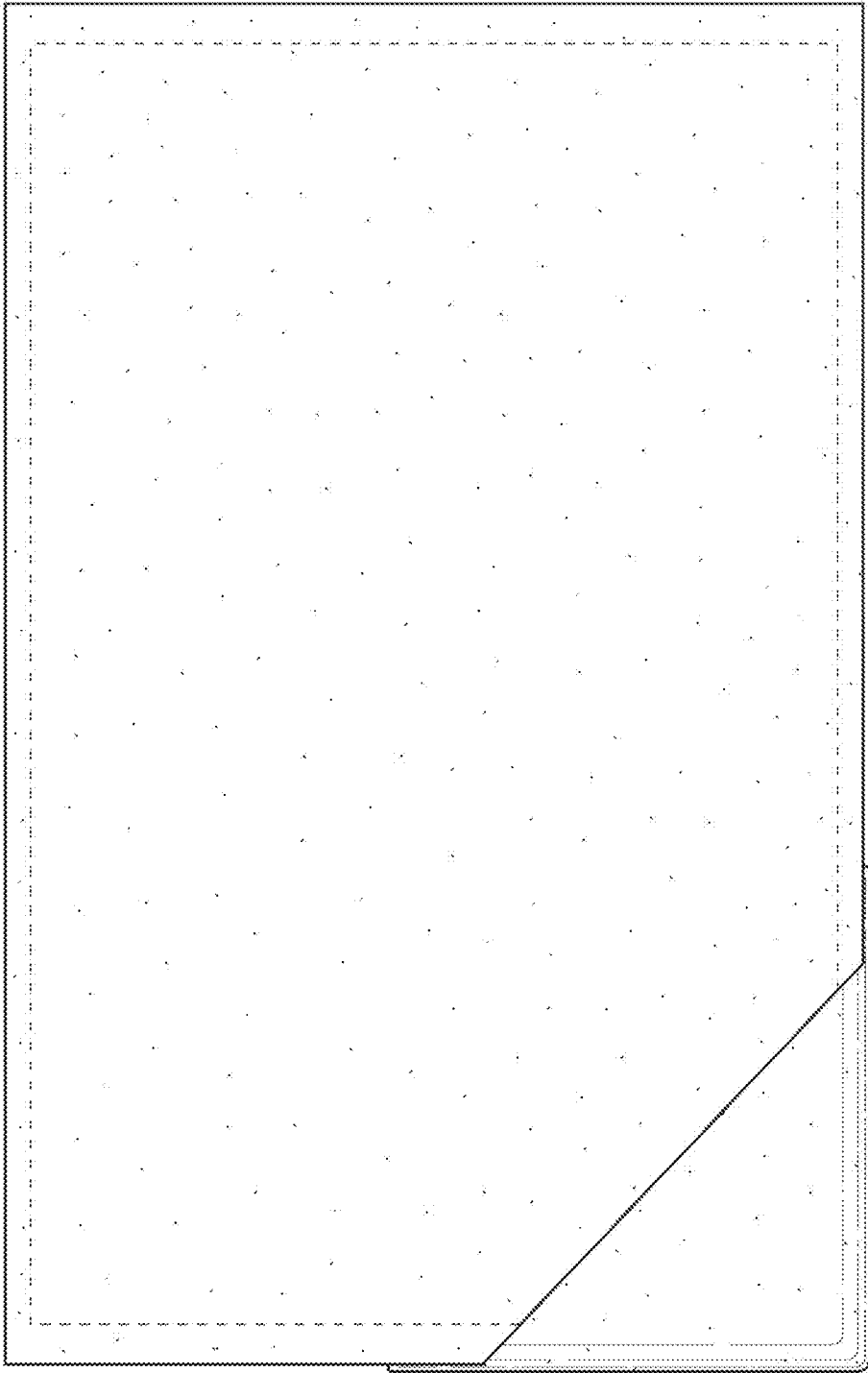

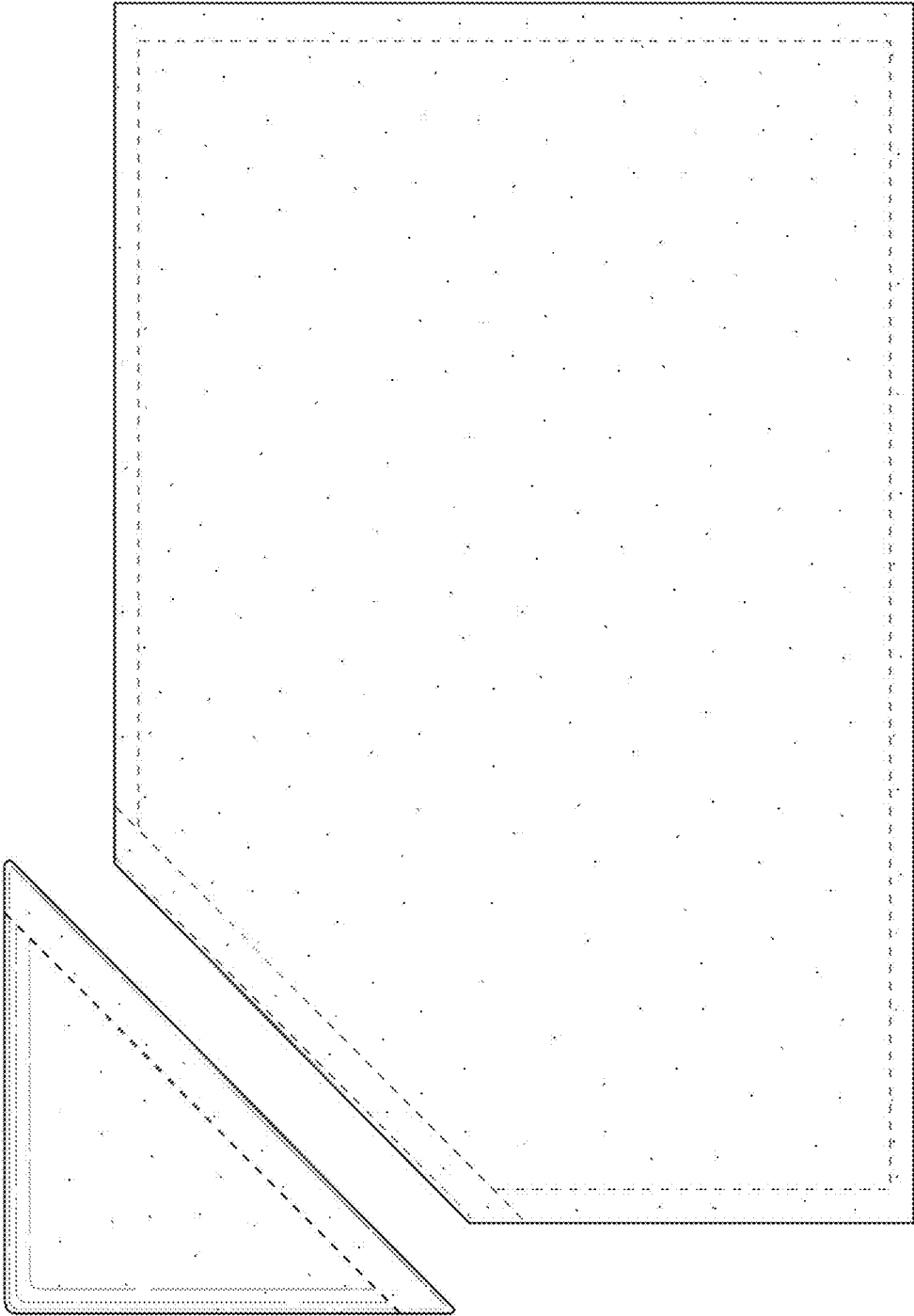

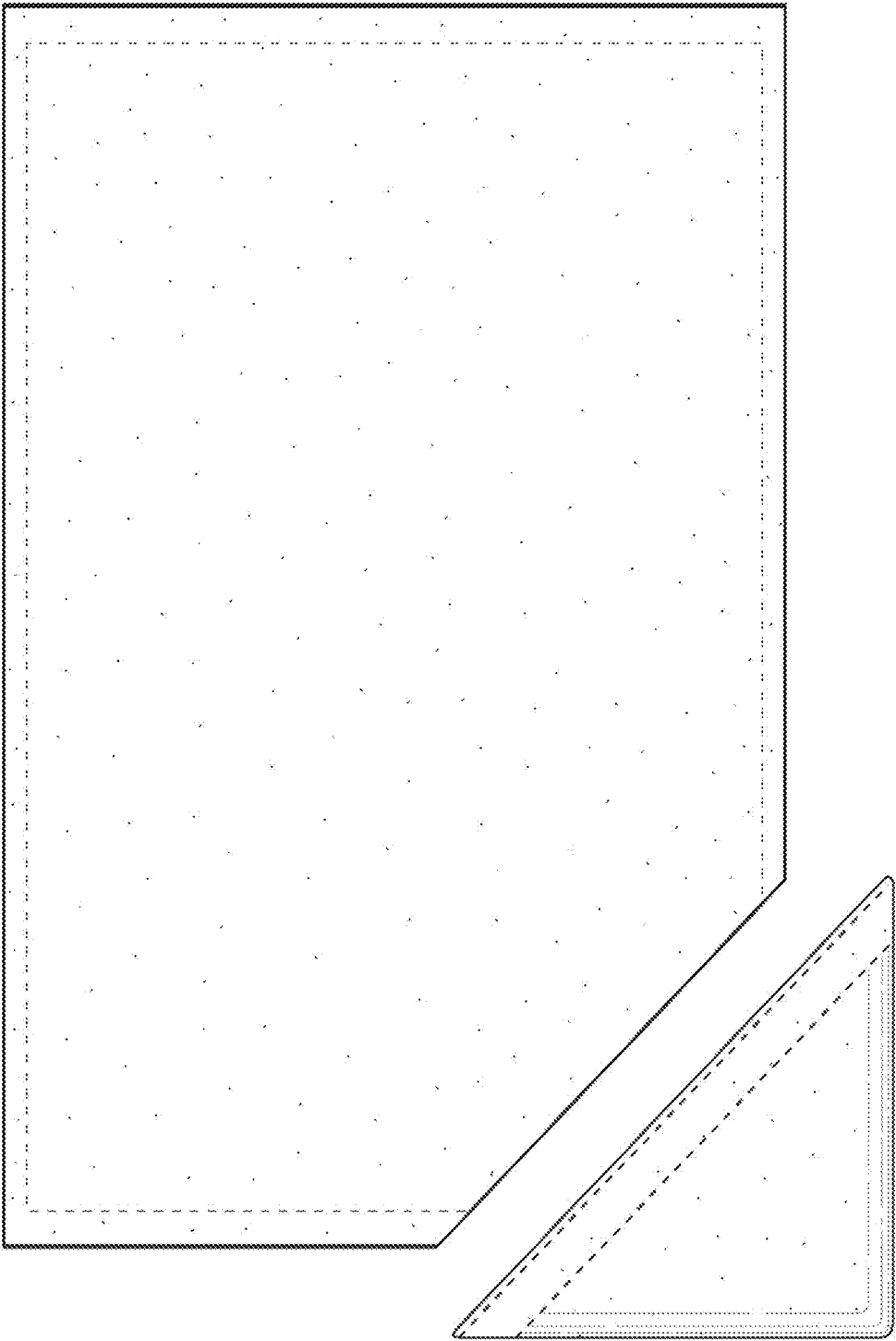

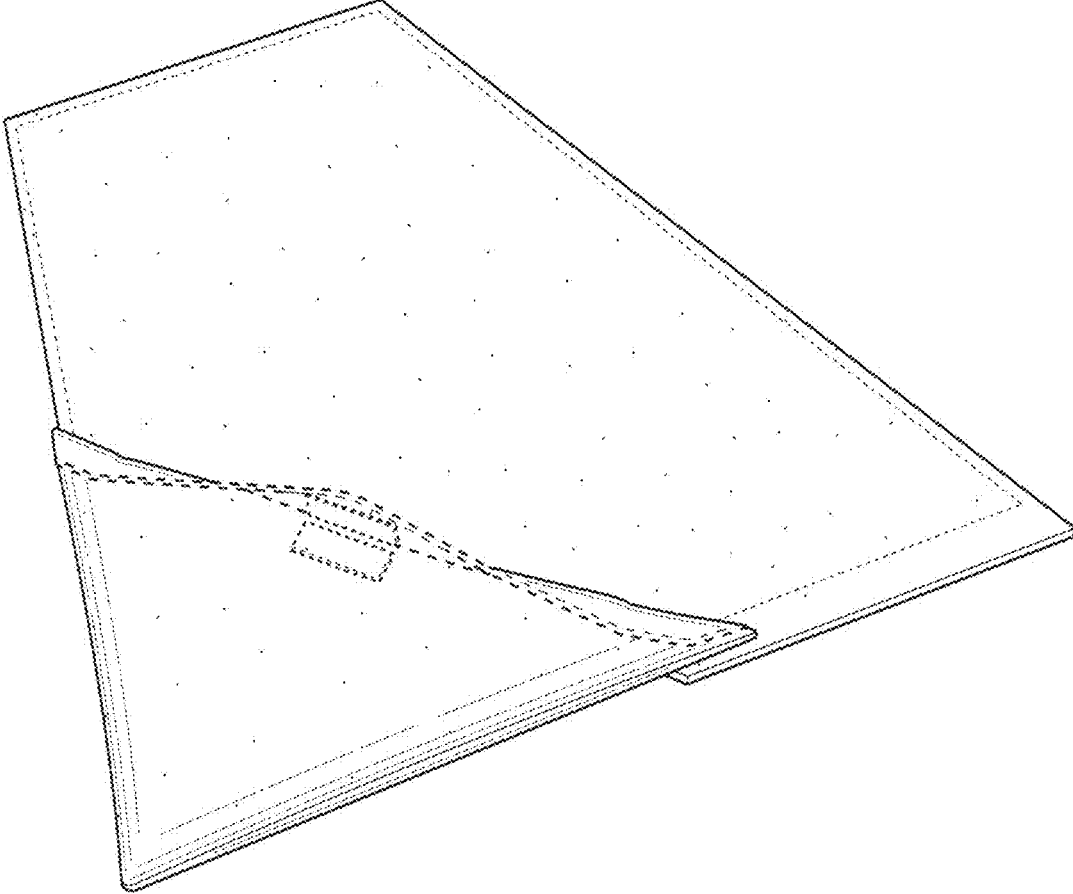

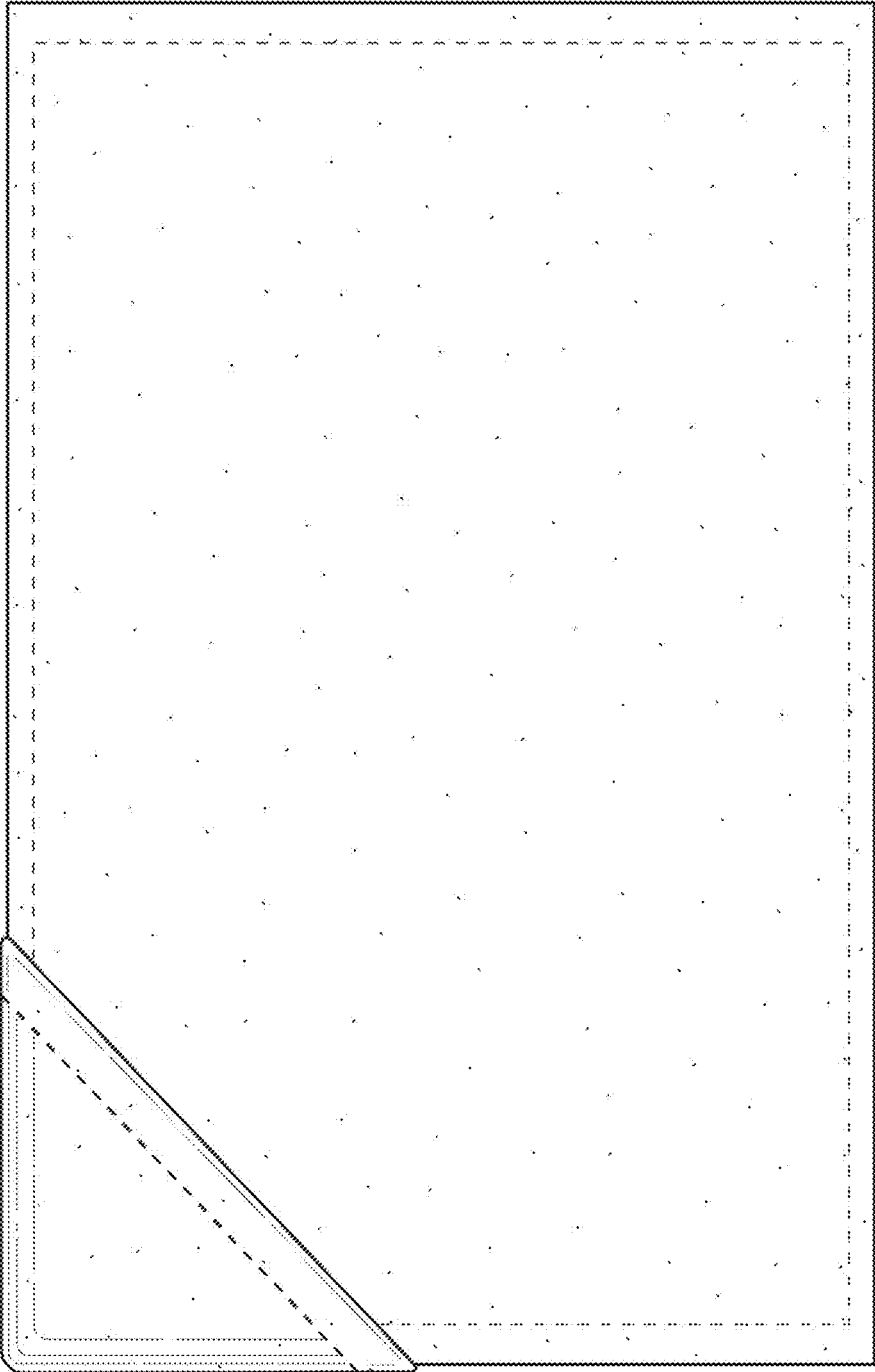

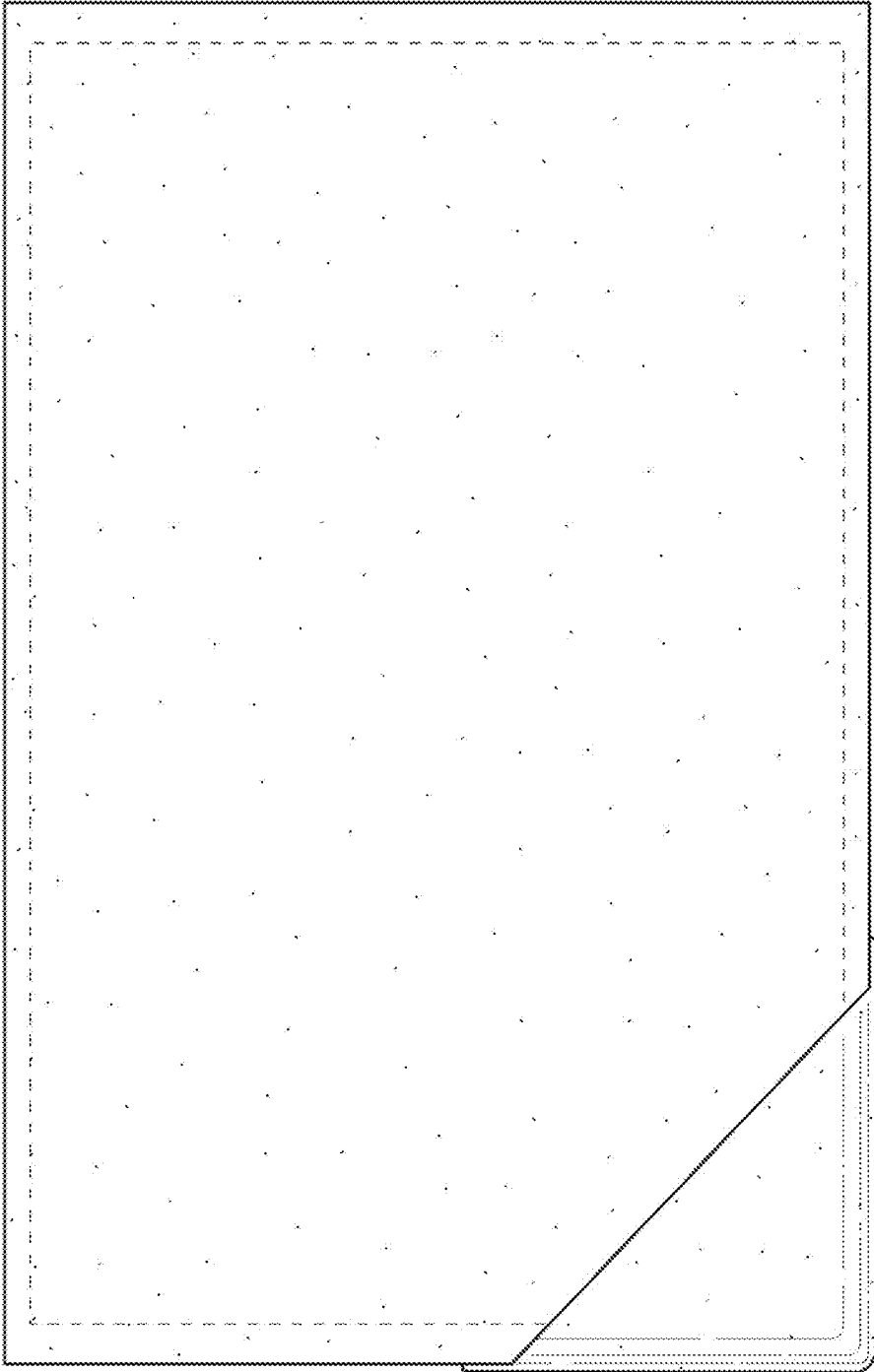

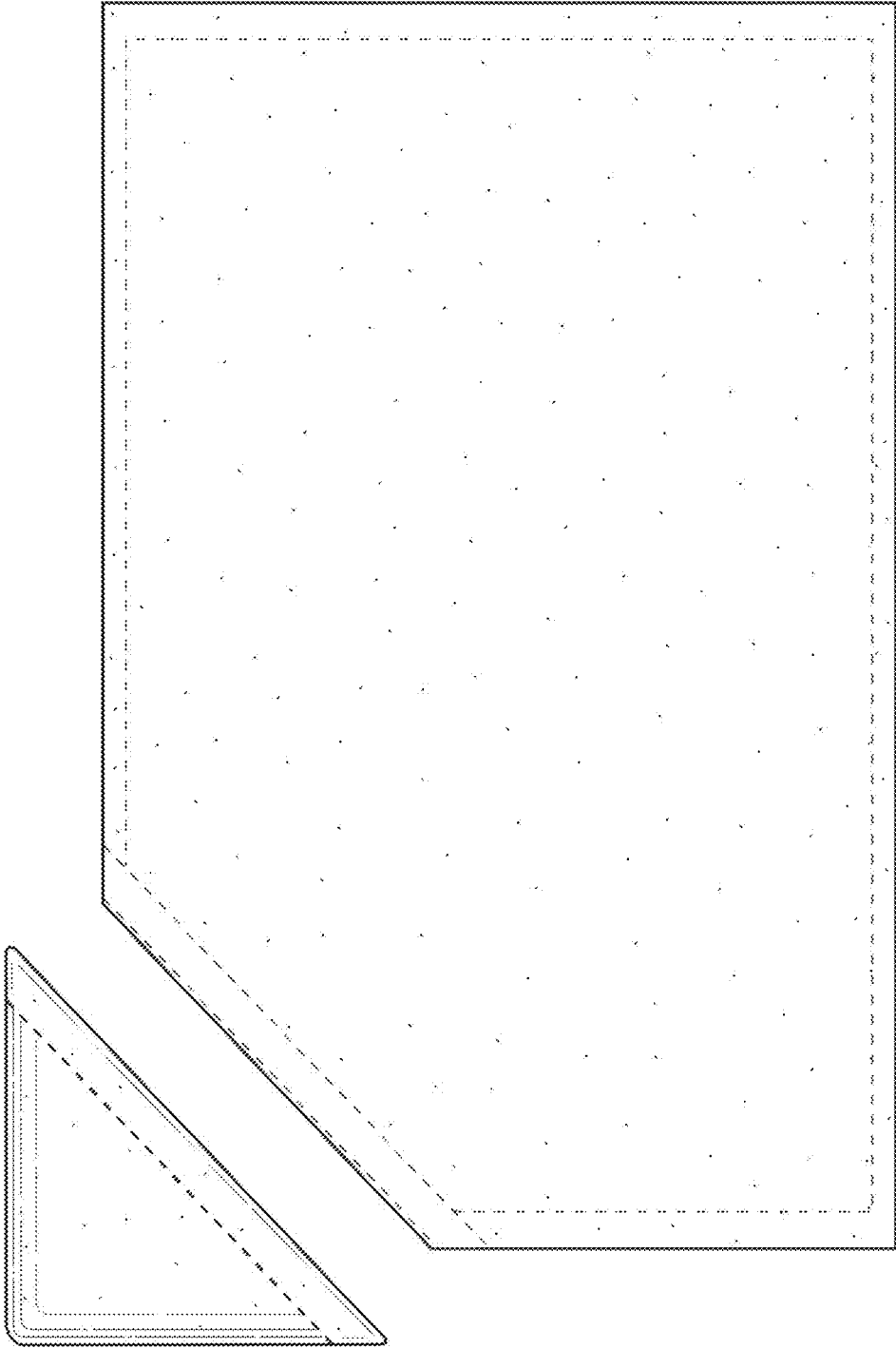

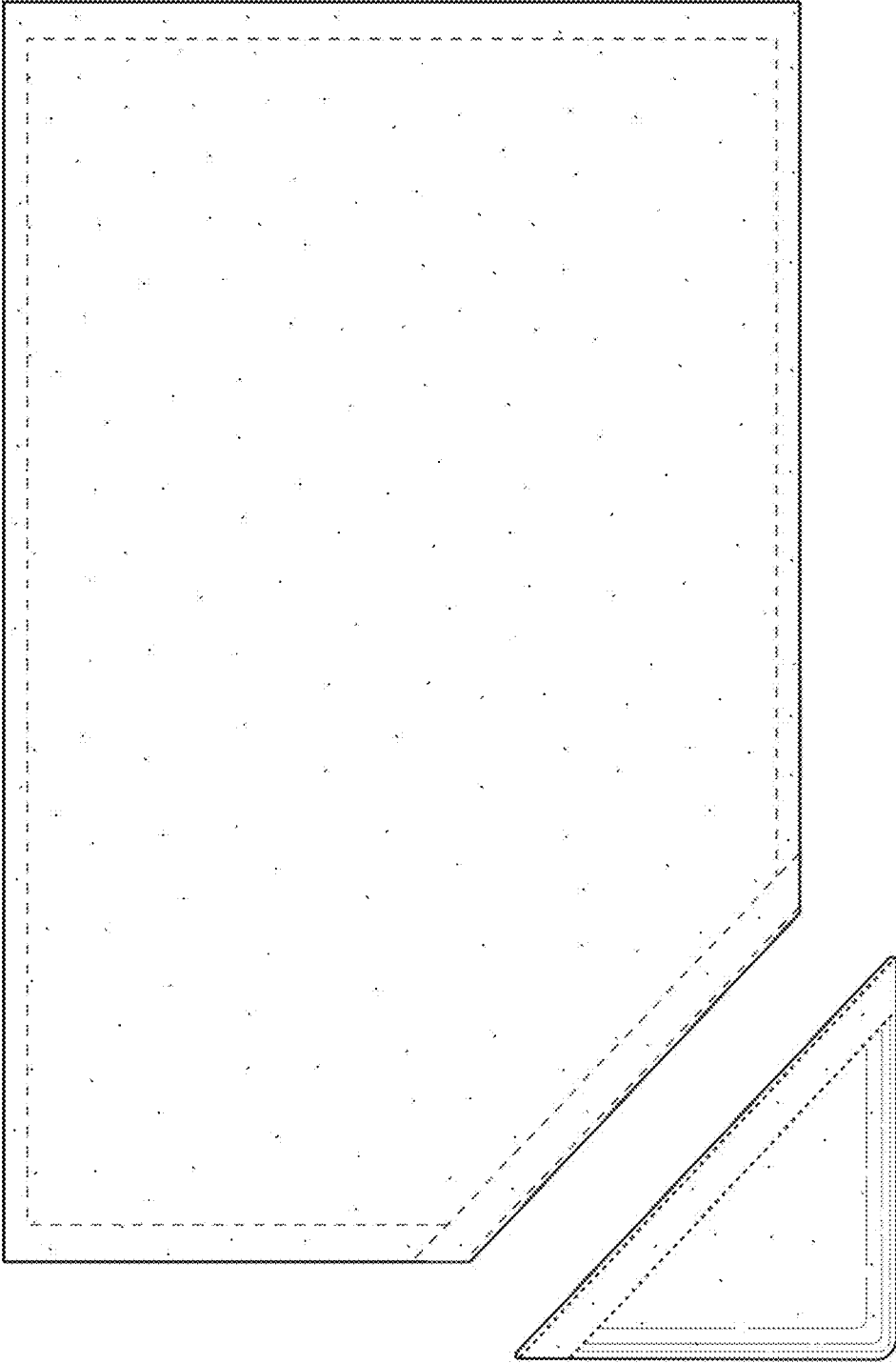
