

(54) Title: KDR AND VEGF/KDR BINDING PEPTIDES



(57) Abstract: The present invention provides, inter alia, peptides, peptide dimer, and multimeric complexes comprising at least one binding moiety for KDR or VEGF/KDR complex, which have a variety of uses wherever treating, detecting, isolating or localizing angiogenesis is advantageous. Particularly disclosed are synthetic, isolated polypeptides capable of binding KDR or VEGF/KDR complex with high affinity (e.g., having a $K_D < 1~\mu M$), and dimer and multimeric constructs comprising these polypeptides.
