**DESCRIPTION**

FIG. 1 is a perspective view of a mobile phone showing our new design;

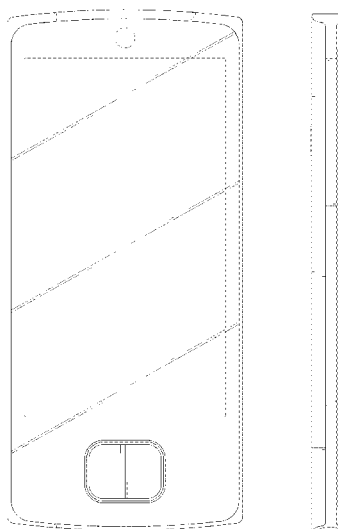

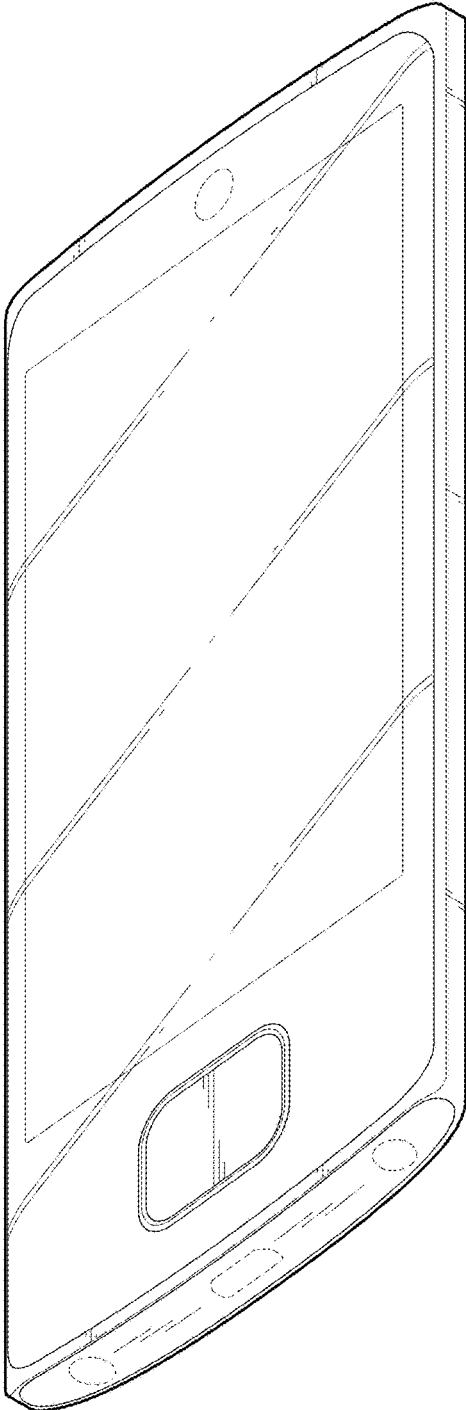

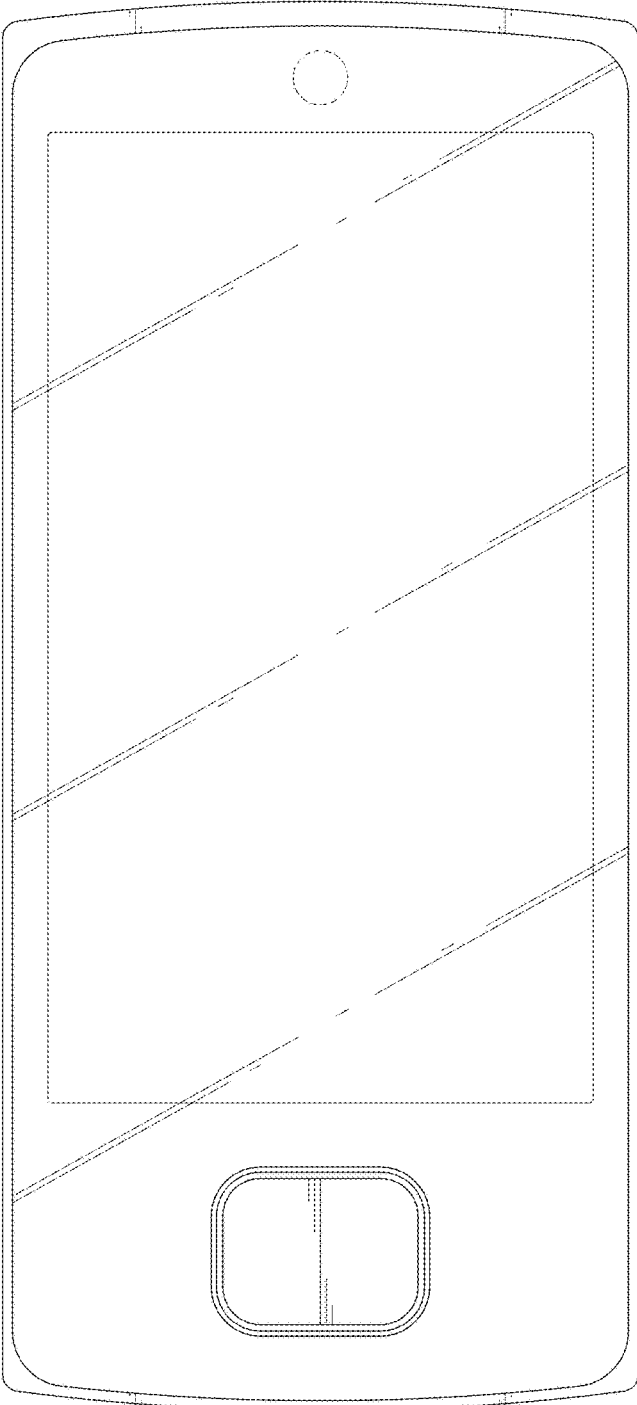

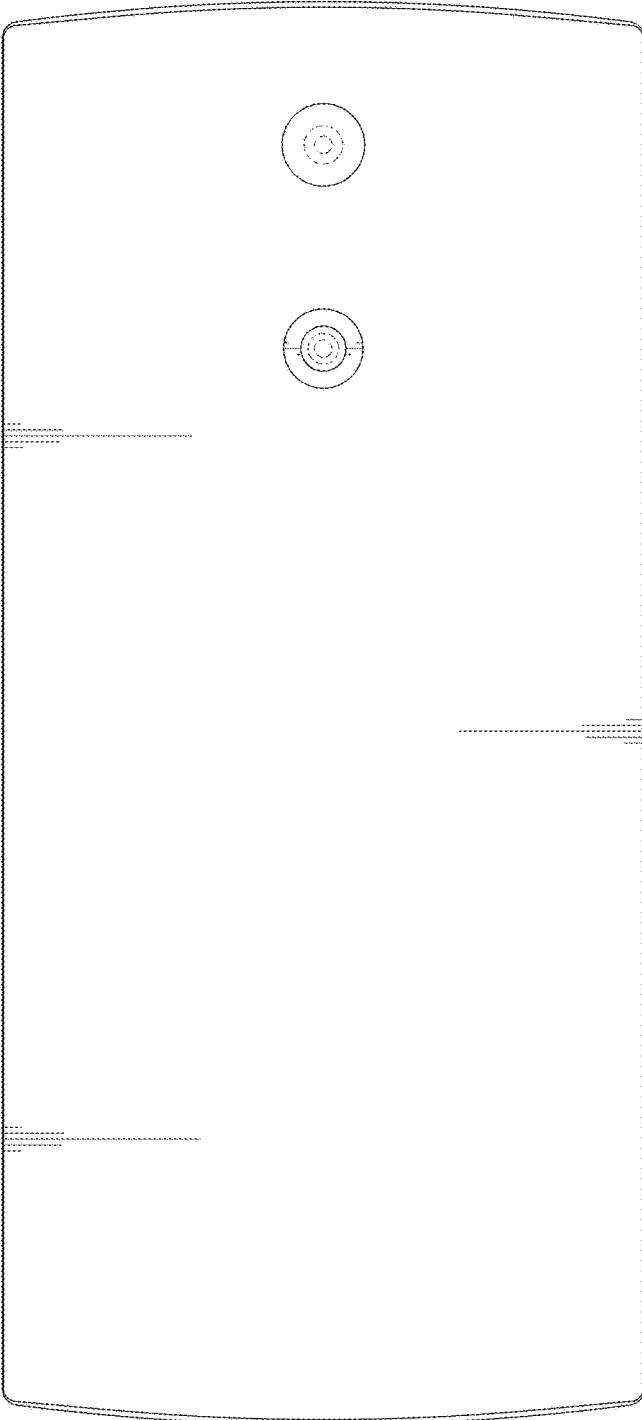
