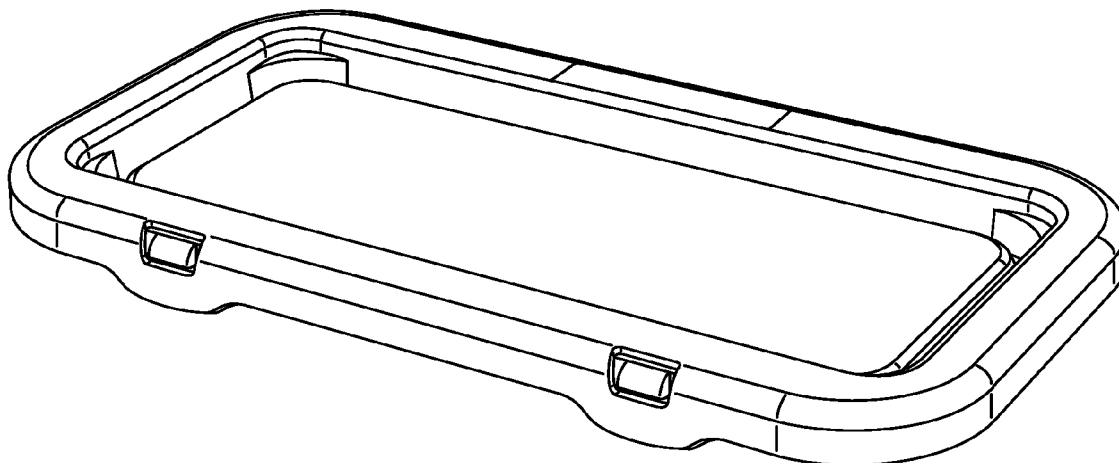
(57) **CLAIM**

The ornamental design for the lid for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a lid for a container embodying our new design;  
FIG. 2 is a front view of a lid for a container;  
FIG. 3 is a back view of a lid for a container;  
FIG. 4 is a left side view of a lid for a container;  
FIG. 5 is a right side view of a lid for a container;  
FIG. 6 is a top view of a lid for a container; and,  
FIG. 7 is a bottom view of a lid for a container.

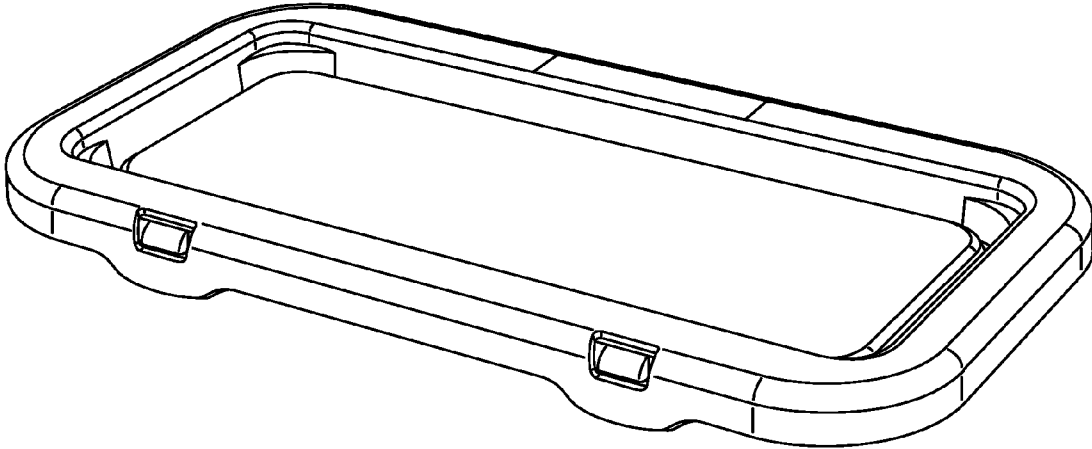

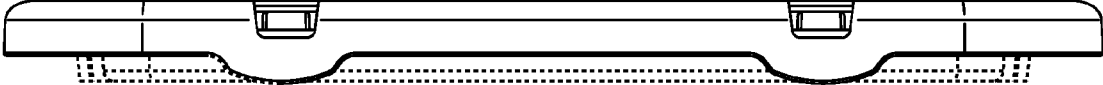

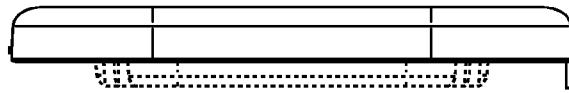

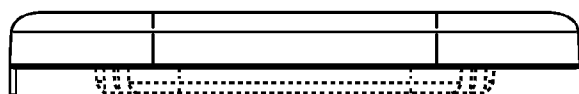

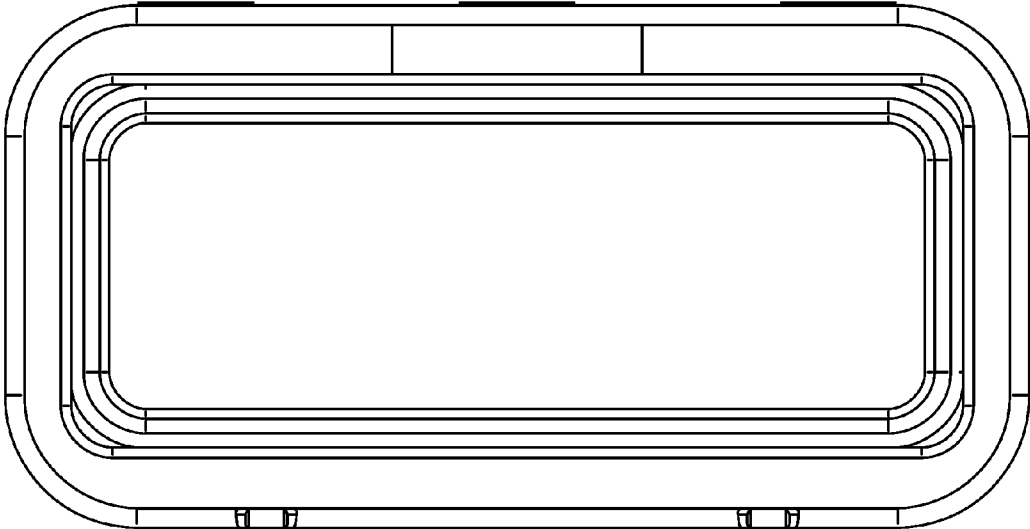

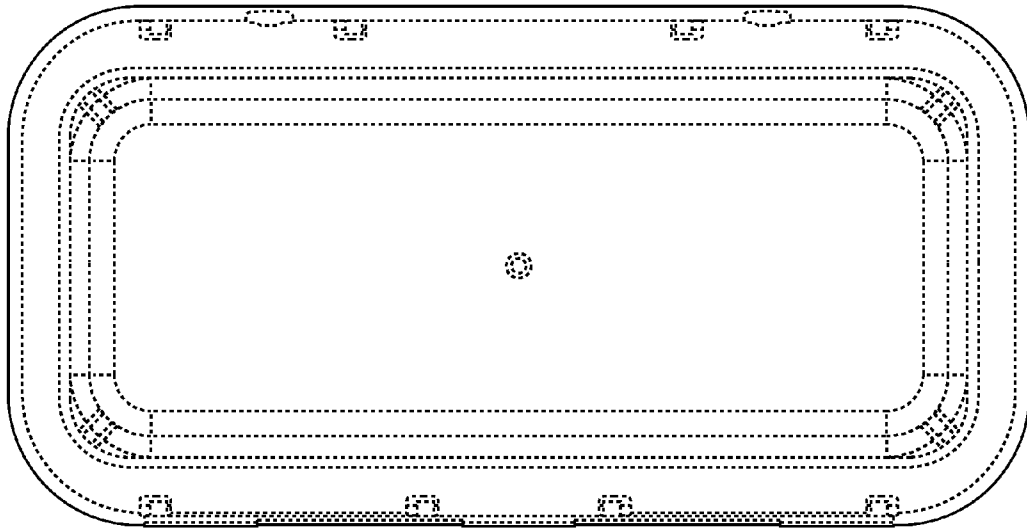
