The ornamental design for an hair press, as shown and described.

DESCRIPTION

FIG. 10 is a left side elevational view thereof;

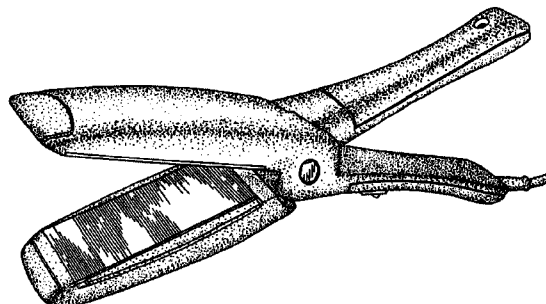
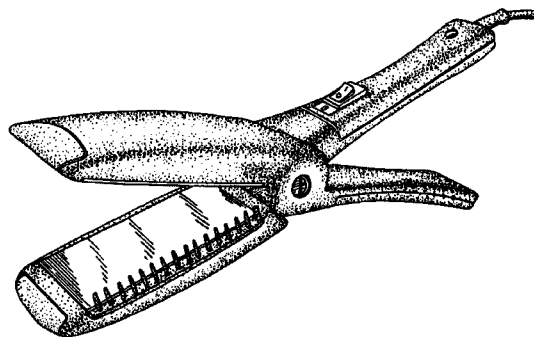
FIG. 11 is a rear elevational view showing the design in a closed position;

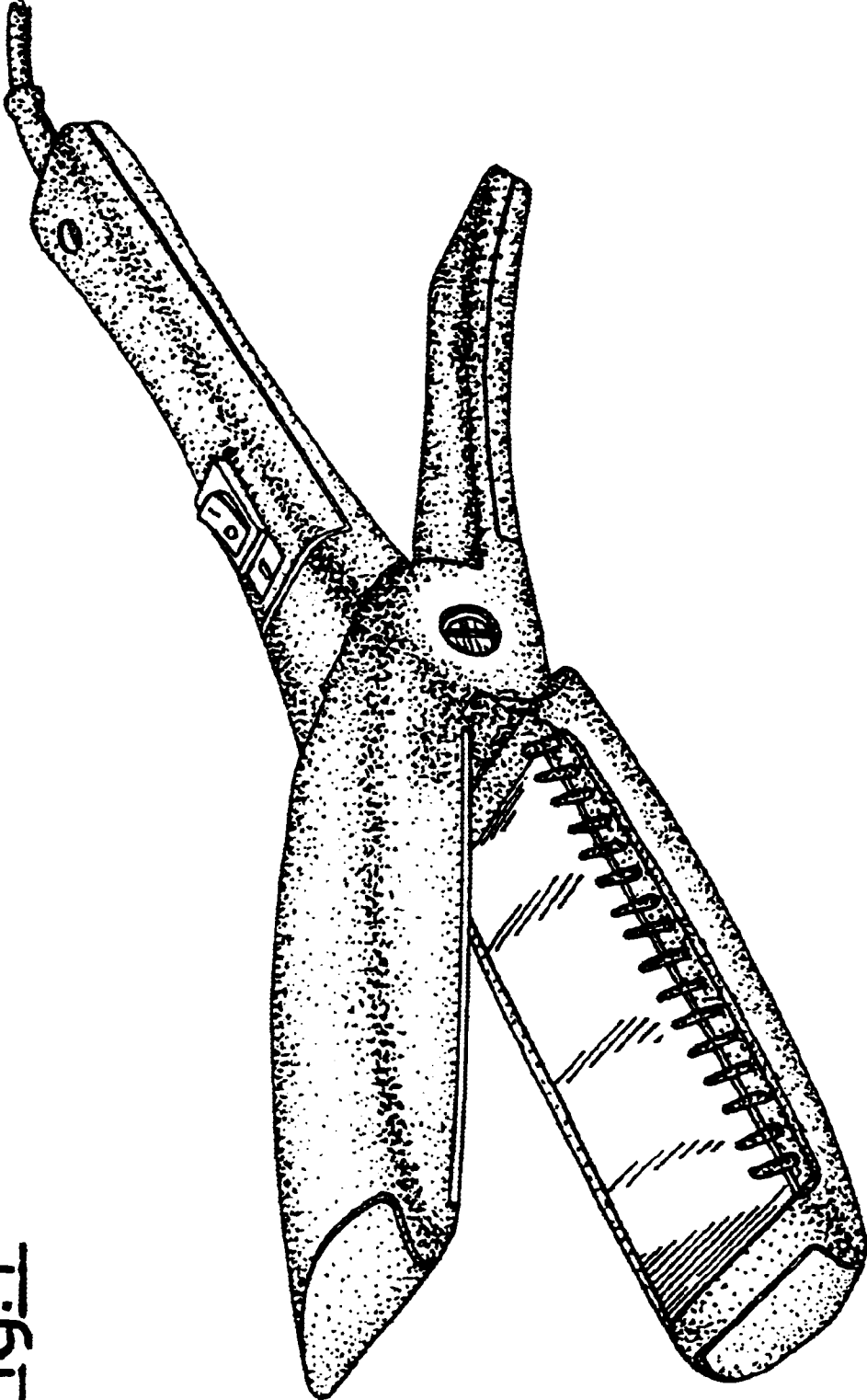

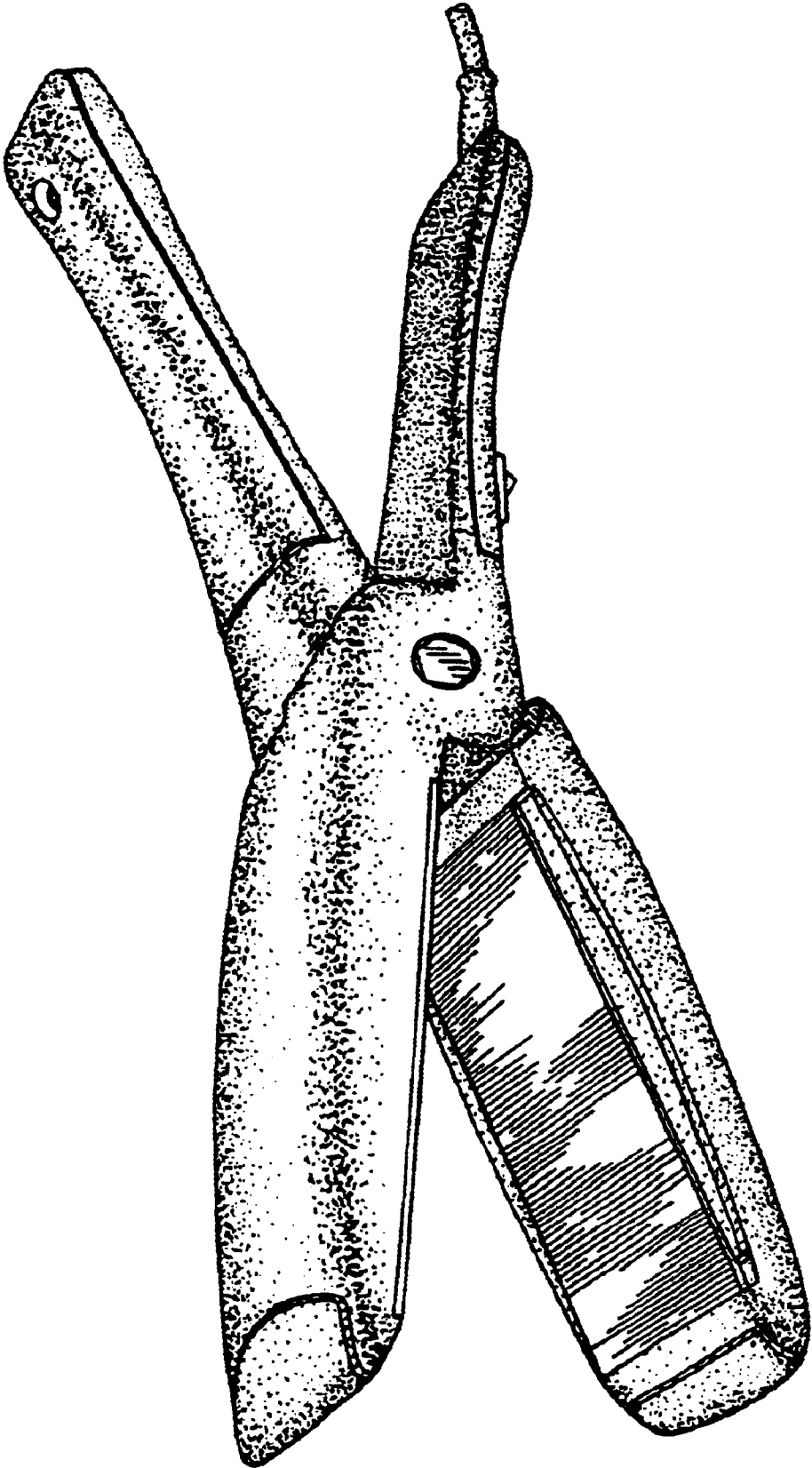

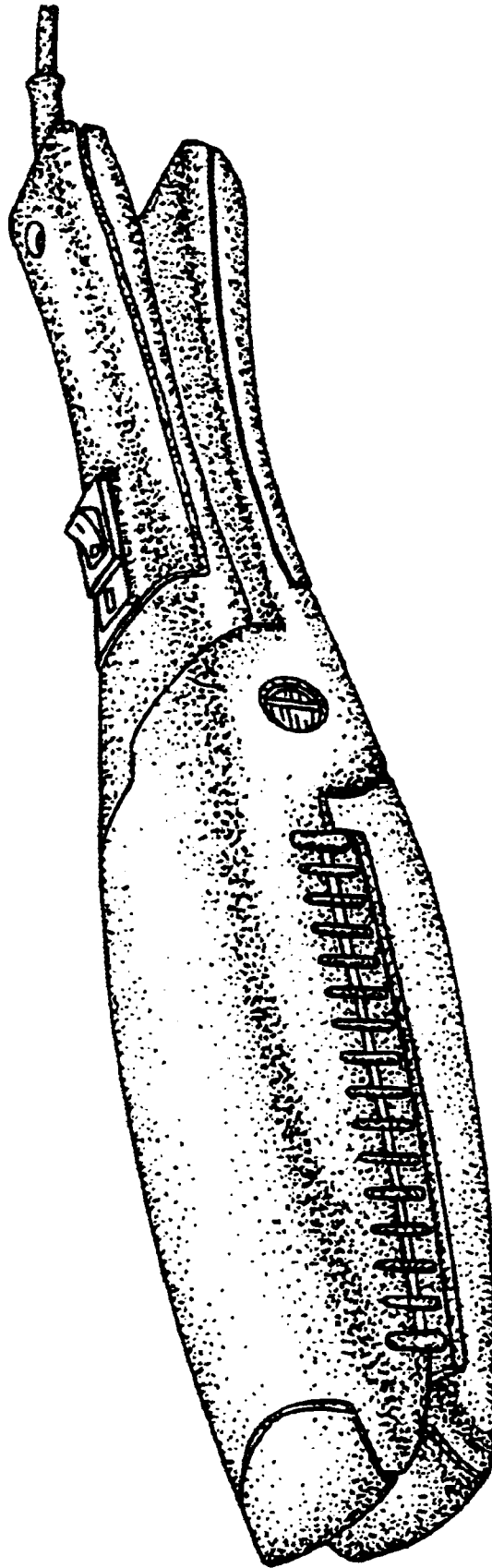

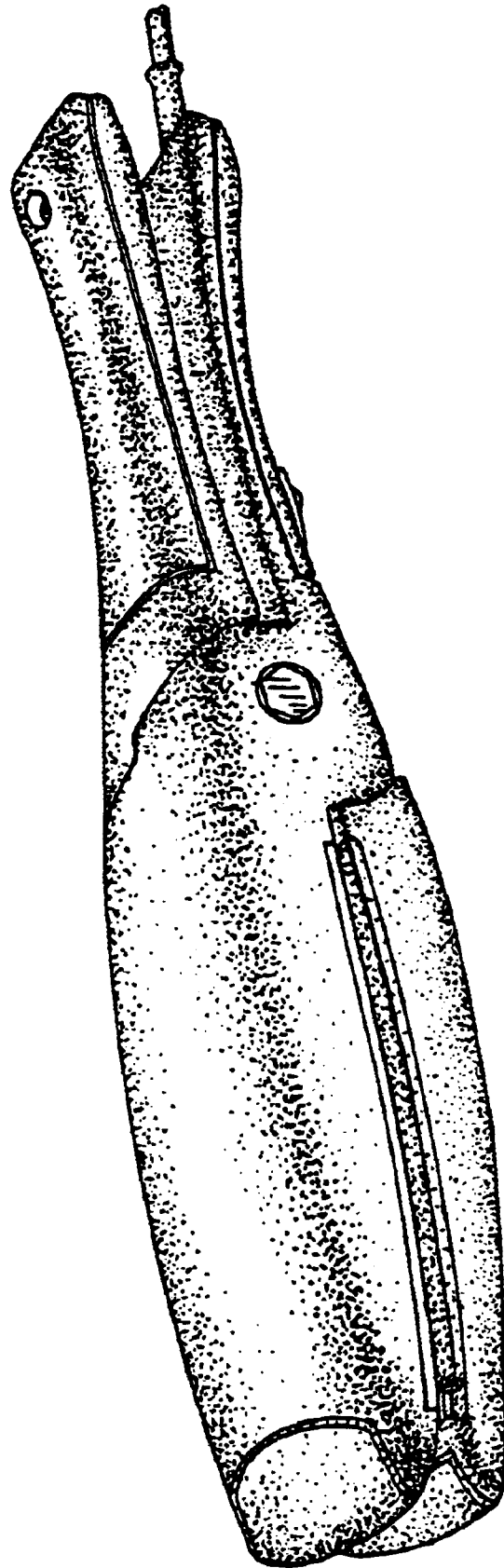
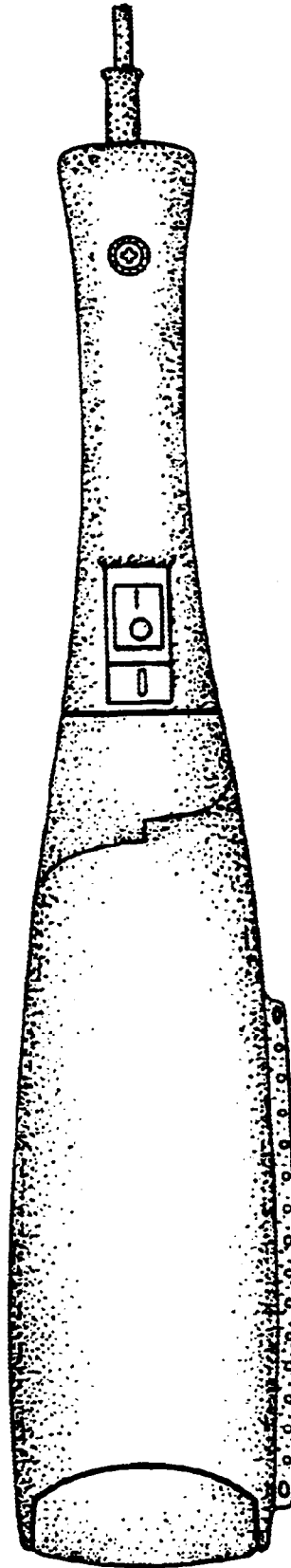

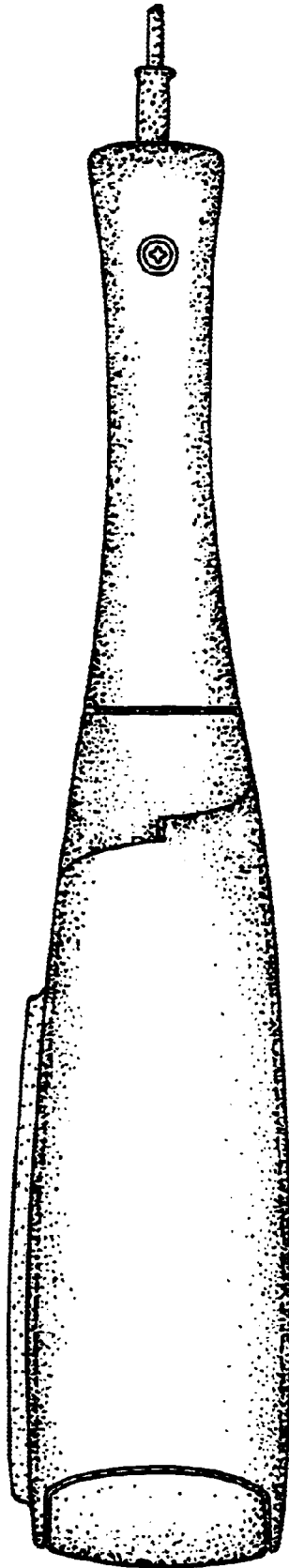
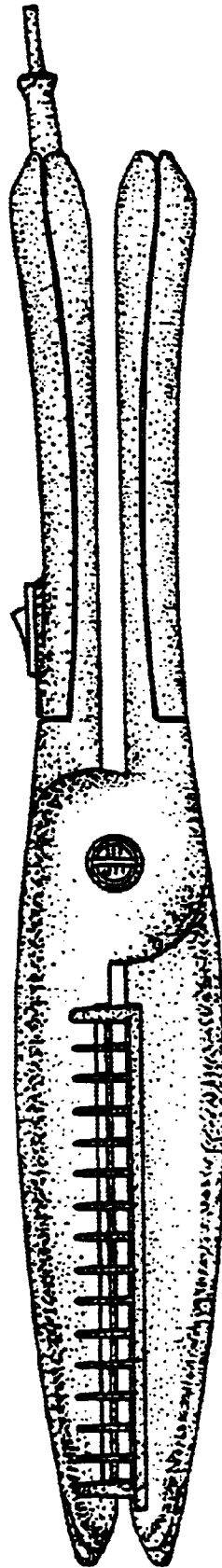

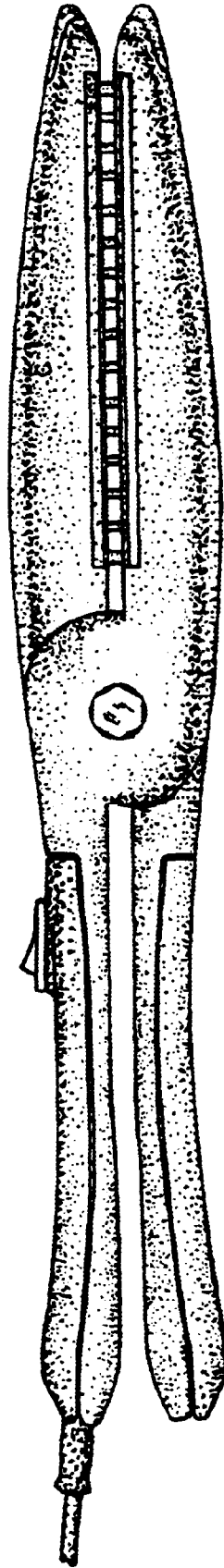

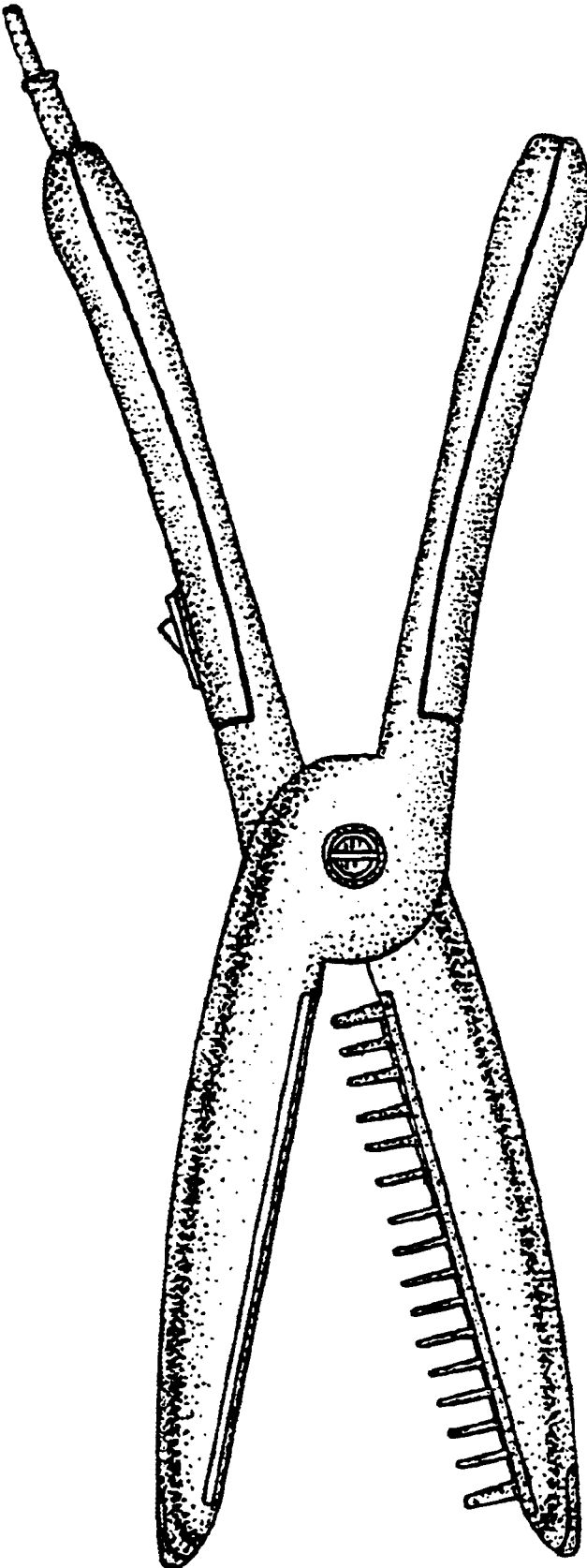

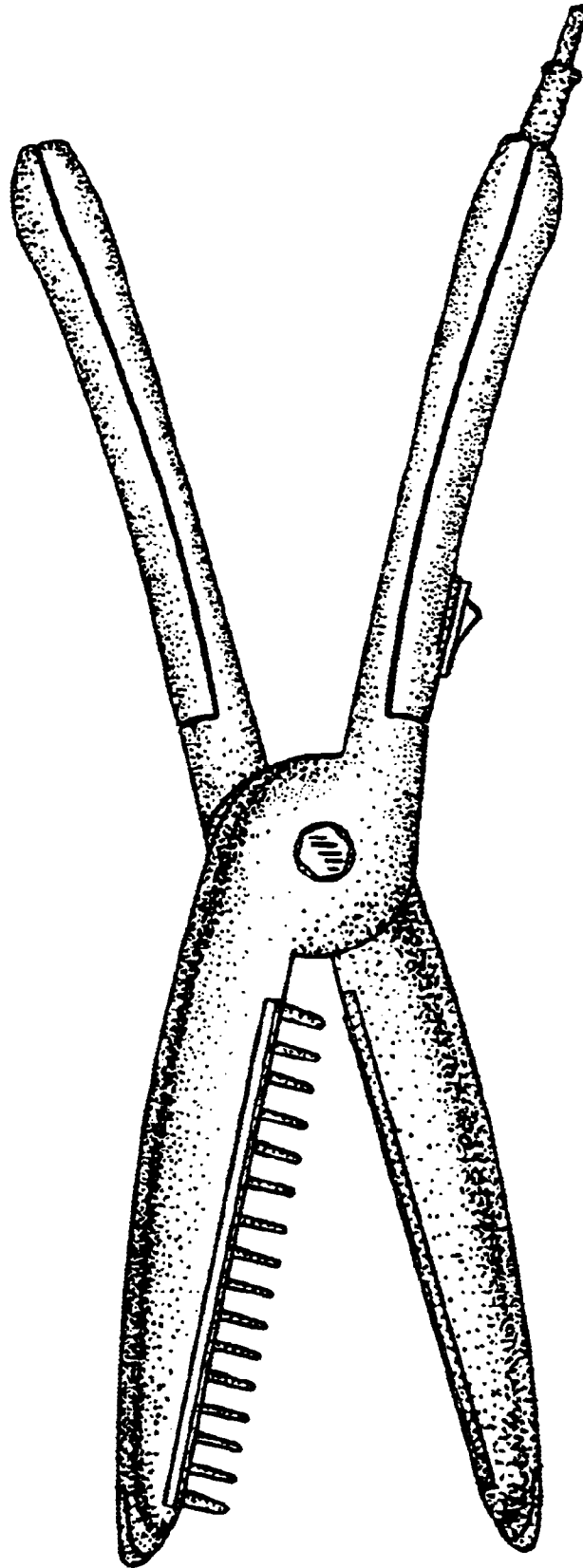

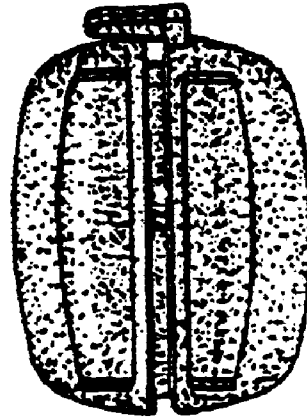

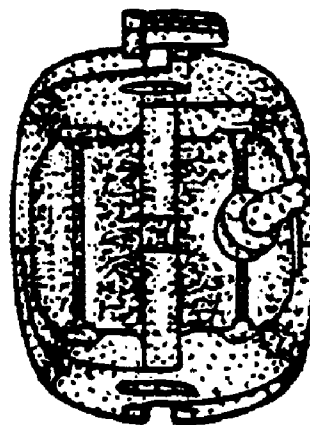

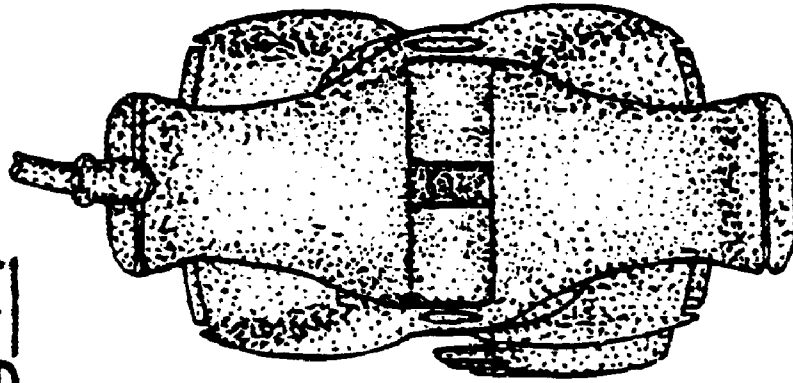
