

SKIRT-SUPPORTER.

Specification of Letters Patent No. 26,491, dated December 20, 1859.

To all whom it may concern:

Be it known that I, D. B. Hale, of the city and State of New York, have invented a new and useful Garment or Article of 5 Apparel for Ladies' Wear for Supporting the Skirts or Lower Garments and Relieving the Abdomen and Hips from All Pressure Therefrom; and I do hereby declare that the following is a full and exact de-10 scription thereof, reference being had to the accompanying drawings and to the letters of reference marked thereon.

Figure 1 is a front view. Fig. 2 is a back

view. Fig. 3 is a side view.

The object and design of my invention is to construct and furnish such an article of dress for ladies' wear, as shall be a sufficient and complete support for the lower parts or skirts of the dress, and wholly pre-20 vent them from bearing against and resting upon the abdomen and hips and which shall also cause them to be supported from and by the shoulders, and without any necessity for the use of stays and stiffeners in the 25 waist or body, and at the same time securing a smooth and tasteful fit to the dress.

My invention consists in combining with or attaching to an ordinary dress waist, or body of any sort, a skirt supporter, which is 30 made by expanding and extending downward such waist or body, and inserting therein, or attaching thereto, a number of entire hoops or circles, or their equivalents, of increasing size or length, which expanded part and its circles may also be so shaped as to perform the office of the ordinary bustle. The waist or body A is made to fit the

body of the wearer, and should, for health's sake be so loose as to allow of free and un-40 constrained motion or turning of the body, but tight enough so as to fit smoothly and without wrinkles. Such waist or body is also so cut and made, that the parts a a pass over the arms or shoulders, and are in fact

45 a part of the waist or body and not attached to it. This waist or body may also be made higher or lower, as desired, and may be so fitted as not to interfere with low necked dresses, while at the same time

50 the parts a a will support the waist, and whatever garments may be attached to or placed over it, and without harm or discomfort to the wearer from such garments,

resting and bearing as they usually do, upon the abdomen and hips. Instead of termi-nating, as this part of the dress usually does,

at or about where the form is naturally the smallest, or at the bottom of the waist of the dress, the part A extends farther downward, and is expaned, basque like according to the 60 fullness of the form of the wearer, and extends far enough to receive from four to six or more hoops b, b', &c. Such expanded part forms a part of A, or is tightly fastened to it in any convenient manner, so that 65 the lower garment, placed over and resting upon such extended part will draw or bear upon the body A, and with it have support from the parts a, a, extending over the

shoulders.

The arrangement of the hoops in the expanded part B is such also as to prevent the weight of the lower garments from bearing and resting upon the abdomen and hips.

The first or upper hoop b should be quite 75 near the smallest diameter of A, and should be in diameter about two inches larger than such smallest diameter of A. The next hoop b' should be a little larger than b, and the space between it and b may be somewhat 80 more than that between the waist line of A, and b. The other hoops b^2 , b^3 , &c., also increase in size. Such hoops will not however vary in size according to any fixed proportion—the varying forms of individuals ren- 85 dering a difference in their relative size necessary—but they should increase in size sufficiently to furnish a support for the skirts and sustain them from bearing on the person, that is such hoops should be so ar- 90 ranged that they shall stand out from the form, instead of resting upon it. This is effectually secured by means of the increasing size of the hoops, and also from firmly attaching the part in which such hoops are 95 placed to the waist or body A. Such hoops are to be fastened together by a slide or catch, as hereinafter described, or in any other way, so that they will form entire and complete circles, and thus make and preserve 100 a shield like protection or guard to the vital organs, entirely encircling the body, and thus, as a natural effect from their arrangement and completeness of circumference, relieving the body from all pressure, weight, 105 and also unnecessary warmth of dress. These hoops may be run or inserted in the part B, as shown in the drawings or may be a skeleton of hoops, firmly attached or suspended from the part A. In either case the same result will be obtained, pro-In either 110 vided the hoops are made entire circles. If

now this waist or body, with the hoops attached to or suspended therefrom, as above described, be put on the person and the skirts and lower garments be put over it, such gar-5 ments must of course rest upon the hoops and will be supported from the shoulders, and can not bear down upon the abdomen, &c., and thus the body will be relieved from their weight and pressure, and the lower 10 limbs will also be less free to move.

The natural weight of the skirts upon the hoops, these last being fastened to the body A, will also have the effect of keeping the waist and dress smooth and graceful, and 15 stays and stiffeners for such purposes are

therefore unnecessary.

The body and the hooped extension may be buttoned or laced, in whole or in part, and in front or at the back; or only the 20 body may be buttoned or laced, which may also have a bone in it to lace over if desired.

As will be at once apparent from the foregoing description this invention is distinguished from other skirt supporters in the 25 means by which the object is attained.

The object sought is a support for the skirts or lower garments which shall not in any way confine or press upon the abdomen or hips. This end is attained by inserting 30 entire circles or hoops in an ordinary waist extended and expanded at the bottom in a form similar to the form of a basque. The waist by its construction sustains the weight of the lower garments while the hoops by 35 their complete rotundity relieve the body from the lateral pressure of the lower gar-This latter feature of relieving the form from the pressure of the lower garments, is entirely independent of the par-40 ticular shape which may be given to the expanded part B, which can be easily altered or changed according to the demands of fashion. If it is desired to have the hoops project behind and form a bustle, the front 45 part of B will be cut nearly straight, and

the flare or expansion will be made the greatest behind. If on the contrary it is desirable to have the dress set out from the form about the same before and behind, this is effected by shaping the part B ac- 50 cordingly. But whatever the shape given the part B, the arrangement of entire circles, or their equivalents, within it, renders it equally effective as a skirt supporter, and its connection with the waist A, relieves the 55

form from pressure.

As will also be apparent from the foregoing description the waist or body A may be made without any stays or stiffeners, and thus the form can be relieved from any 60 pressure or constraint therefrom. Its construction thus allows such object to be attained, which cannot be effected with any other similar garment. The ordinary cor-set body, with stays and stiffeners, may however be used in place of the body without stays, if for any reason desirable: in such case bands may be passed over the shoulders as a substitute for the parts a, a.

This garment does not interfere with 70 any feeking and can be as readily adapted.

any fashion, and can be as readily adapted to small skirts as to large ones, and to skirts with few or many hoops. It is equally useful and convenient, both as a waist and a skirt supporter under all circumstances 75 whether hooped skirts are worn or not, and in all cases will be a relief to the form.

What I claim as my invention and desire

to secure by Letters Patent is-

The waist (A) in combination with the 80 extension (B) expanded by the insertion of hoops, (b b' b'') having their ends connected by tying them, and forming entire circles substantially in the manner and for the purposes set forth.
