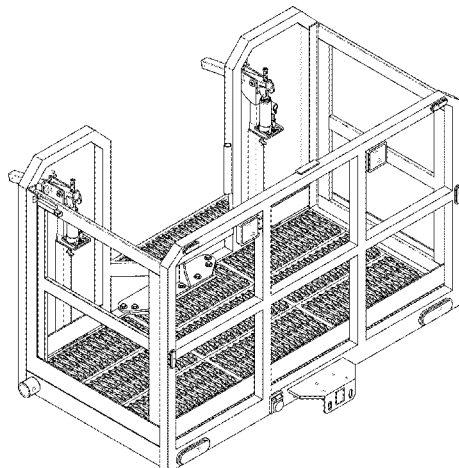

(57) **CLAIM**

The ornamental design for a vehicle-mounted platform, as shown and described.

FIG. 1 is a right side view of a vehicle-mounted platform showing the new design, with the vehicle-mounted platform shown mounted to a rear of a vehicle.
FIG. 2 is a top front perspective view of the vehicle-mounted platform of FIG. 1.
FIG. 3 is a top rear perspective view thereof.
FIG. 4 is a front view thereof.
FIG. 5 is a rear view thereof.
FIG. 6 is a right side view thereof.
FIG. 7 is a left side view thereof.
FIG. 8 is a top view thereof.
FIG. 9 is a bottom view thereof.
FIG. 10 is a top front perspective view of a second embodiment of the vehicle-mounted platform showing the new design.
FIG. 11 is a top rear perspective view of the vehicle-mounted platform of FIG. 10.
FIG. 12 is a front view of the vehicle-mounted platform of FIG. 10.
FIG. 13 is a rear view of the vehicle-mounted platform of FIG. 10.
FIG. 14 is a right side view of the vehicle-mounted platform of FIG. 10.
FIG. 15 is a left side view of the vehicle-mounted platform of FIG. 10.
FIG. 16 is a top view of the vehicle-mounted platform of FIG. 10; and,

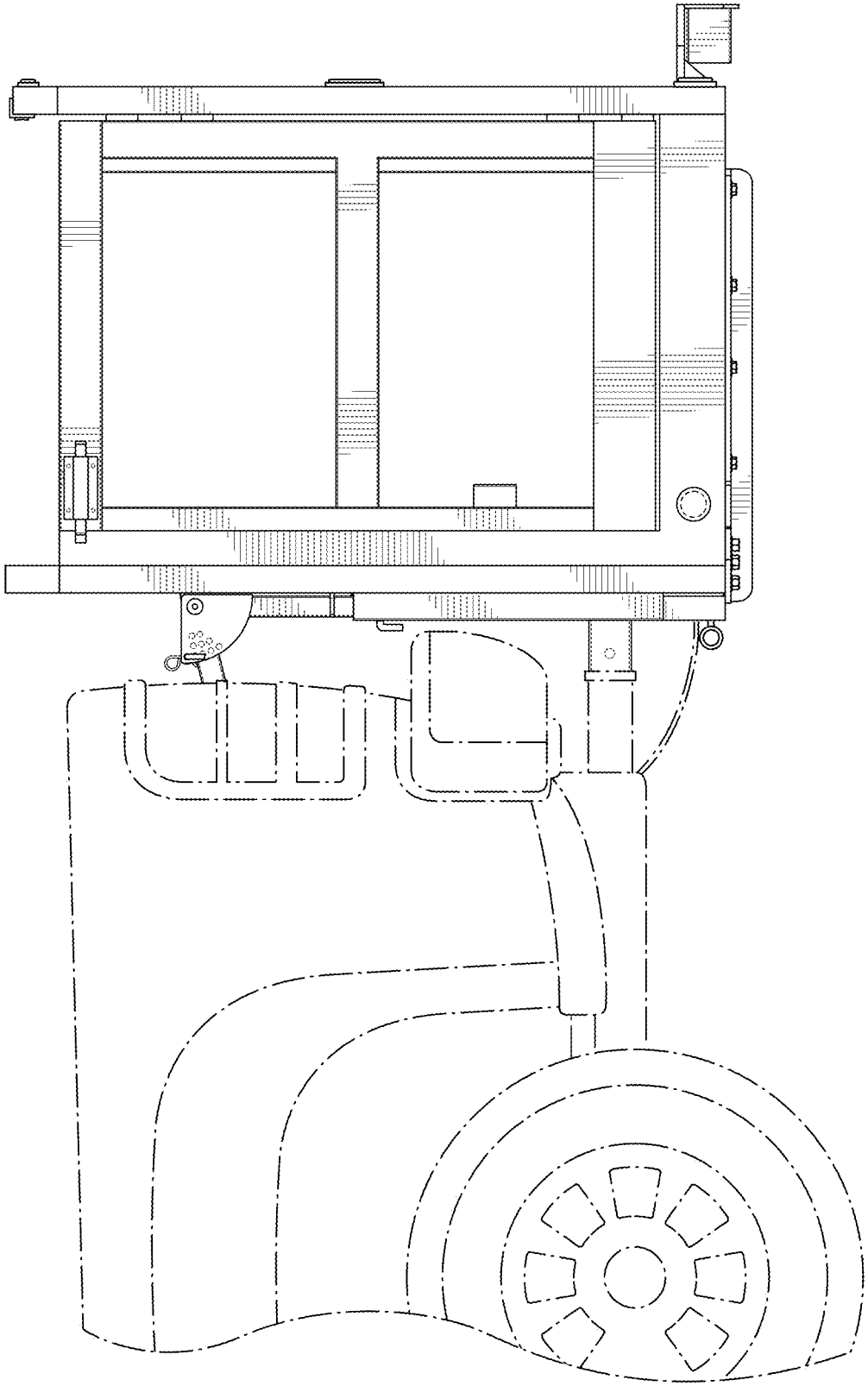

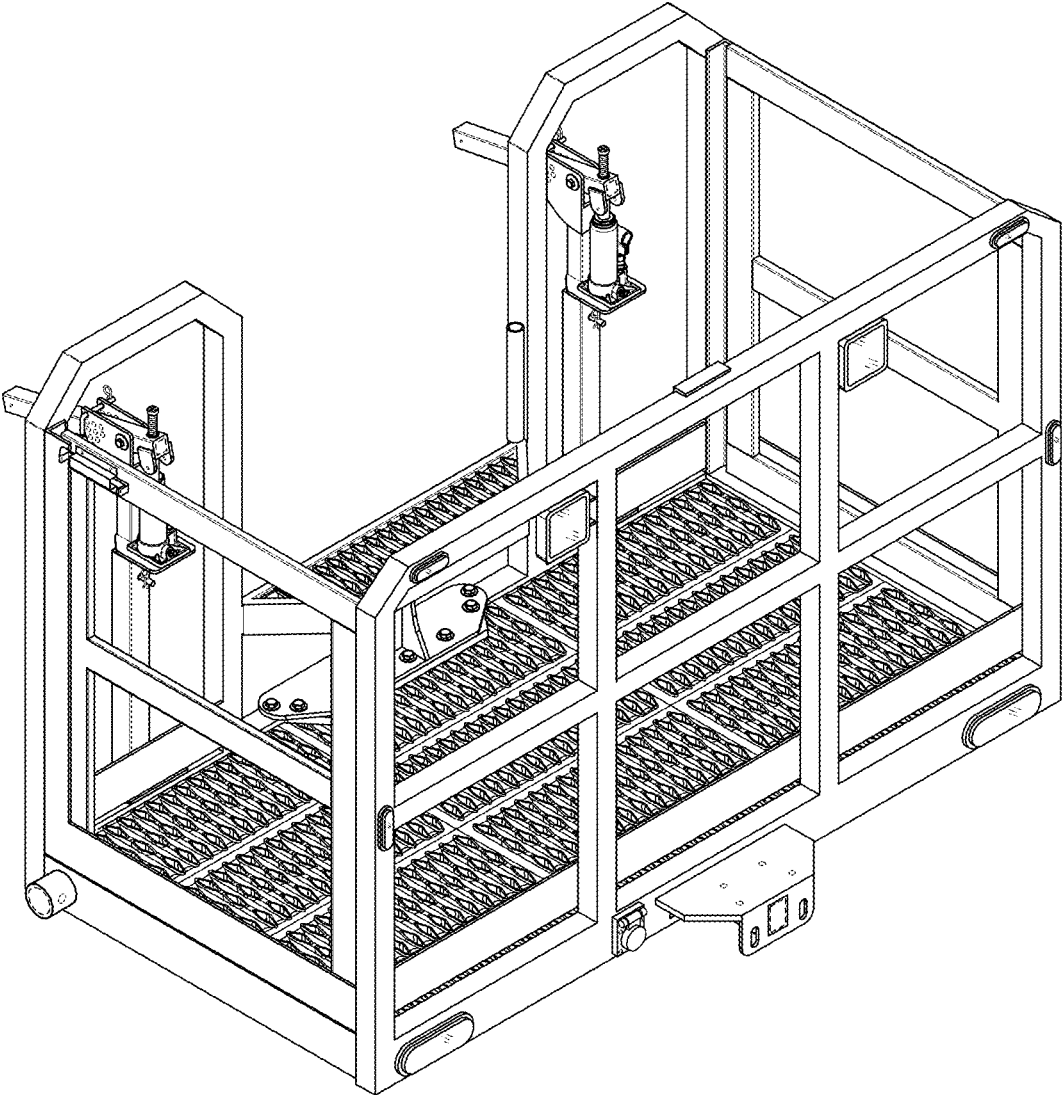

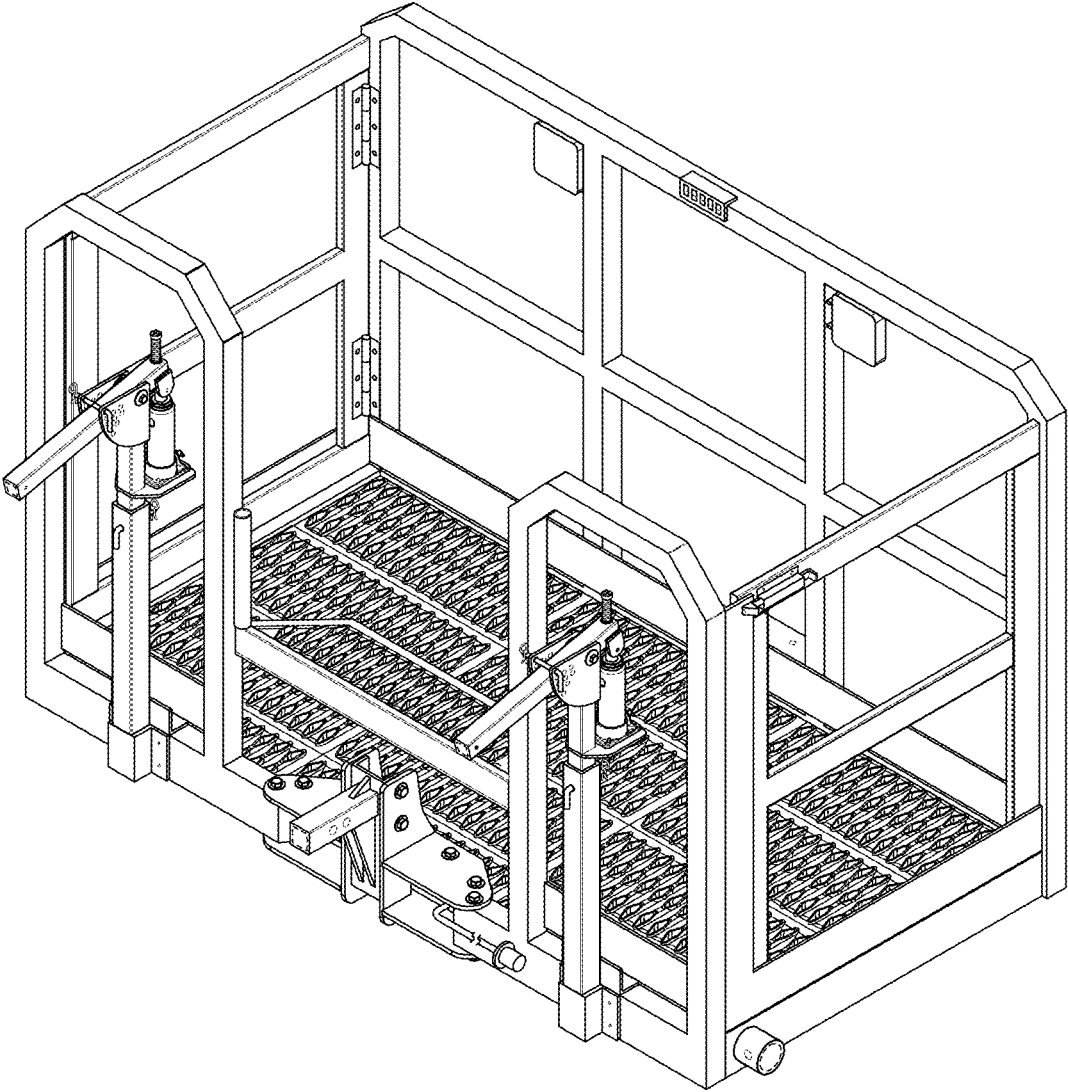

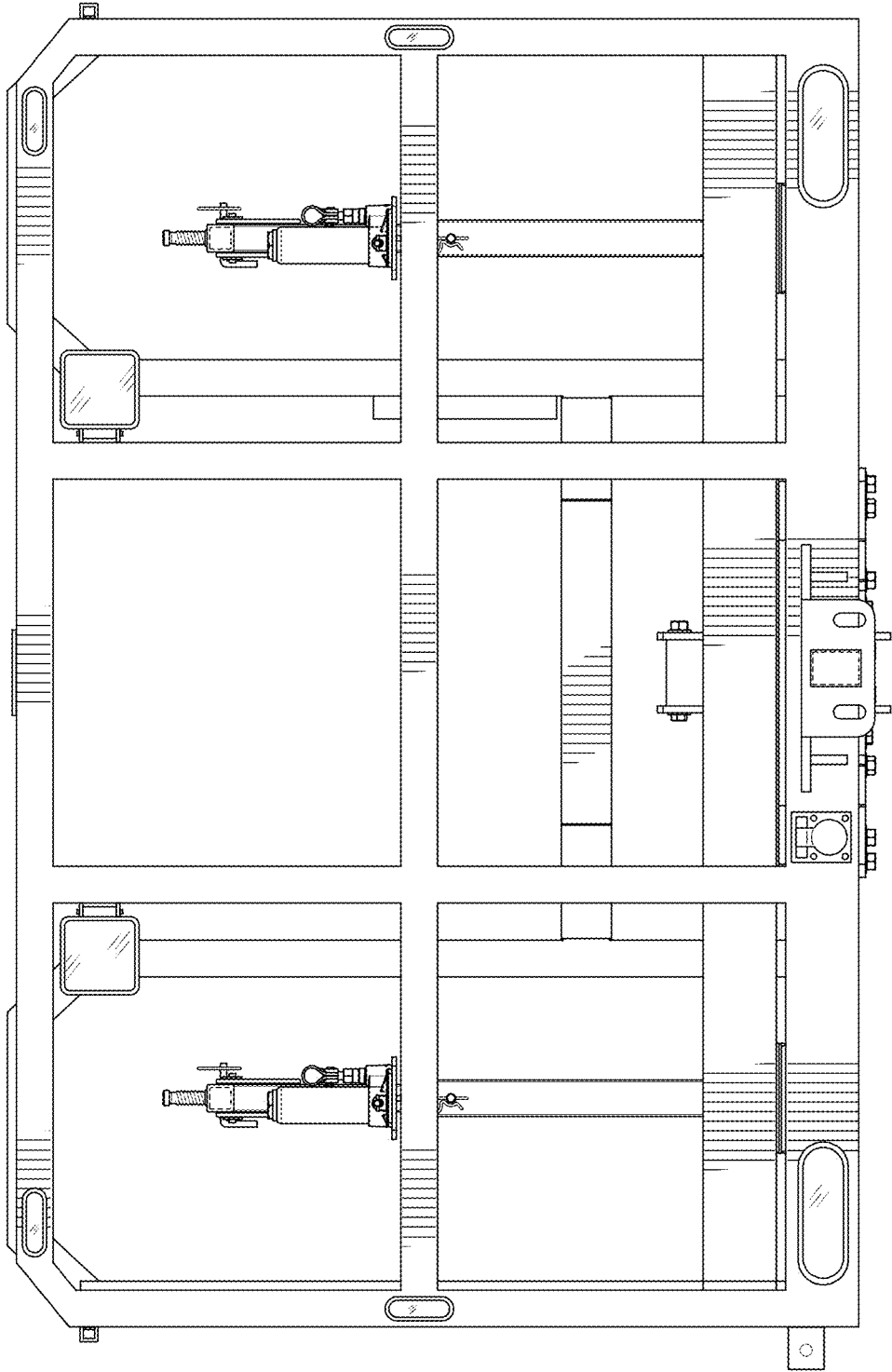

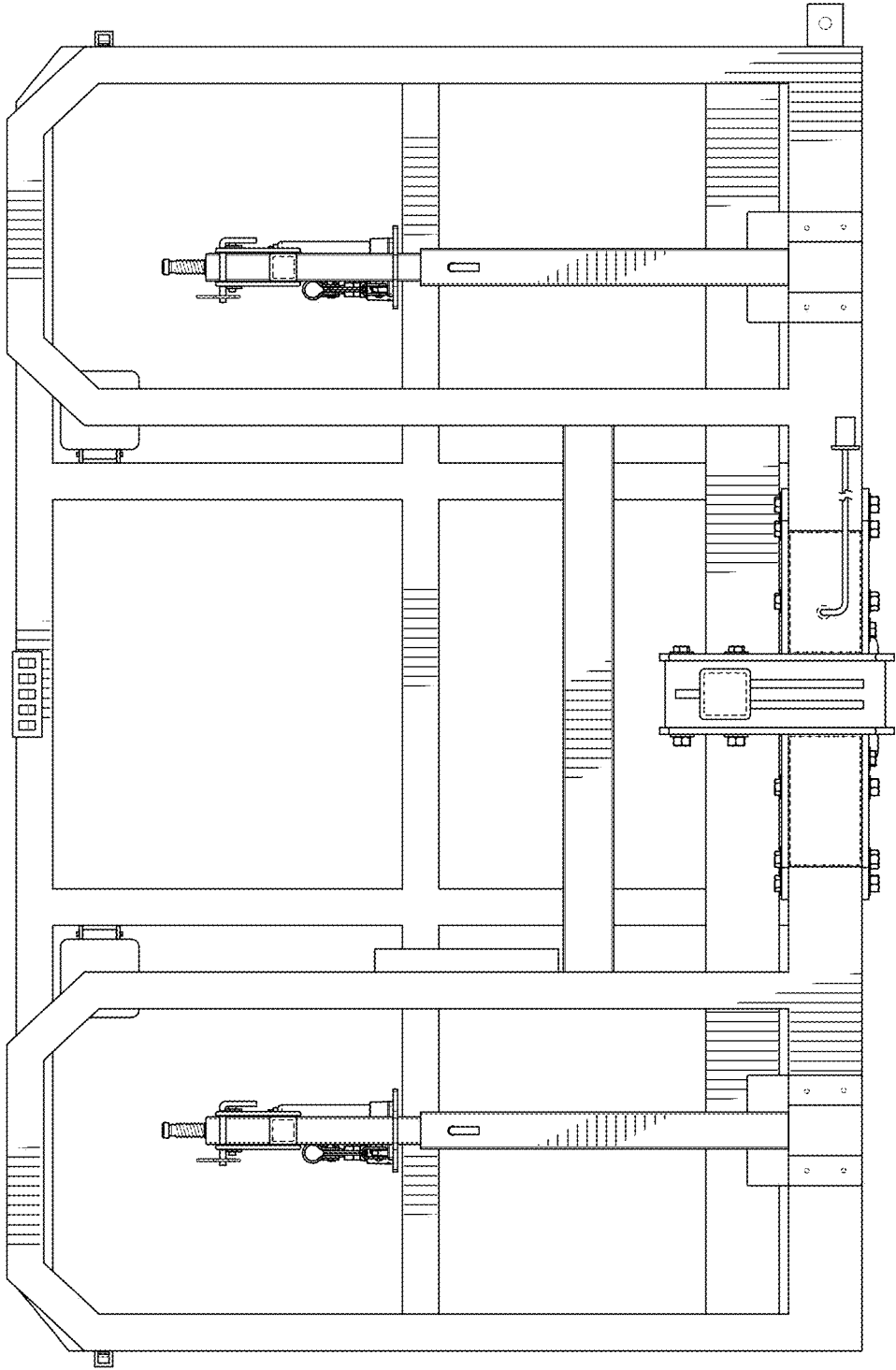

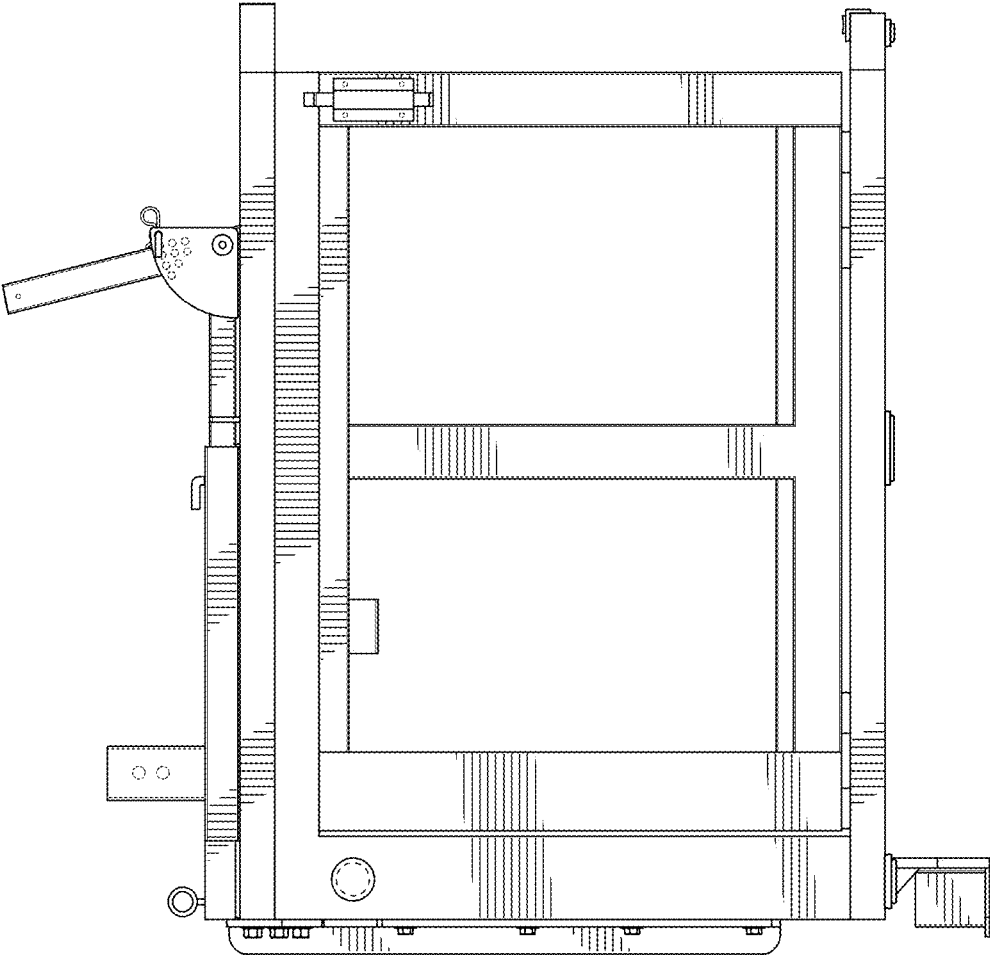

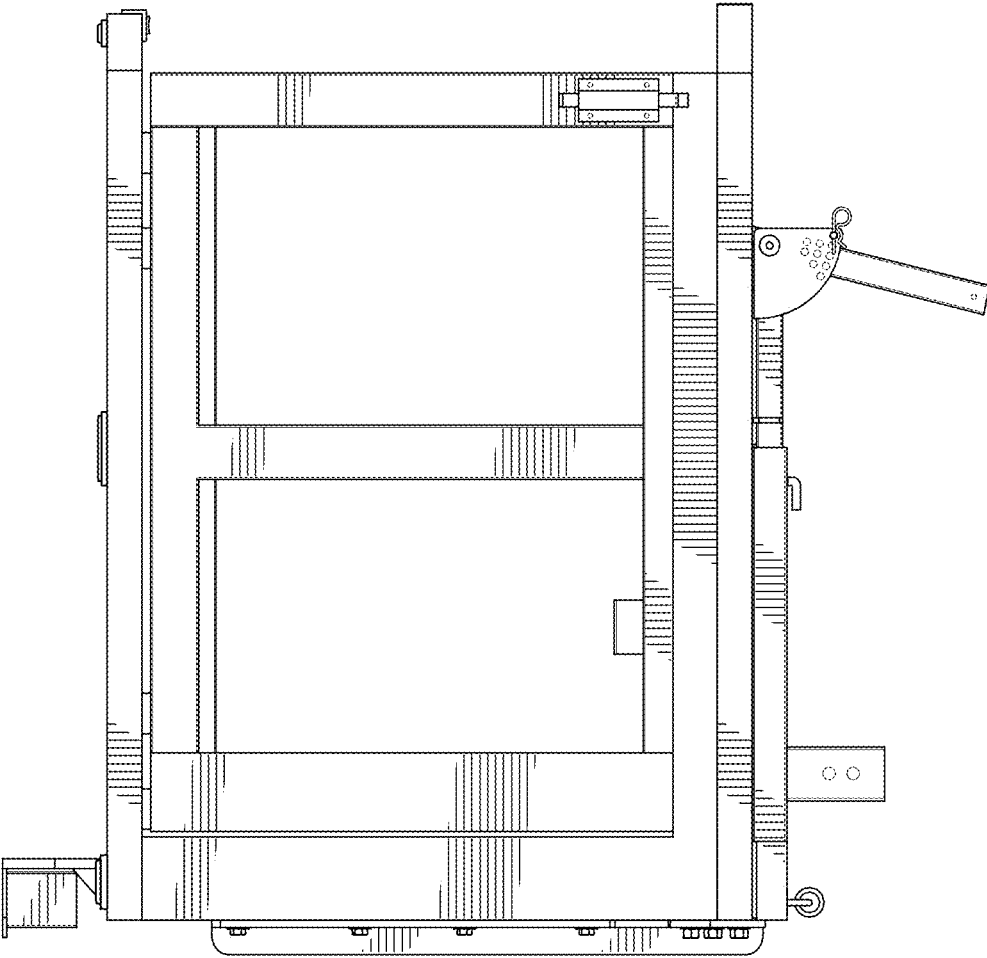

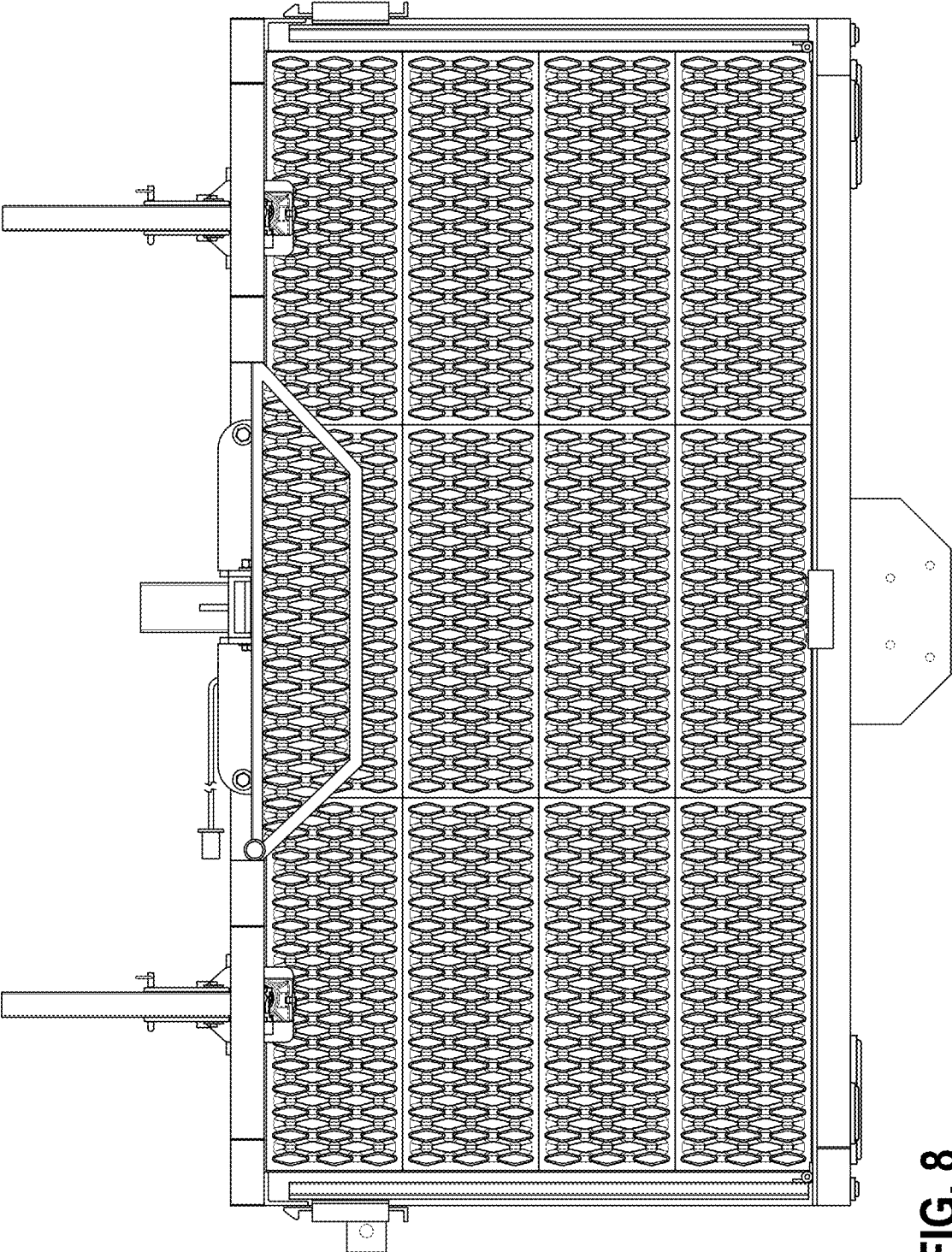

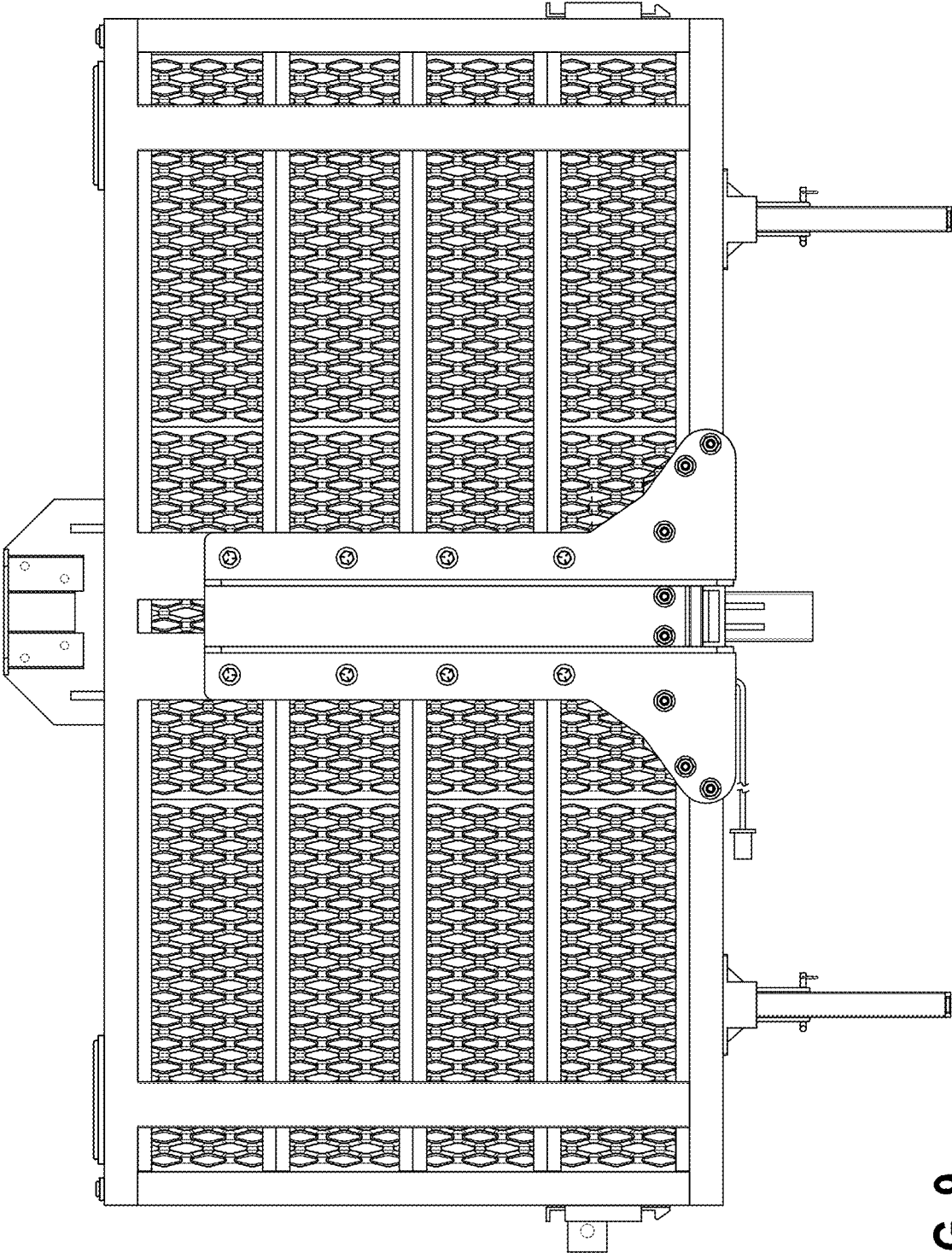

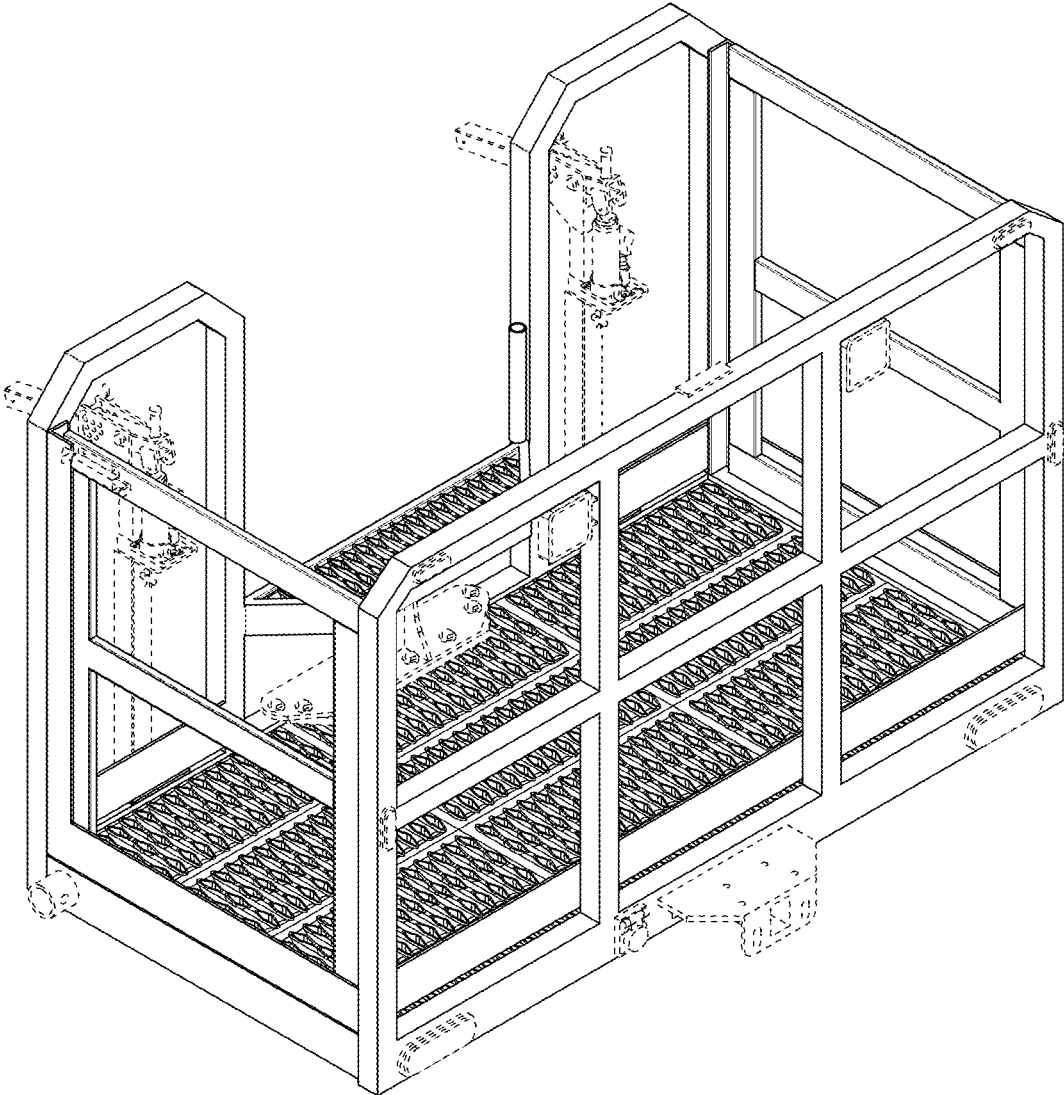

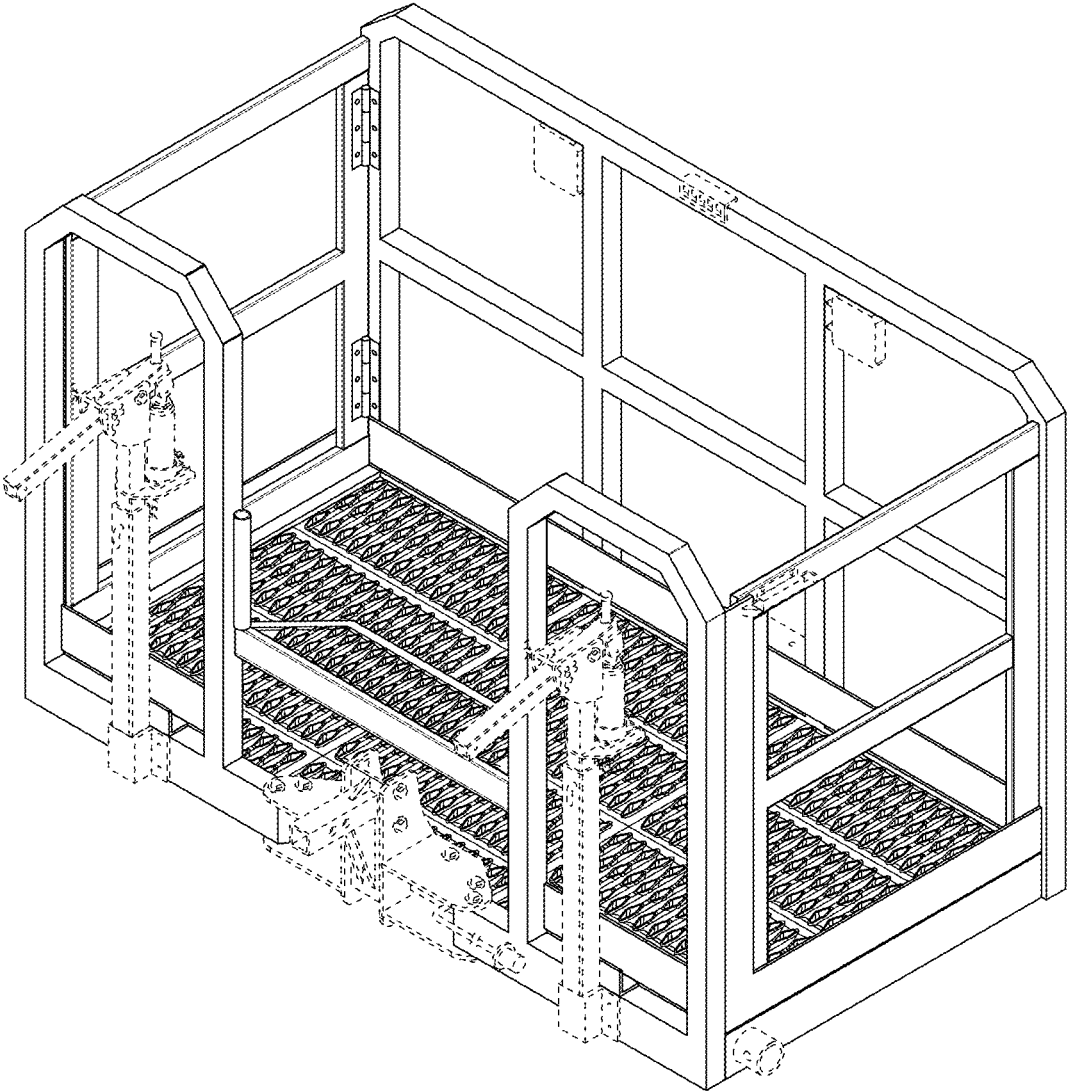

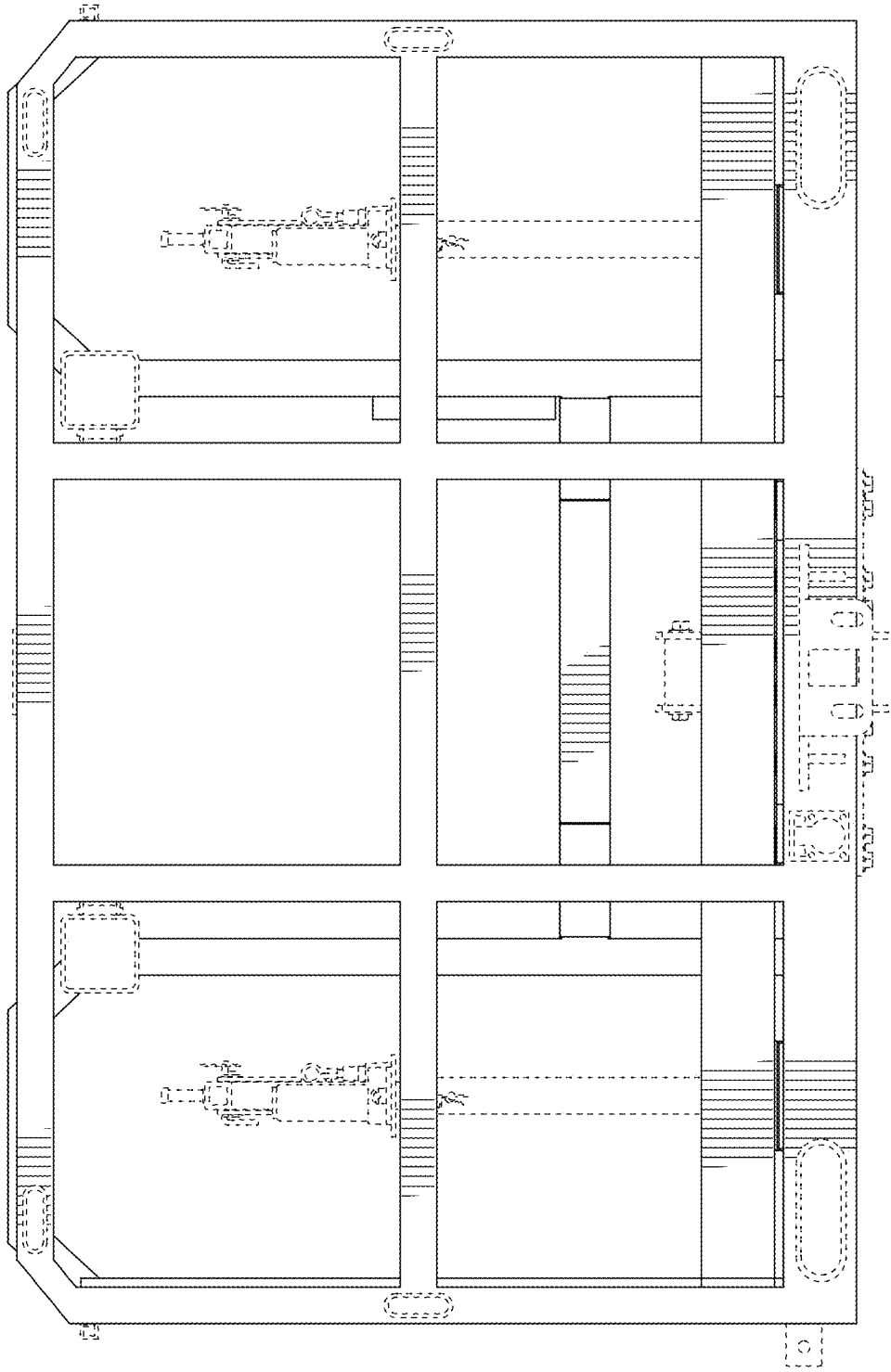

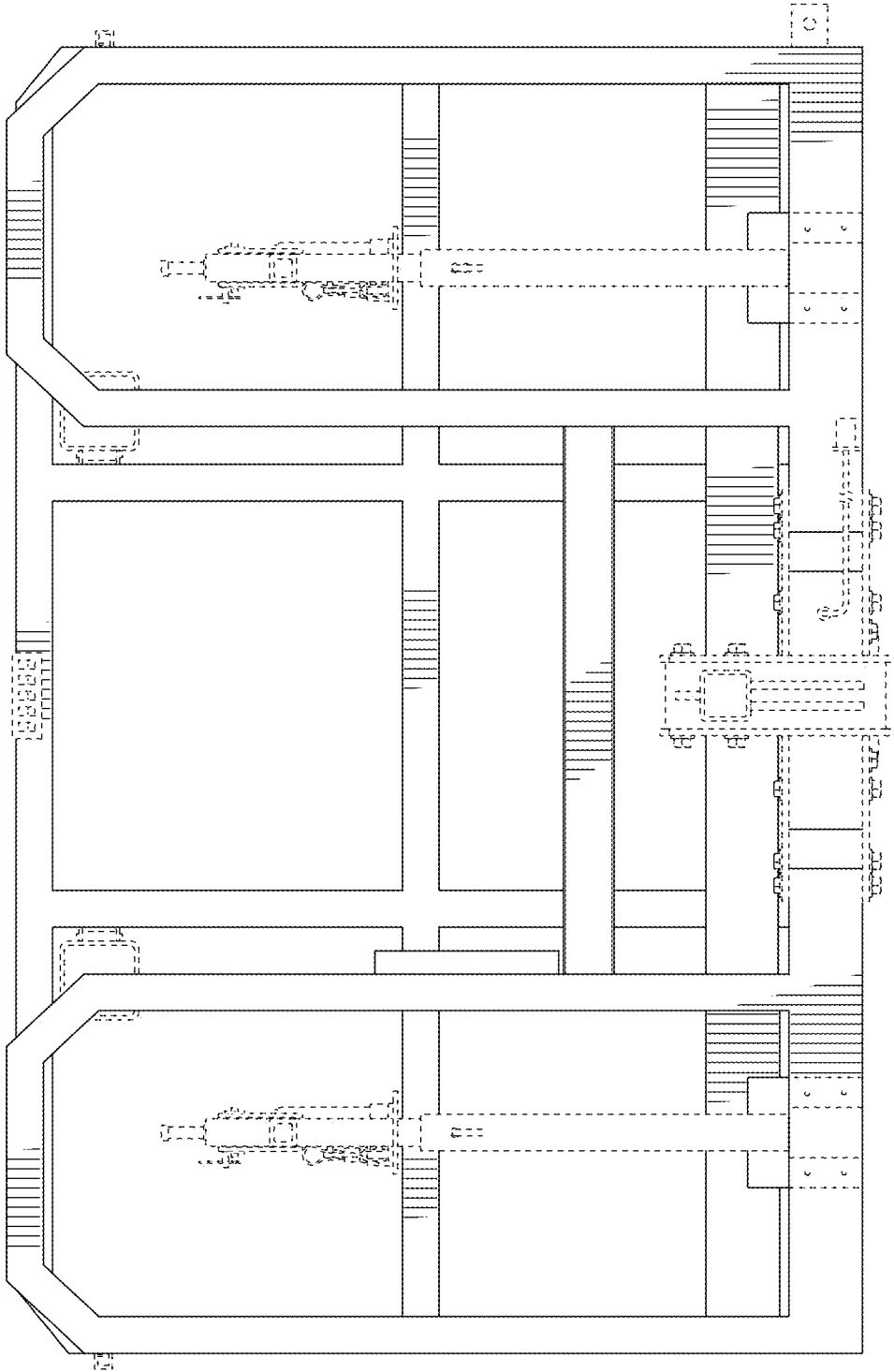

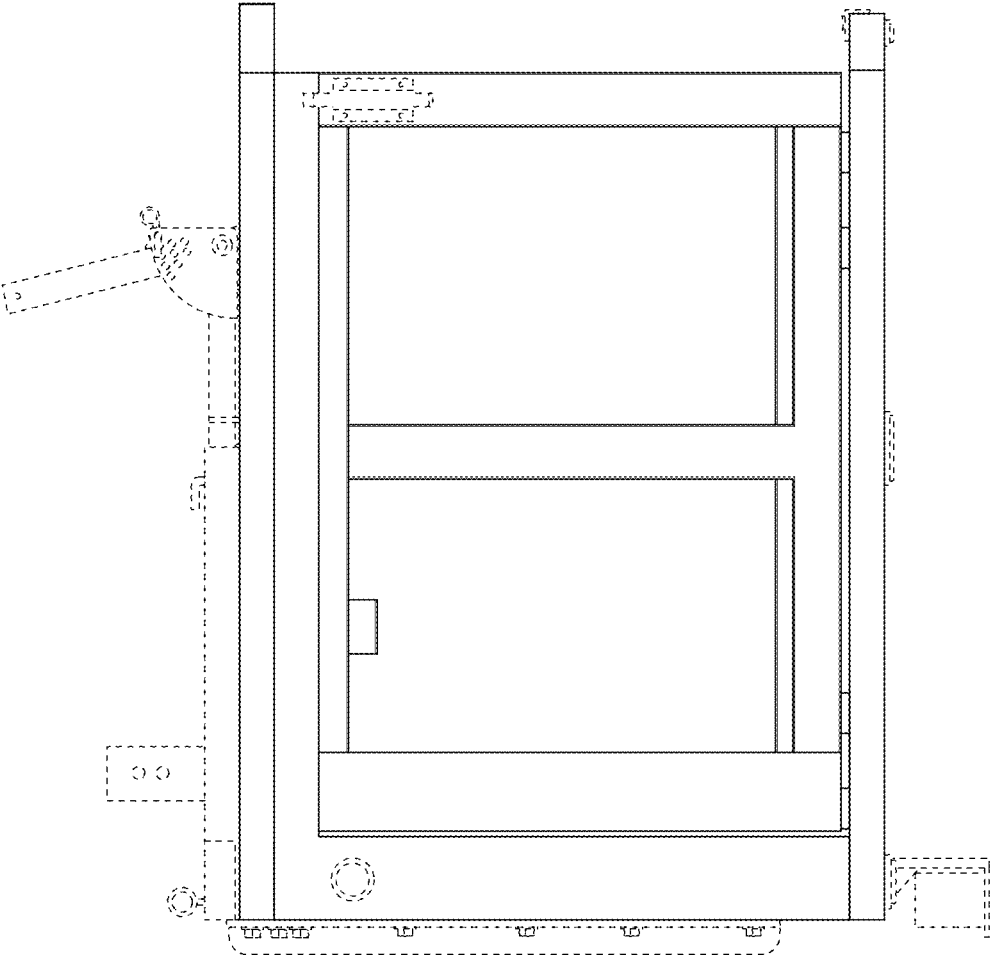

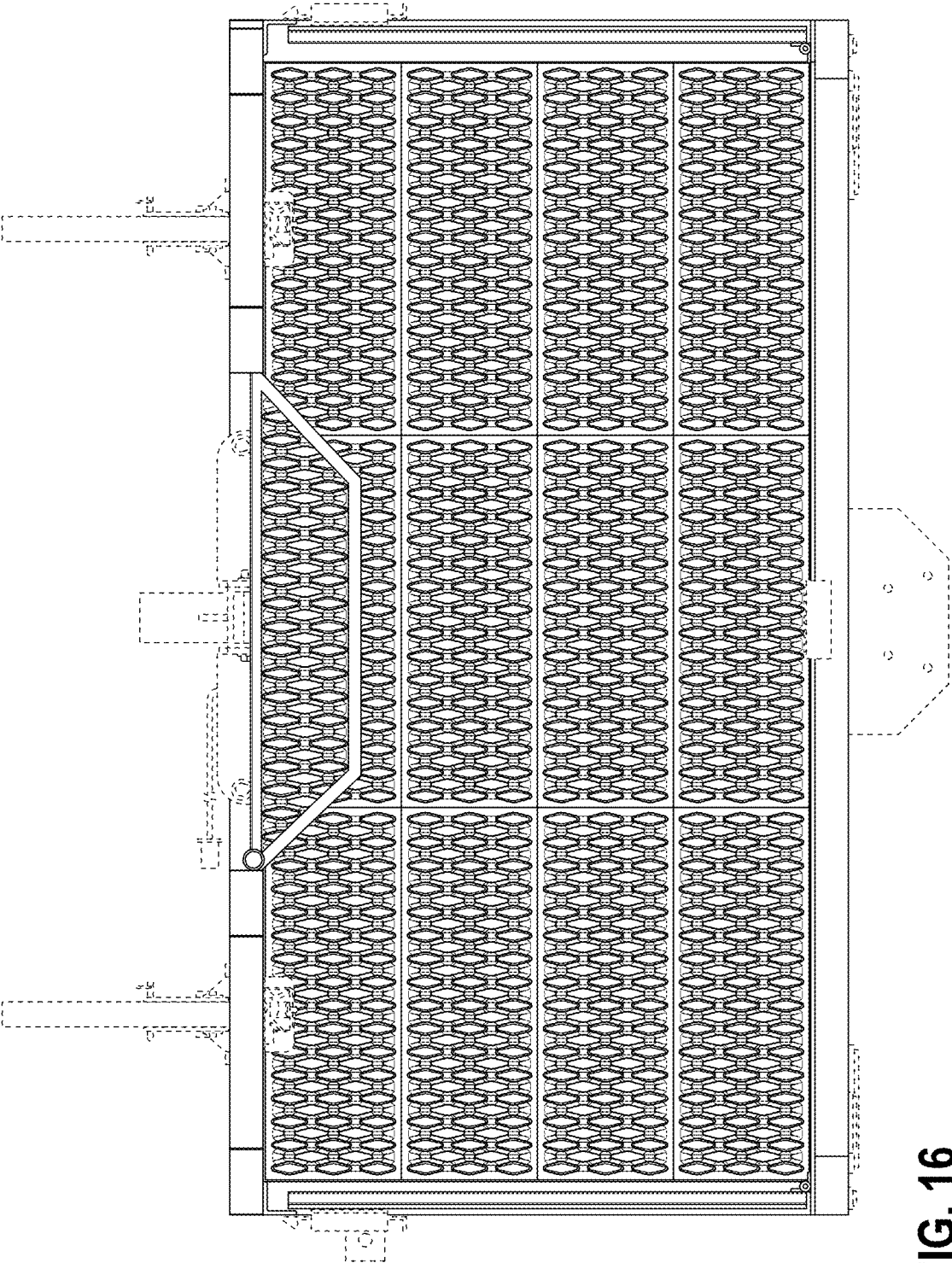

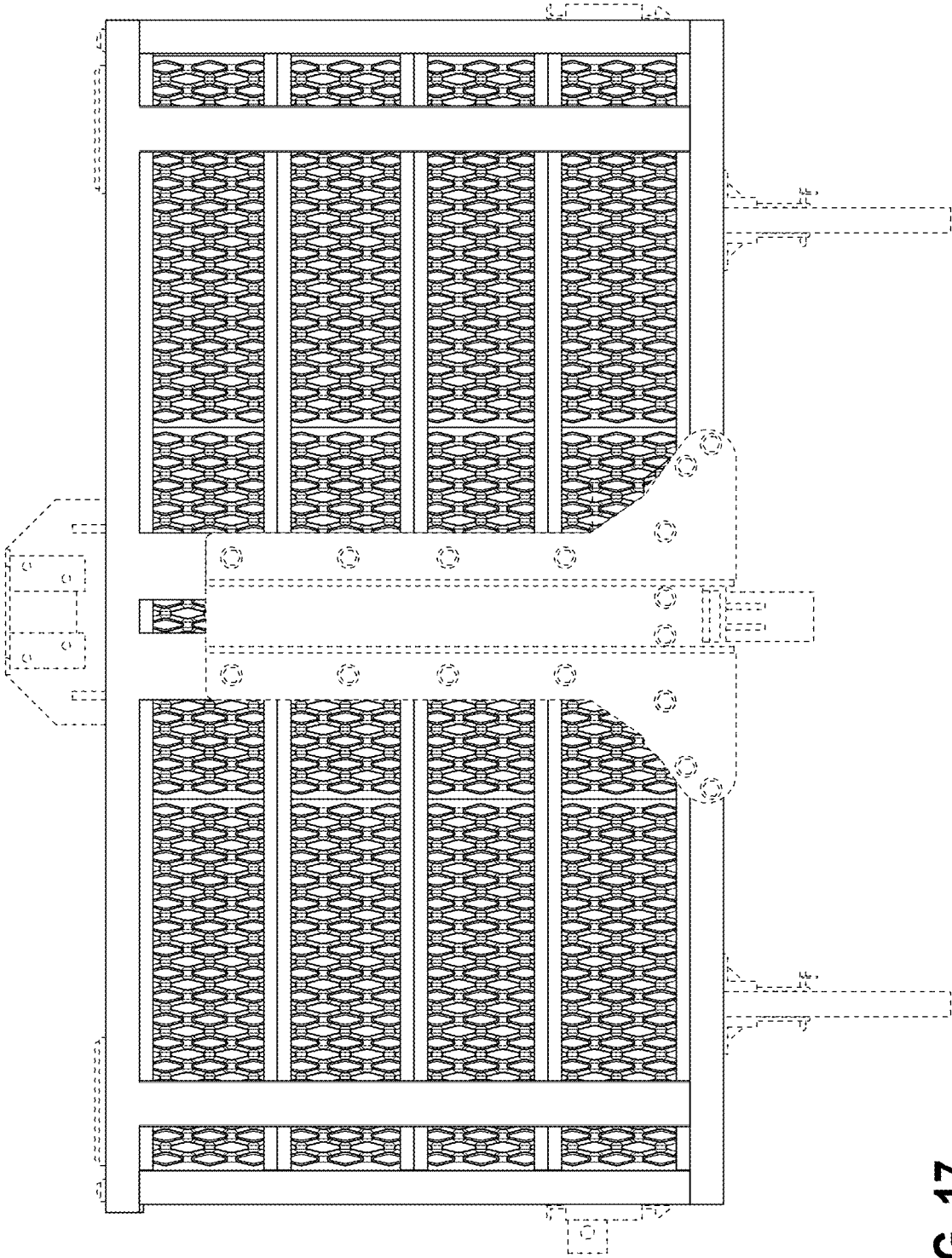
