(57) **CLAIM**

The ornamental design for jeans, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of jeans, wherein the jeans are unfastened or open.

FIG. 2 is a front view of the jeans of FIG. 1.

FIG. 3 is a back view of the jeans of FIG. 1.

FIG. 4 is a right side view of the jeans of FIG. 1.

FIG. 5 is a left side view of the jeans of FIG. 1.

FIG. 6 is a top view of the jeans of FIG. 1.

FIG. 7 is a bottom view of the jeans of FIG. 1.

FIG. 8 is a perspective view of the jeans of FIG. 1, wherein the jeans are fastened or closed.

FIG. 9 is a perspective view of a second embodiment of jeans, wherein the jeans are unfastened or open; and,

FIG. 10 is a perspective view of the jeans of FIG. 9, wherein the jeans are fastened or closed.

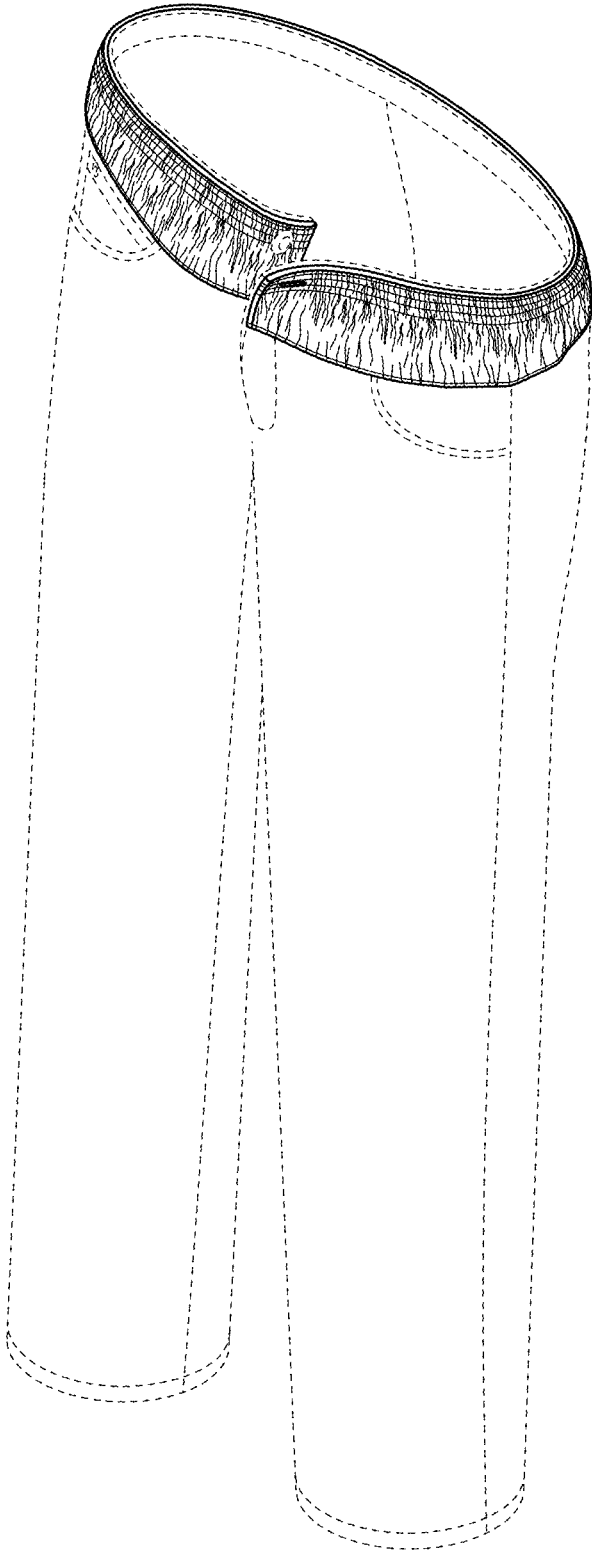

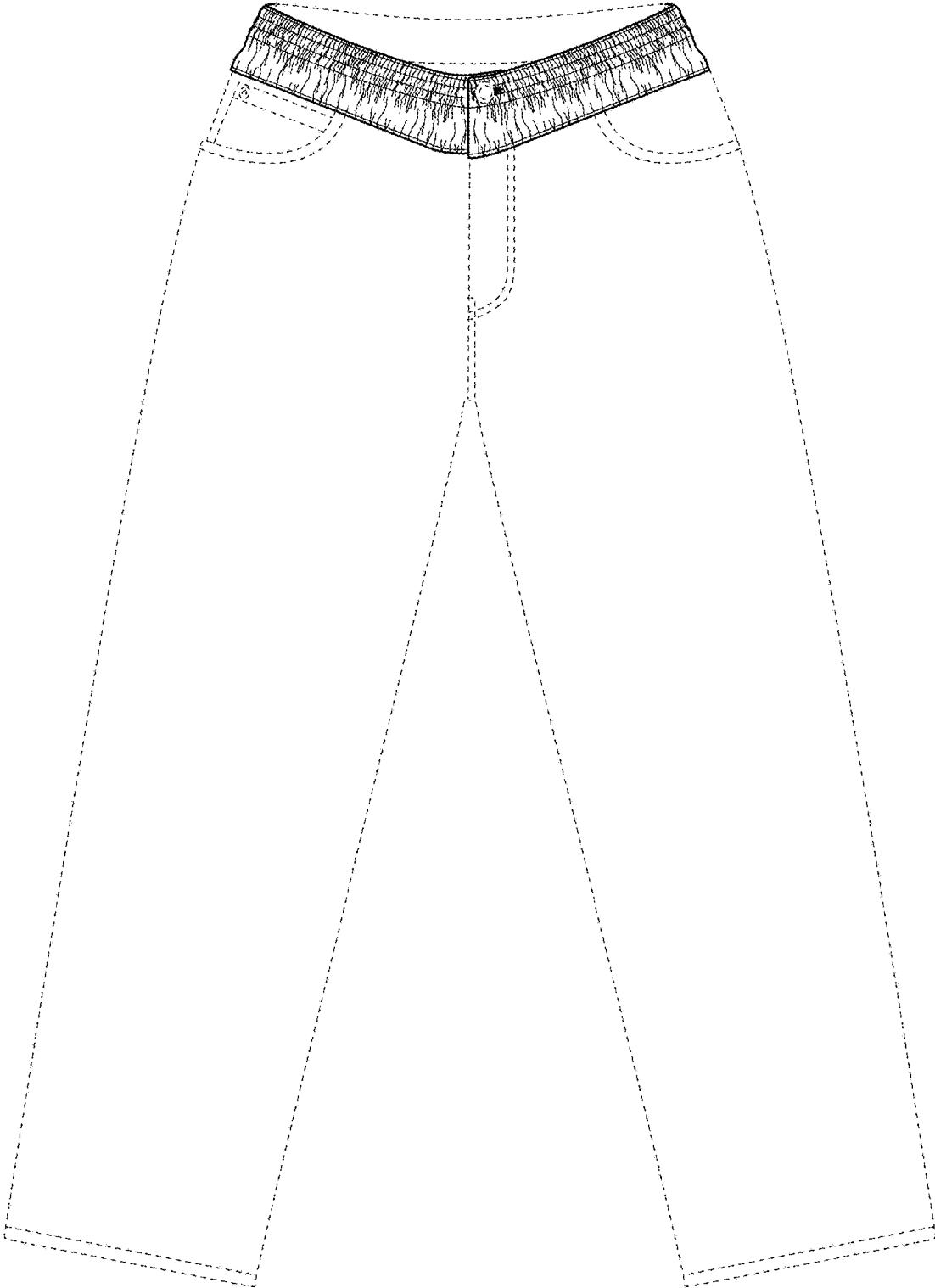

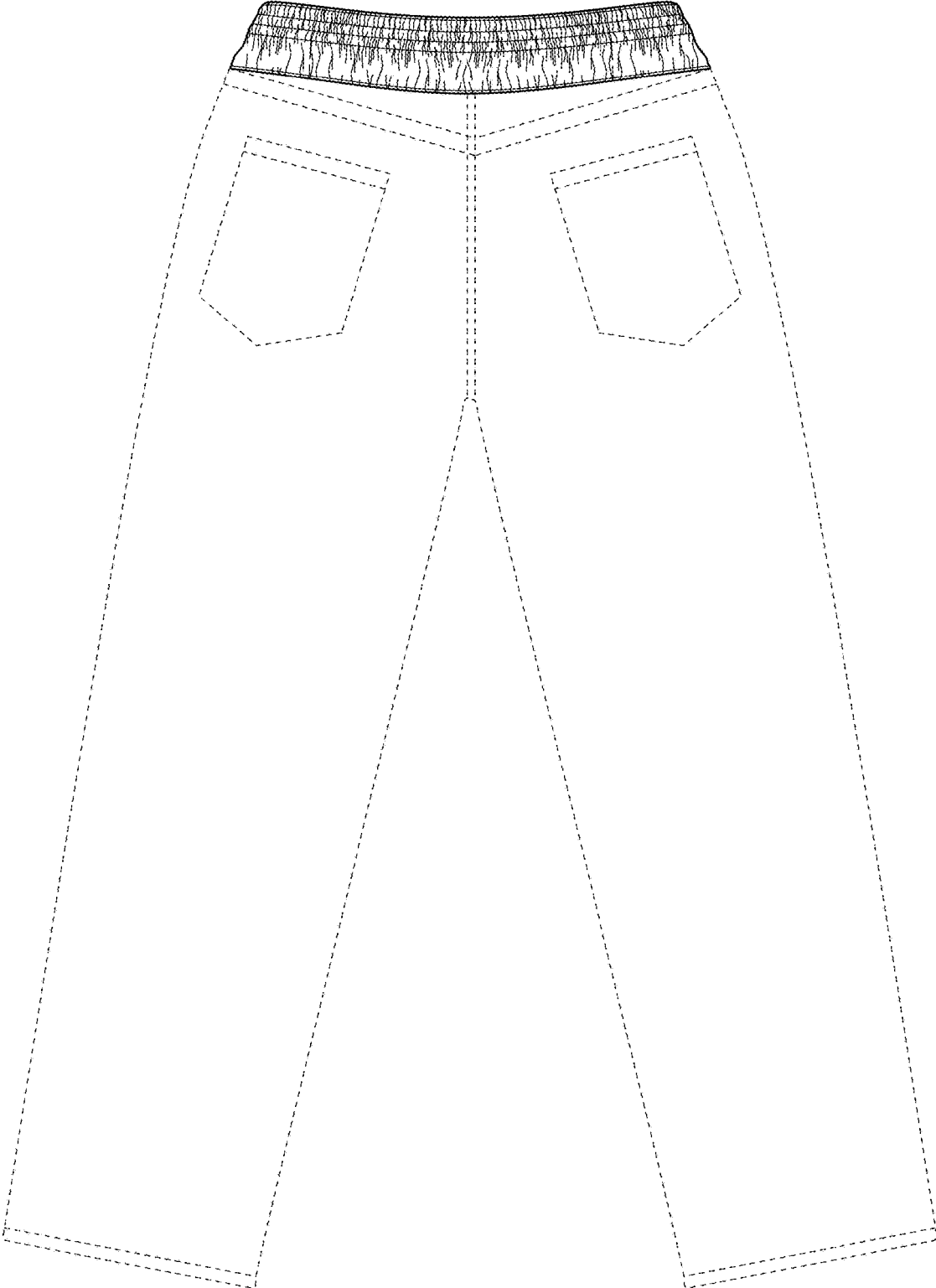

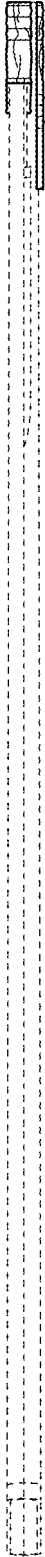

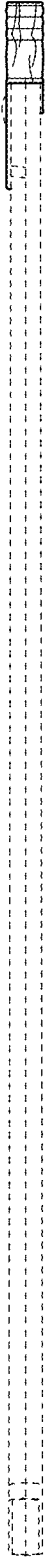

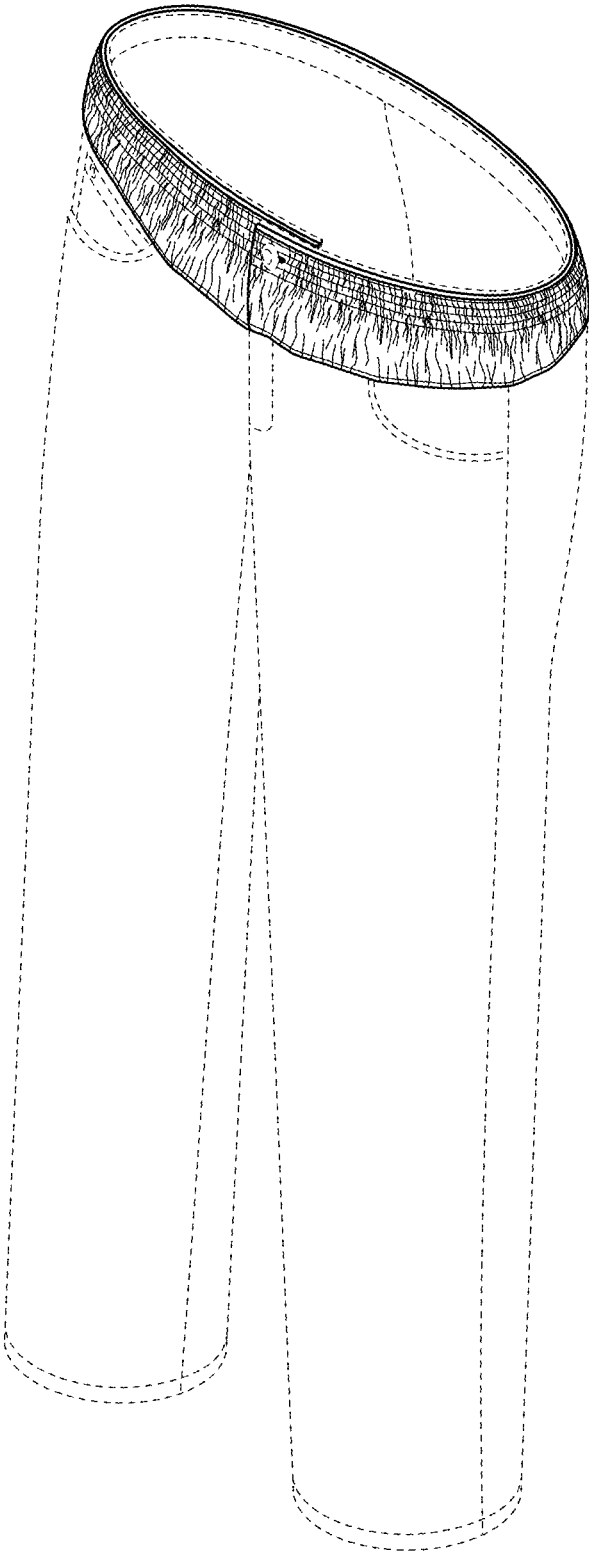

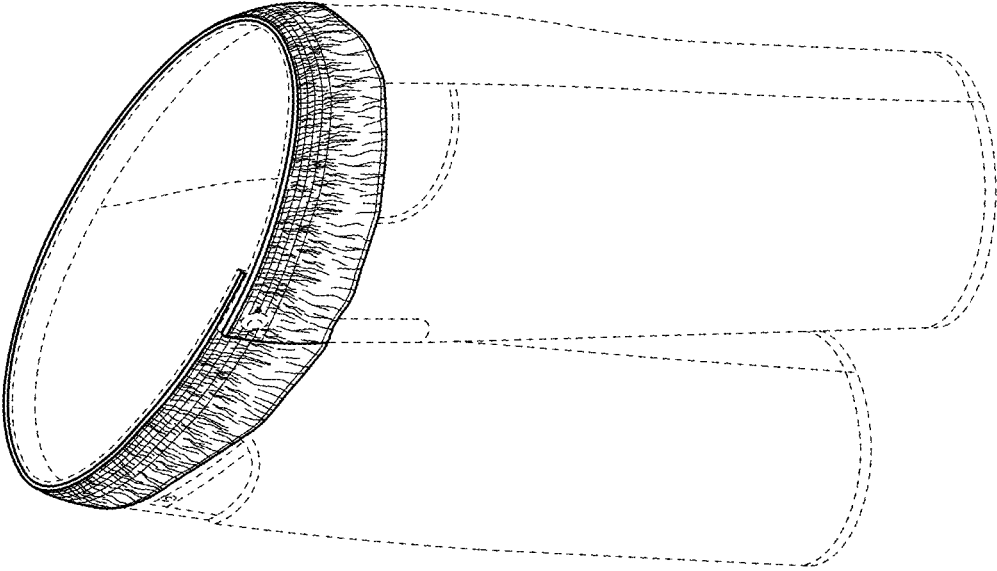

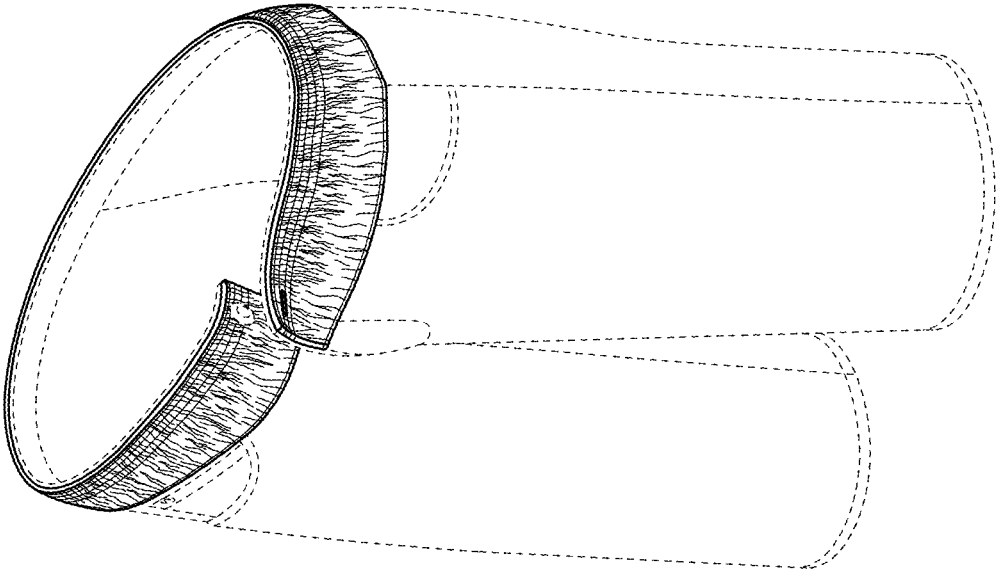
