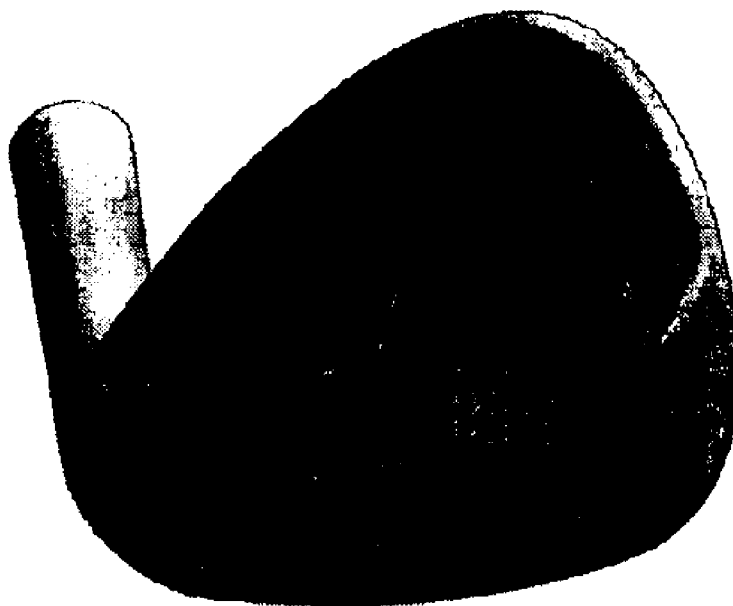
(57) **CLAIM**

The ornamental design for a wedge-type golf club head, as shown and described.

DESCRIPTION

FIG. 1 is an elevated rear perspective view of a wedge-type golf club head showing the new design;
FIG. 2 is a top view thereof;
FIG. 3 is a toe view thereof;
FIG. 4 is a heel view thereof;
FIG. 5 is a front or face view thereof;
FIG. 6 is a back or rear view thereof; and,
FIG. 7 is a bottom or sole view thereof.

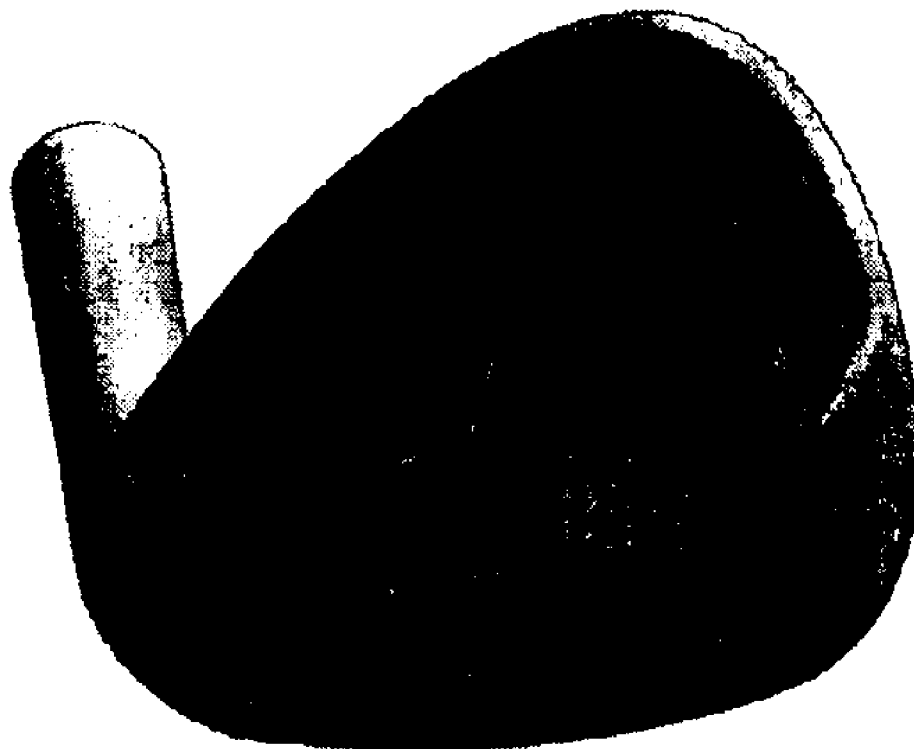

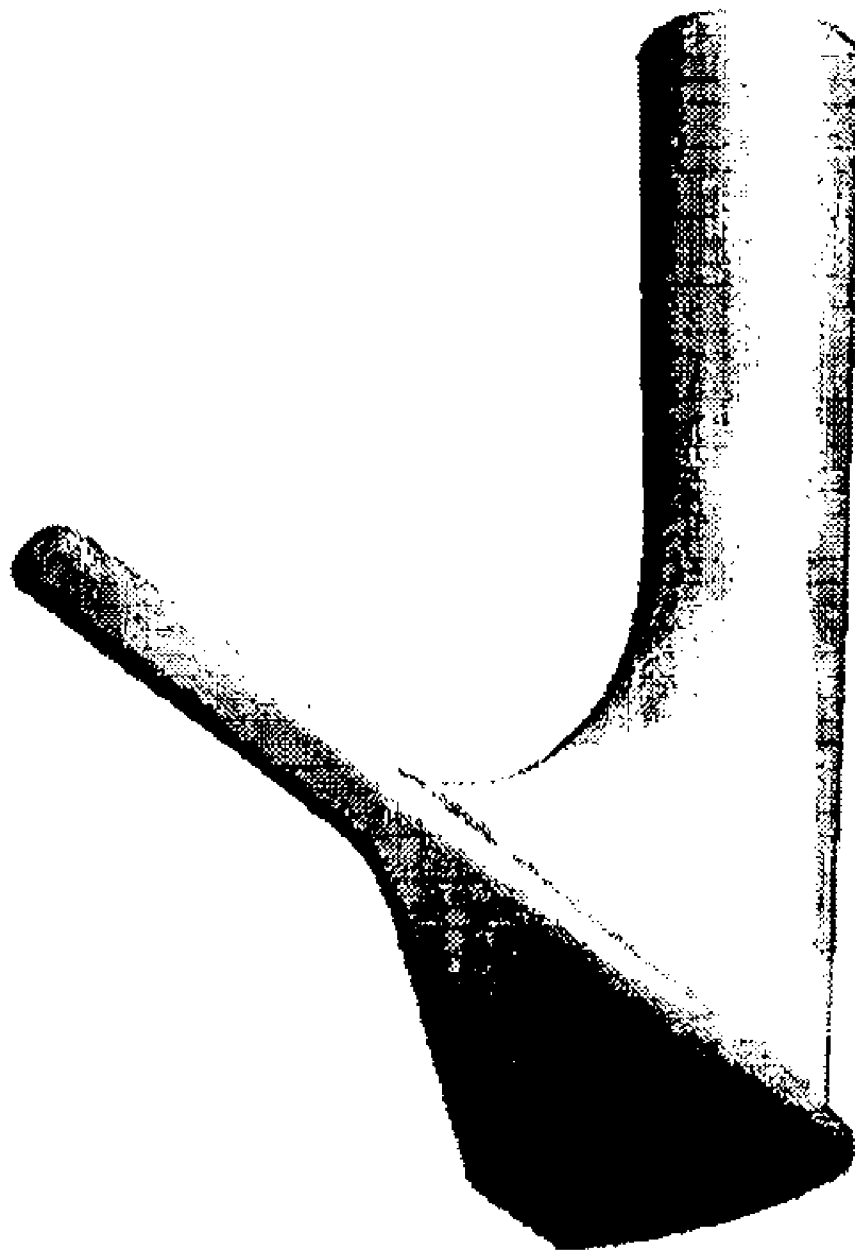

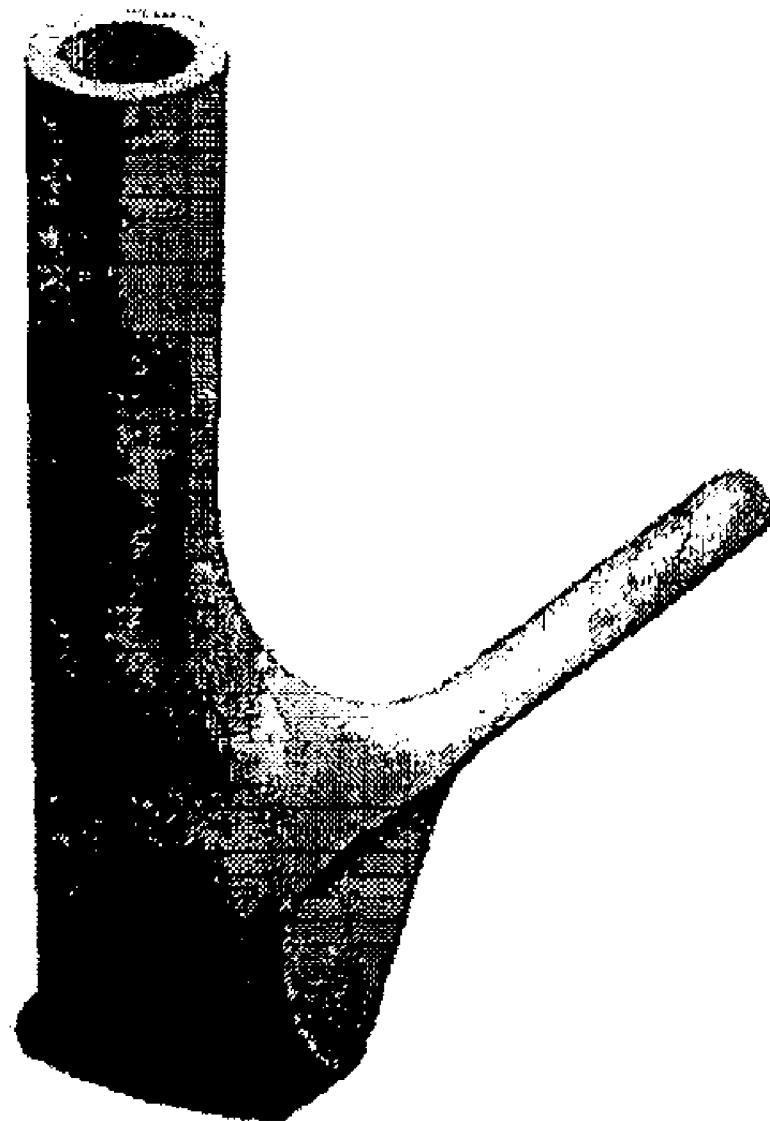

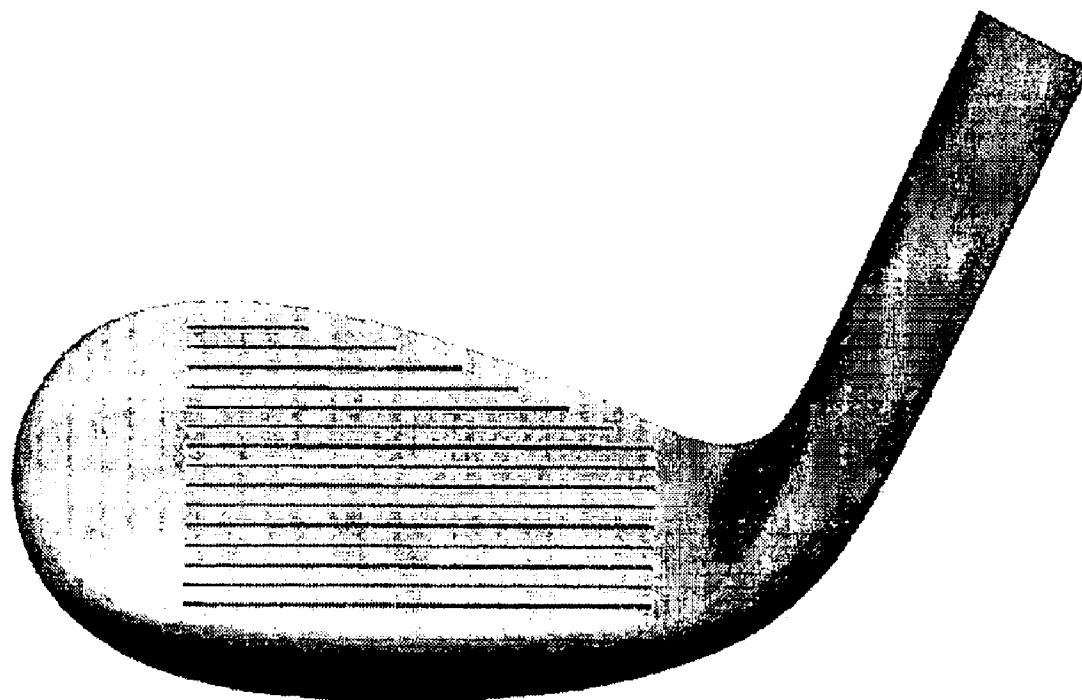

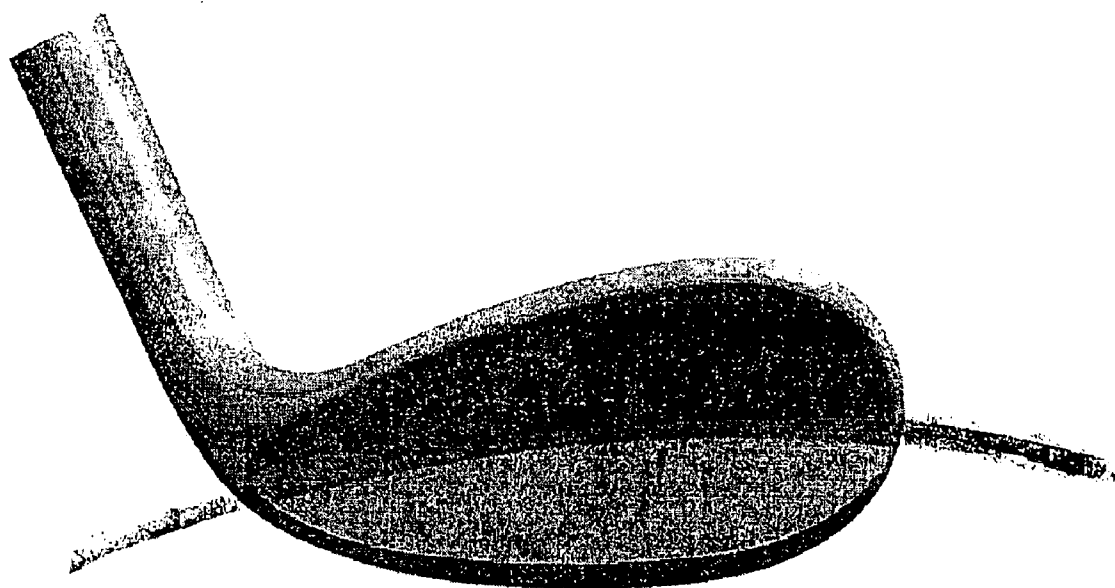

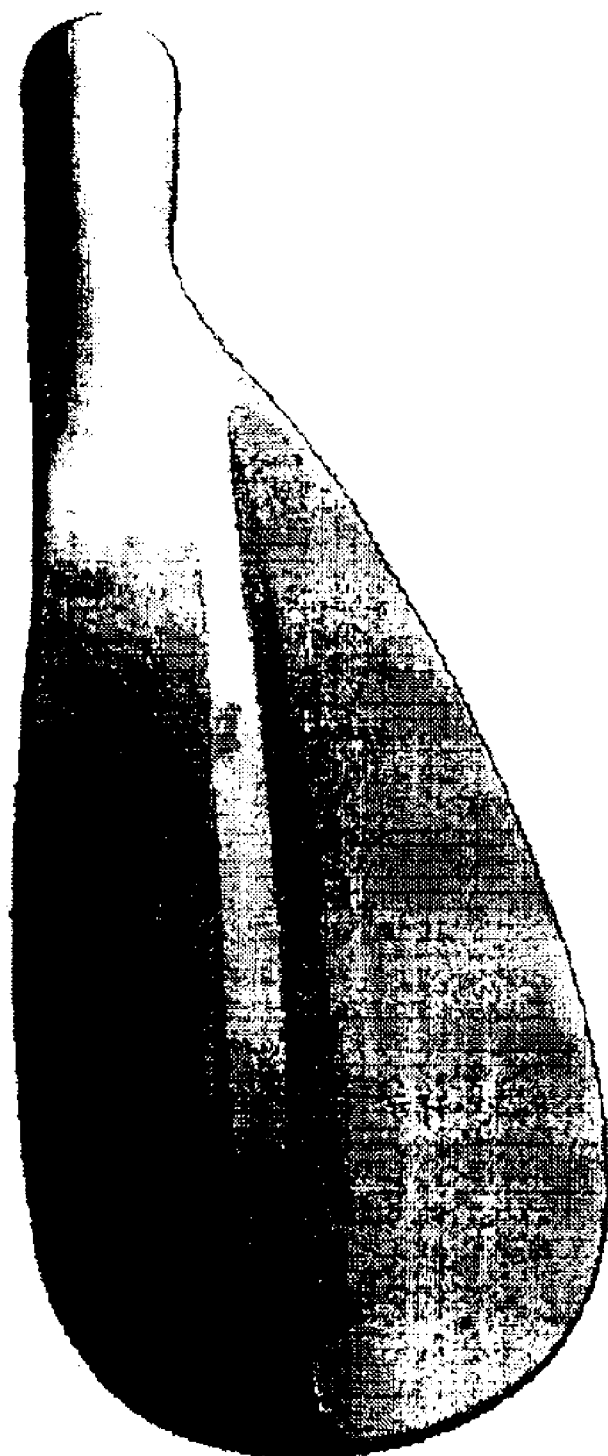
