(57) **CLAIM**

The ornamental design for a channel trim, as shown and described.

**DESCRIPTION**

FIG. 1 is a first perspective view of the channel trim, showing the new design.

FIG. 2 is a front view of the channel trim of FIG. 1.

FIG. 3 is a back view of the channel trim of FIG. 1.

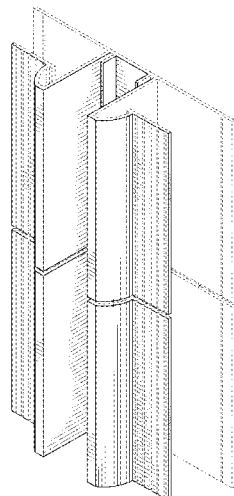
FIG. 4 is a first side view of the channel trim of FIG. 1.

FIG. 5 is a second side view of the channel trim of FIG. 1.

FIG. 6 is a top view of the channel trim of FIG. 1; and, FIG. 7 is a bottom view of the channel trim of FIG. 1.

The channel trim is shown with symbolic breaks in its length. The appearance of any portion of the channel trim between the break lines forms no part of the claimed design. The broken lines in the drawings depict portions of the channel trim that form no part of the claimed design.

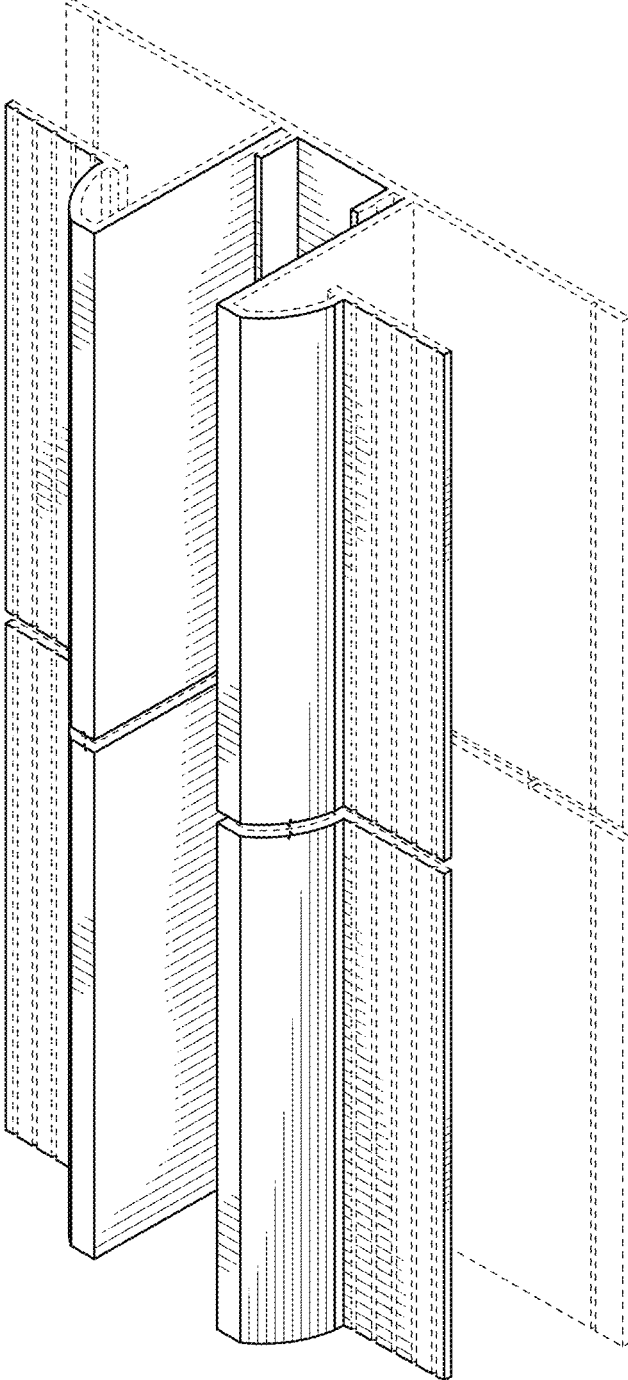

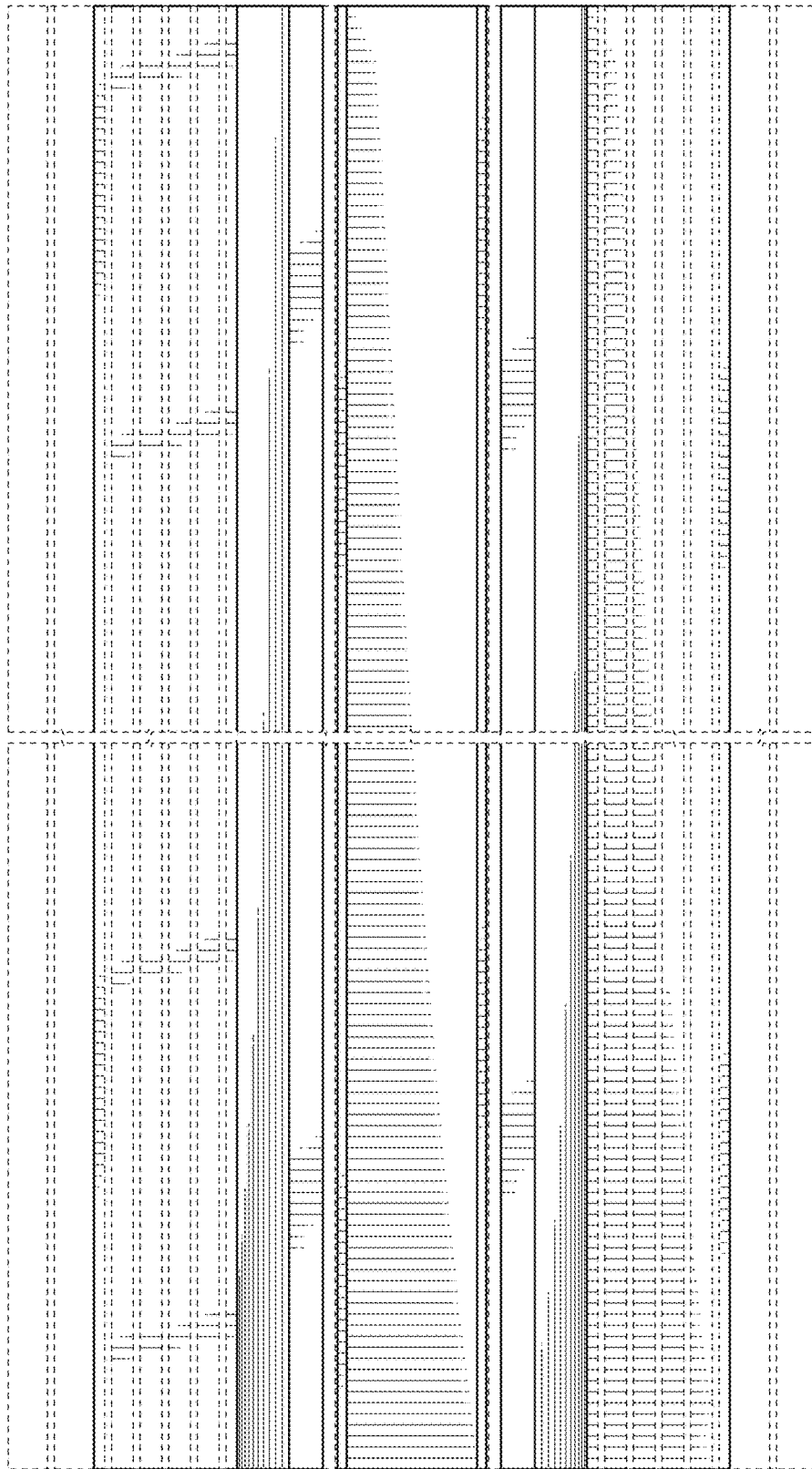

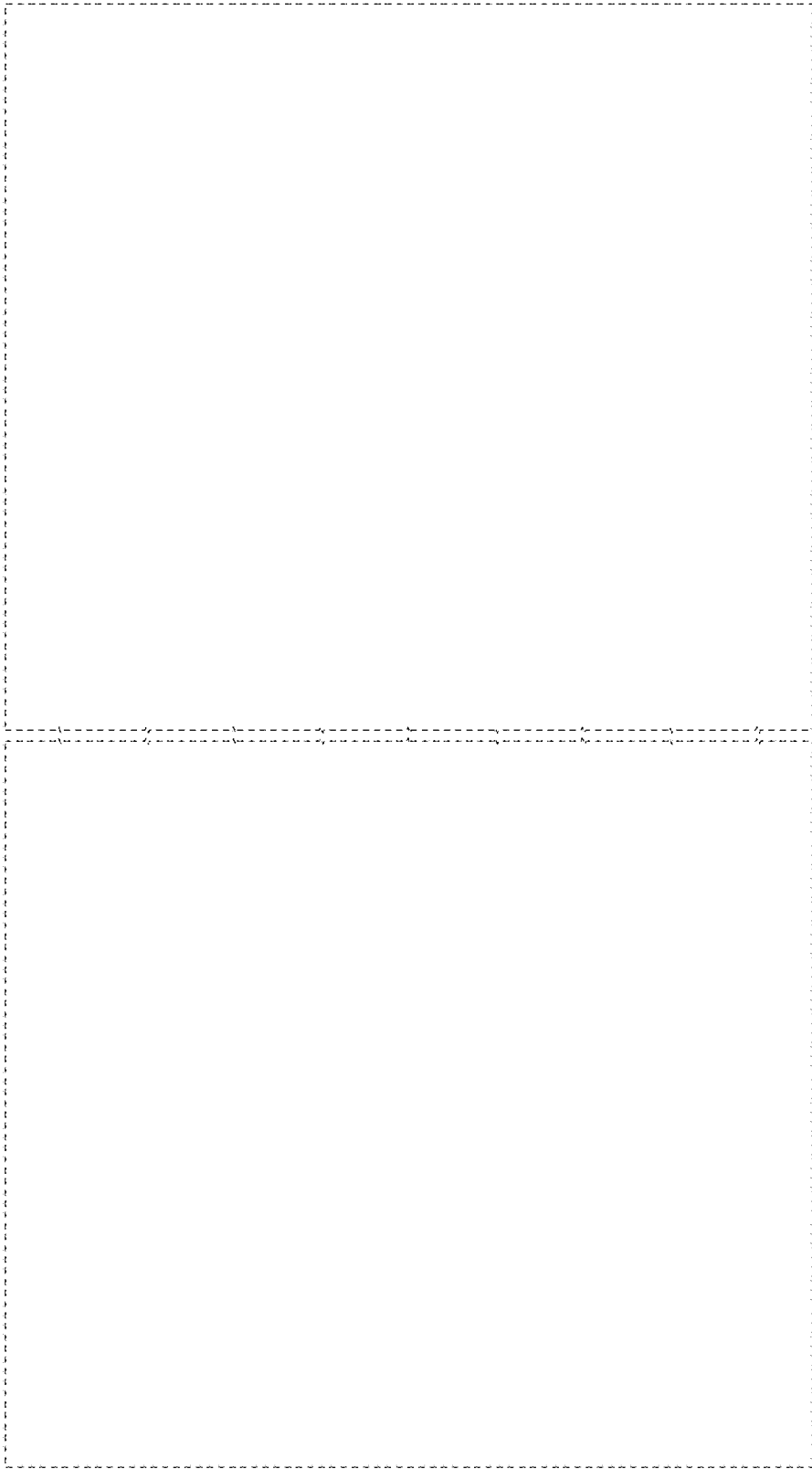

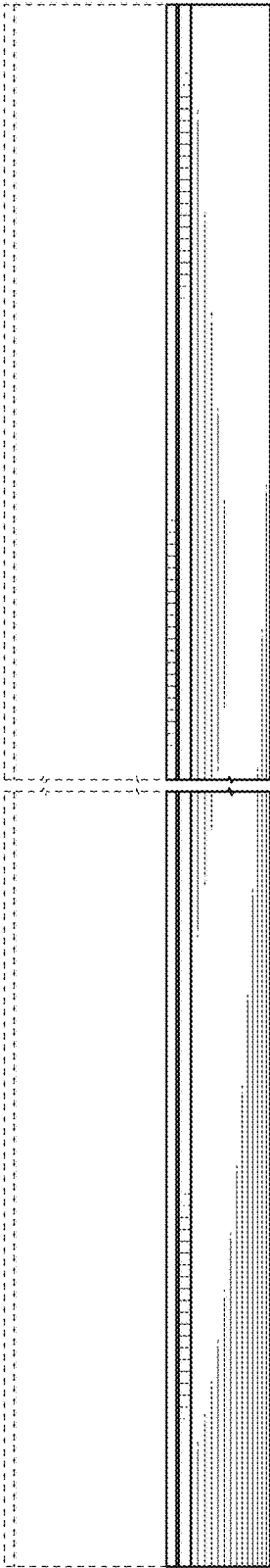

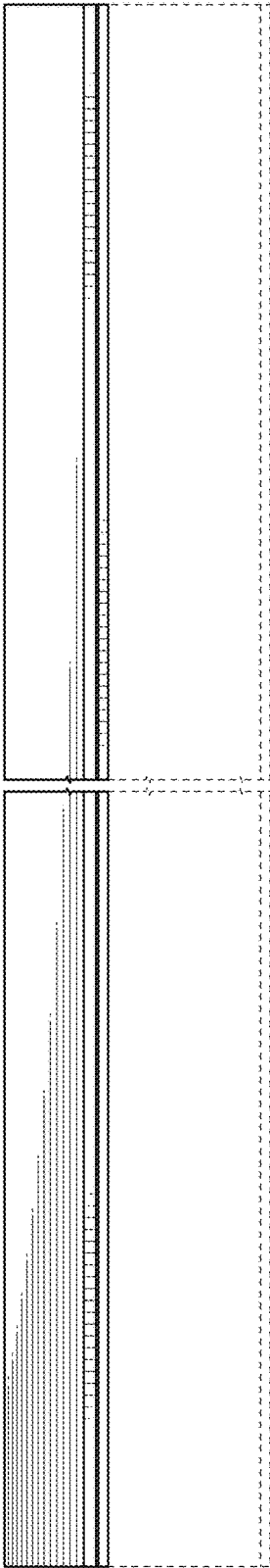

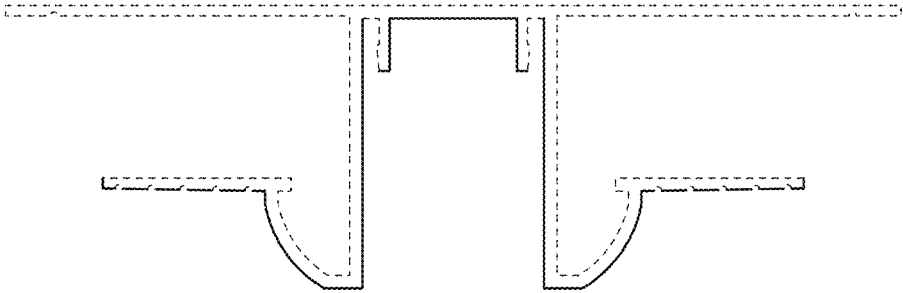

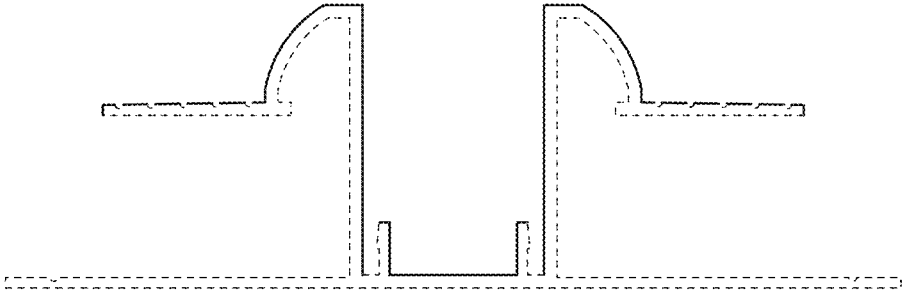
