FIG. 1 is a perspective view of a finger ring showing my new design;

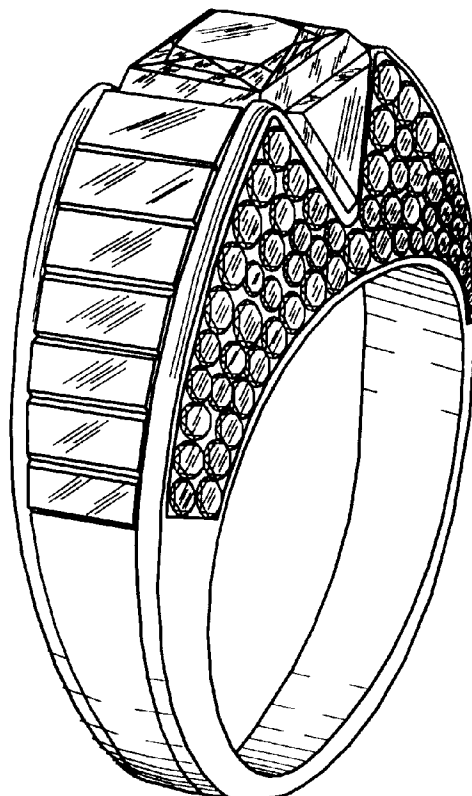
FIG. 2 is a front elevational view, the rear elevational view being a mirror image thereof;

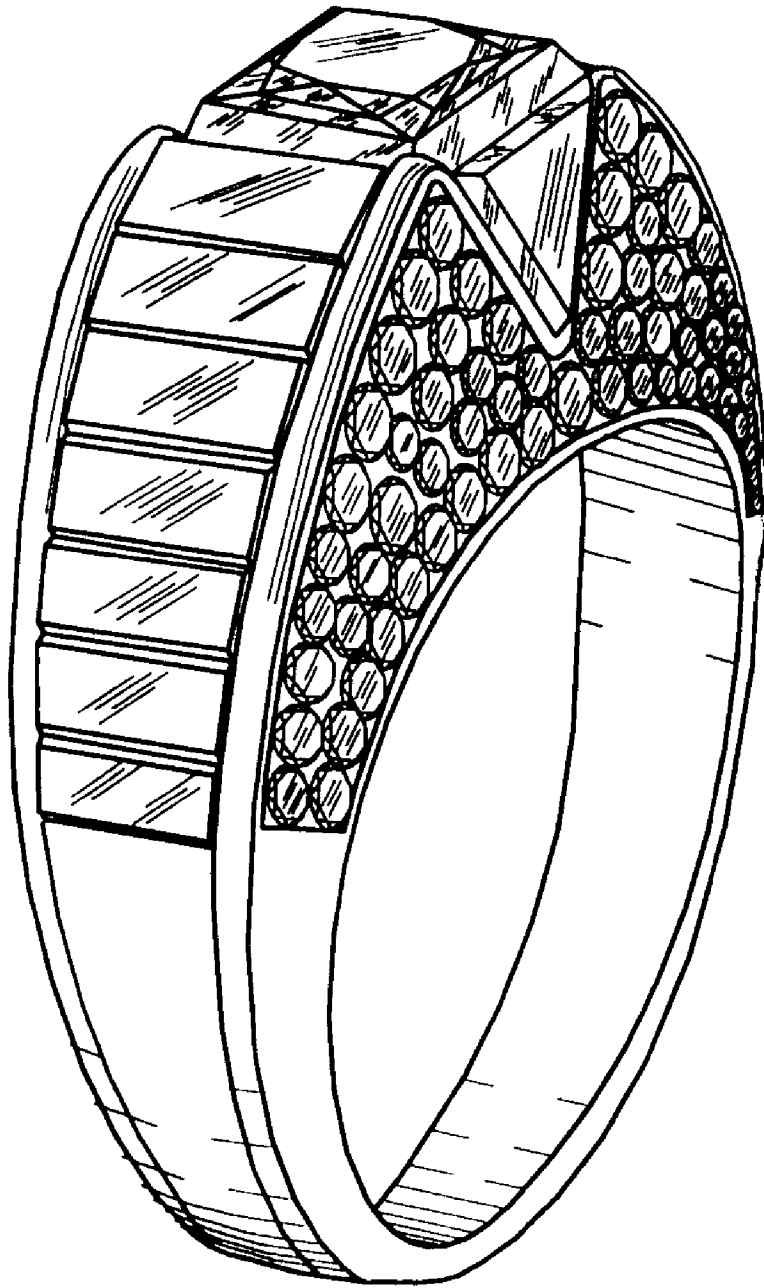

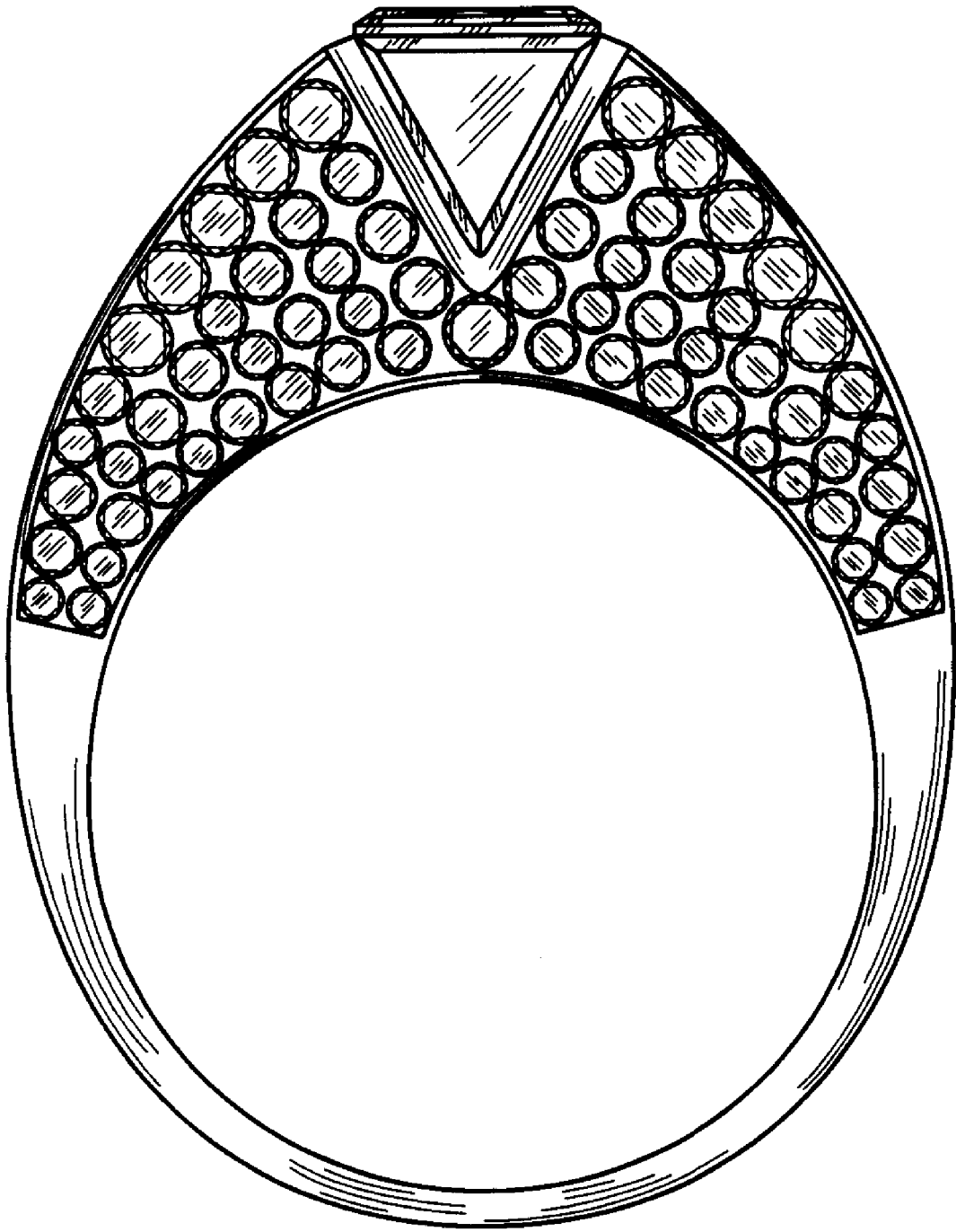

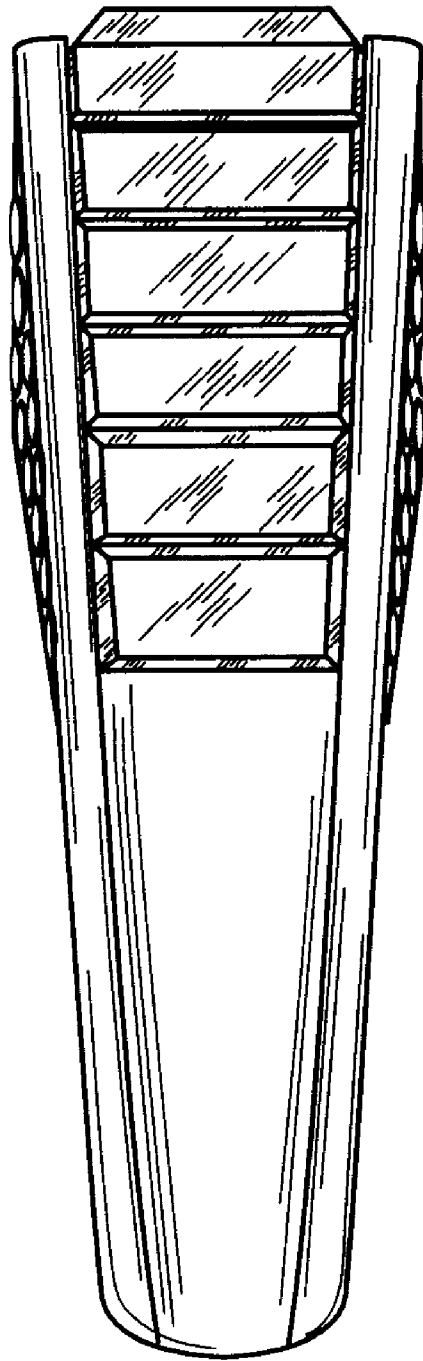

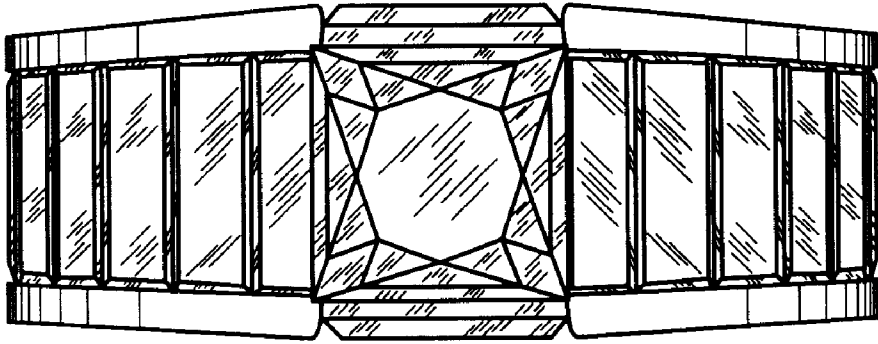

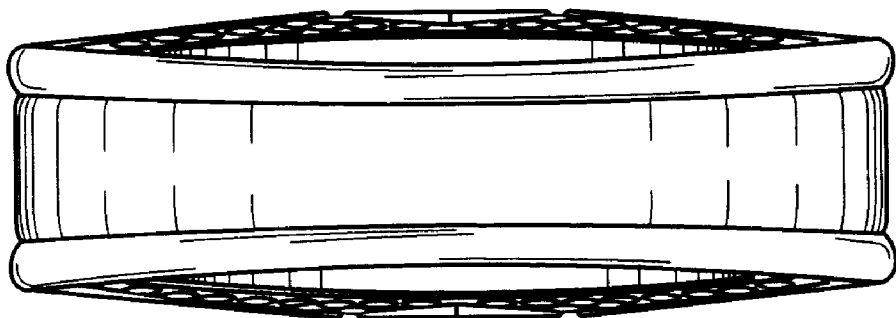
