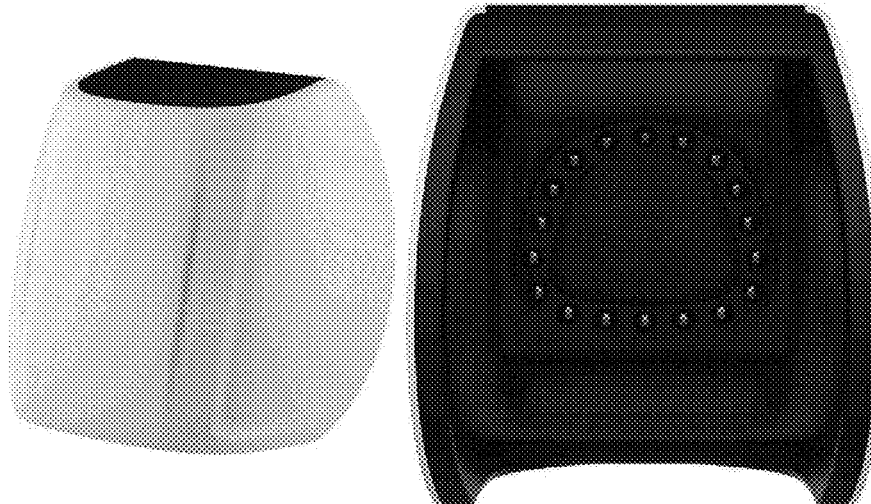

DESCRIPTION

FIG. 1 is a perspective view of a knee brace massager; FIG. 2 is a side view thereof; FIG. 3 is a side view opposite that of FIG. 2 thereof; FIG. 4 is a top view thereof; FIG. 5 is a bottom view thereof; FIG. 6 is a back view thereof; and, FIG. 7 is a front view thereof. The drawings and descriptions represent the left side embodiment. The claim is also for a mirror image right side embodiment.
