DESCRIPTION

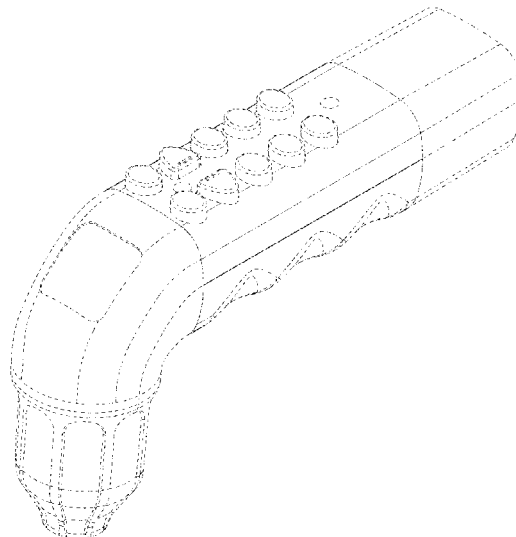
FIG. 1 is top front perspective view of a bar gun according to the design;

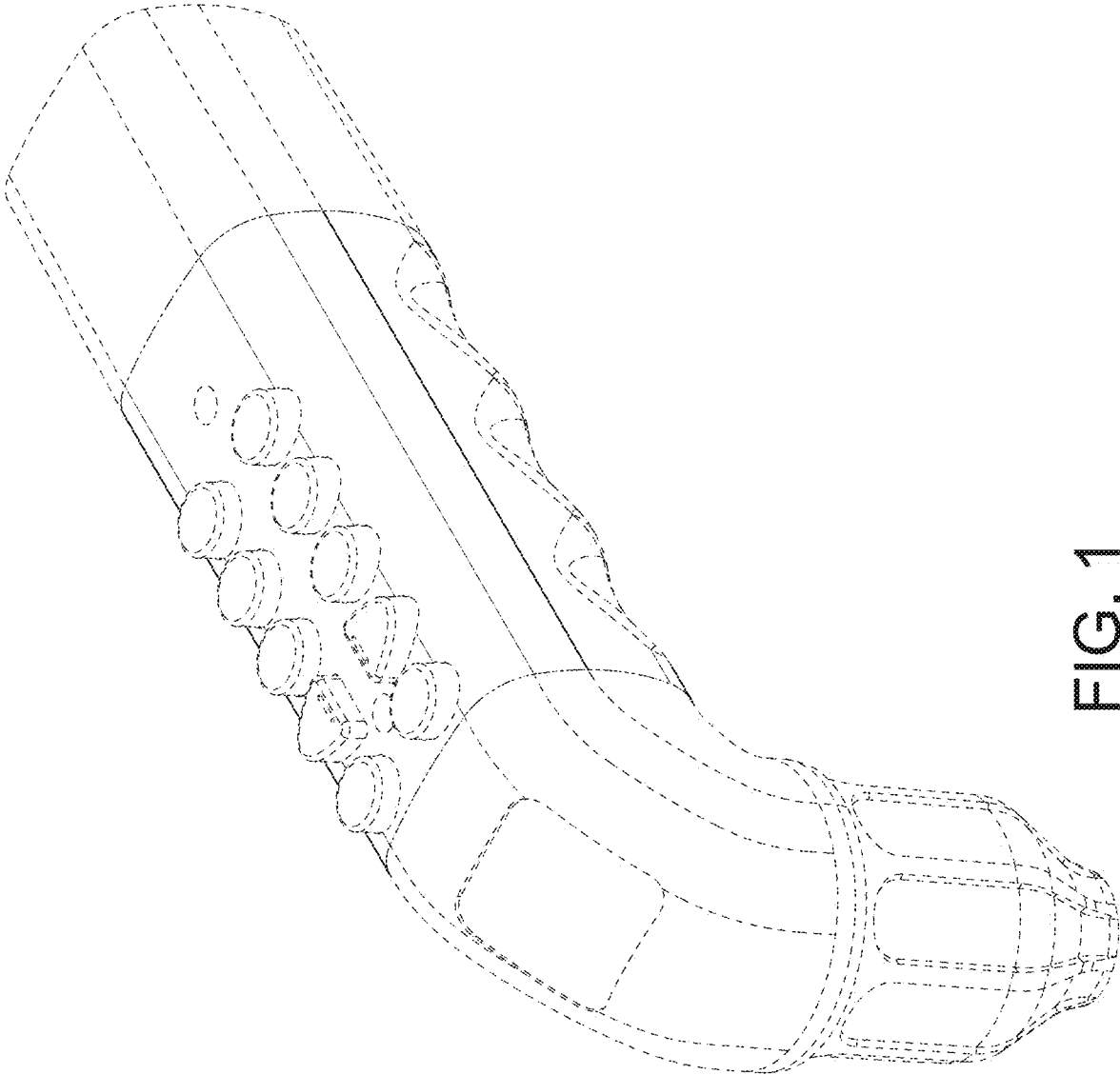

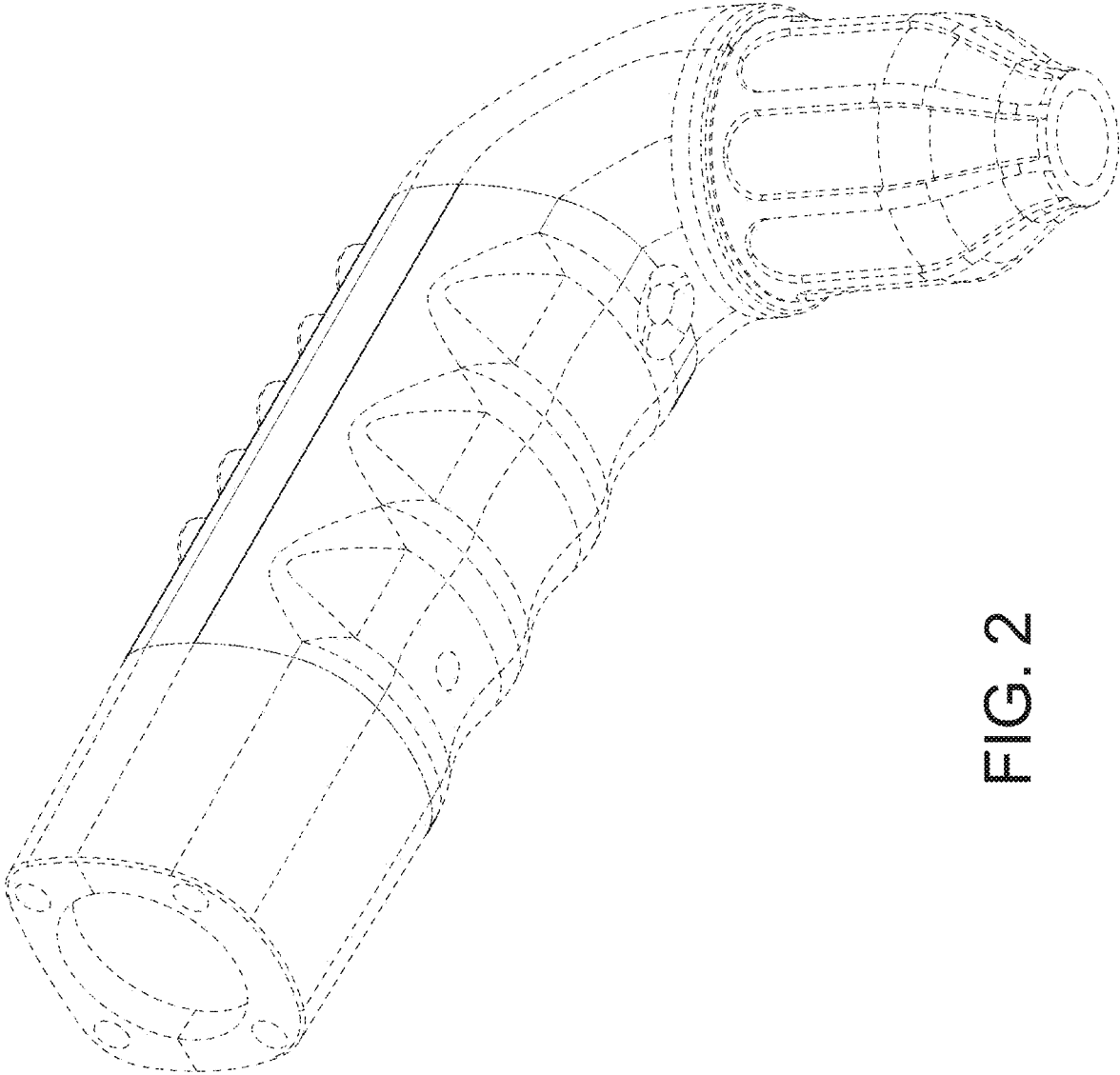

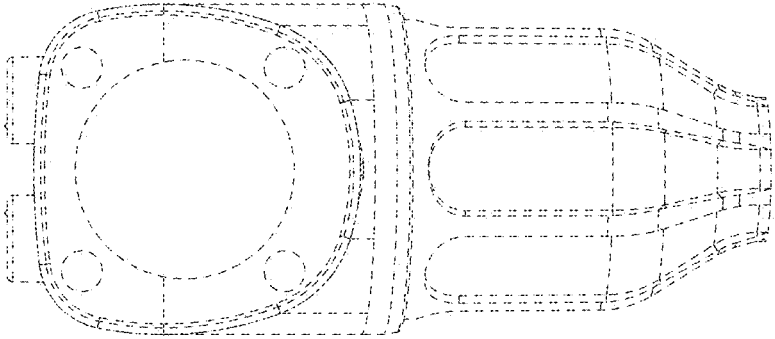

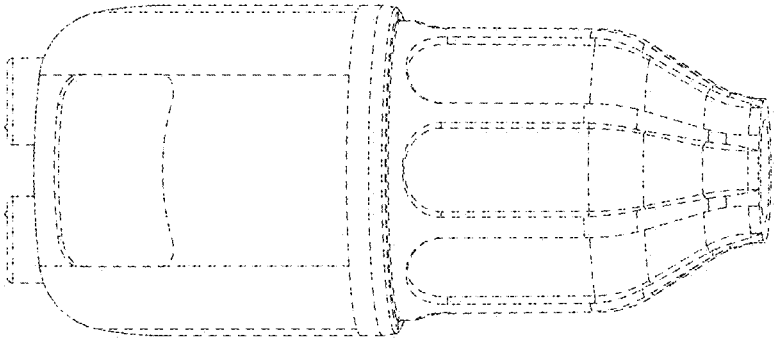

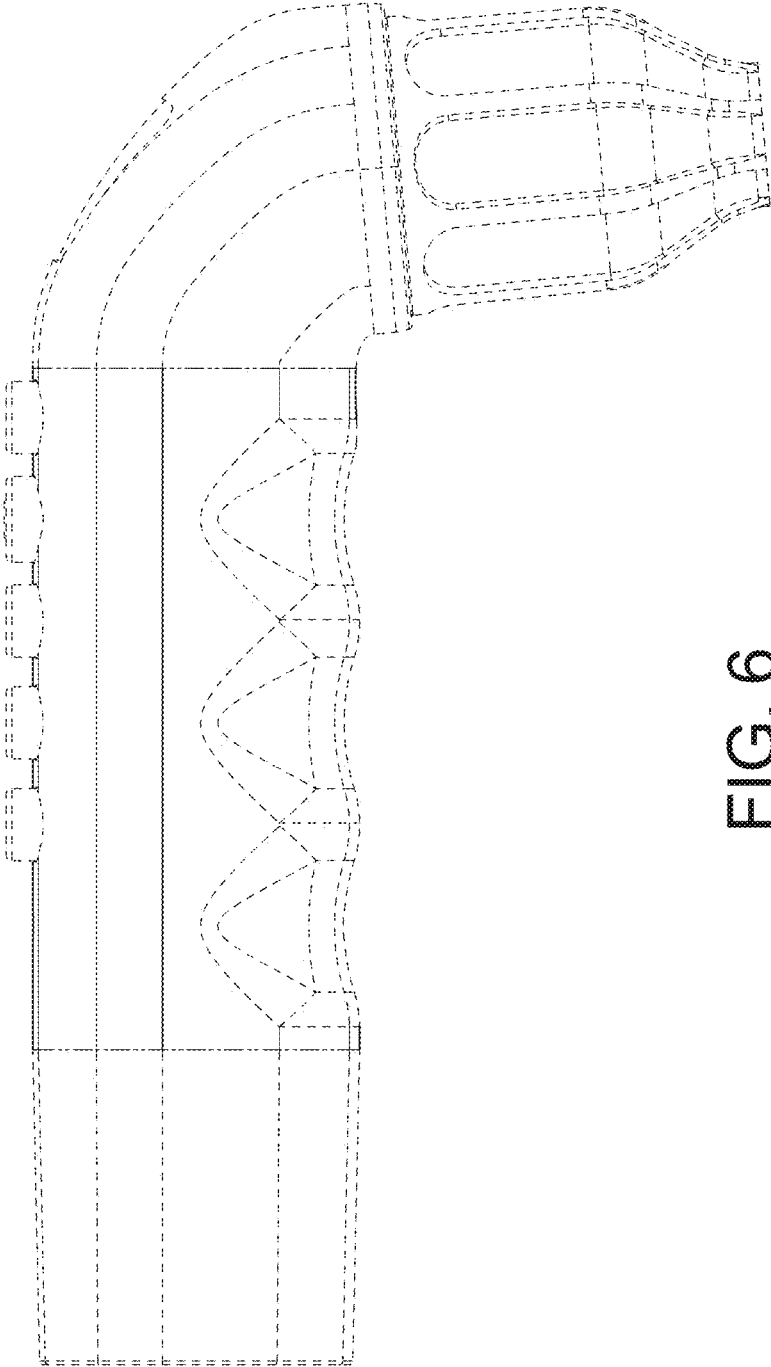

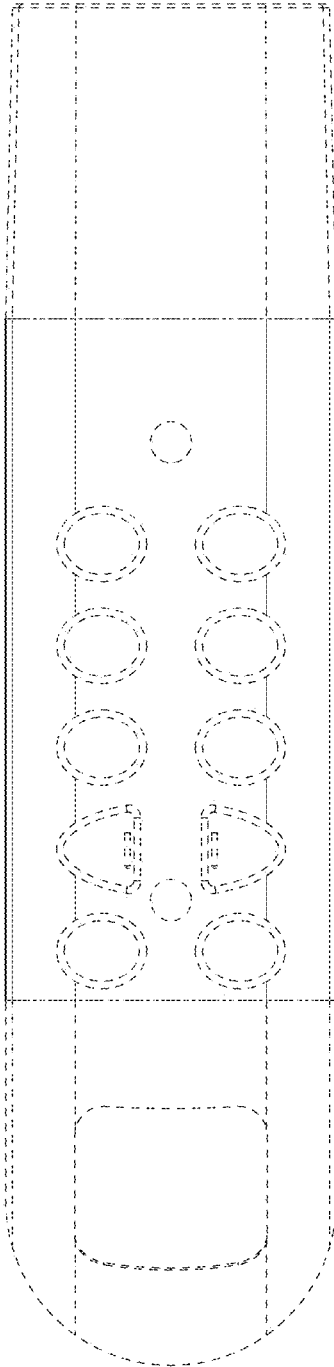

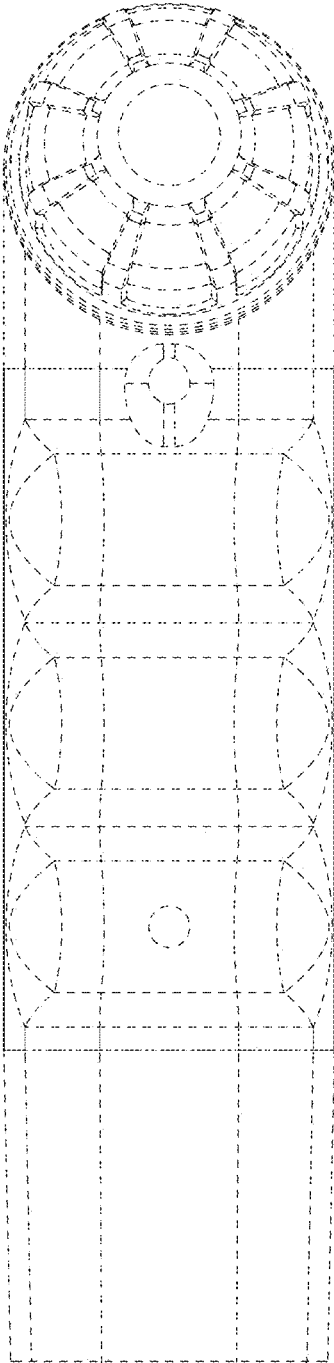
