FIG. 5 is a rear view of a vehicle visor attachment in an alternative position of use,

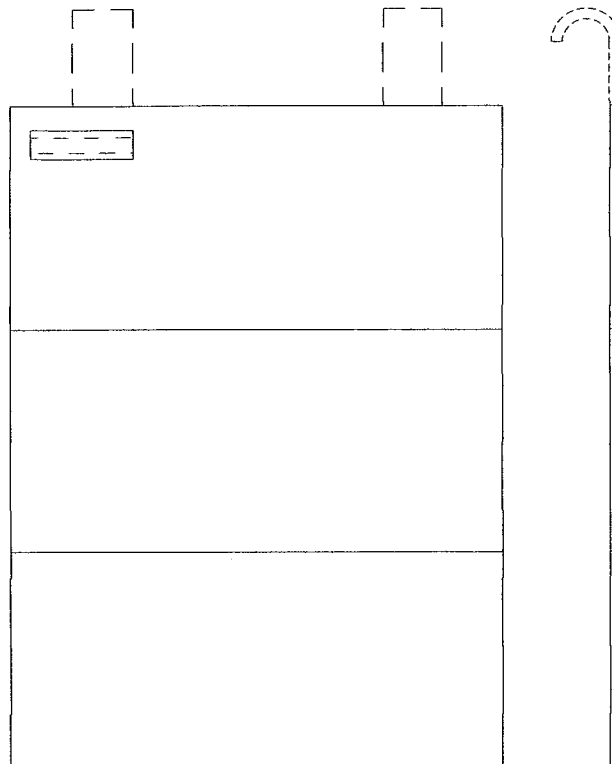
FIG. 6 is a side view of a vehicle visor attachment in an alternative position of use,

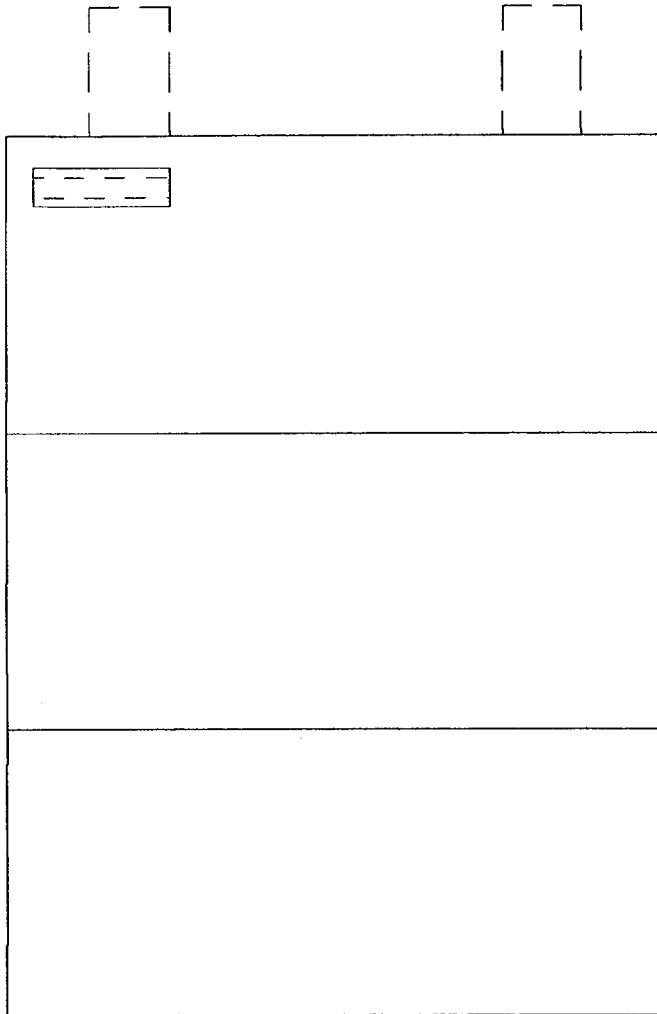

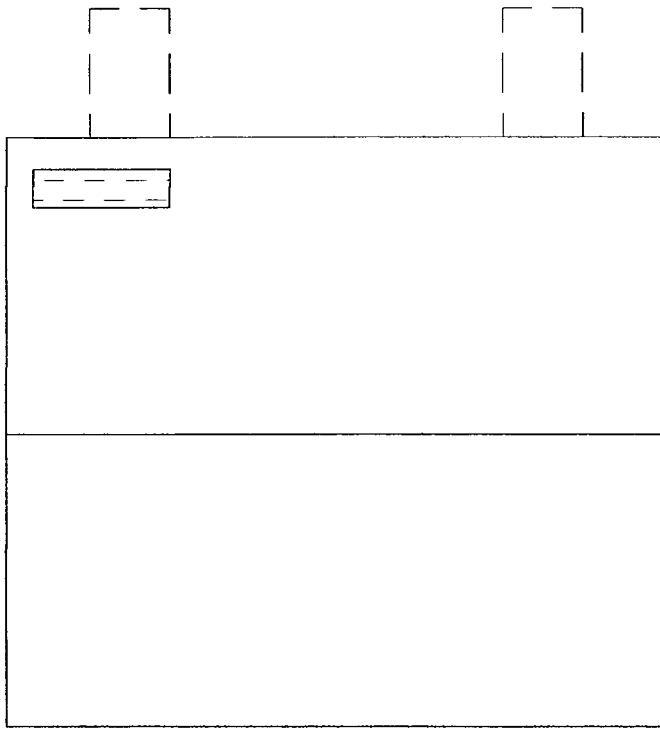

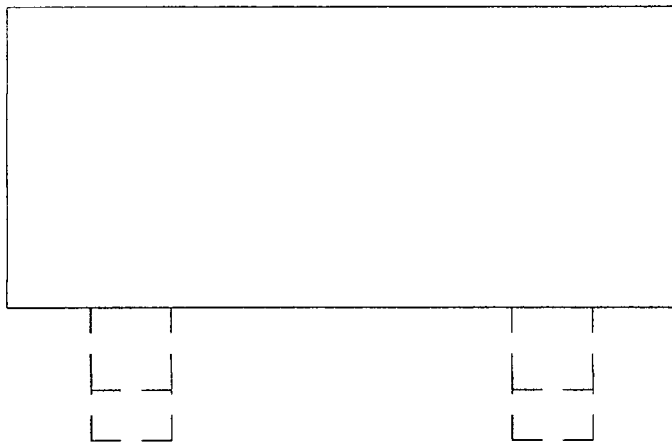

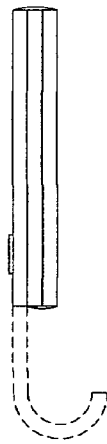

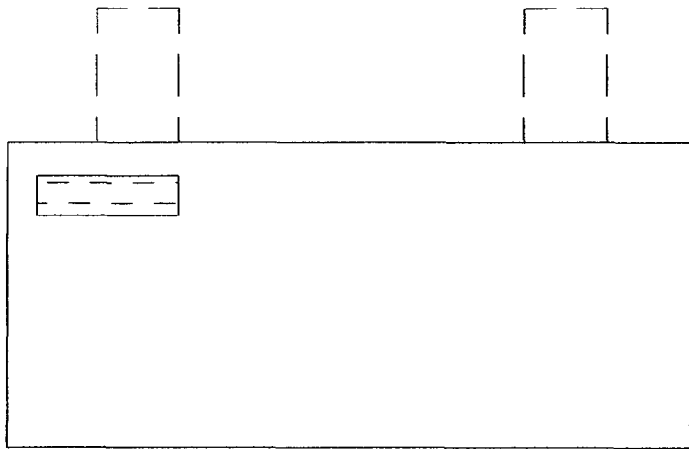

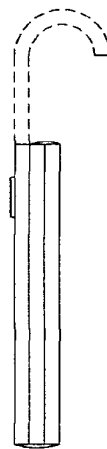
