FIG. 21 is a top view thereof;

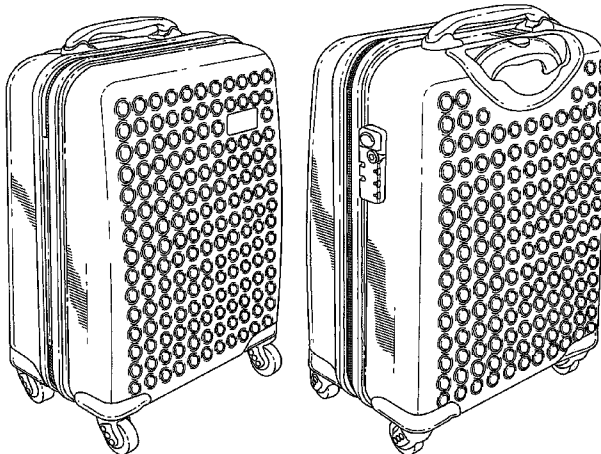

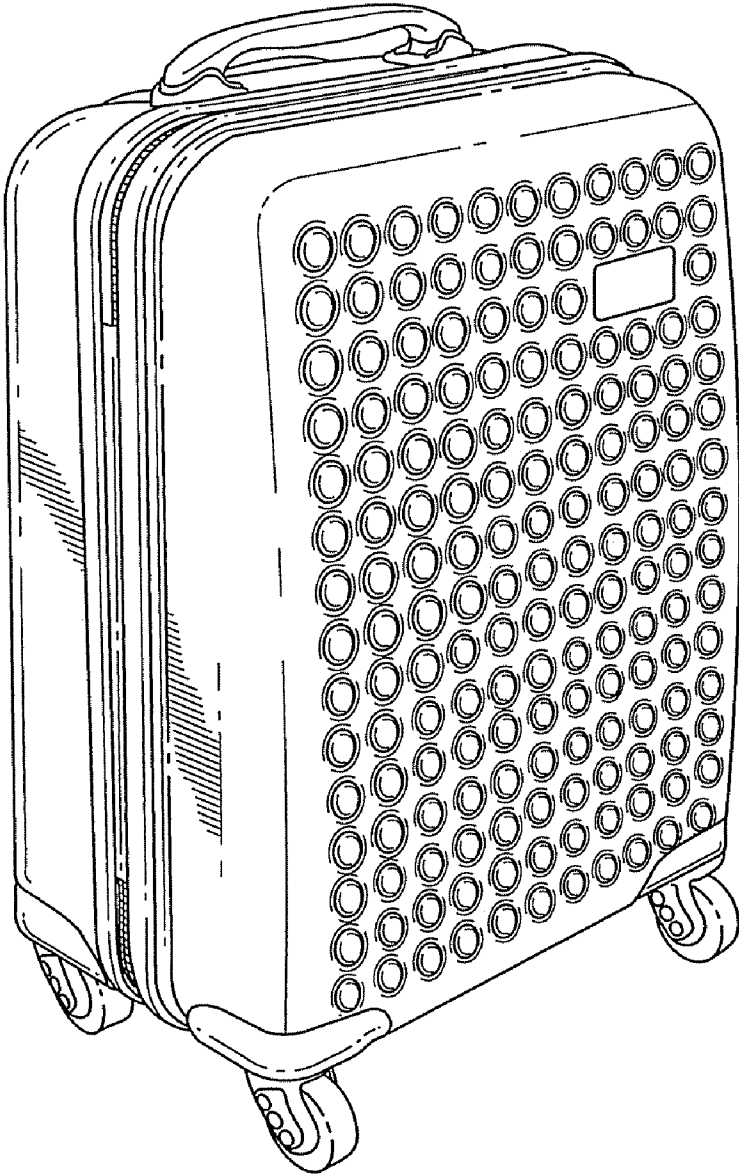

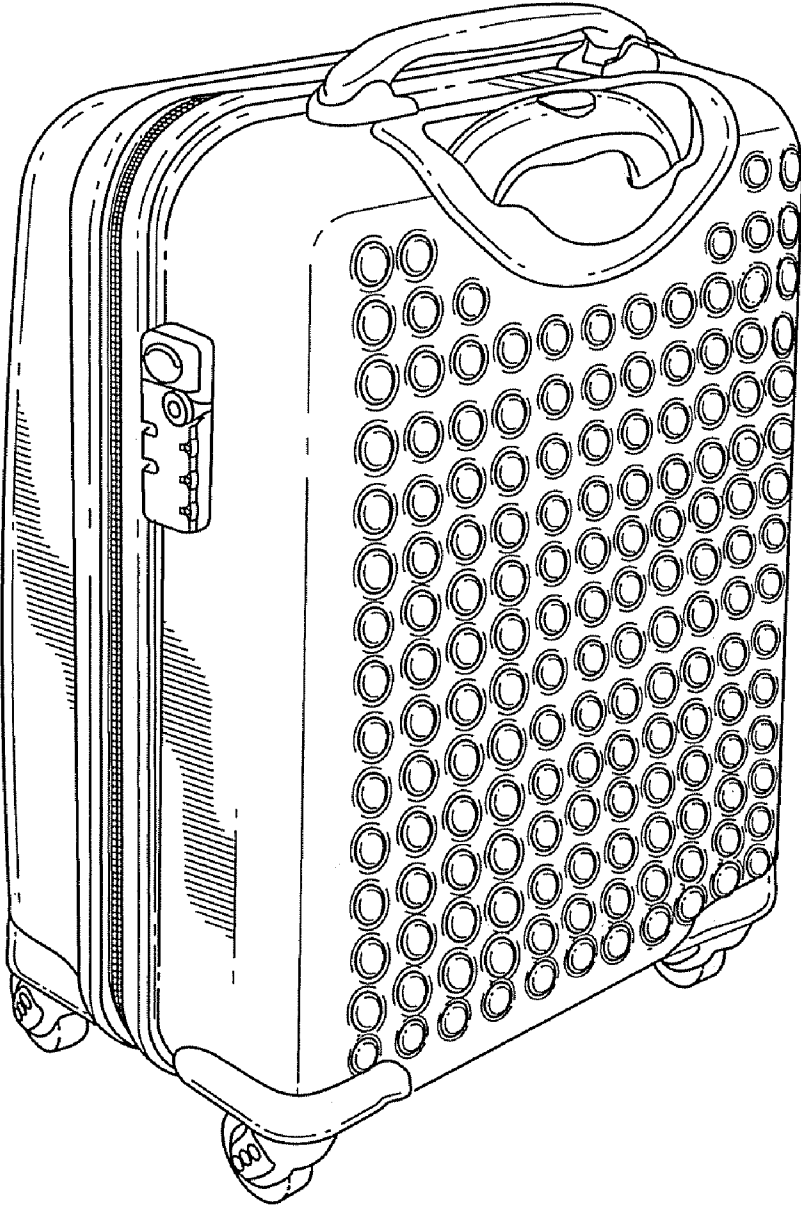

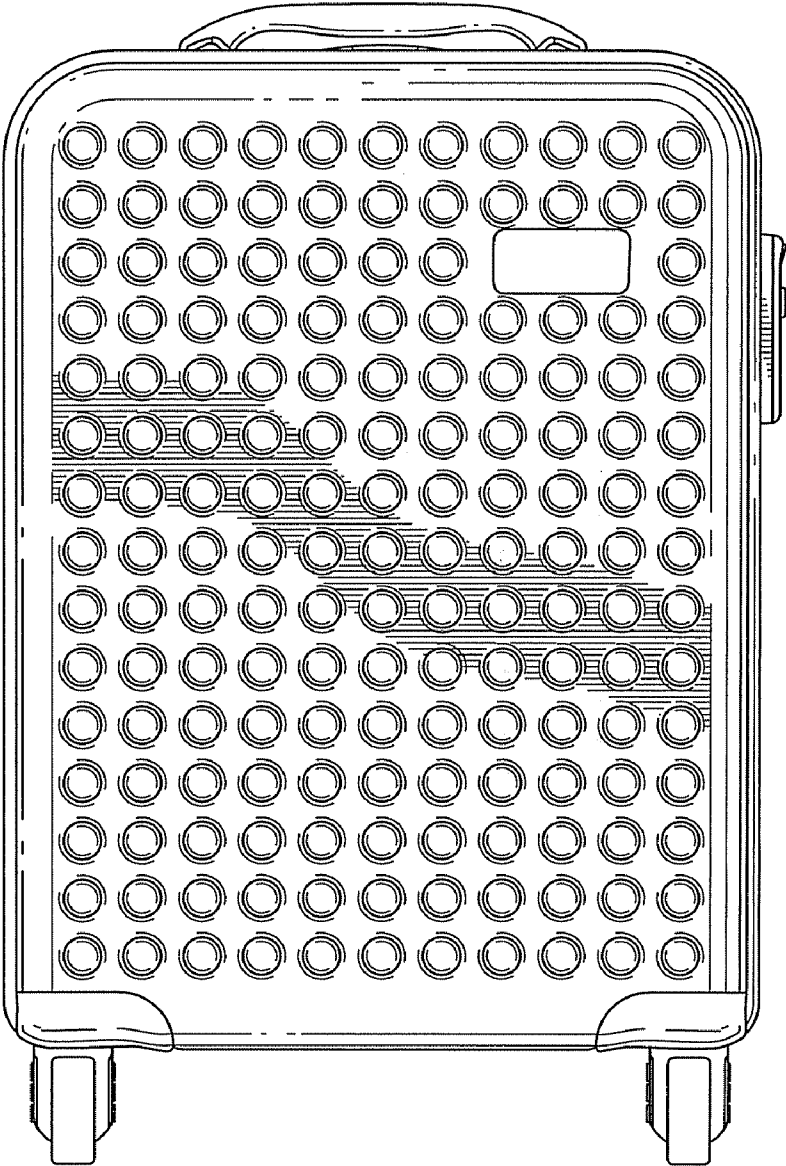

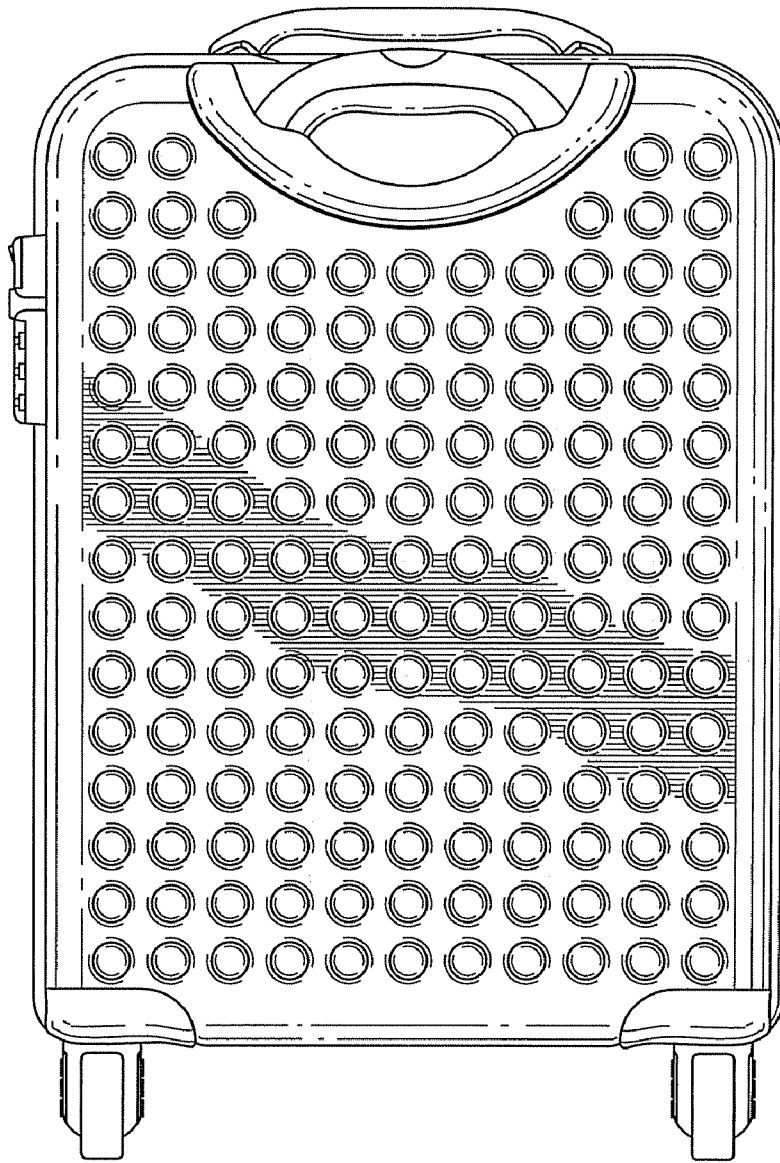

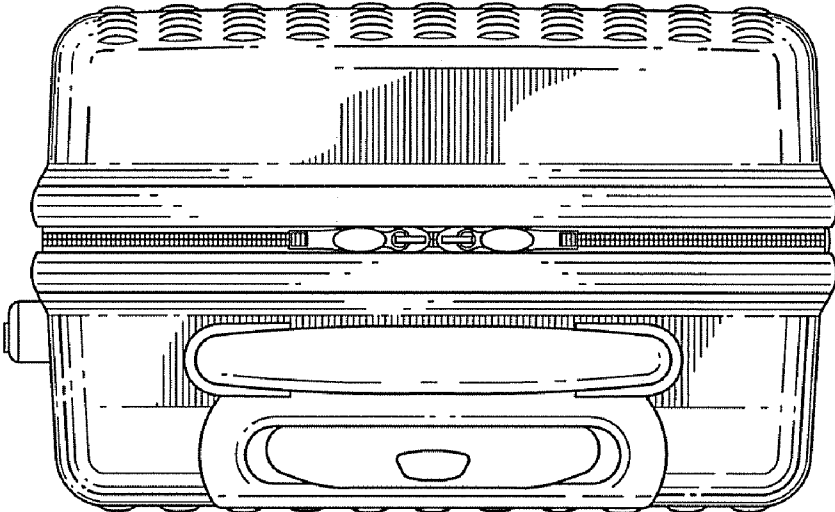

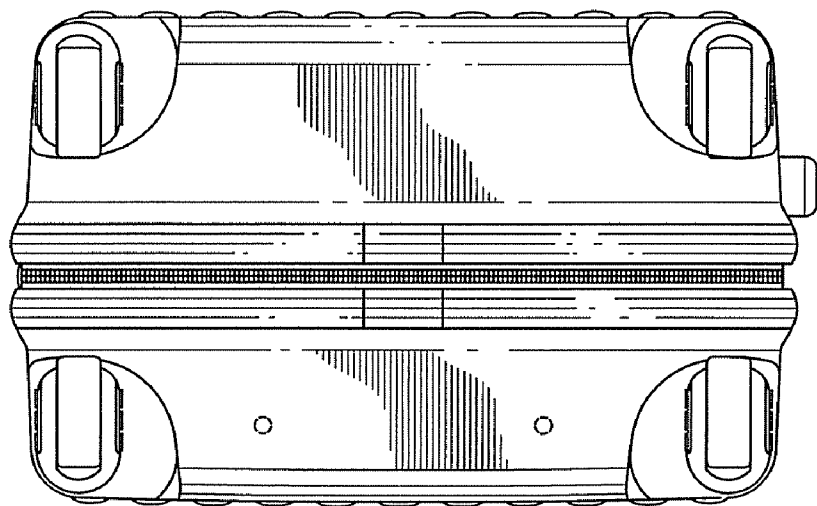

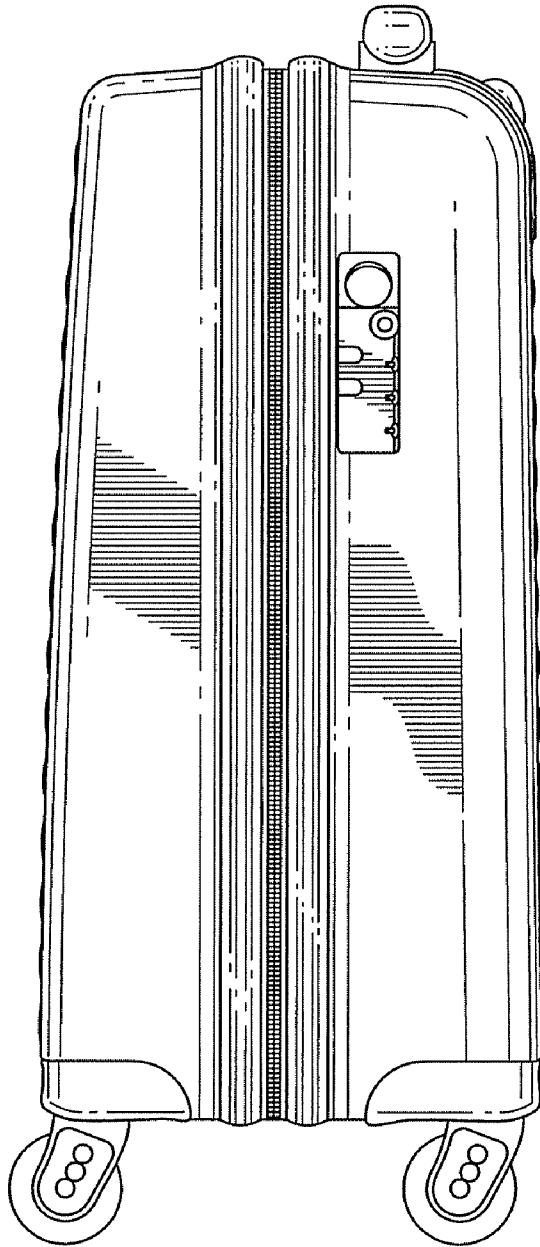

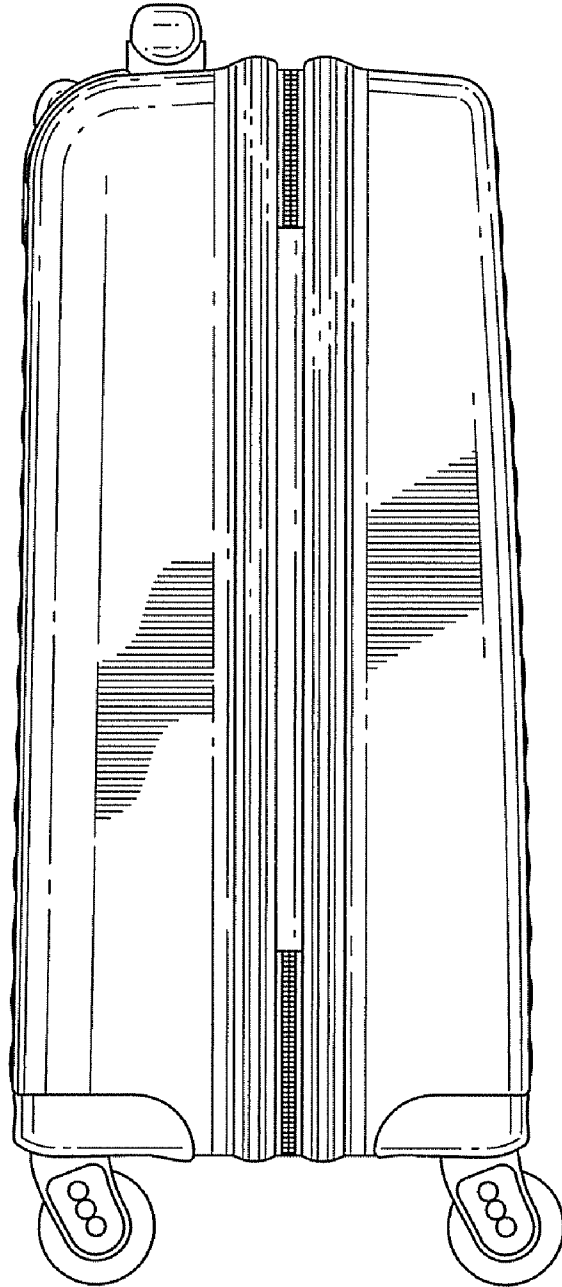

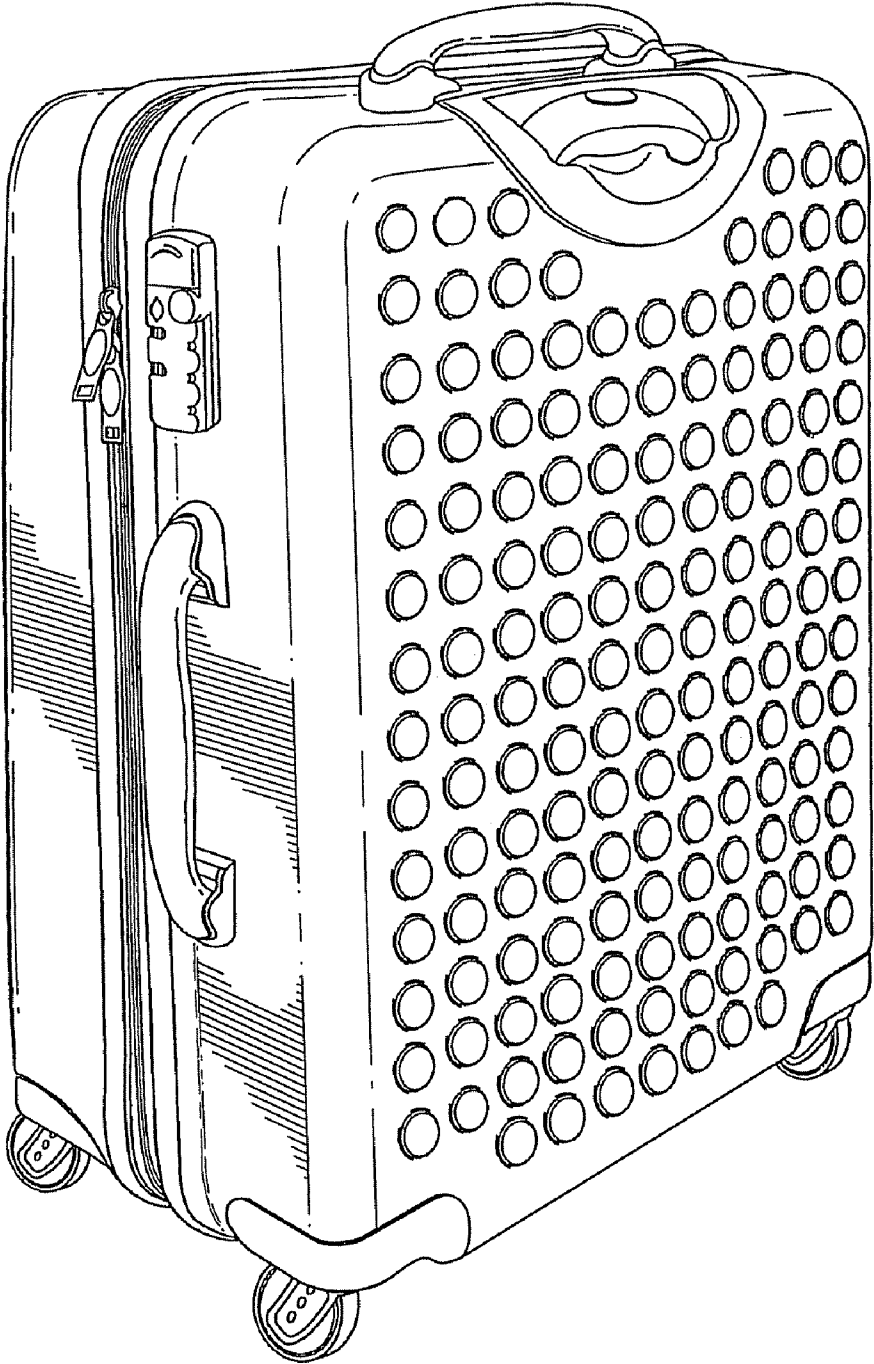

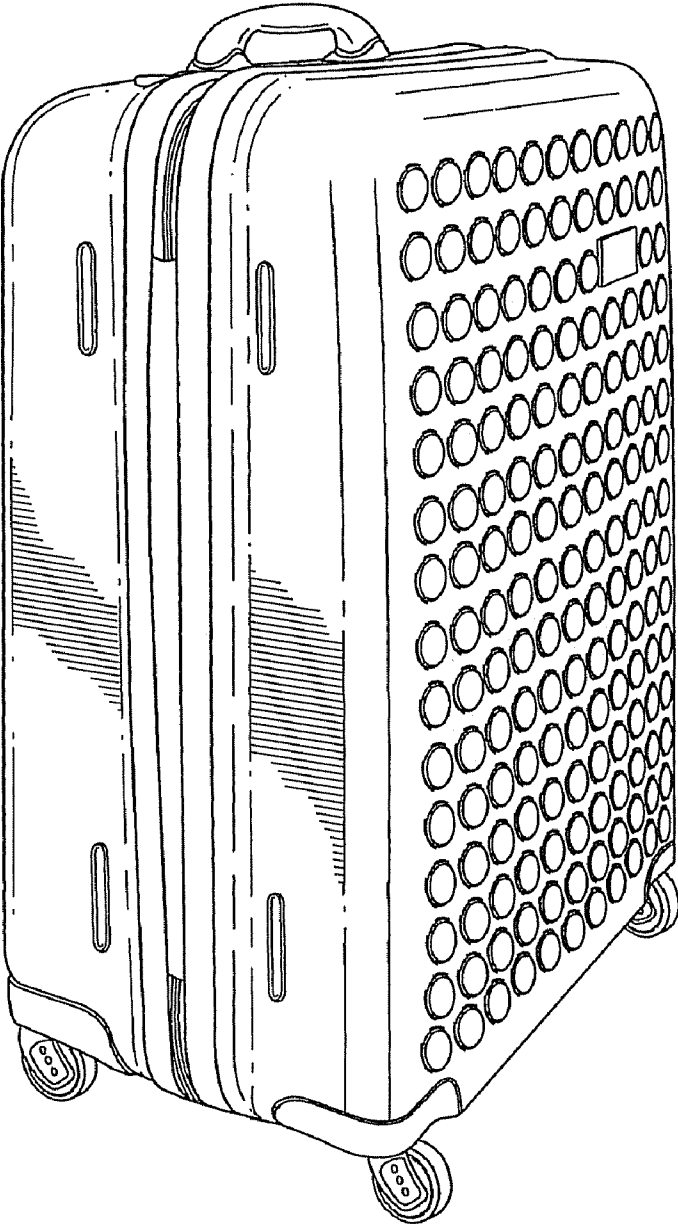

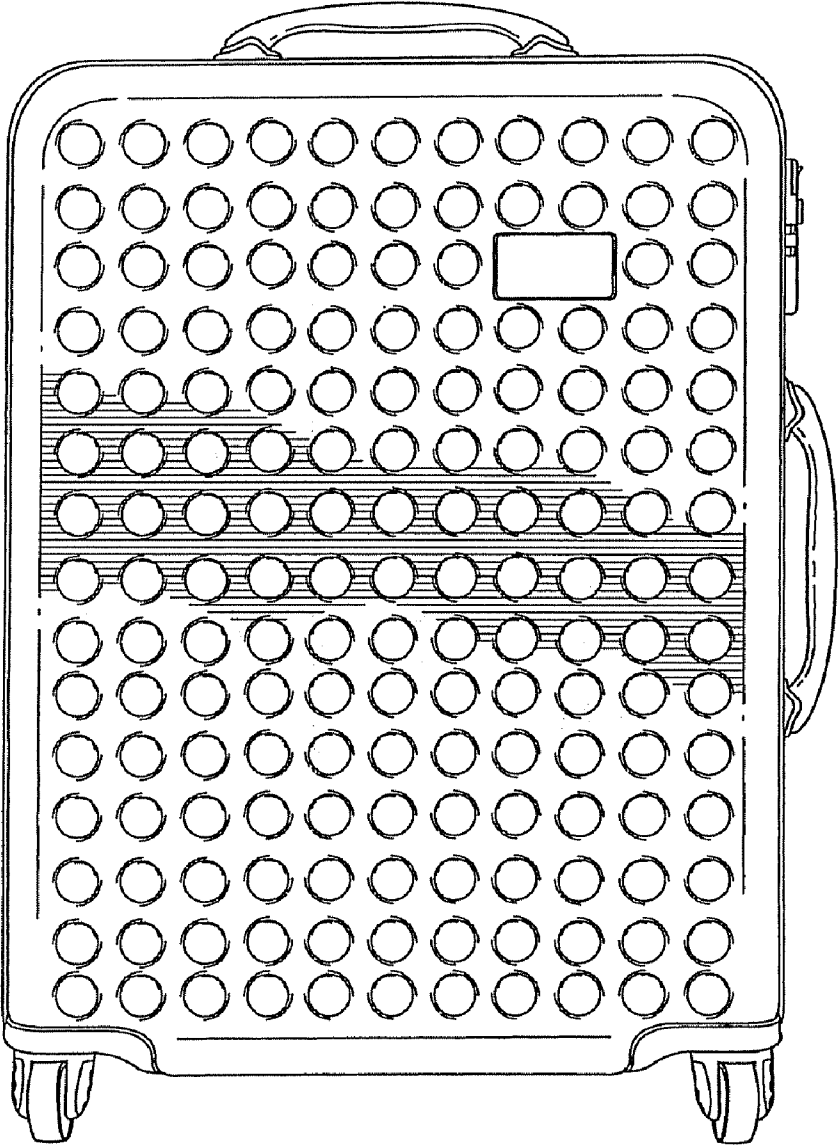

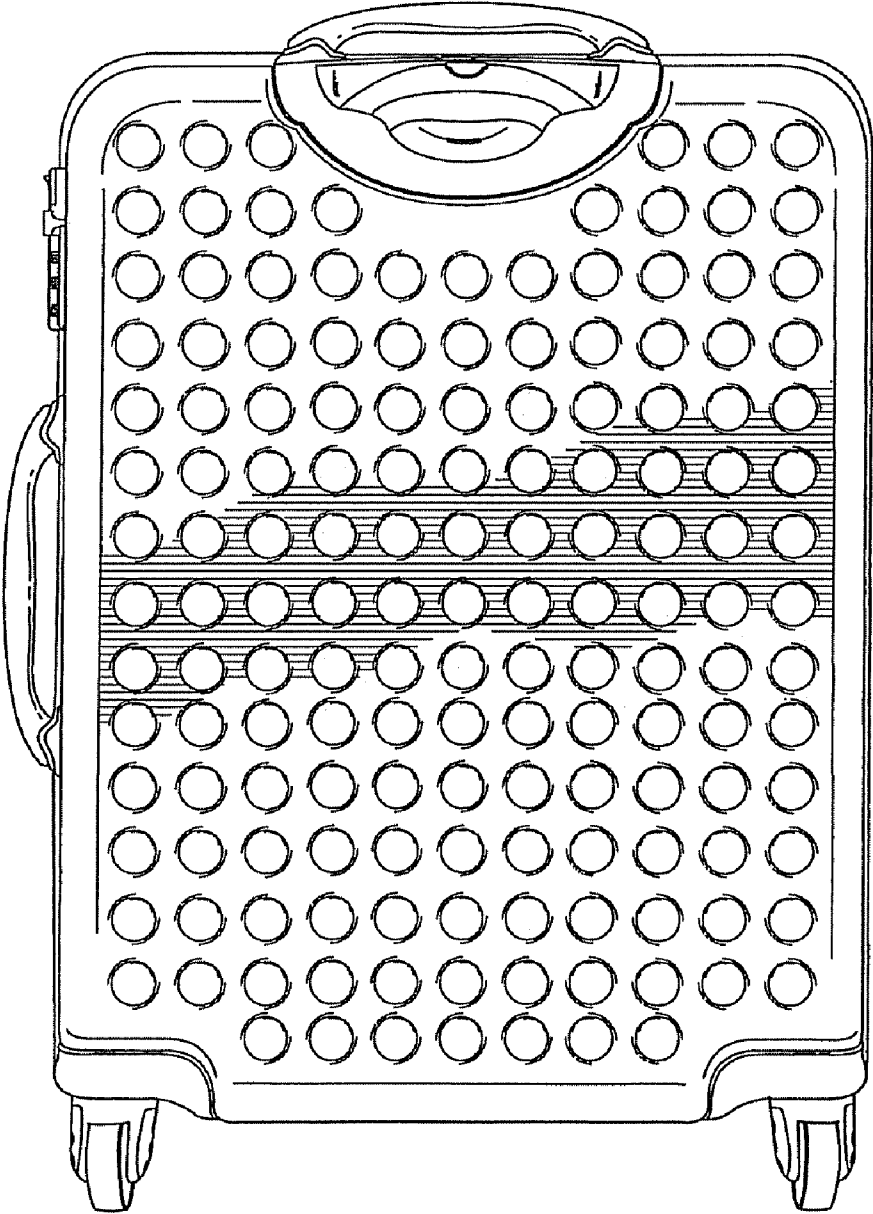

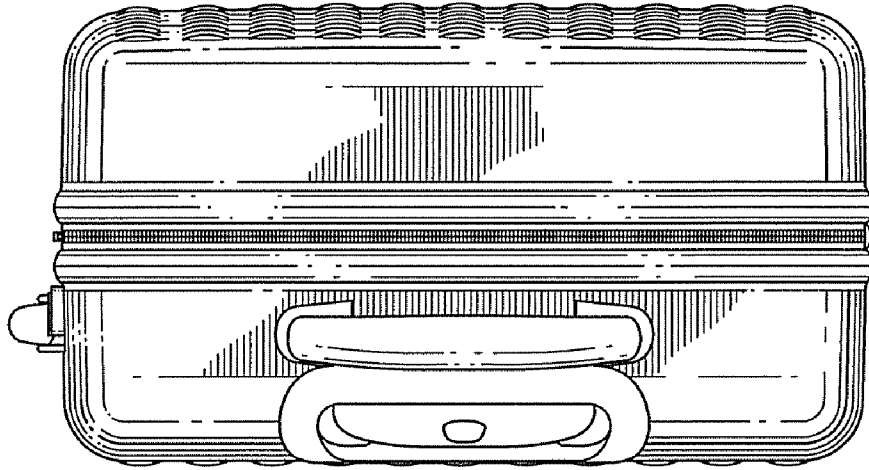

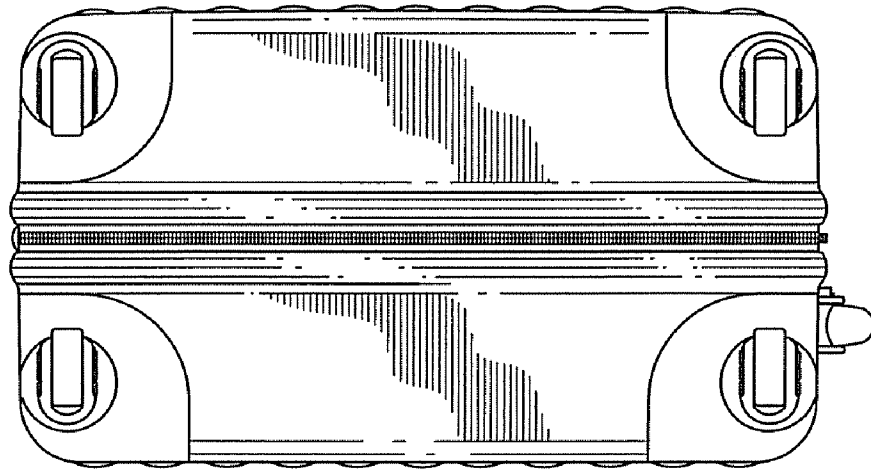

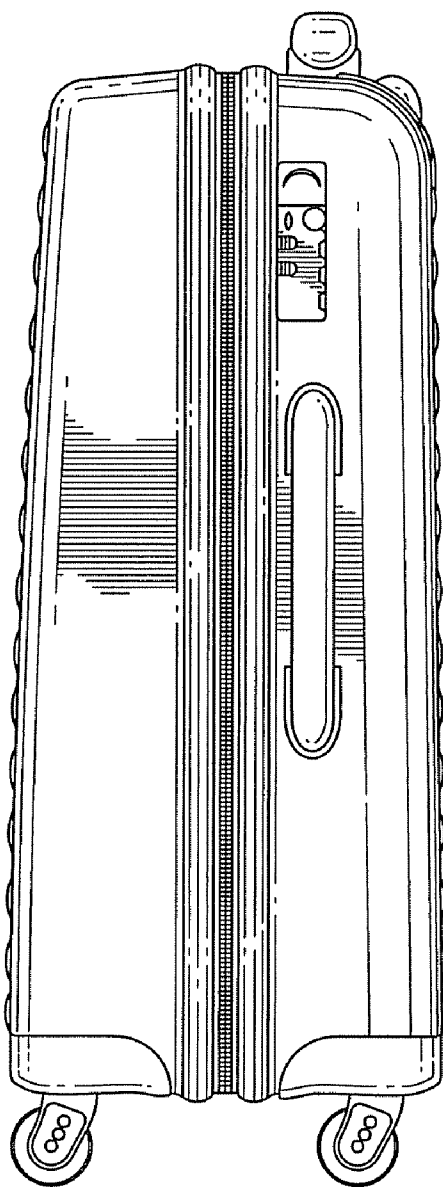

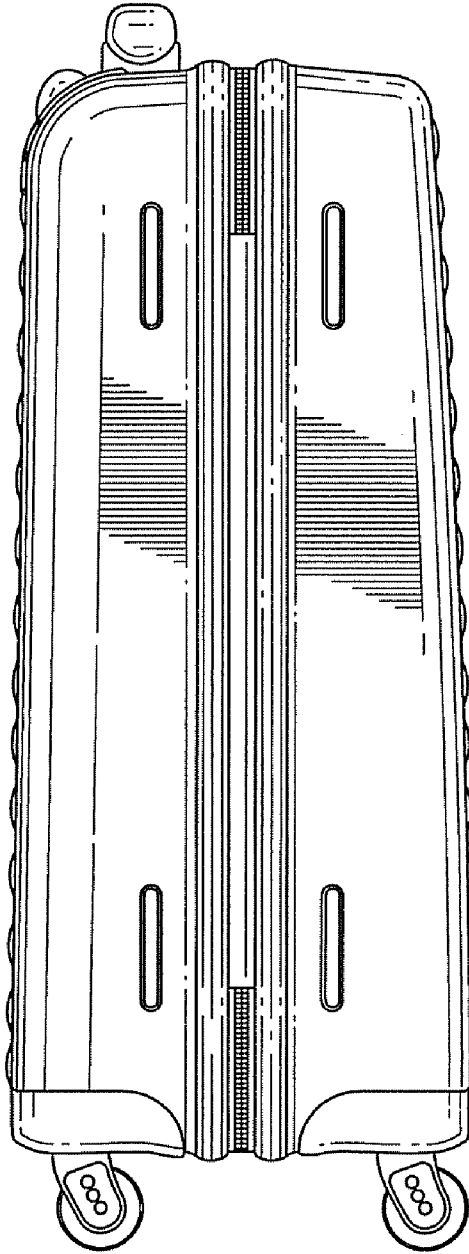

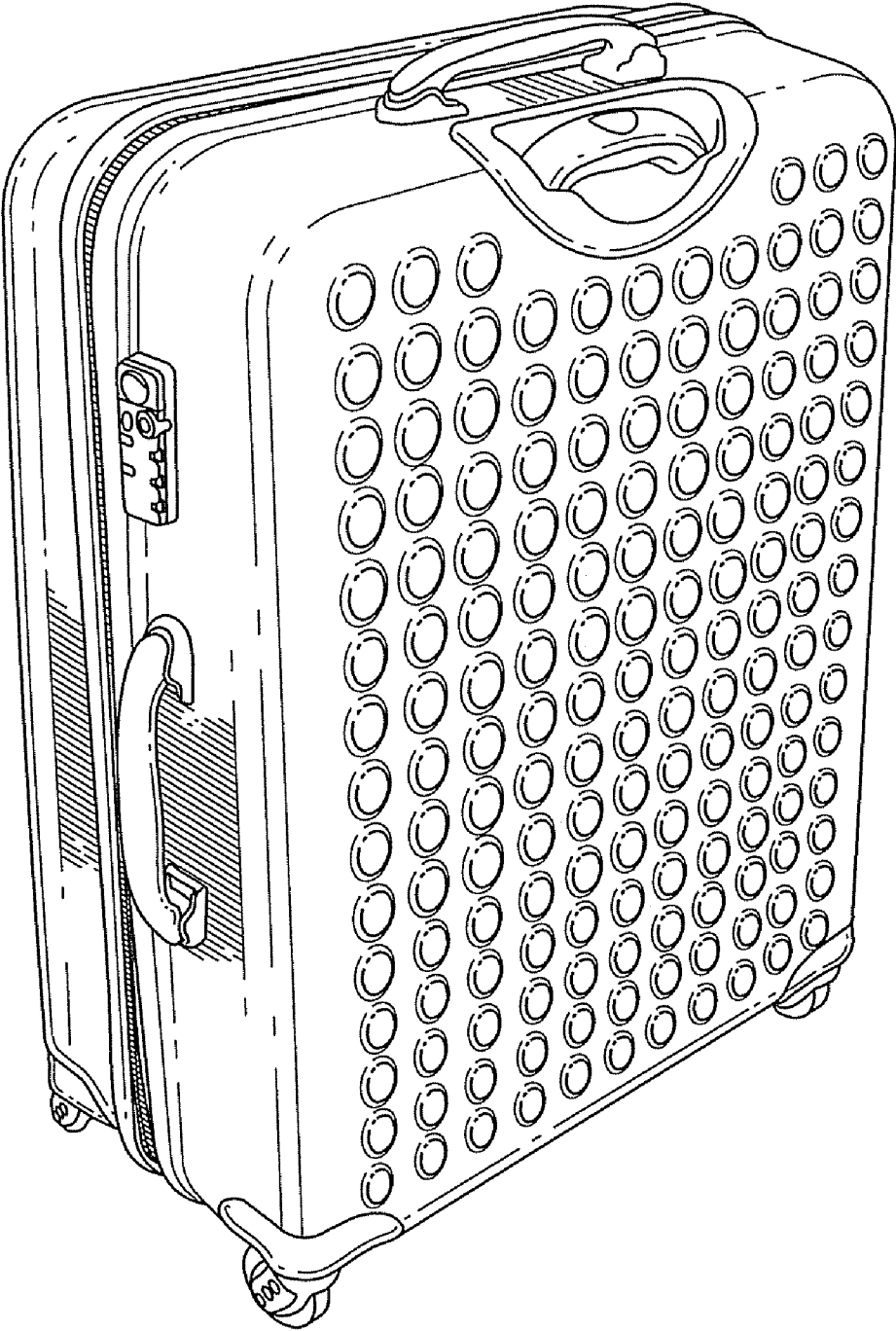

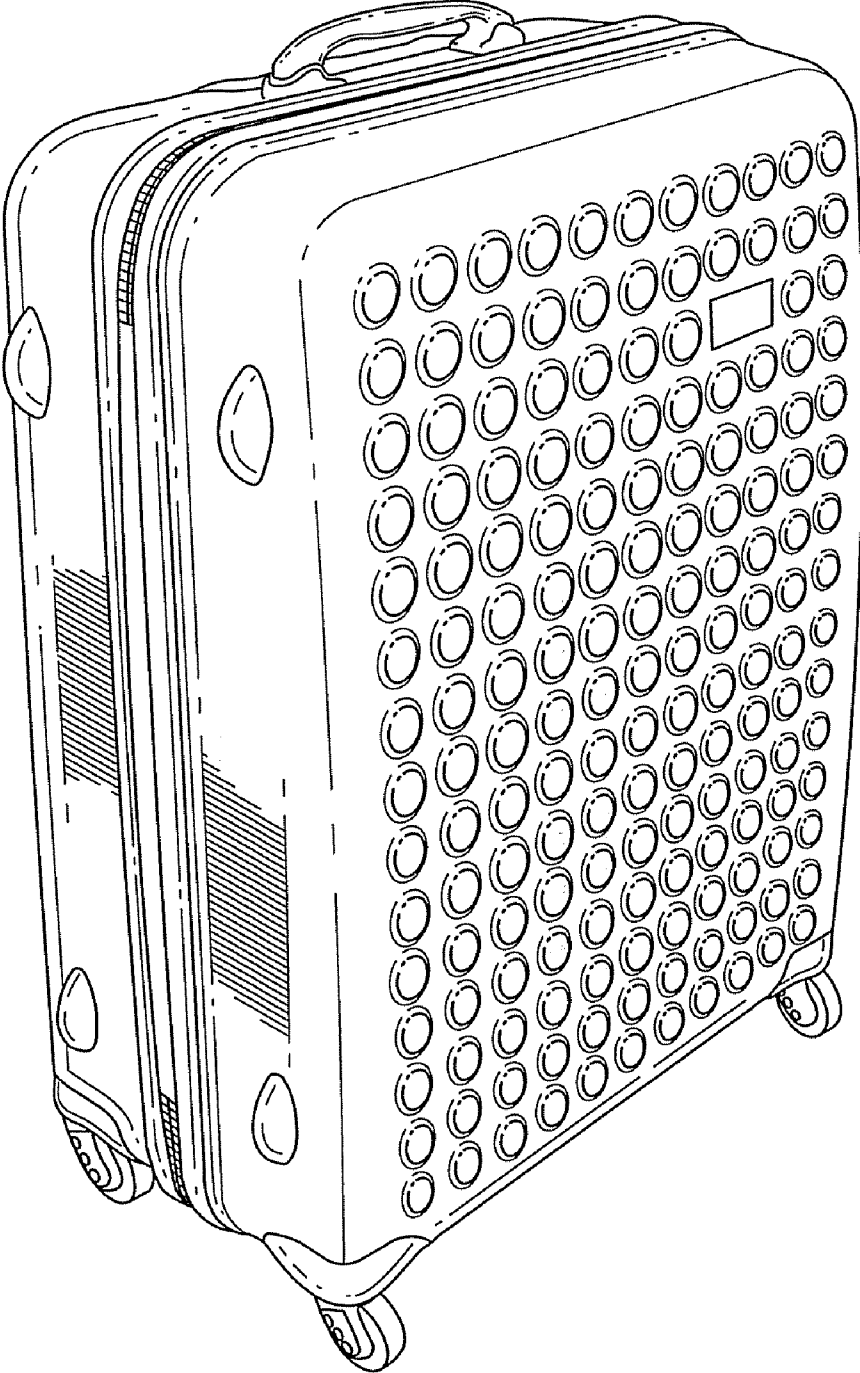

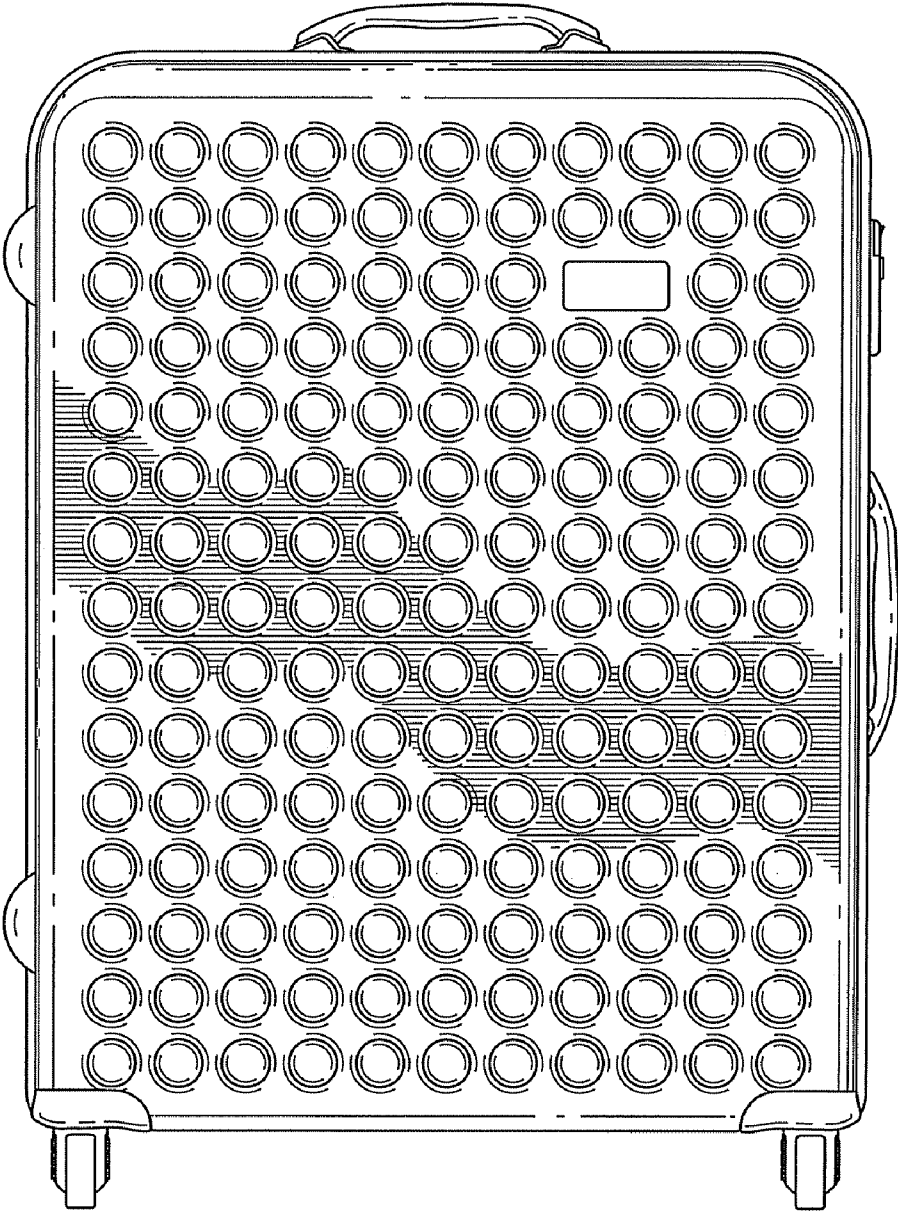

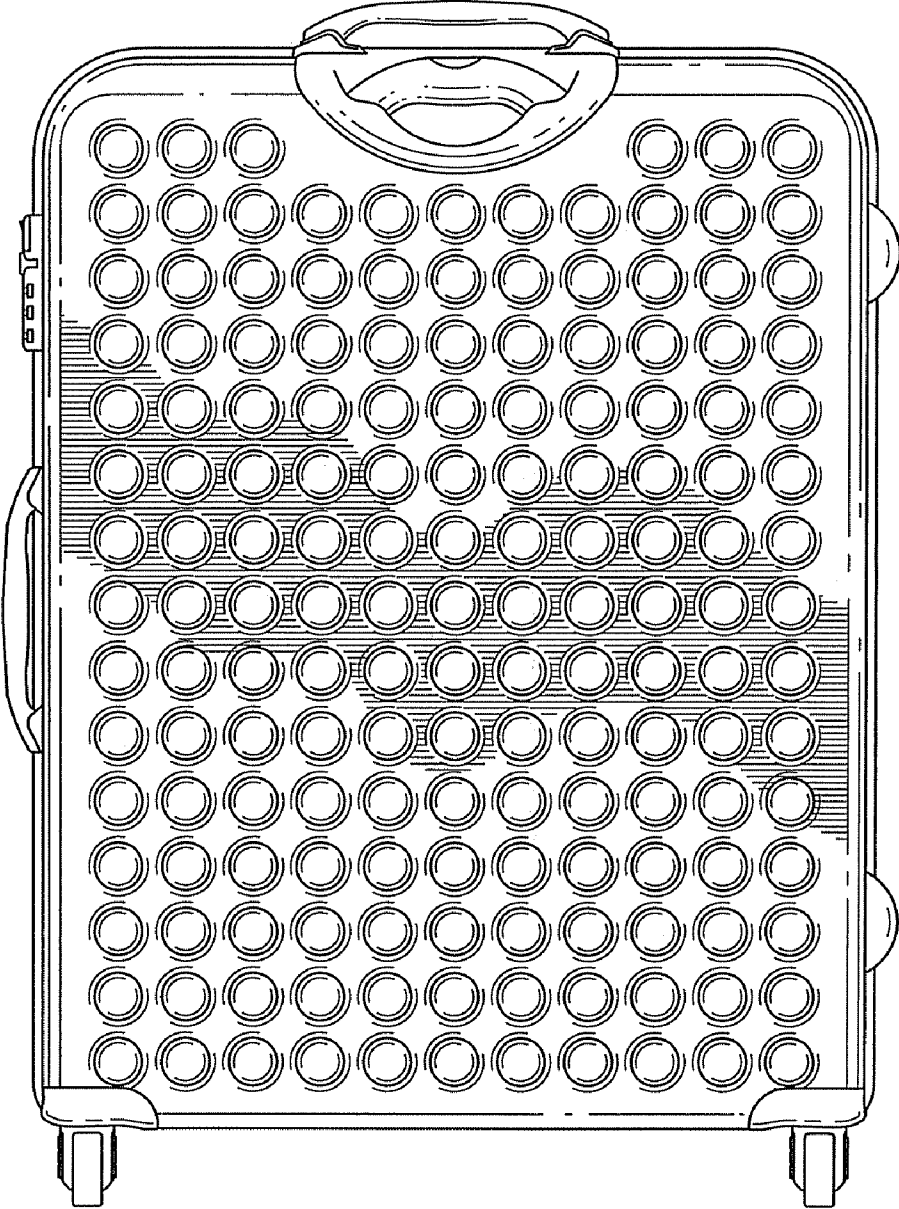

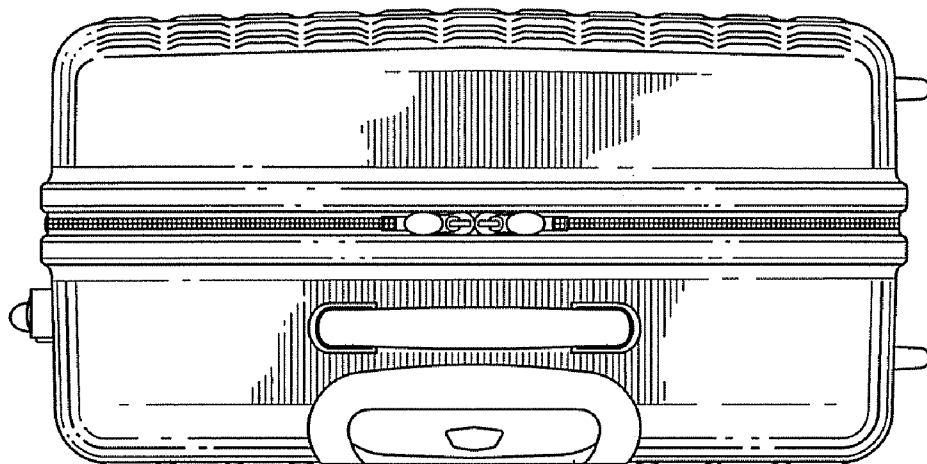

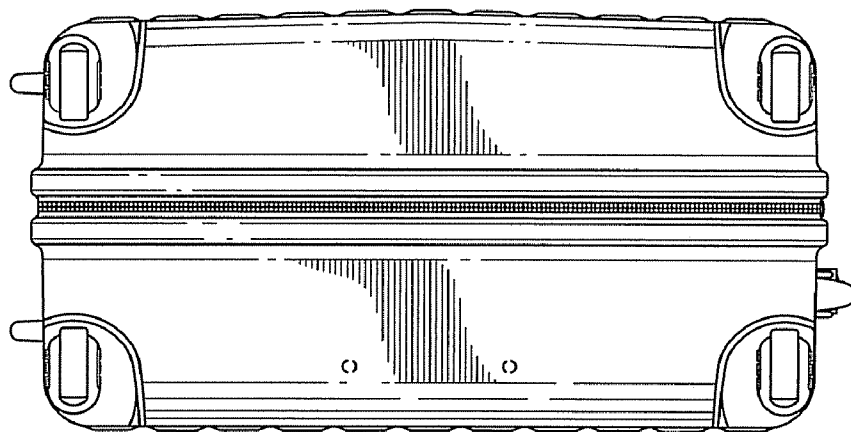

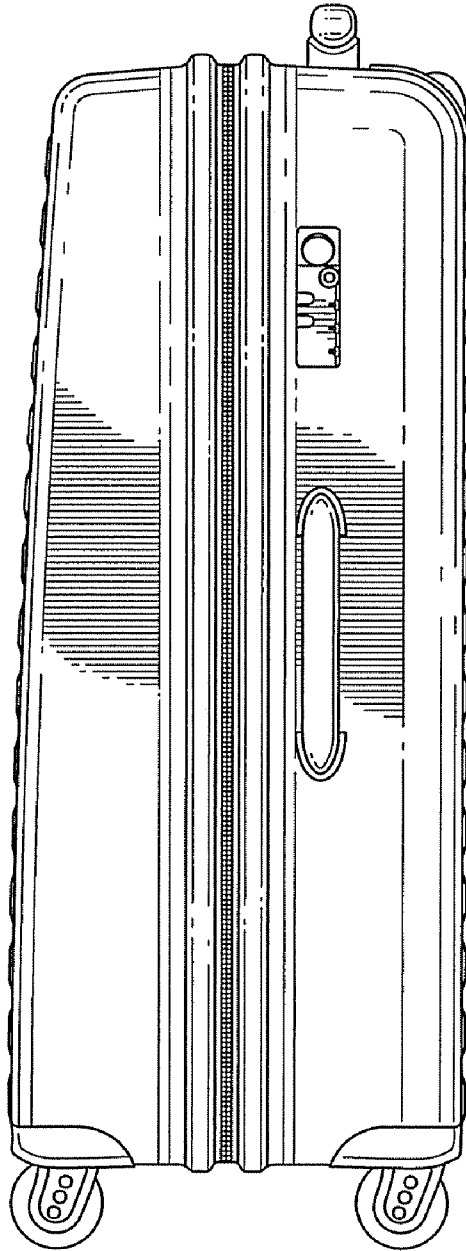

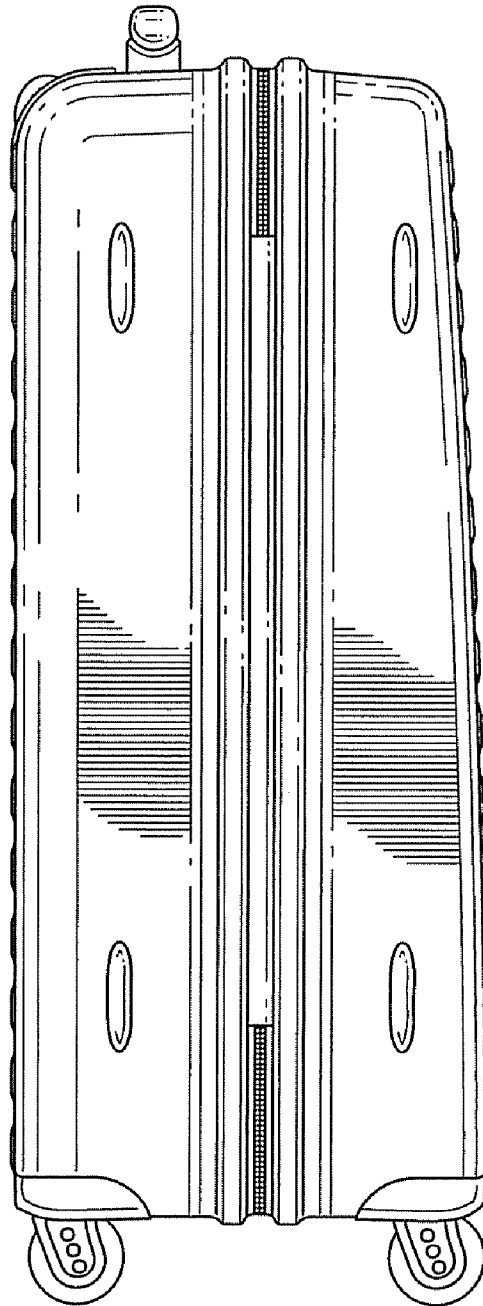
