(57) **CLAIM**

The ornamental design for a stackable clothing divider having wide pulling tab, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the stackable clothing divider having wide pulling tab showing our new design;

FIG. 2 is right side view thereof;

FIG. 3 is a bottom view thereof;

FIG. 4 is a top view thereof; and,

FIG. 5 is a perspective view of the stackable clothing divider having wide pulling tab.

The back view of the stackable clothing divider having wide pulling tab is a mirror image of FIG. 1, and the left side view is a mirror image of FIG. 2.

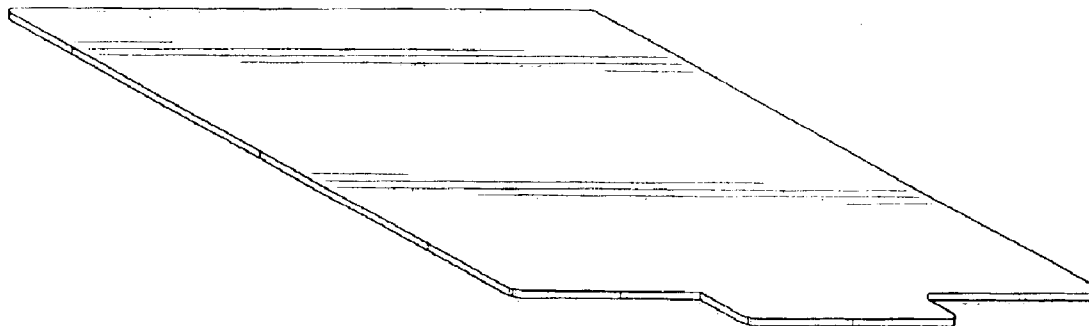

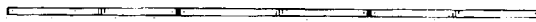

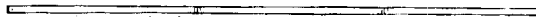

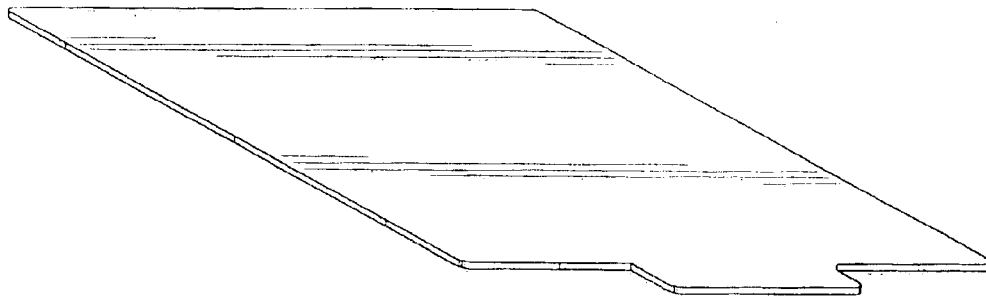
