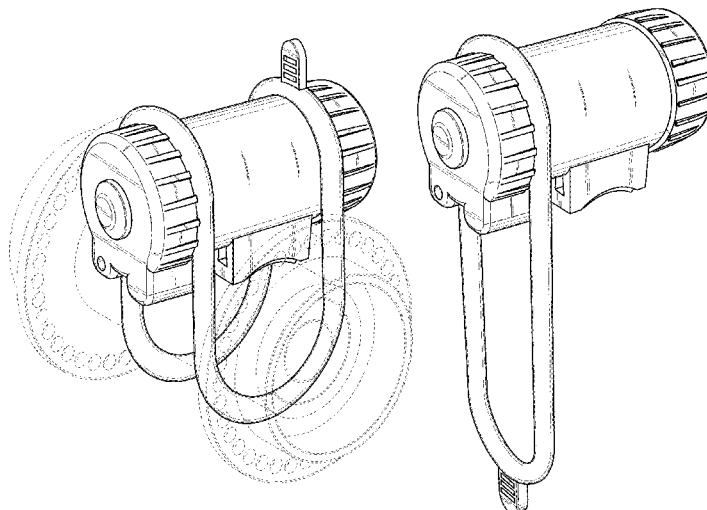
(57) **CLAIM**

The ornamental design for a battery pack, as shown and described.

**DESCRIPTION**

FIG. 1 is a left perspective view of a battery pack in a secured position;  
FIG. 2 is a left side view thereof;  
FIG. 3 is a right side view thereof;  
FIG. 4 is a rear view thereof;  
FIG. 5 is a front view thereof;  
FIG. 6 is a top view thereof; and  
FIG. 7 is a bottom view thereof; and,  
FIG. 8 is a left perspective view of a battery pack in an unsecured position.

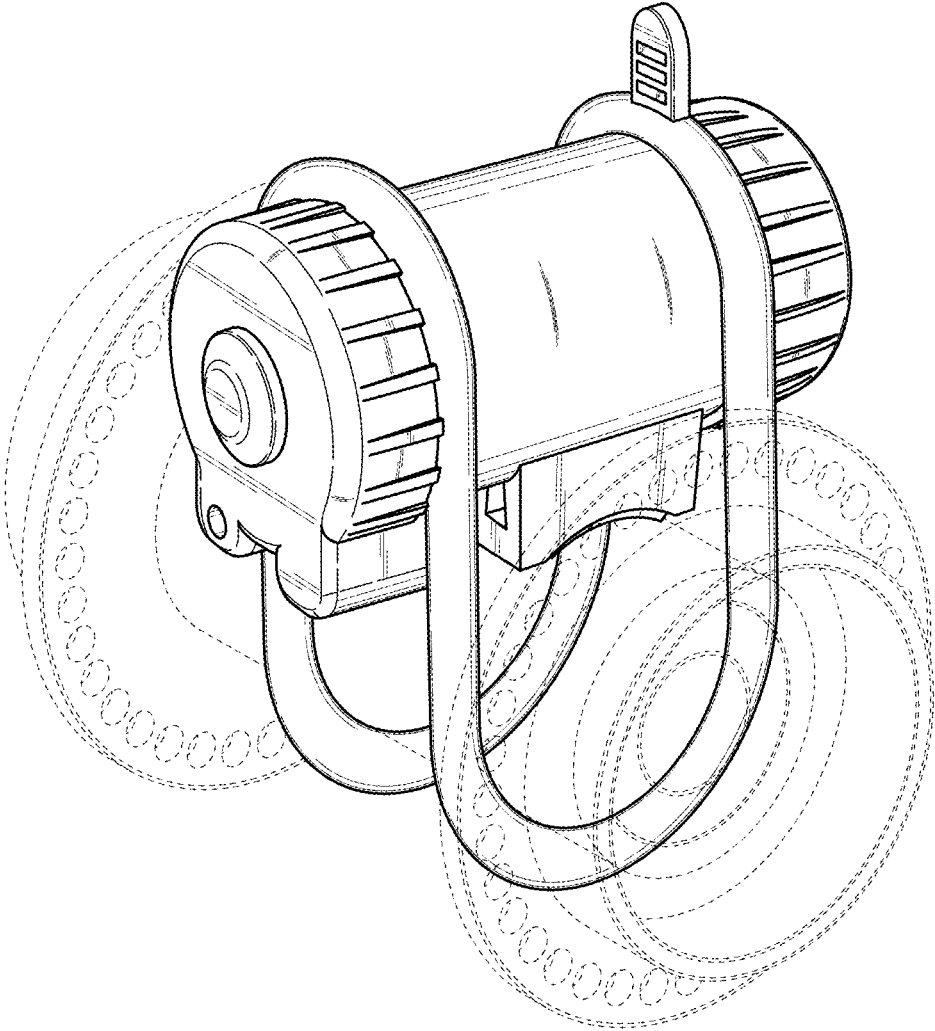

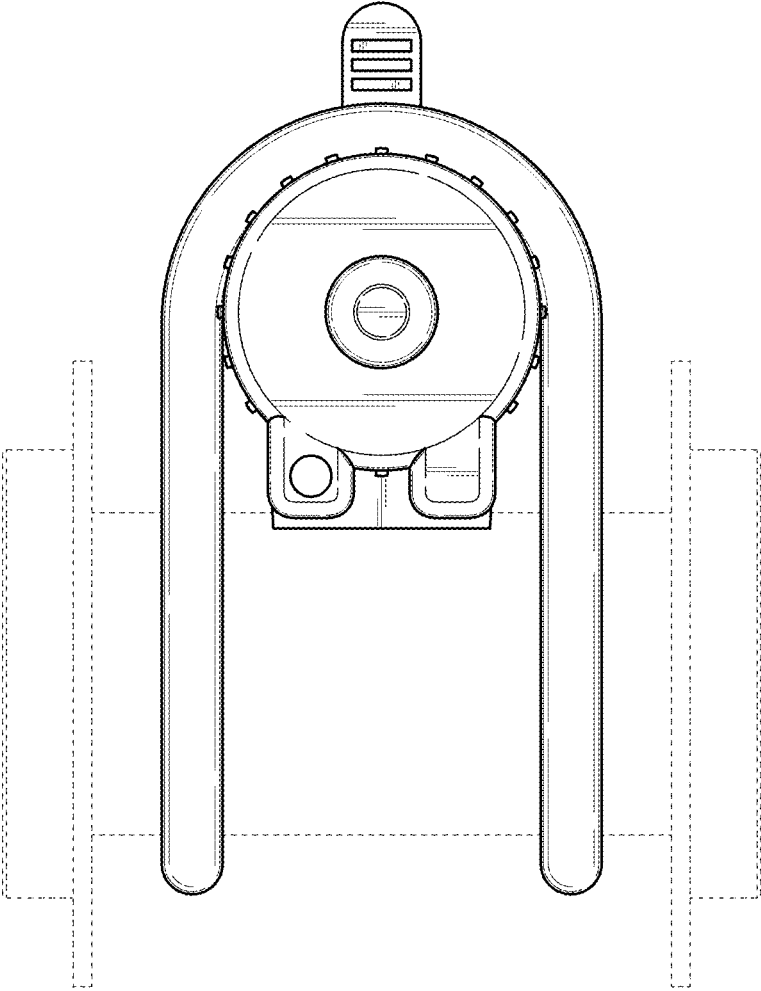

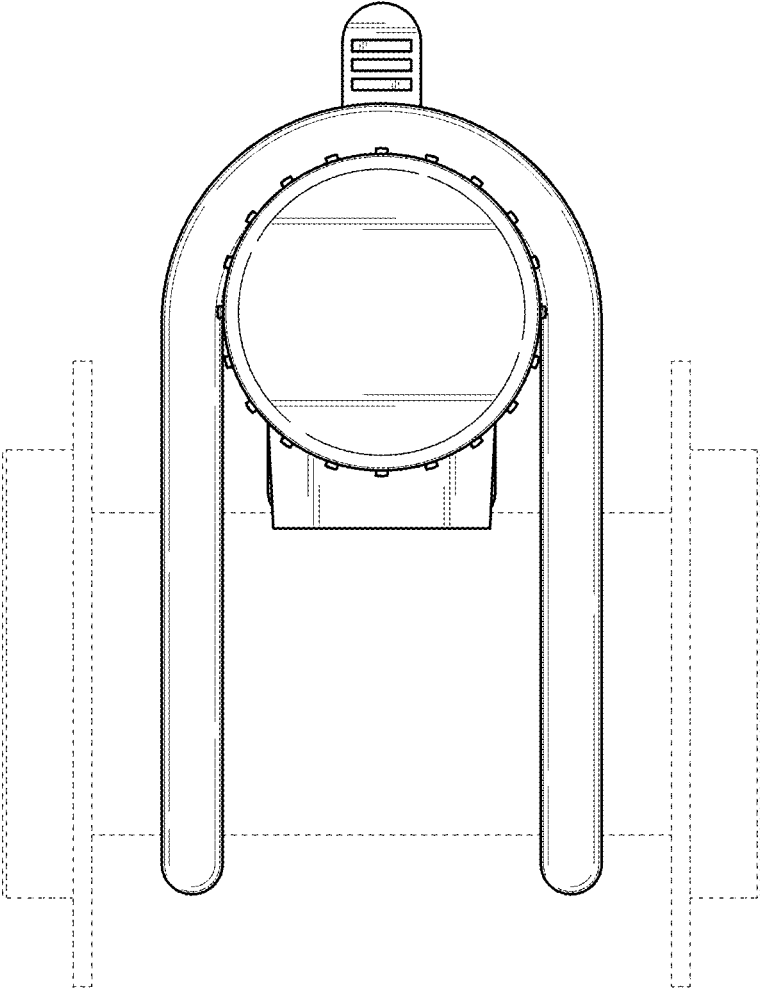

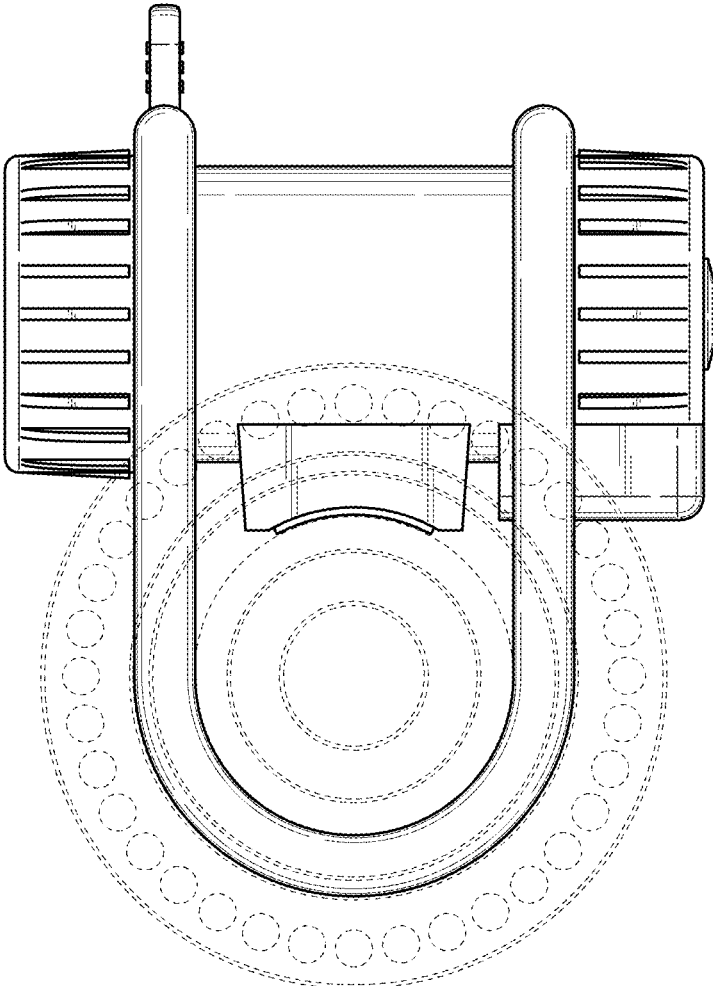

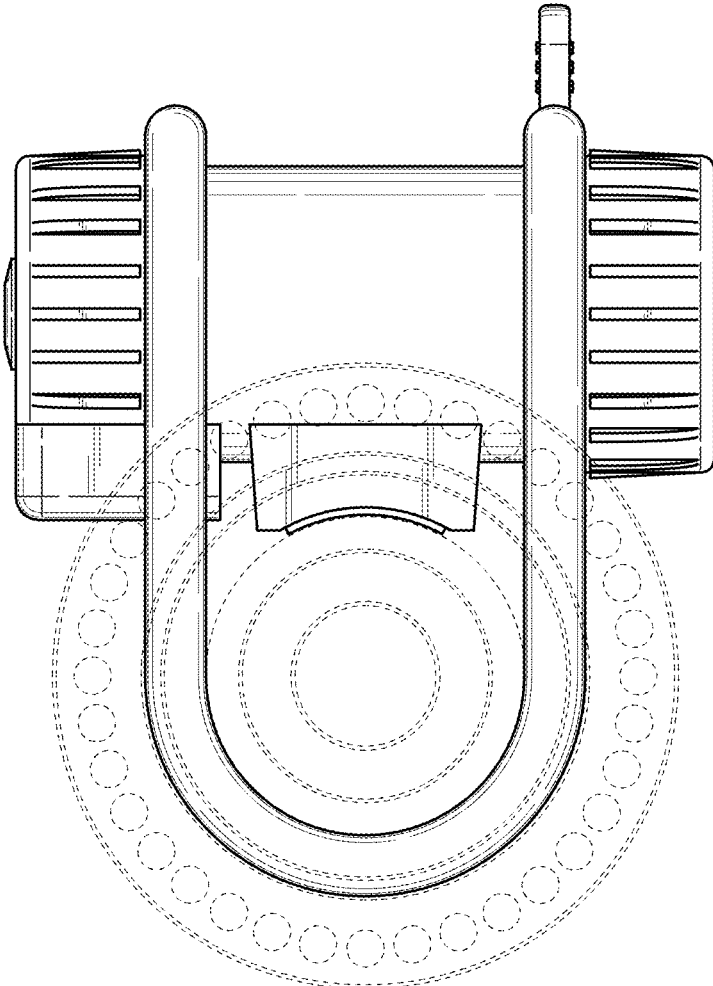

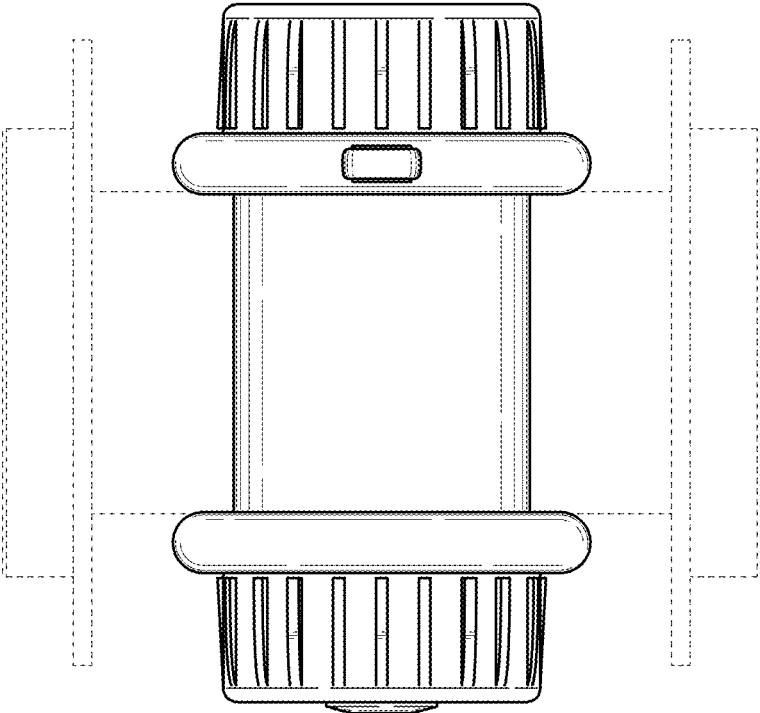

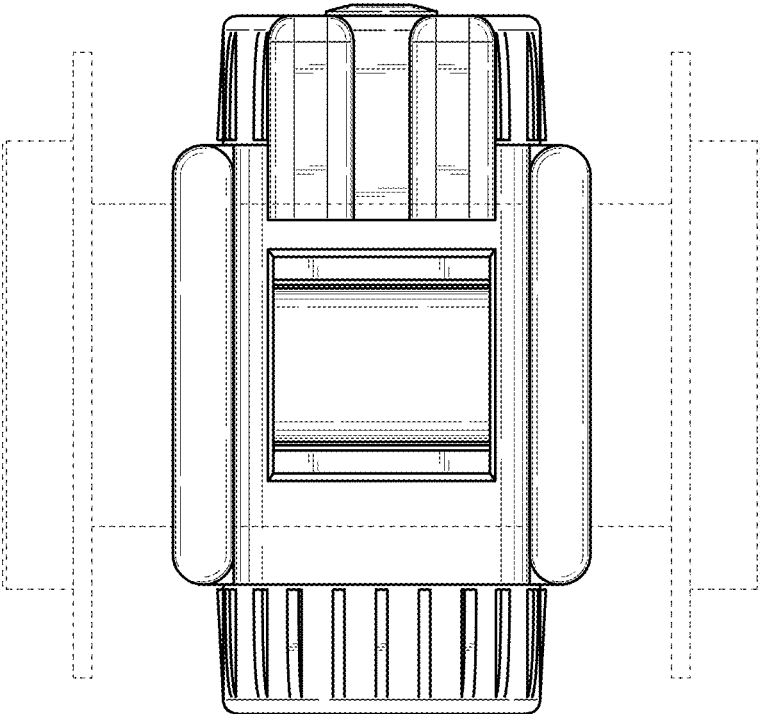

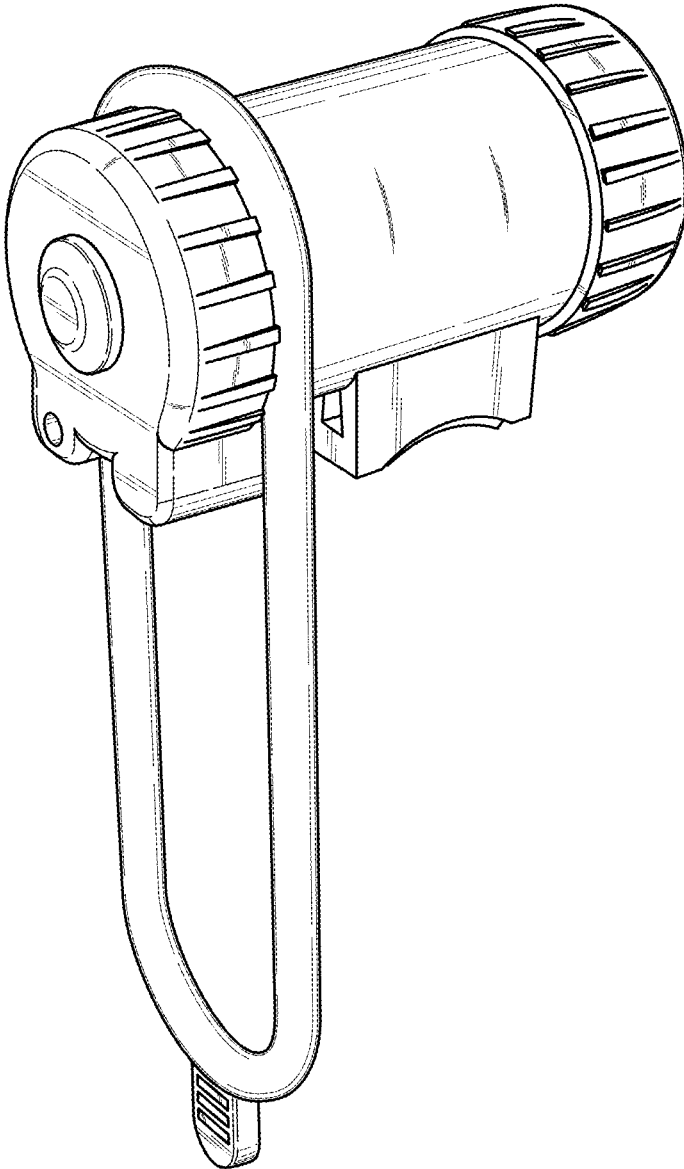
