DESCRIPTION

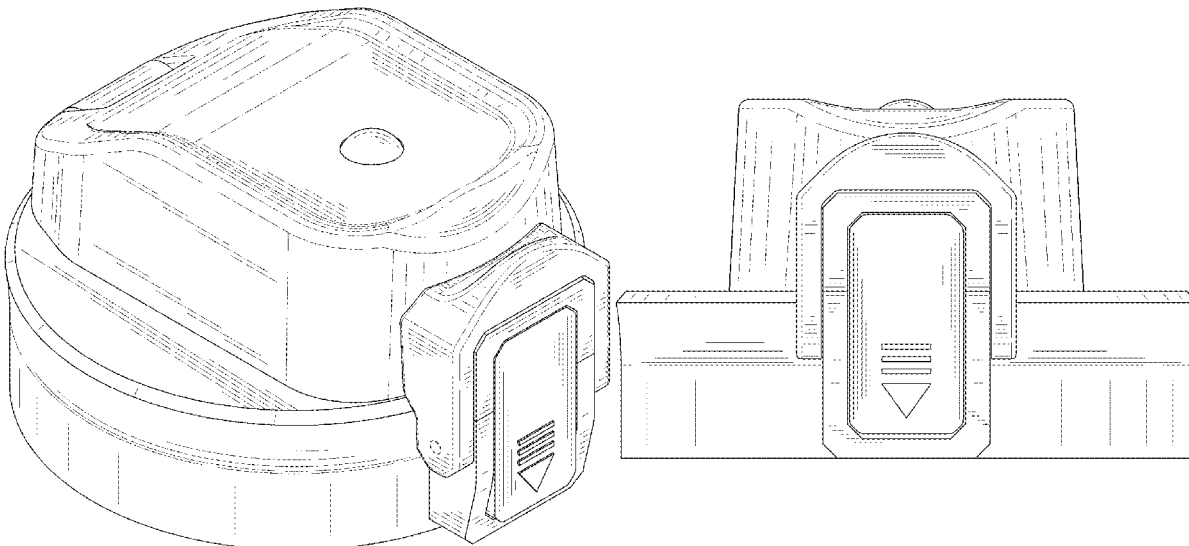
FIG. 1 is a front, top and right side perspective view of a lid for water bottle showing my new design;

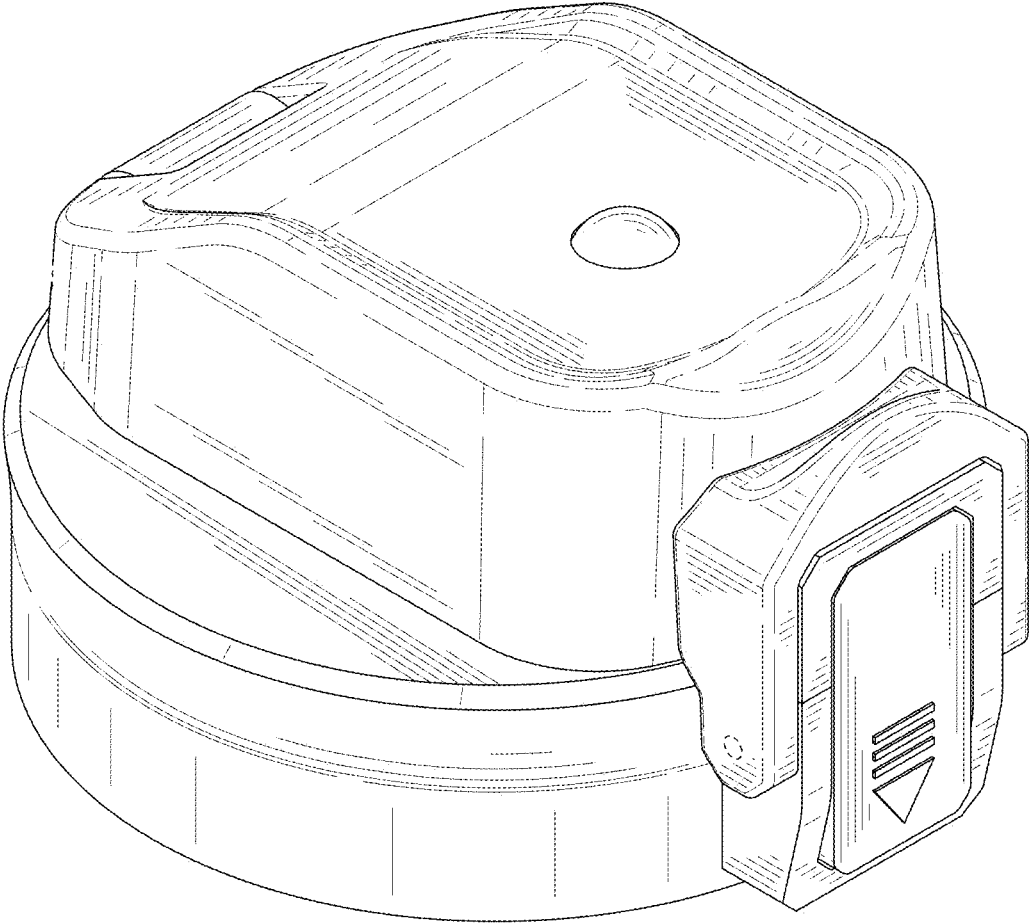

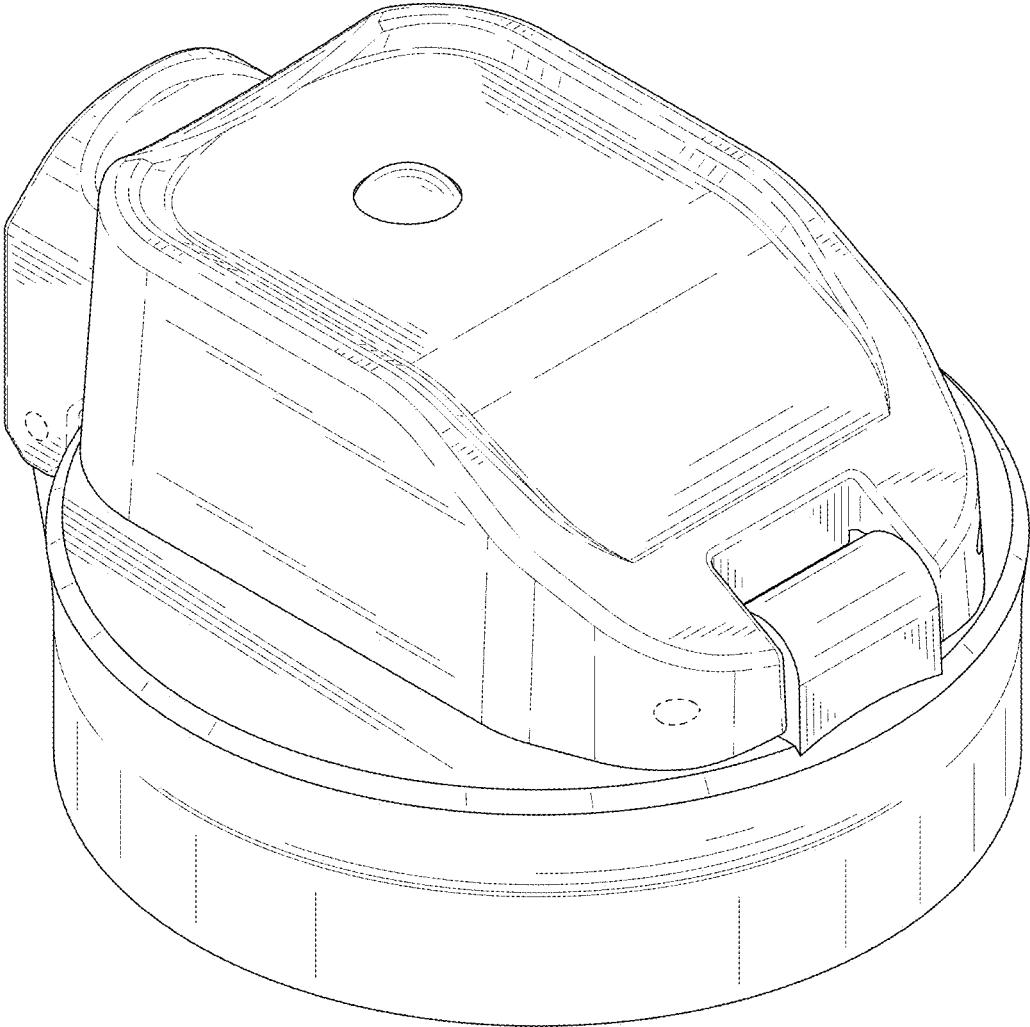

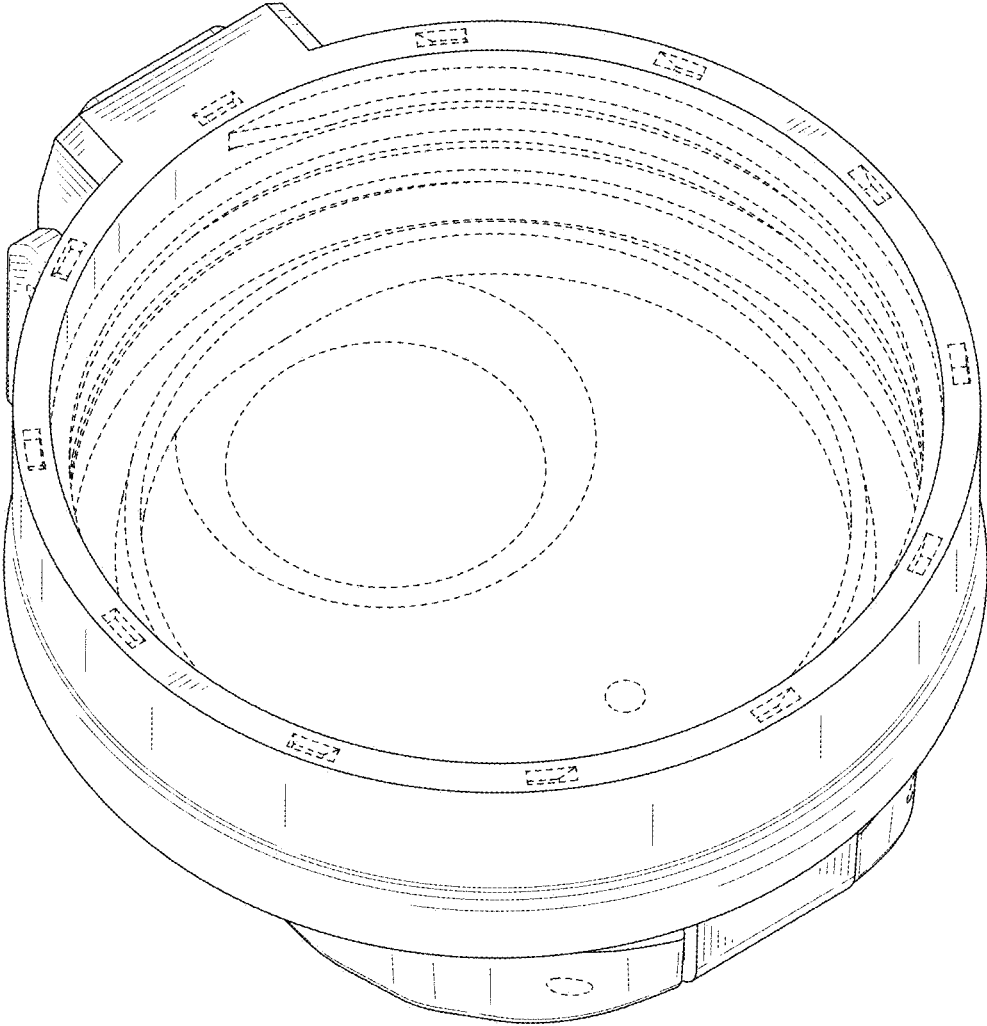

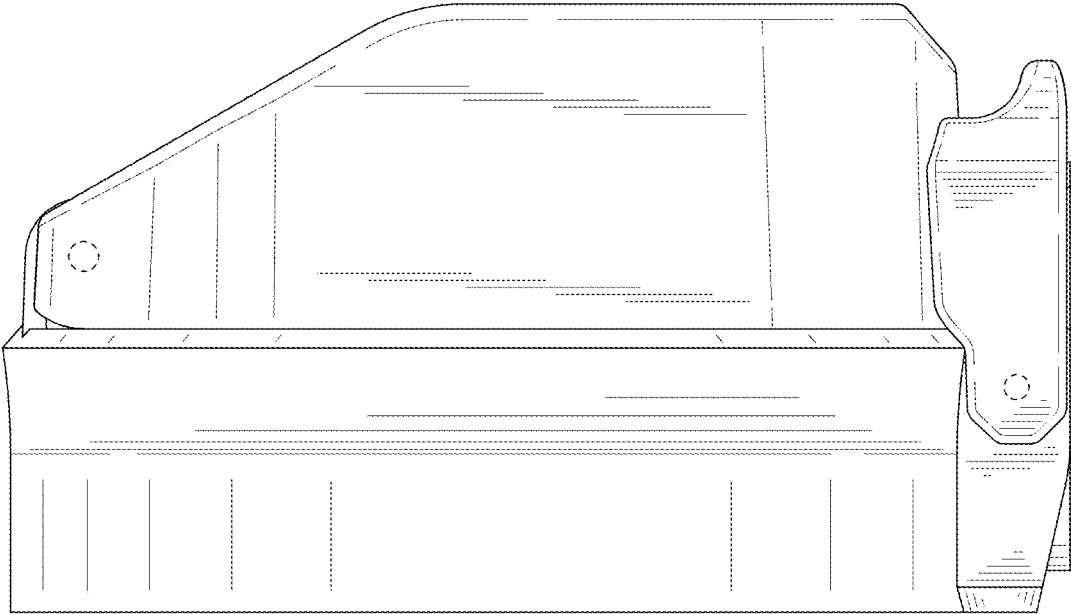

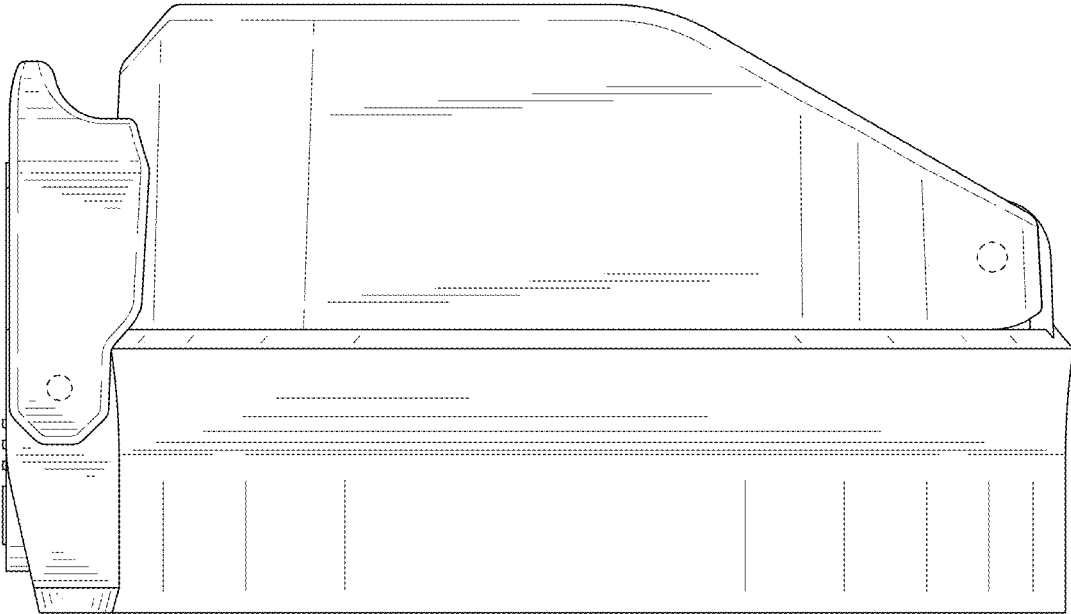

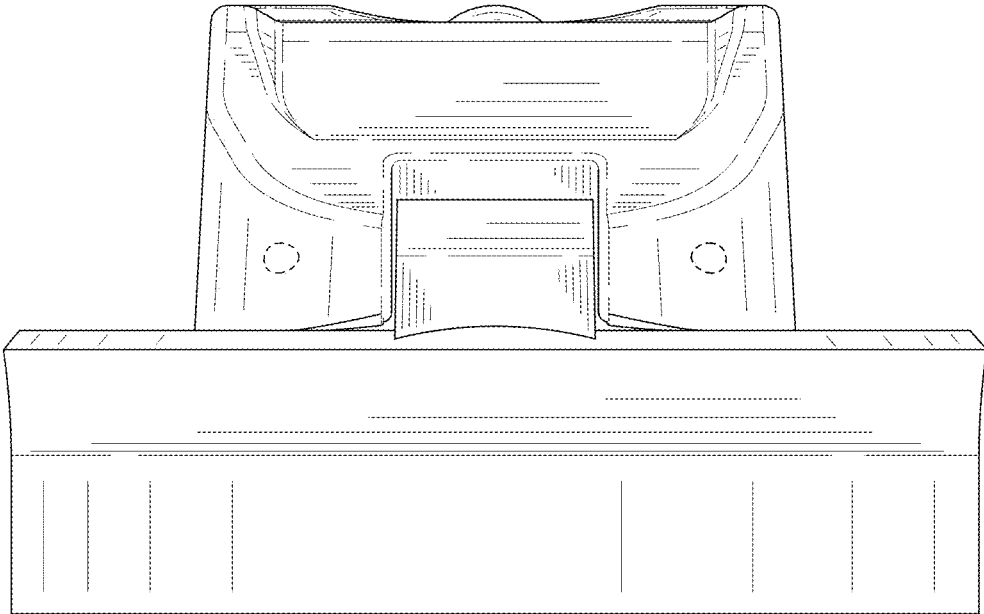

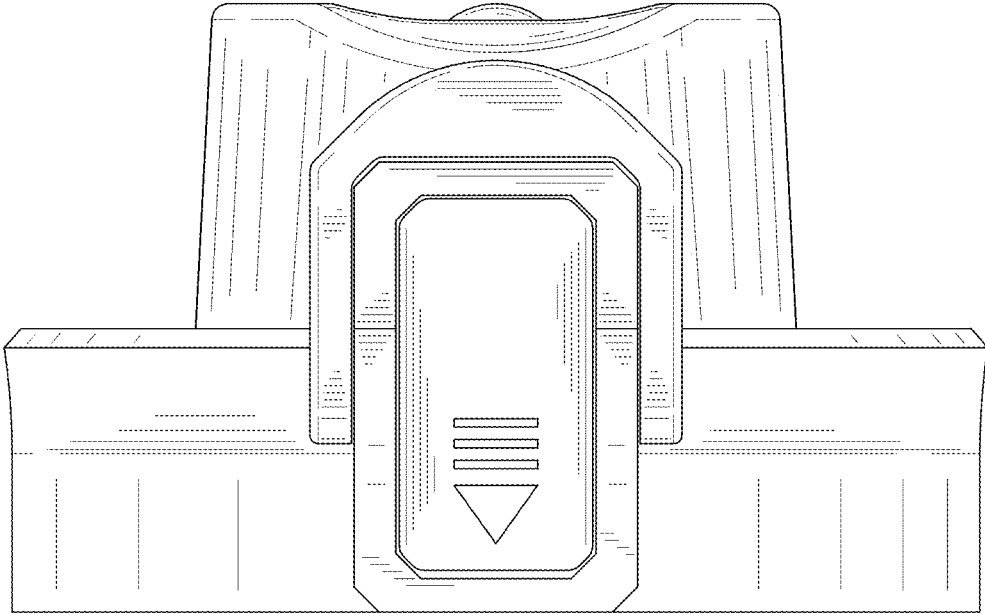

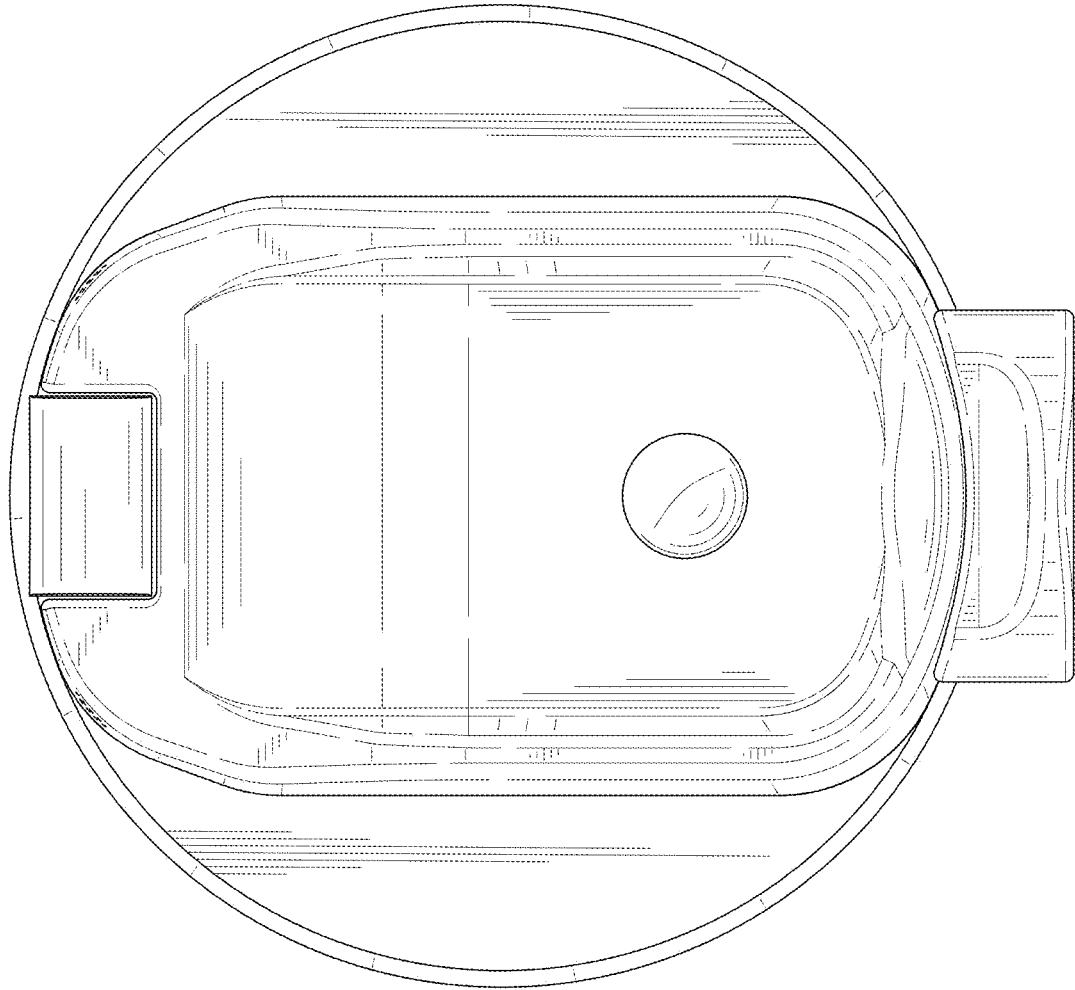

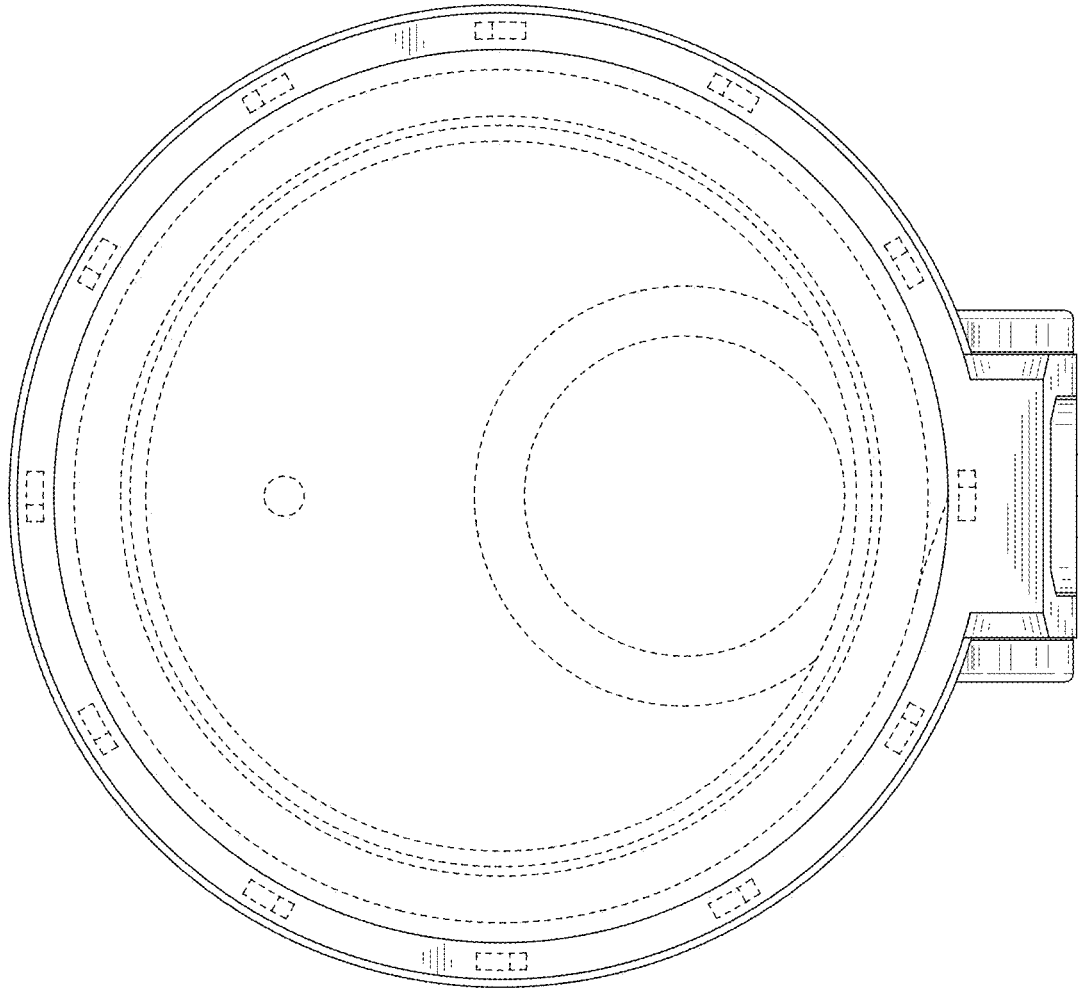
