In view of D1 (US 2010/101872) disclosing a remote controller where the trickplay speed is controlled according to the number of parallel movements detected and their direction, the technical problems solved by the identified groups of invention (Managing the display of actual reproduction information and providing guidance for selecting a gesture according to the intended use) are neither the same nor corresponding and therefore the 2 groups are not linked by a same general inventive concept. Therefore, the application lacks unity (At. 82 EPC).
