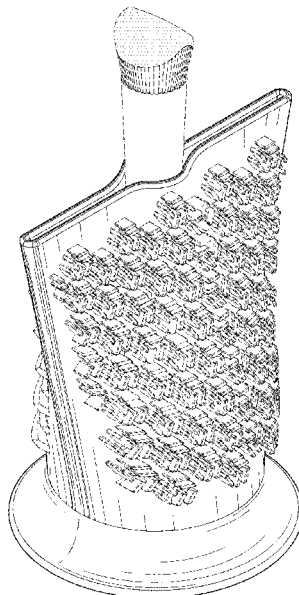

FIG. 1 is a front perspective view of a cosmetic brush protective cover showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a rear perspective view thereof; FIG. 9 is a perspective view showing a usage state of the cosmetic brush protective cover, in which a front portion of a cosmetic brush is shown in broken lines forming no part of the claimed design and protrudes from one end of the cosmetic brush protective cover, the front portion including bristles that are also shown in broken line represent the ends of the unclaimed bristles which form no part thereof; and, FIG. 10 is a perspective view showing another usage state, in which a rear portion of the cosmetic brush protruding out of another end of the cosmetic brush protective cover is shown in broken lines forming no part of the claimed design. The broken lines depict portions of the cosmetic brush protective cover in which the design is embodied that form no part of the claimed design.

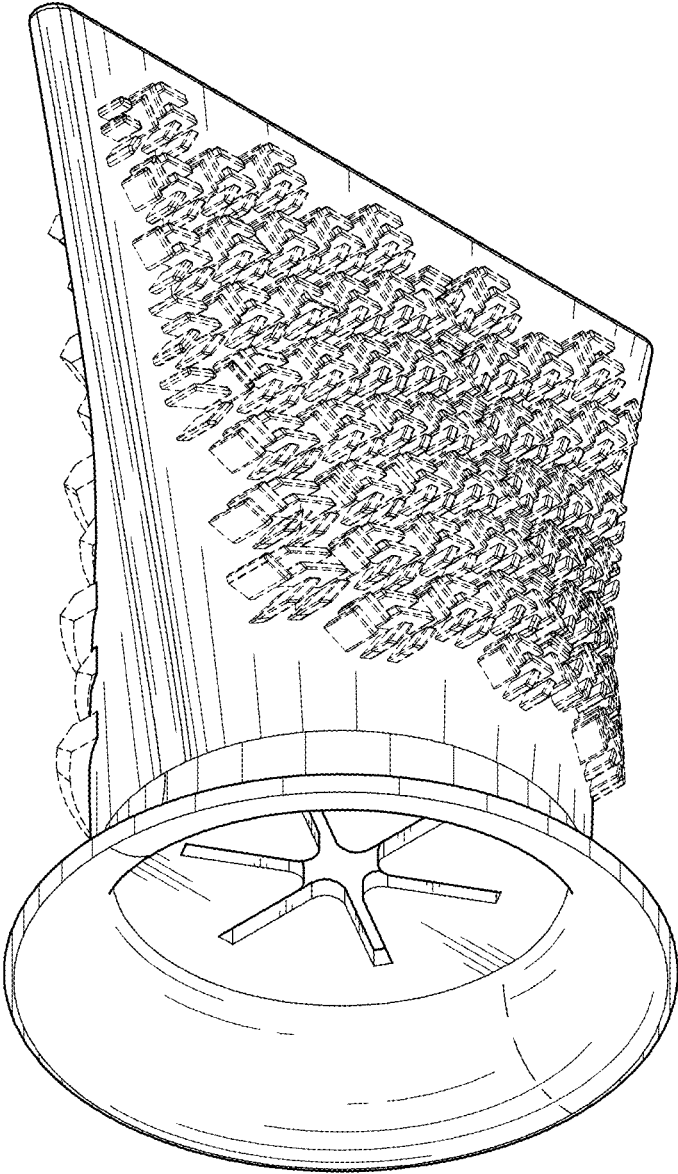

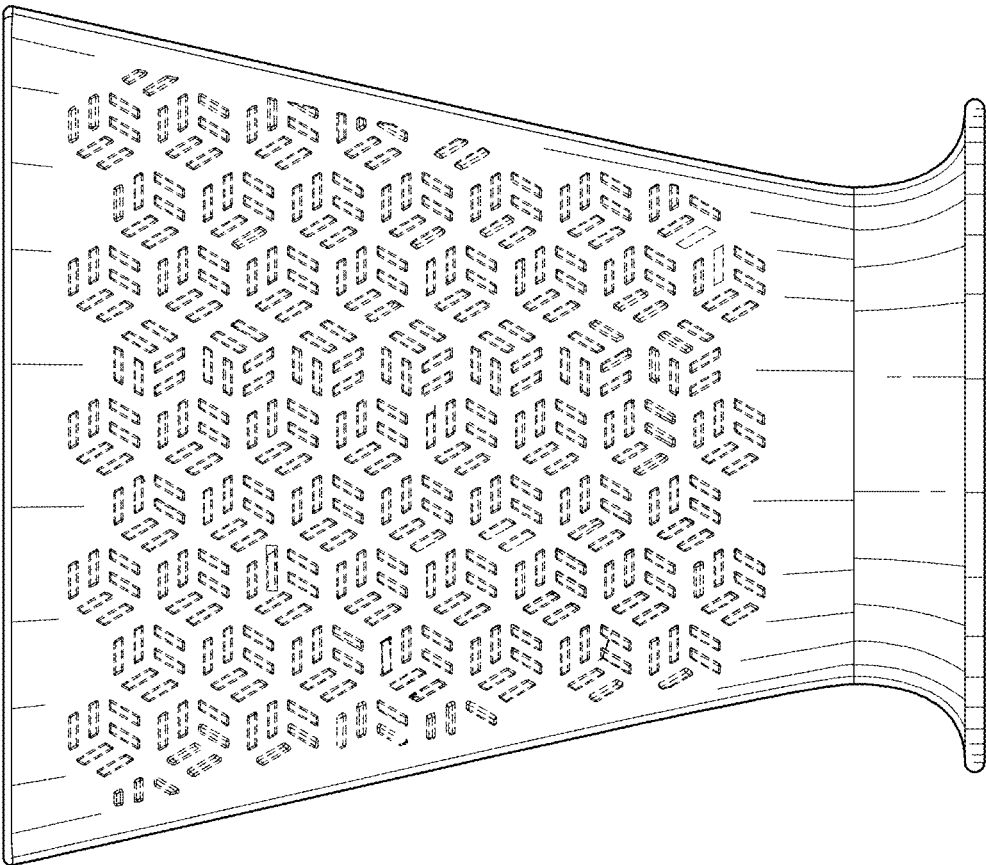

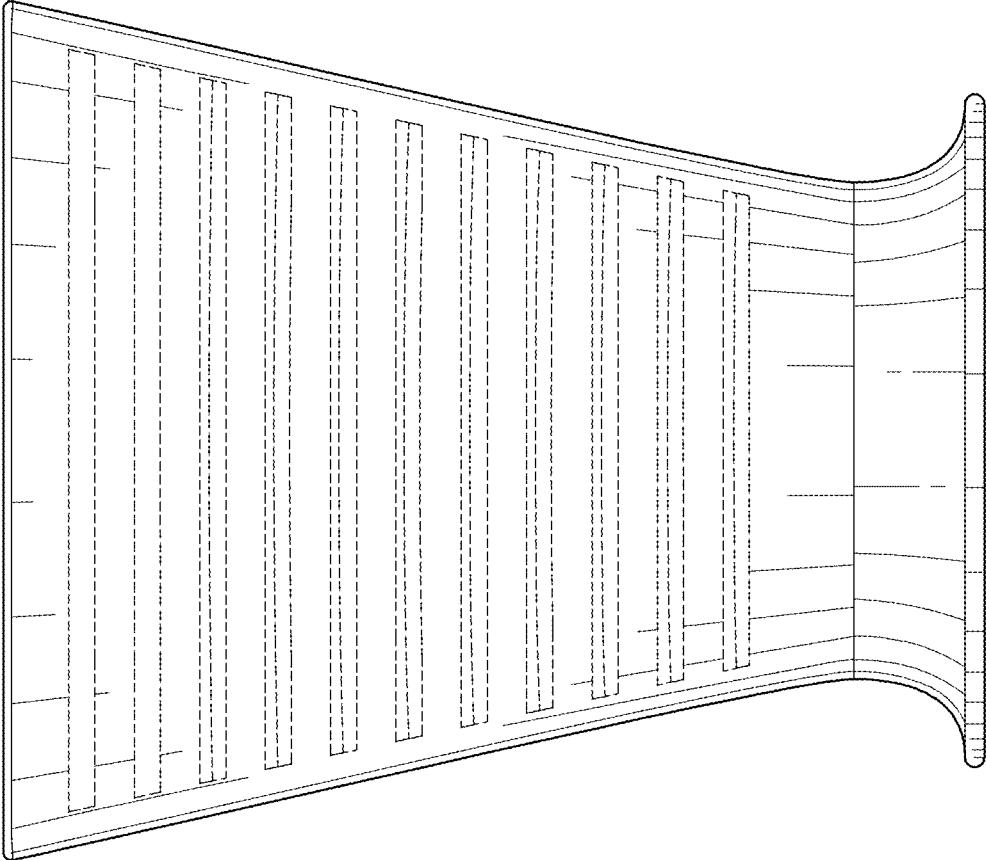

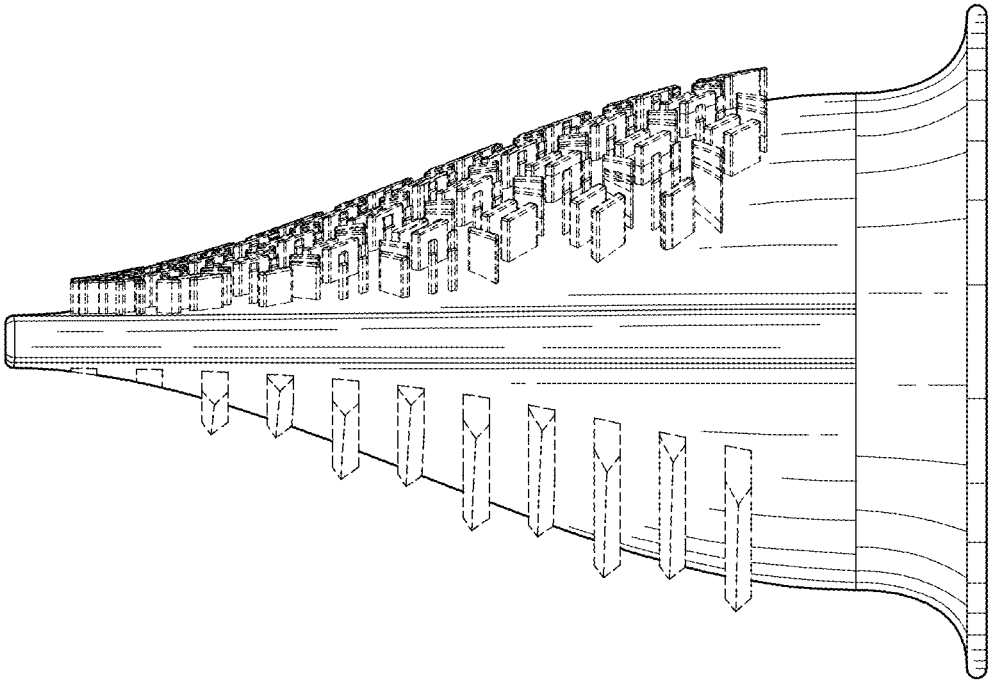

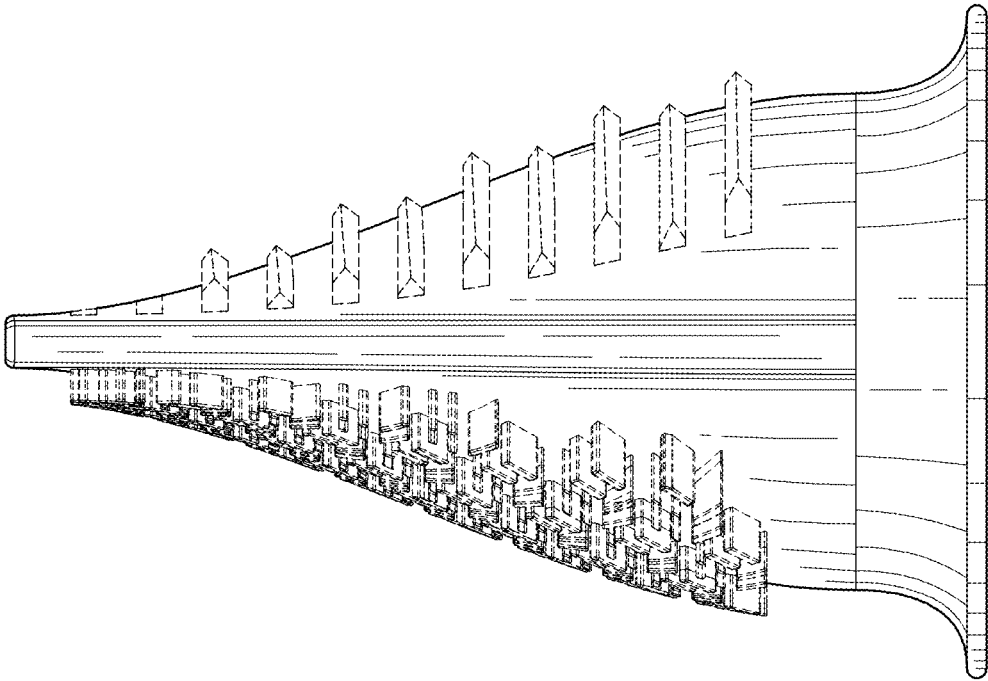

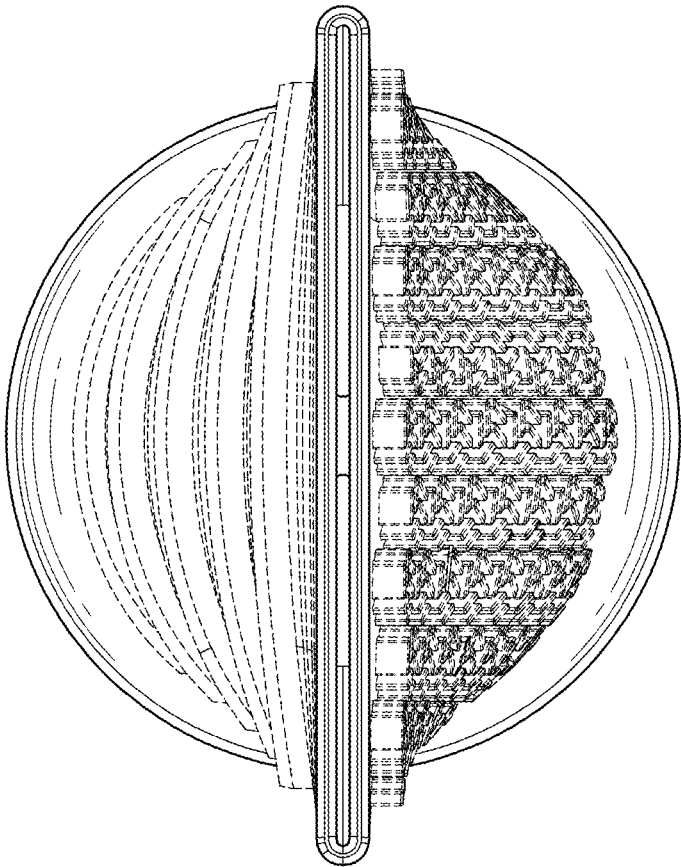

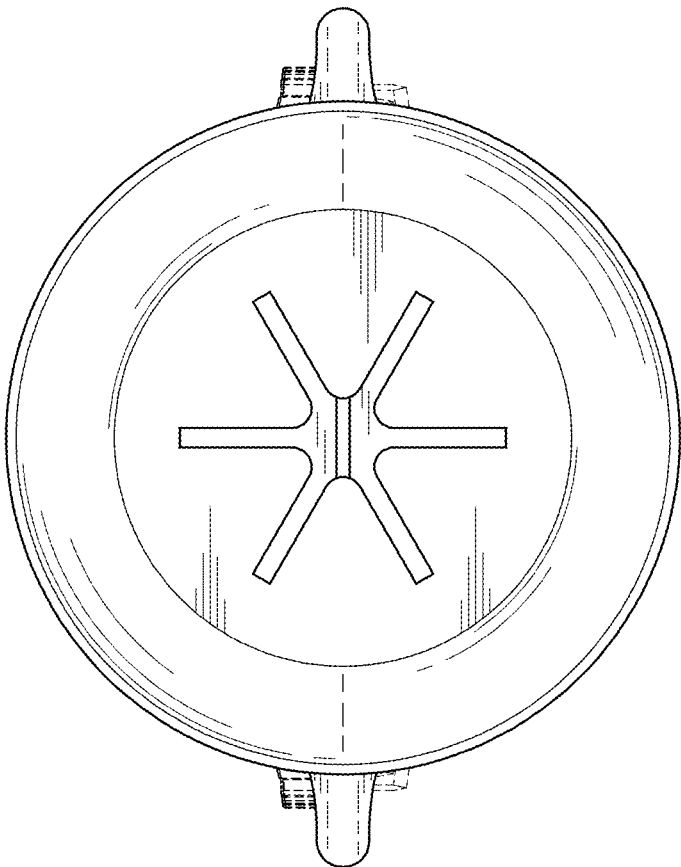

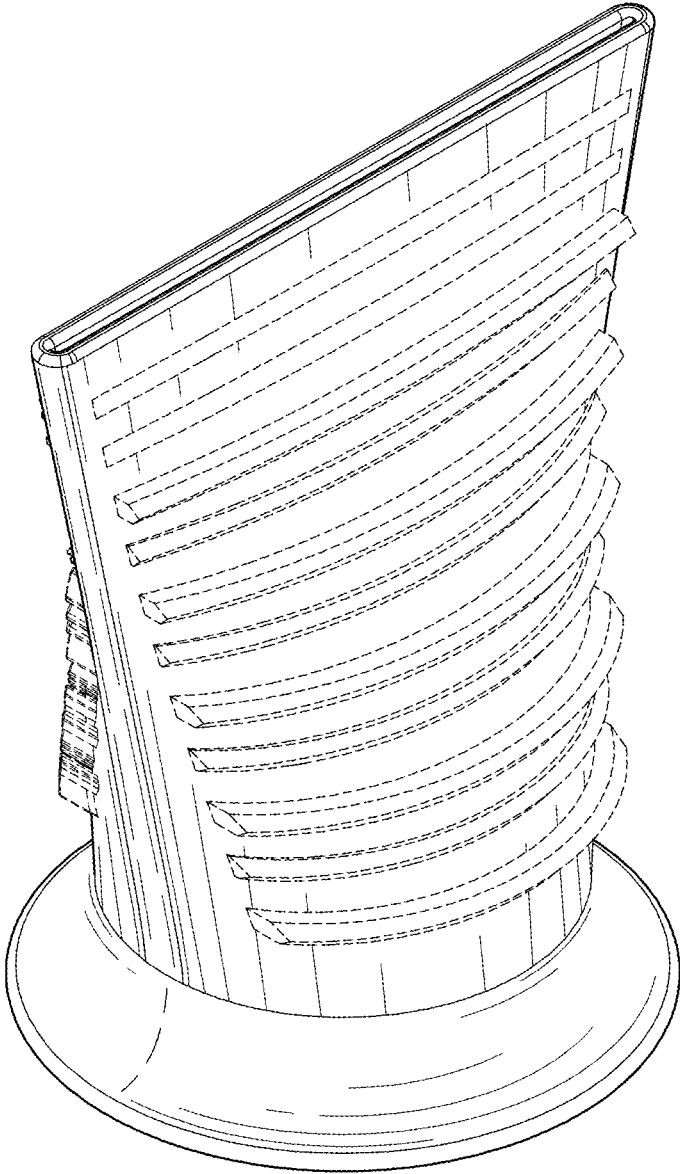

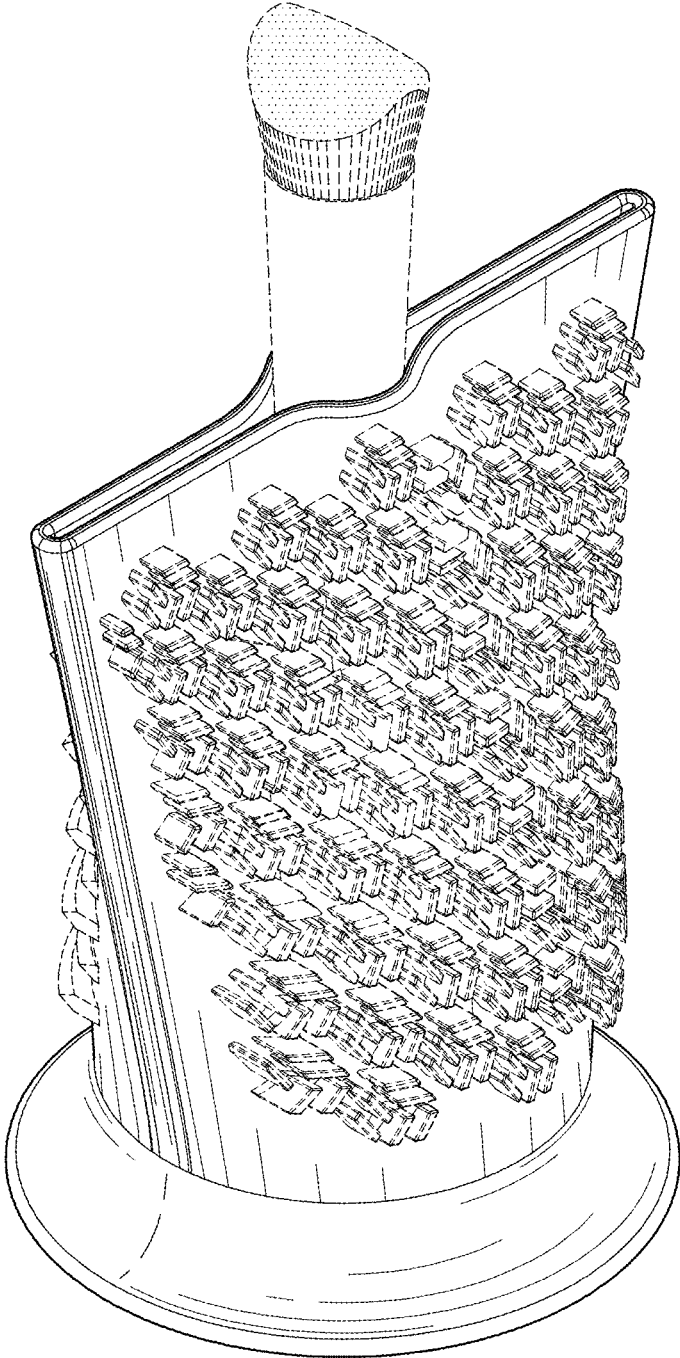

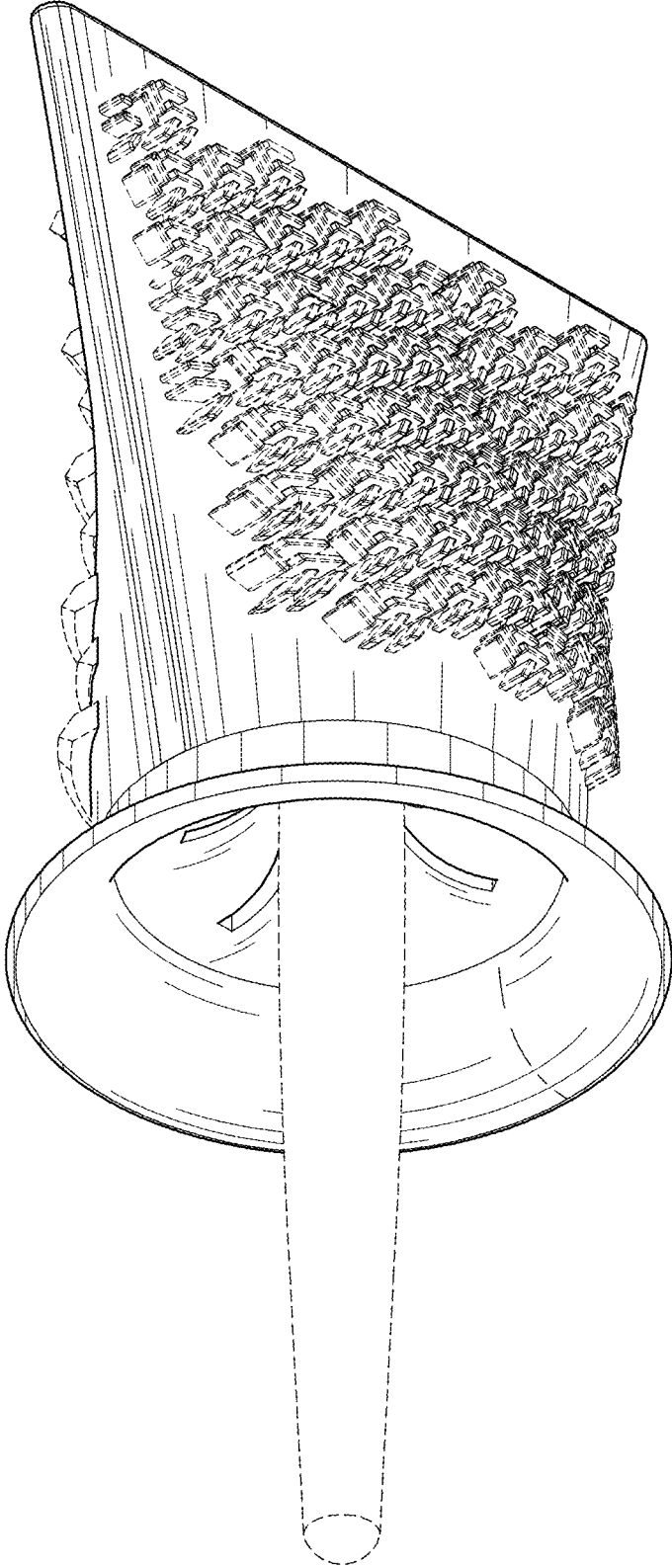
