The ornamental design for an animated user interface for a display screen, as shown and described.

**DESCRIPTION**

FIG. 3 is a third image thereof;

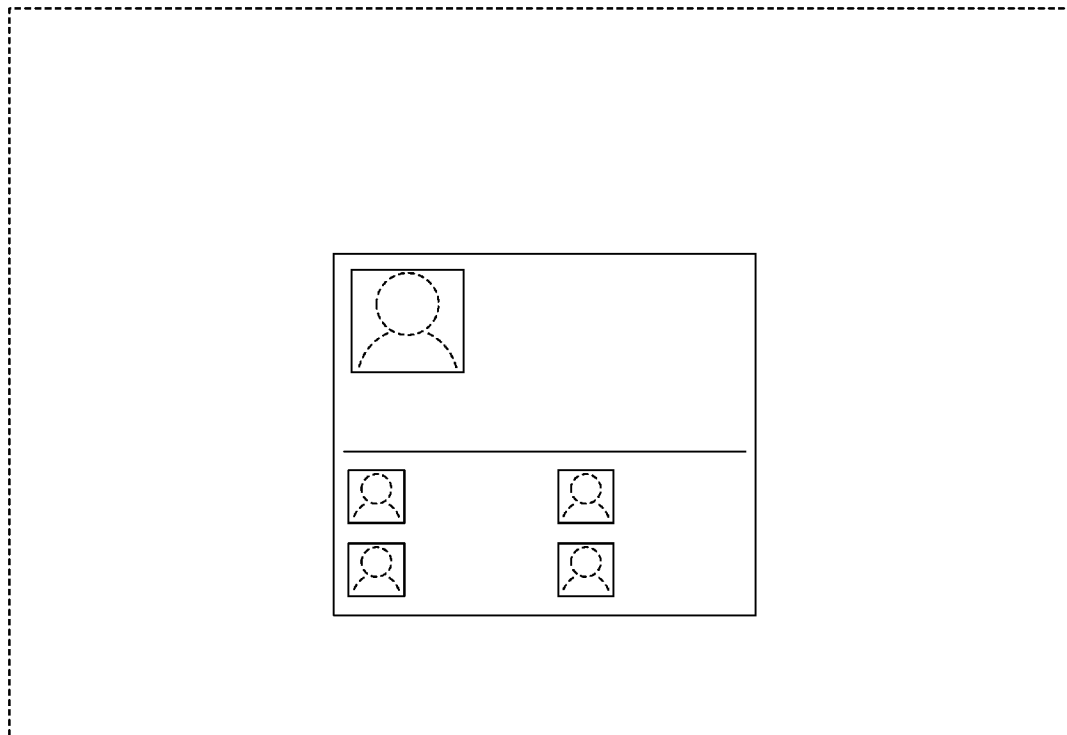
FIG. 4 is a fourth image thereof; and,

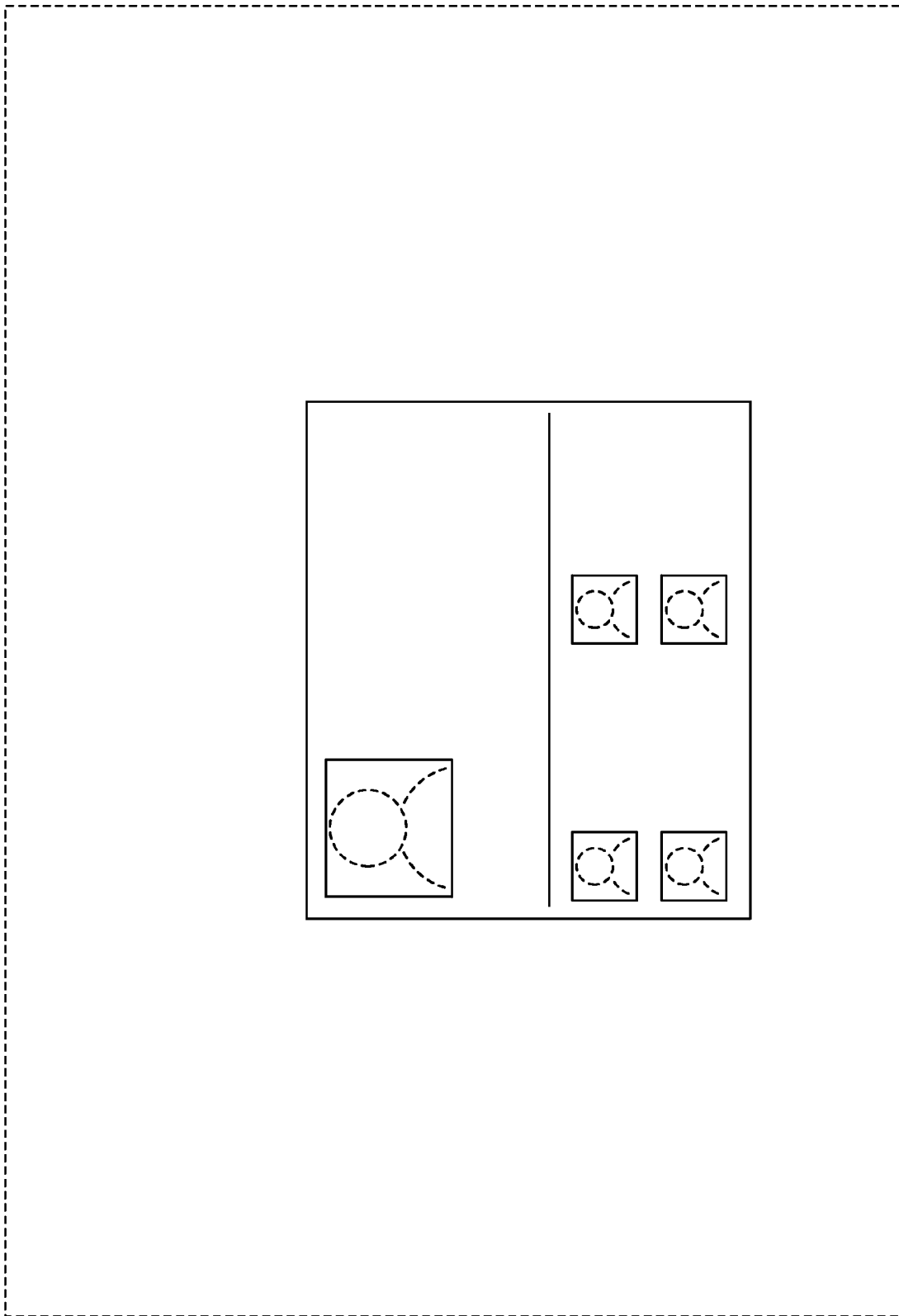

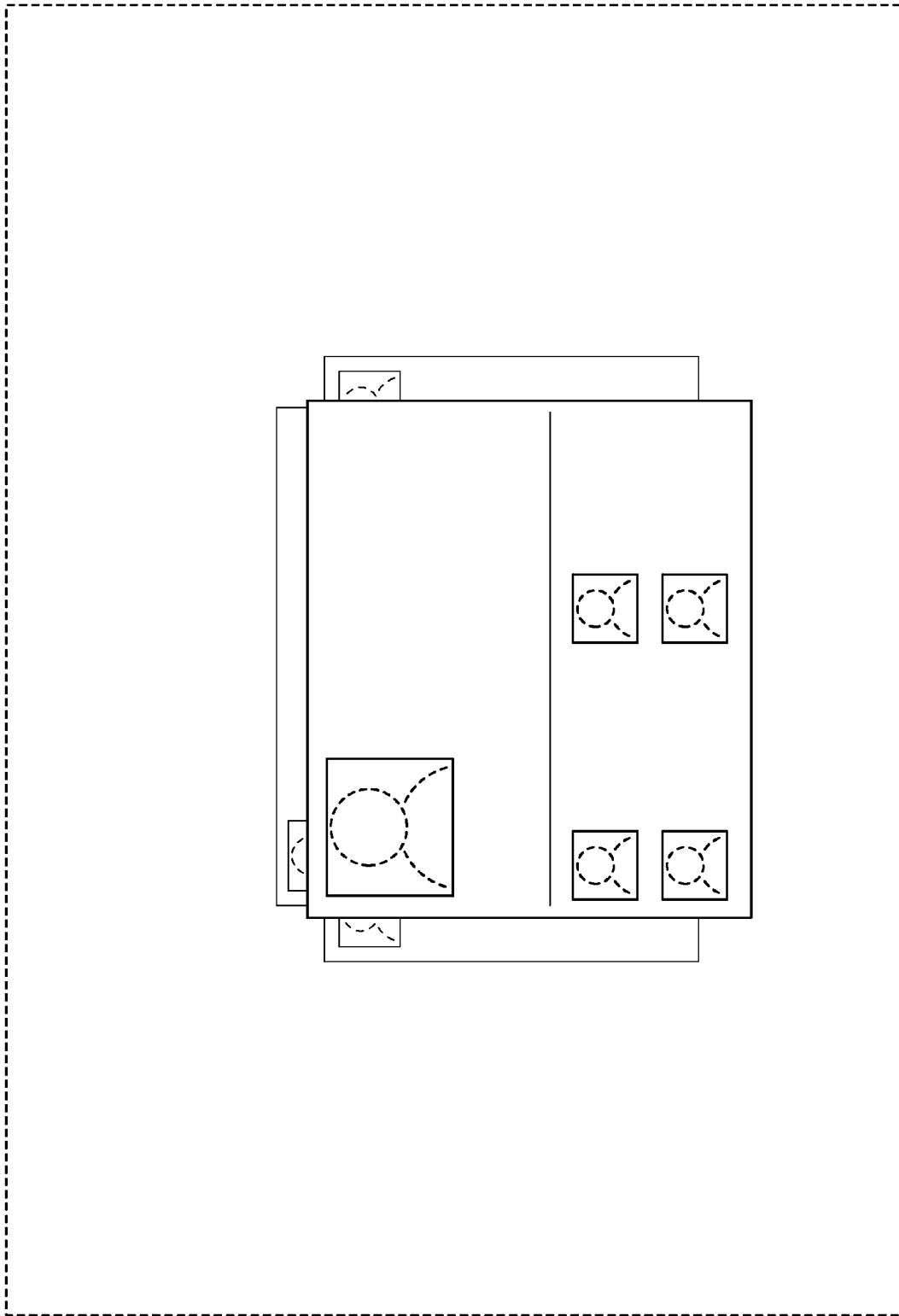

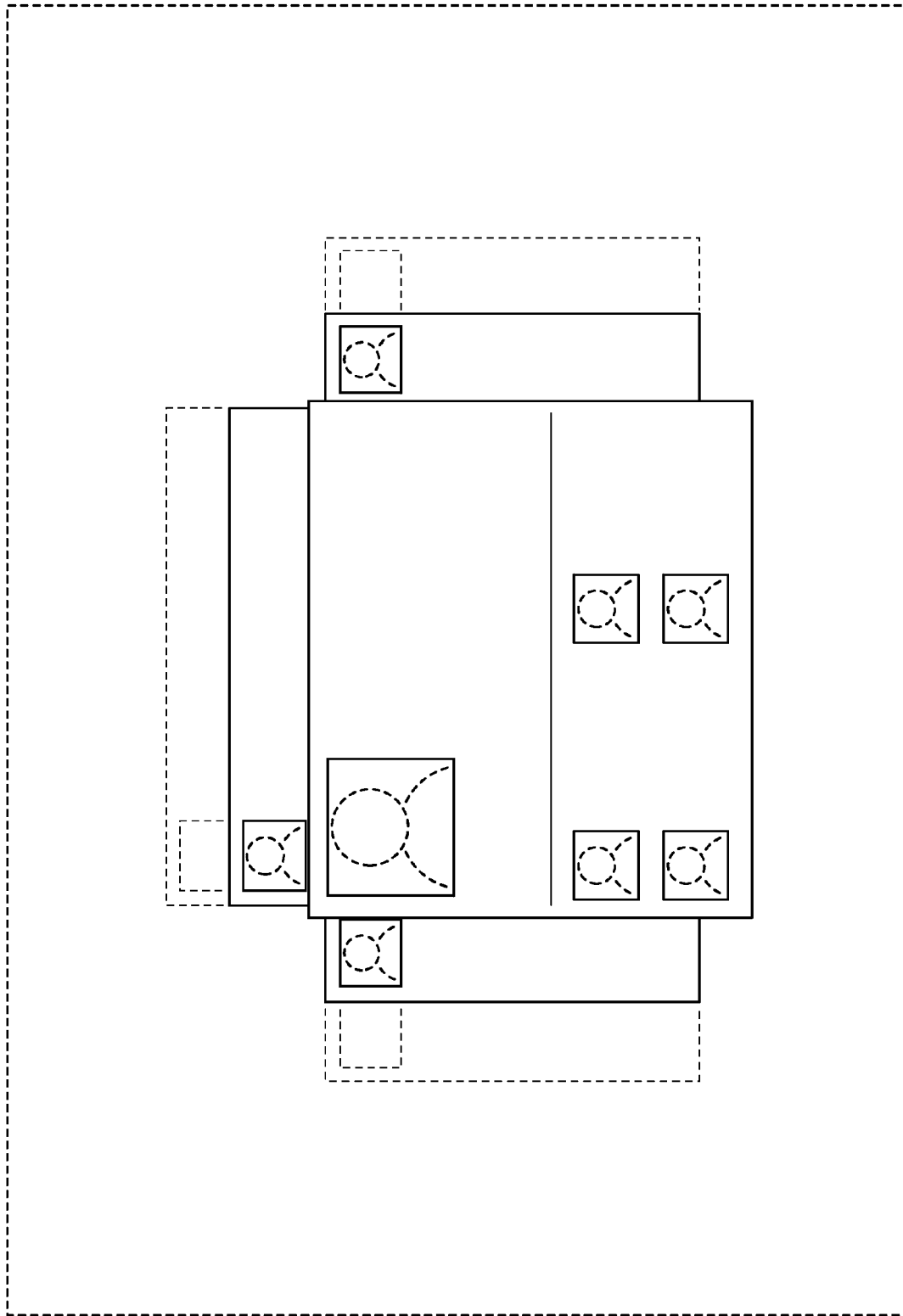

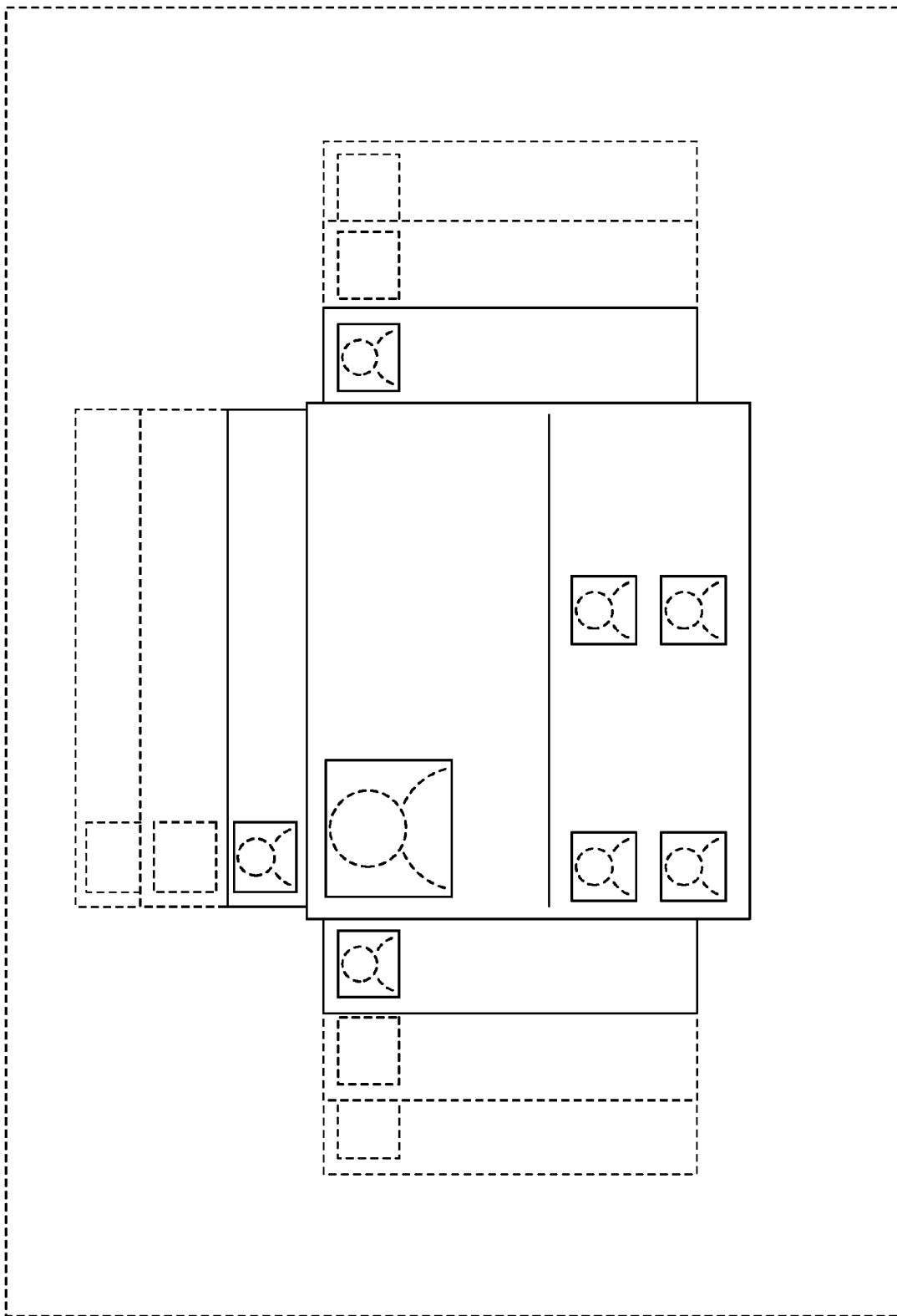

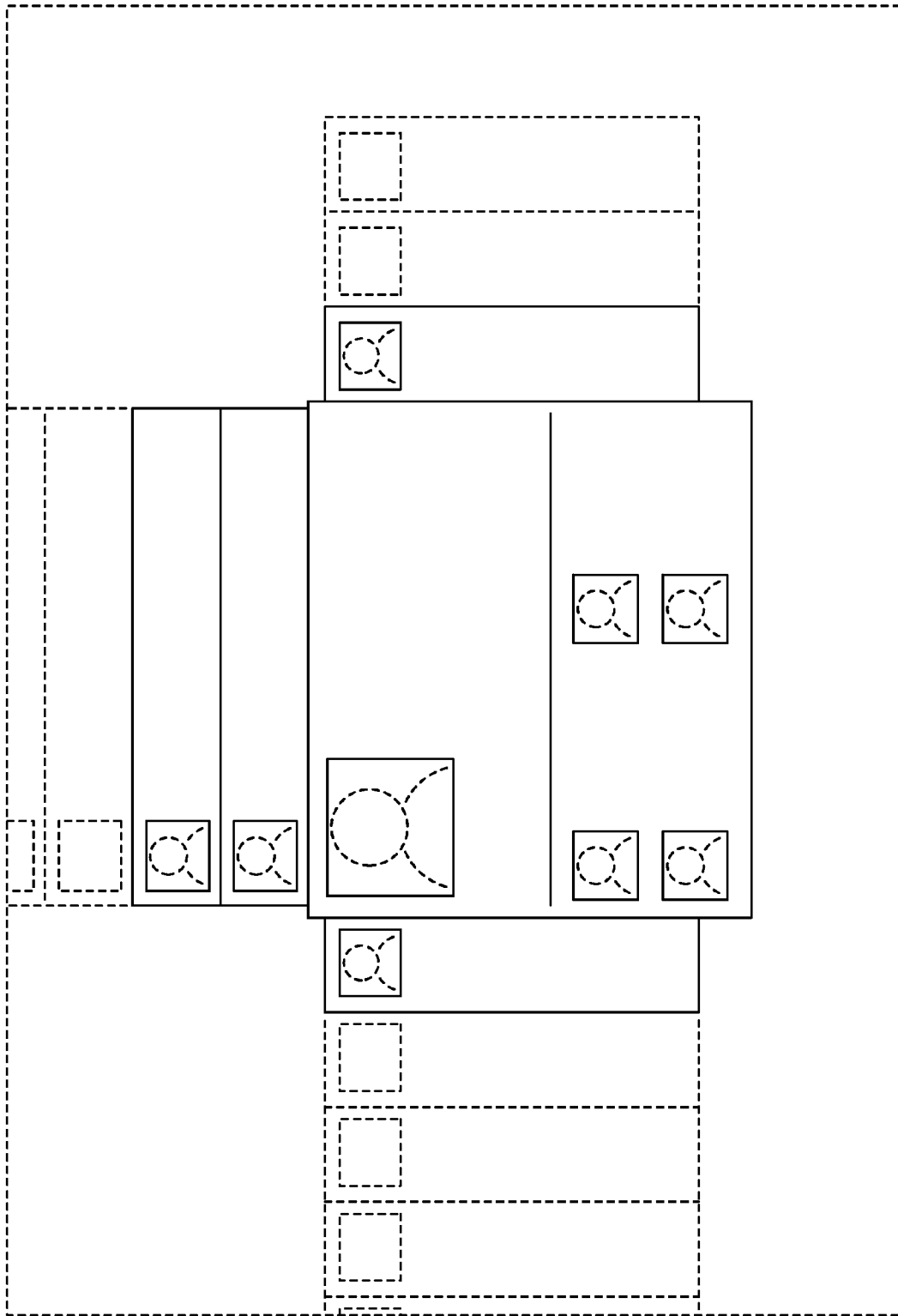
