(57) **CLAIM**

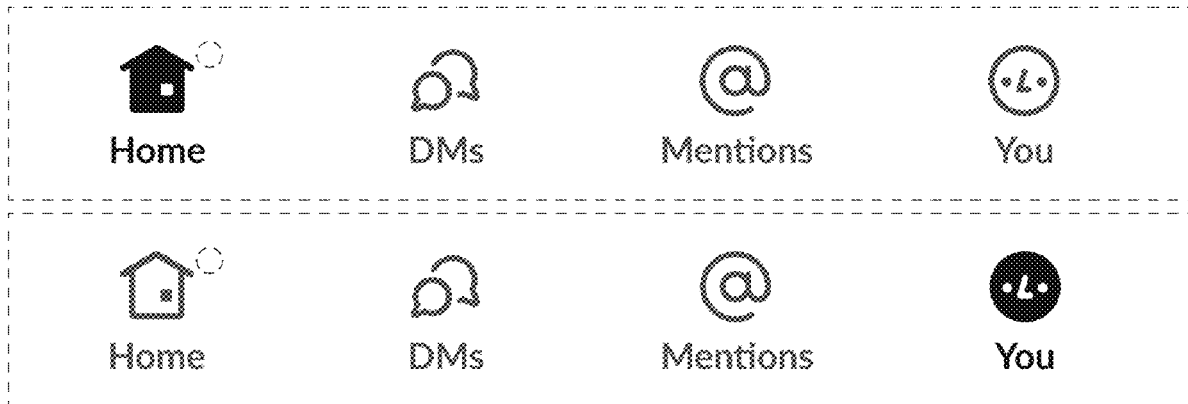
The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface showing the claimed design; FIG. 2 is a second embodiment thereof; FIG. 3 is a third embodiment thereof; and, FIG. 4 is a fourth embodiment thereof.
