FIG. 1 is a perspective view of a bottle showing my new design;

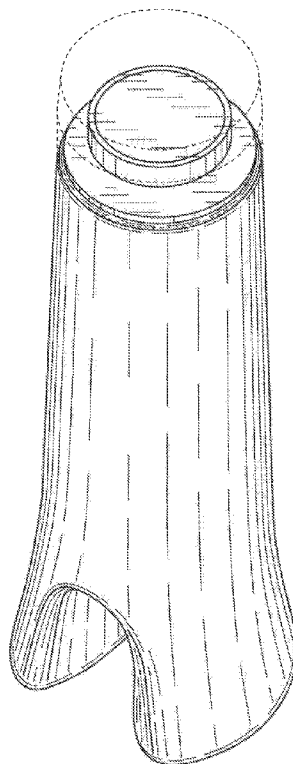
FIG. 2 is a front view thereof;

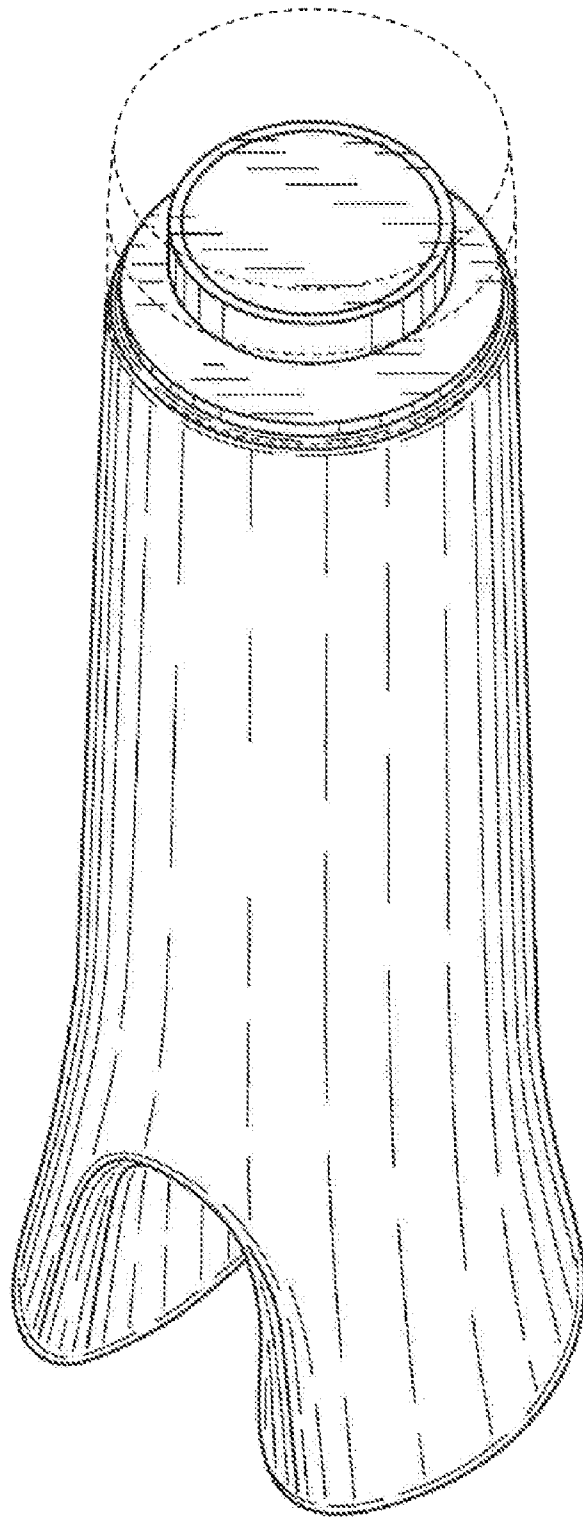

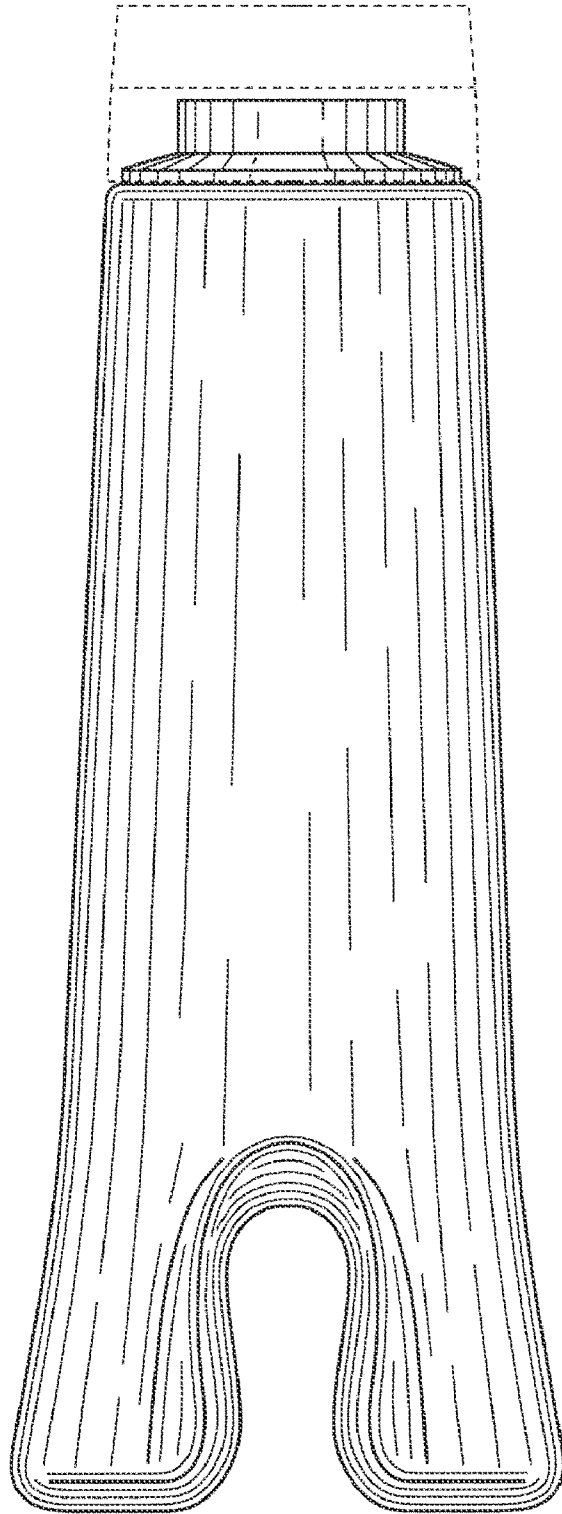

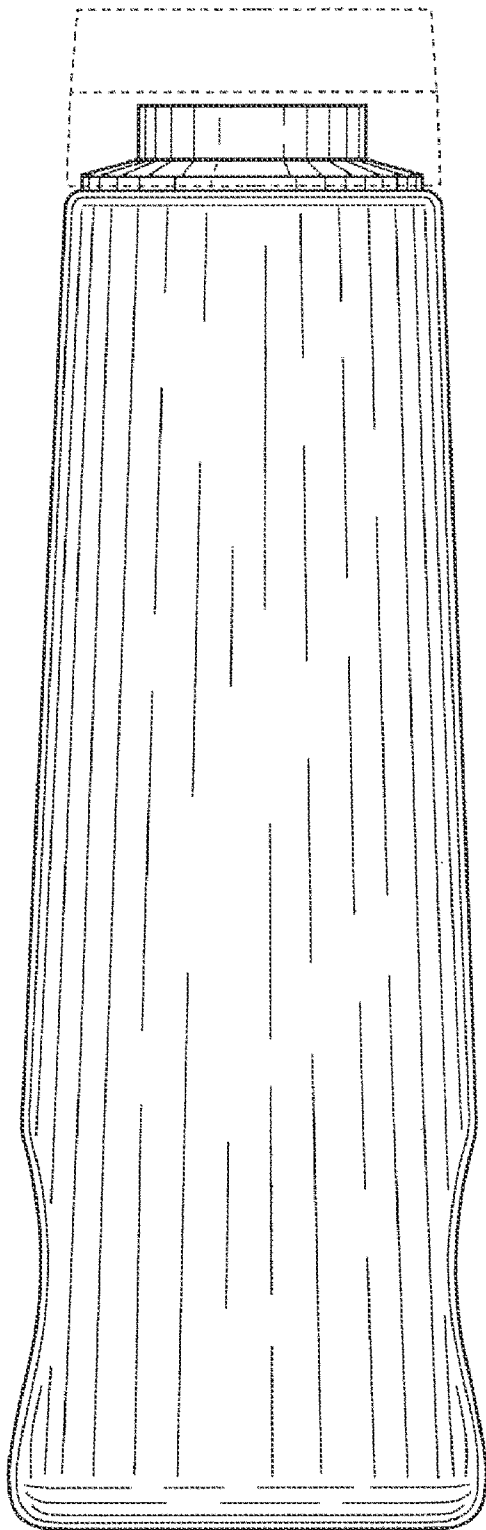

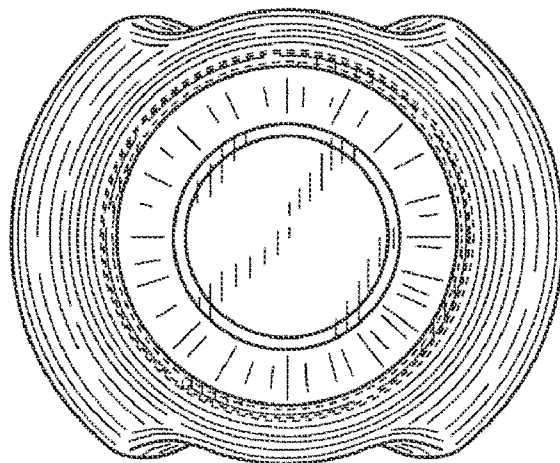

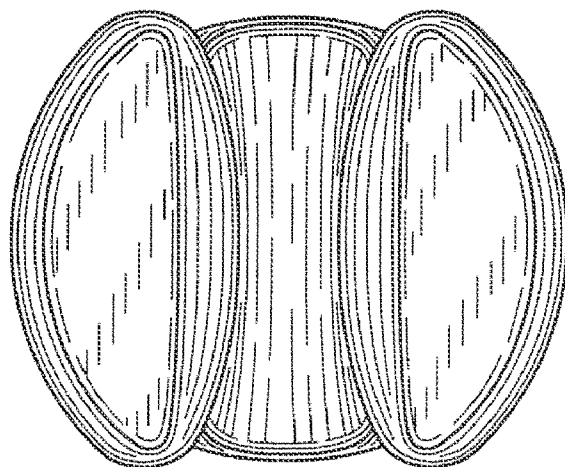
