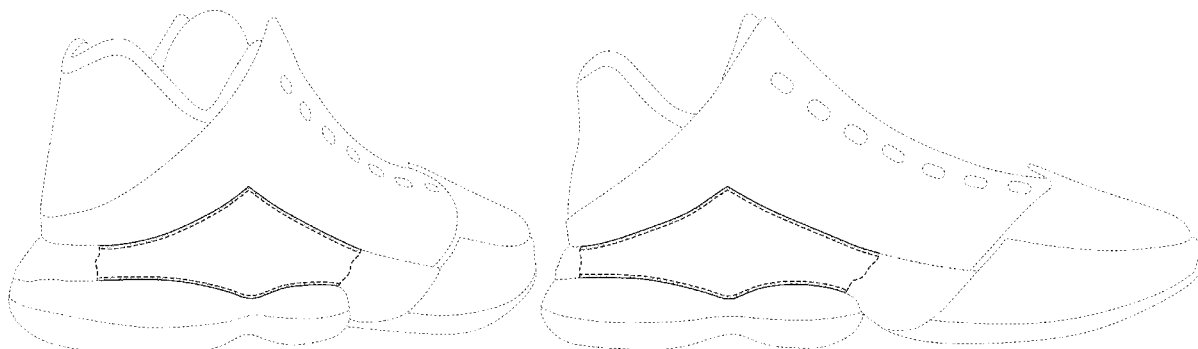
(57) **CLAIM**

I claim the ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear perspective view of a shoe, showing my new design;  
FIG. 2 is a left side view thereof;  
FIG. 3 is a front perspective view thereof; and,  
FIG. 4 is a rear view thereof.  
The broken lines adjacent to the shaded area represent unclaimed boundaries of the claimed design. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

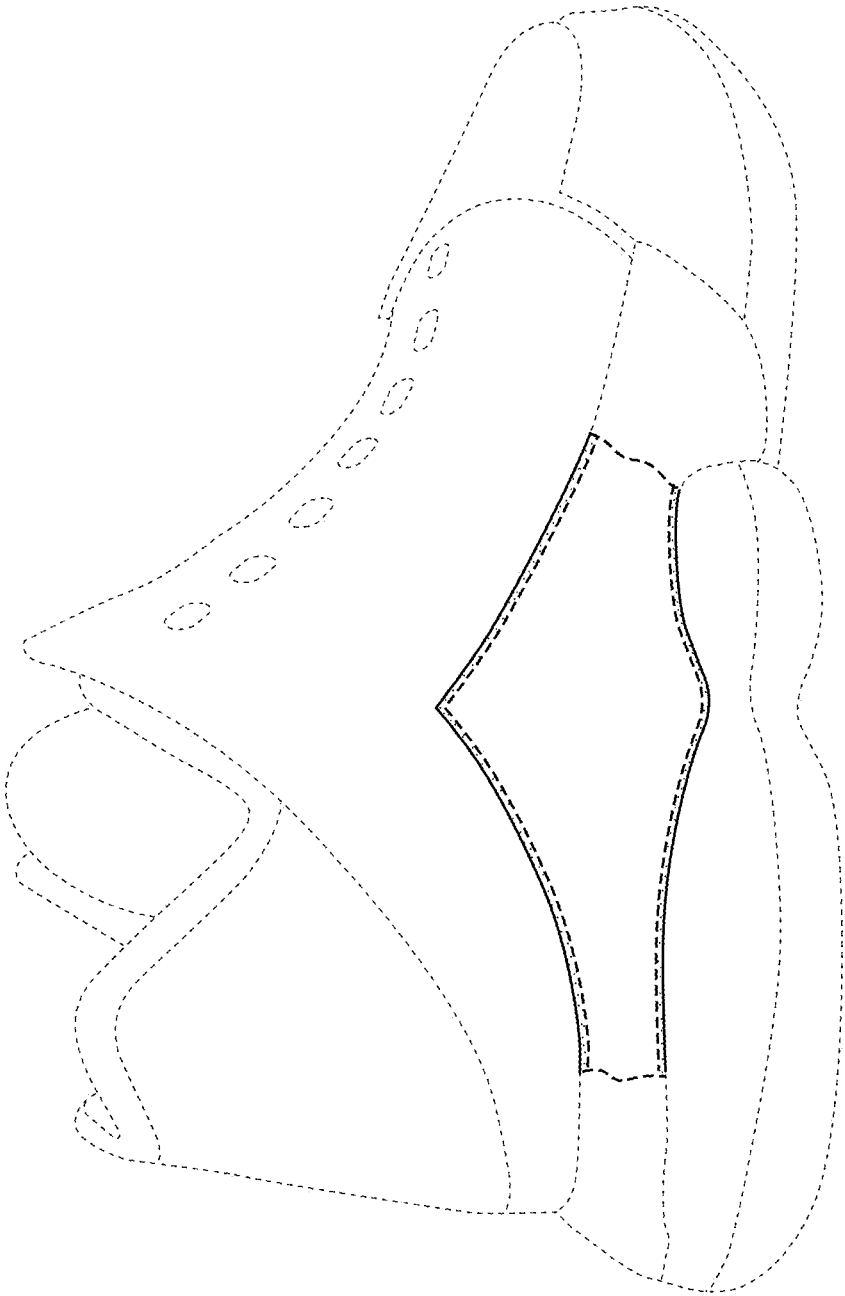

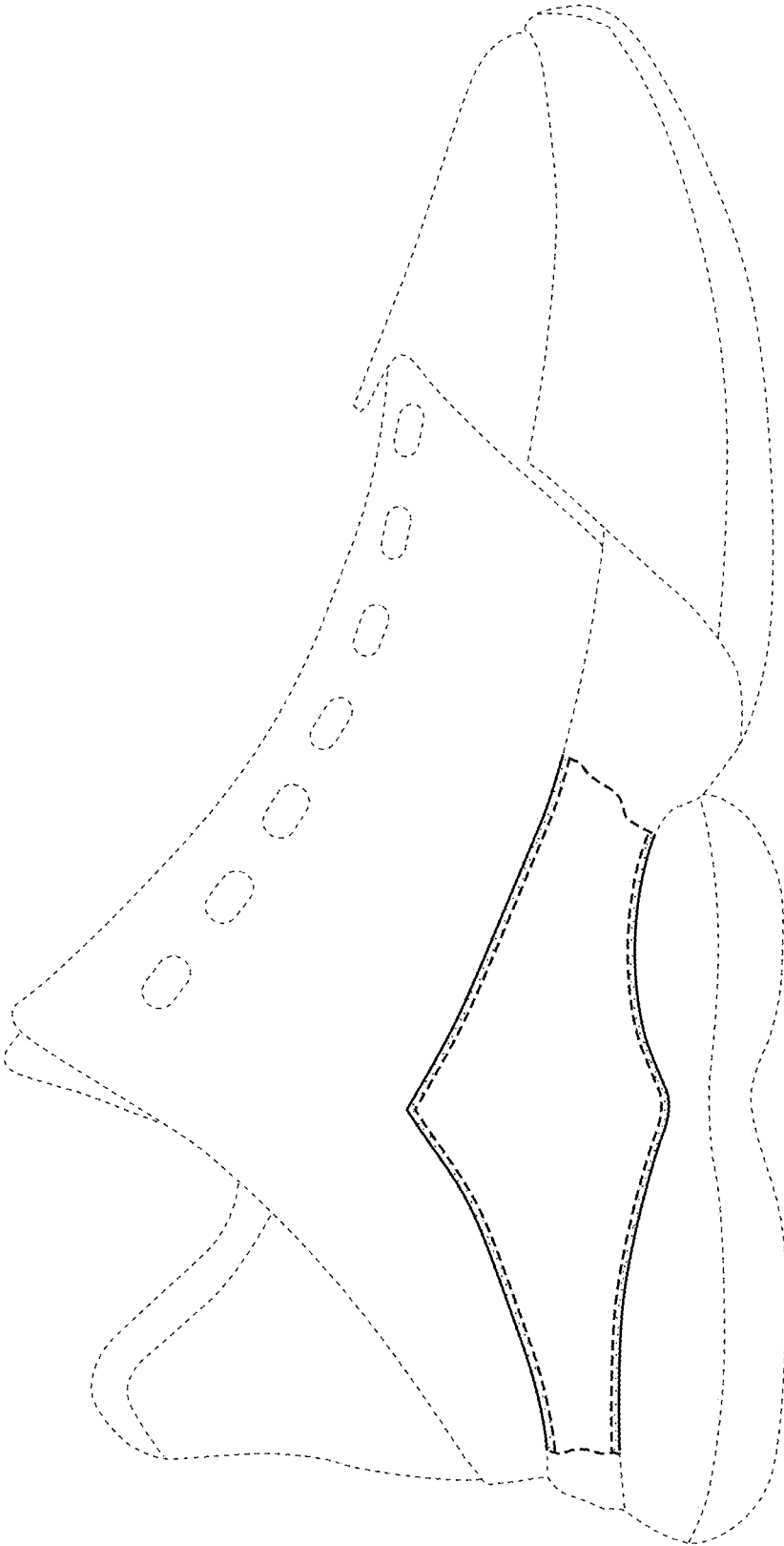

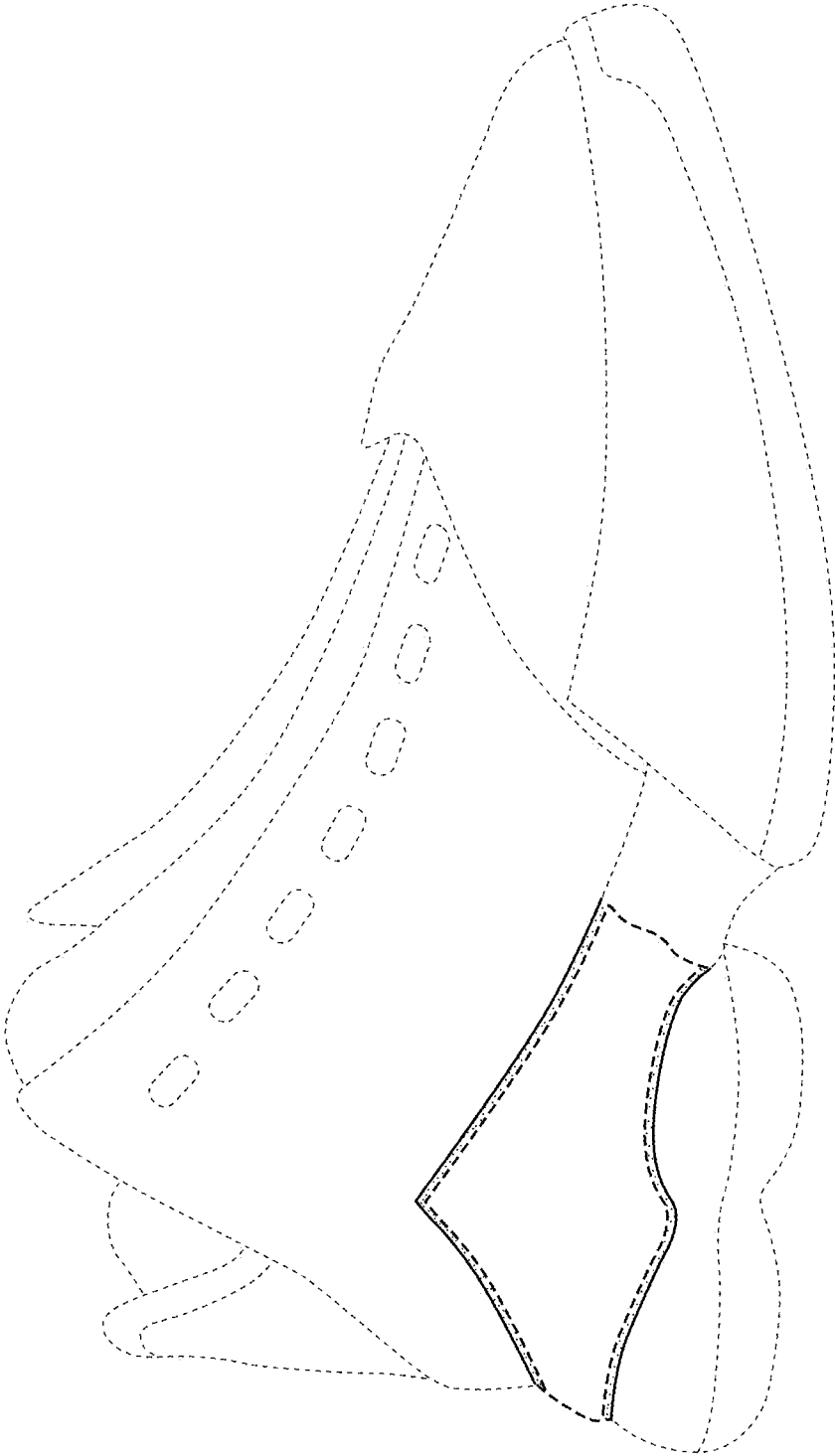

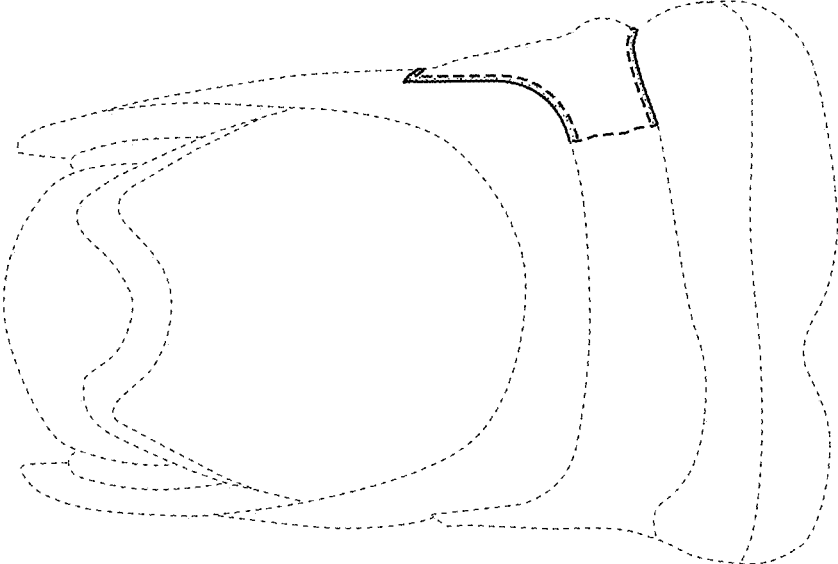
