mobiles of FIG. 1.

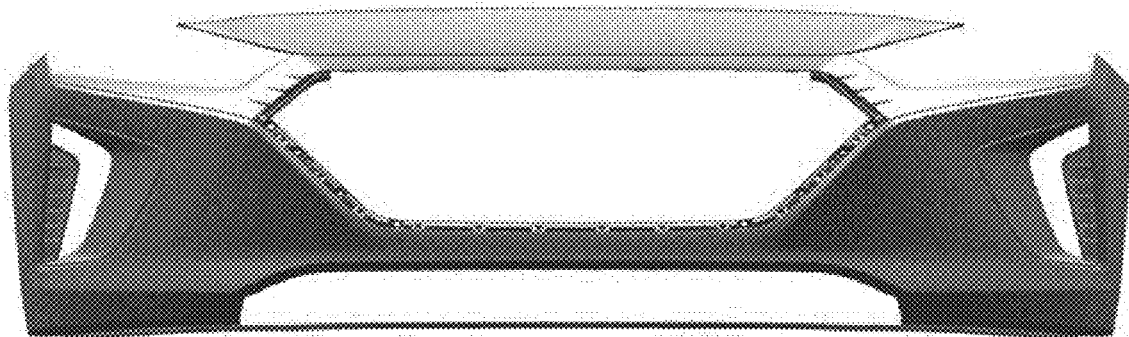
FIG. 4 is a left side view of the front bumper cover for

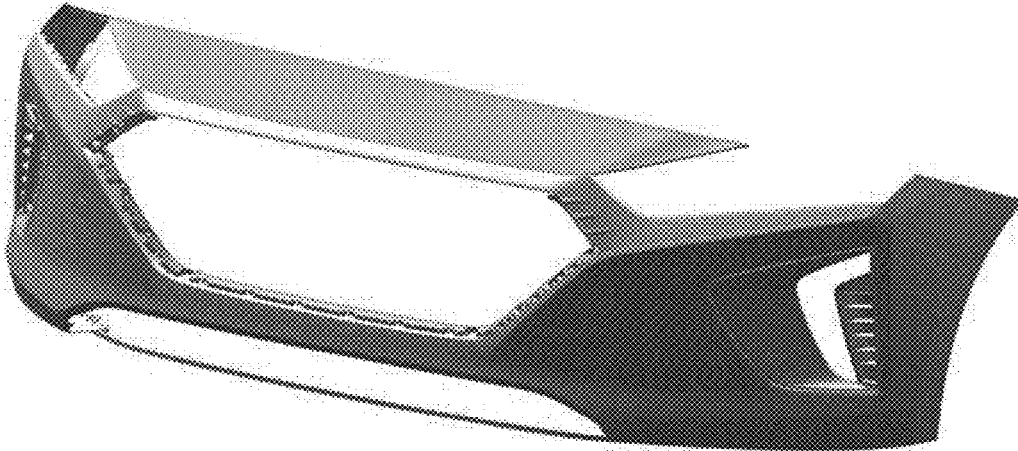

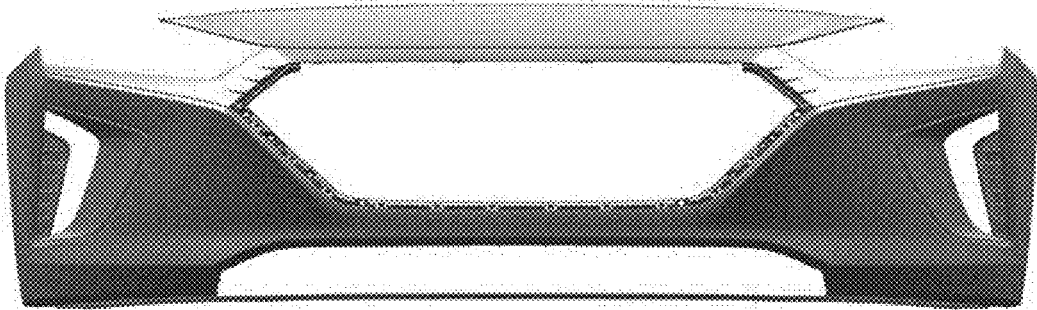

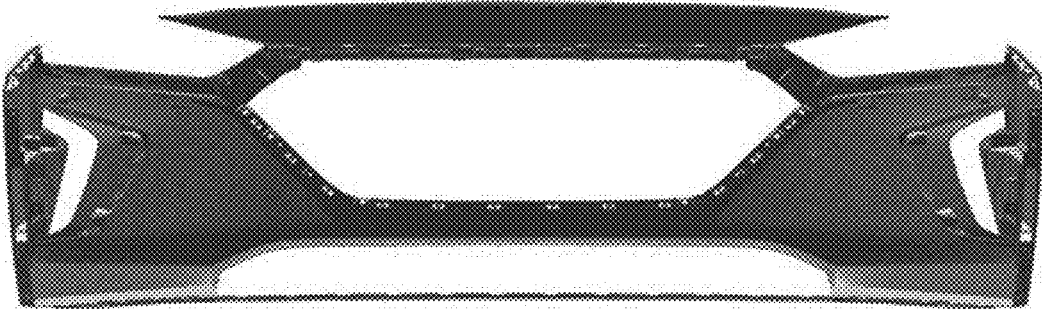

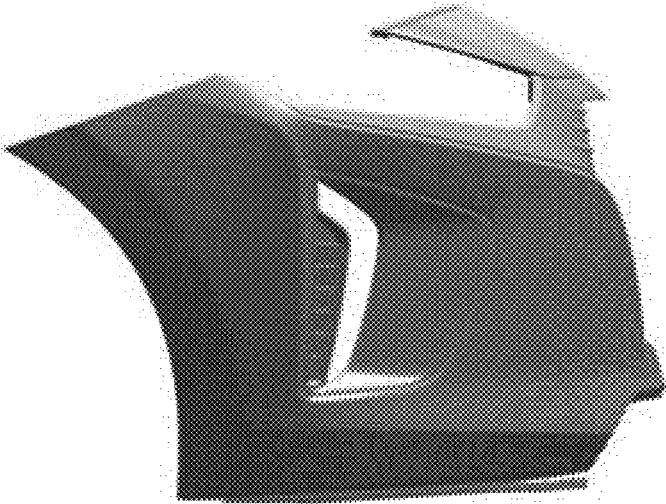

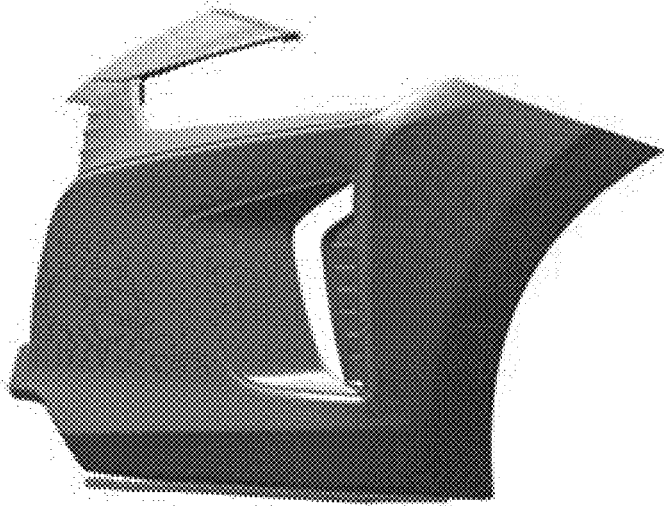

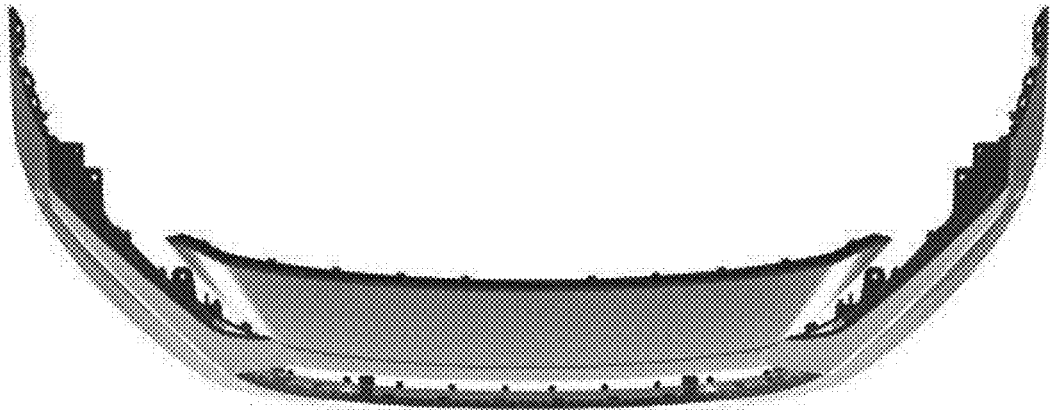
