FIG. 13 is a perspective view of a fourth embodiment of a dispensing bottle and cap in combination according to the present design.

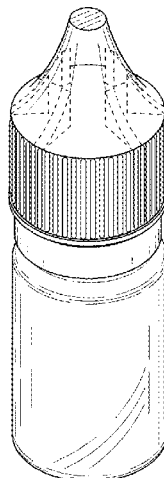
FIG. 14 is an elevation view thereof.

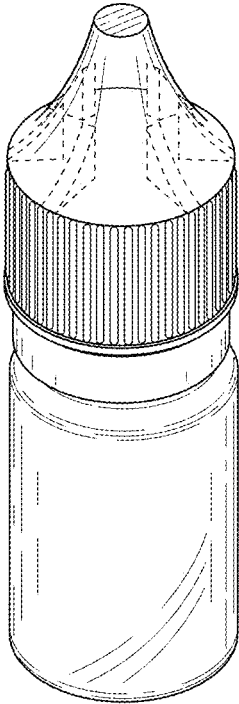

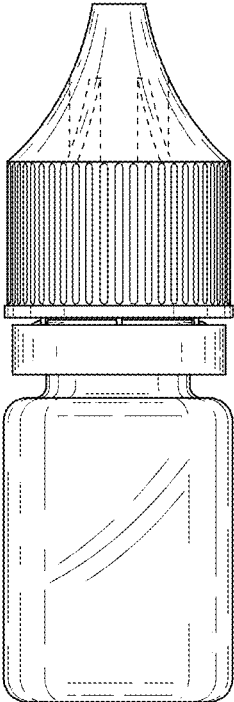

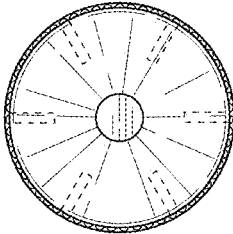

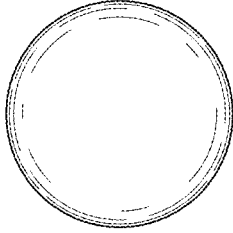

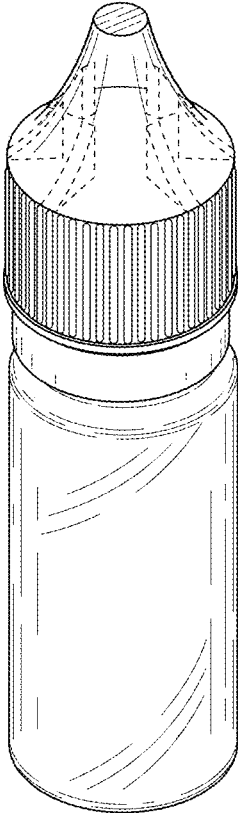

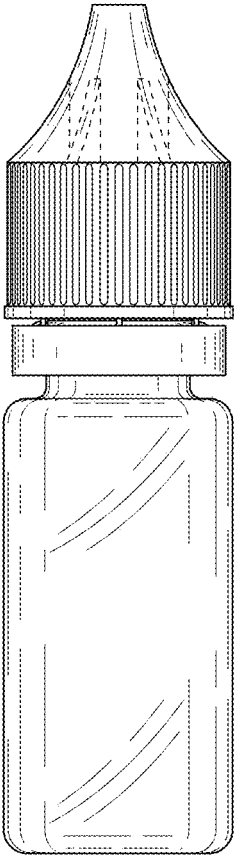

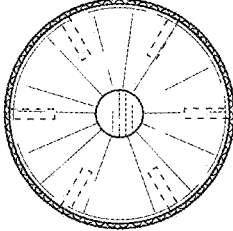

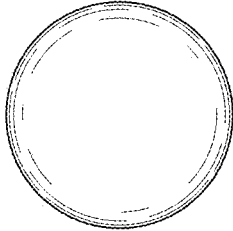

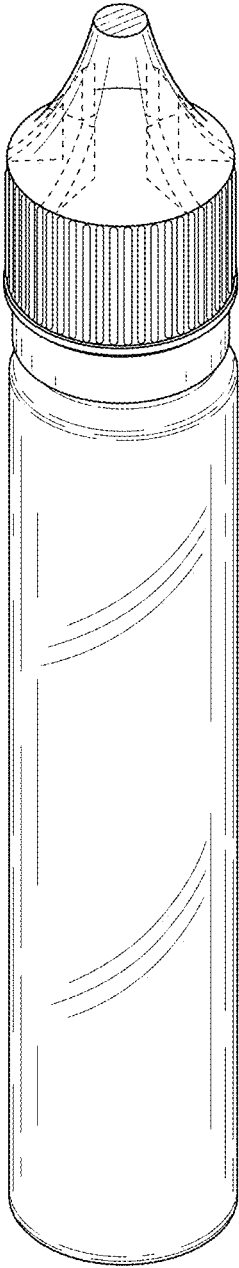

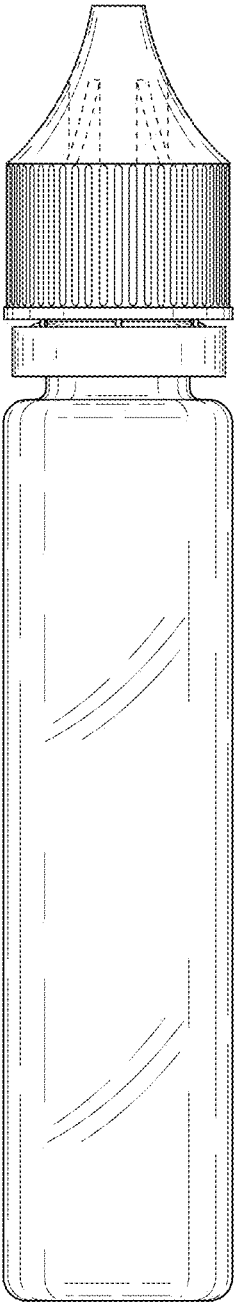

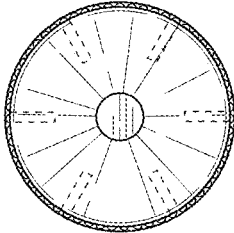

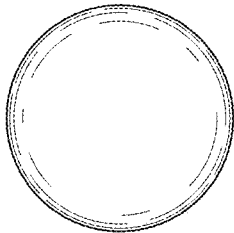

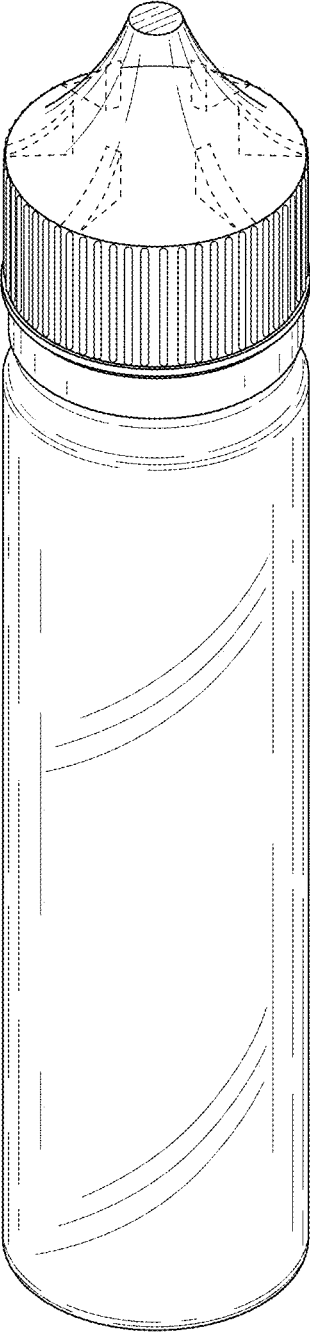

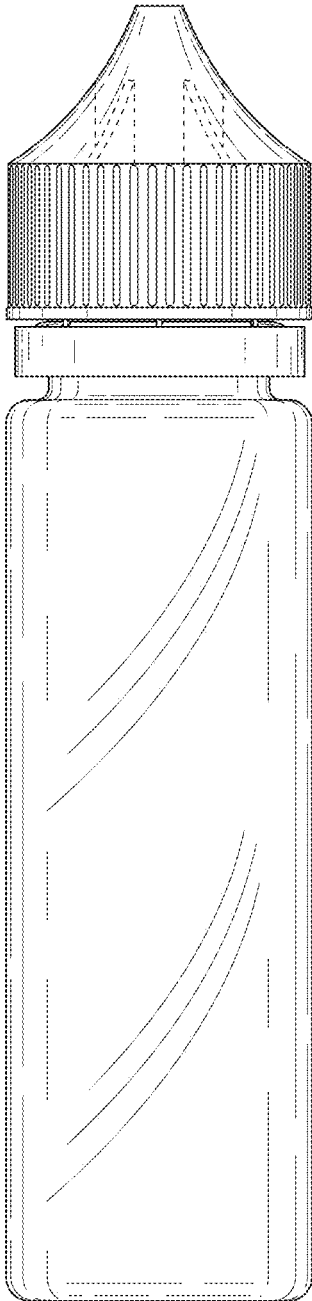




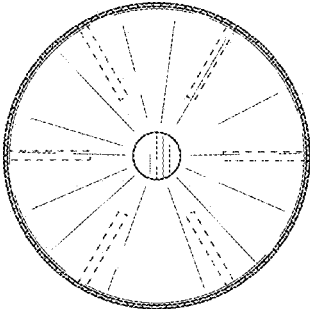
