FIG. 1.

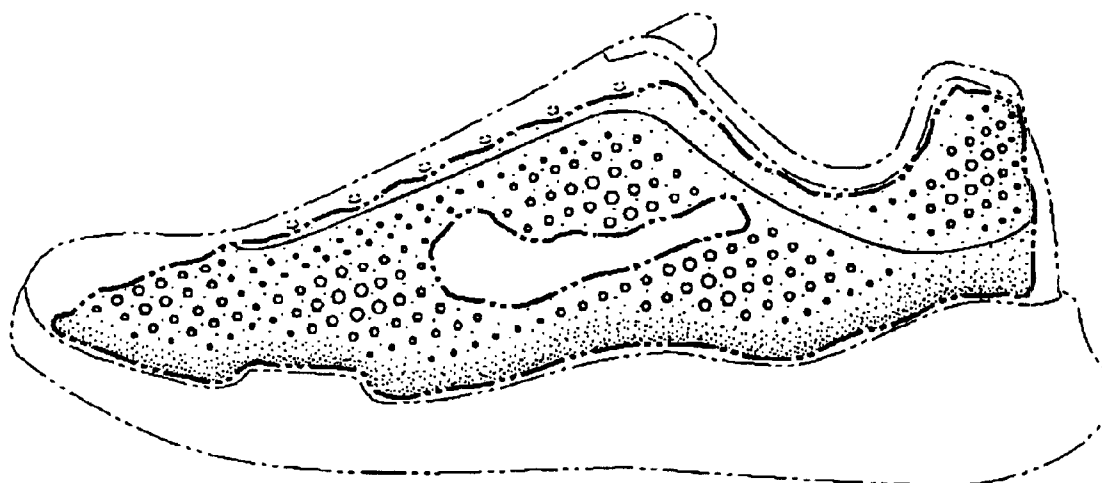
The uneven broken line immediately adjacent to the shaded

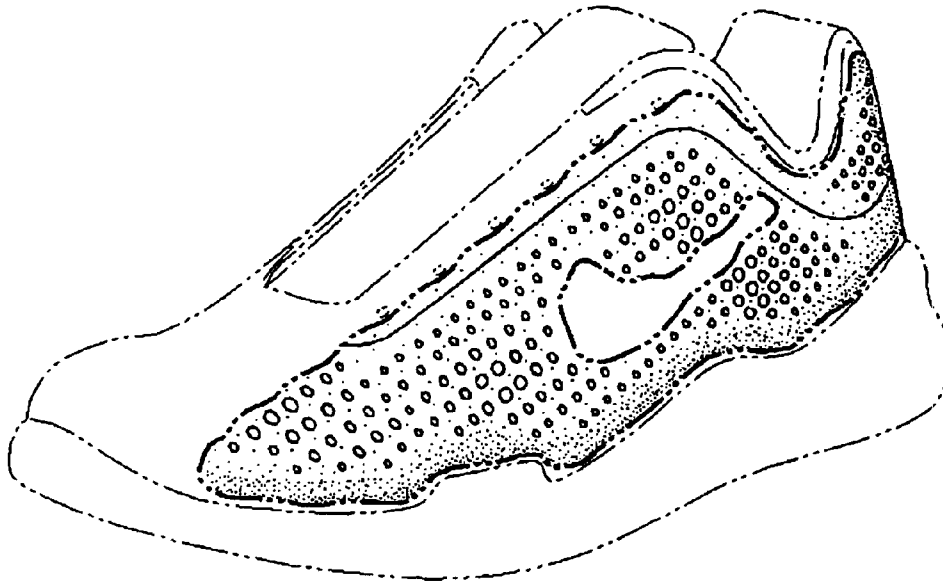

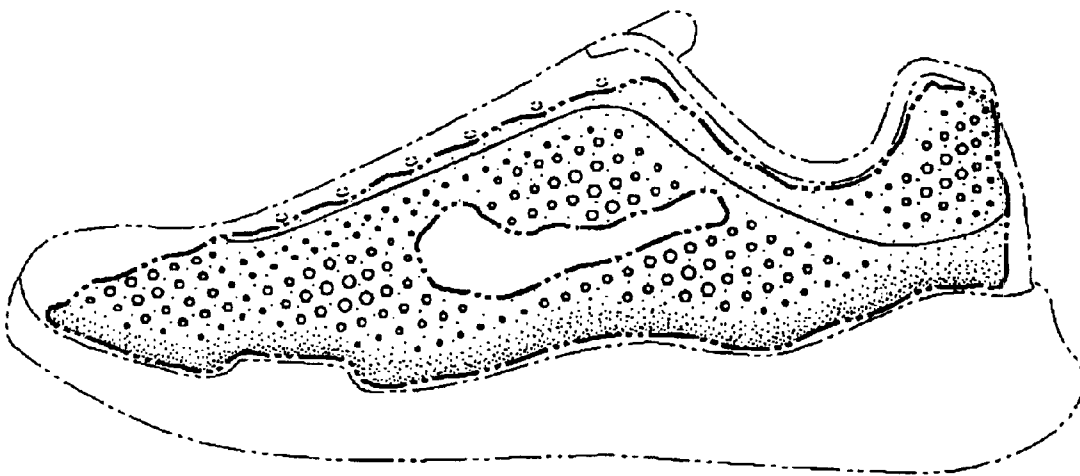

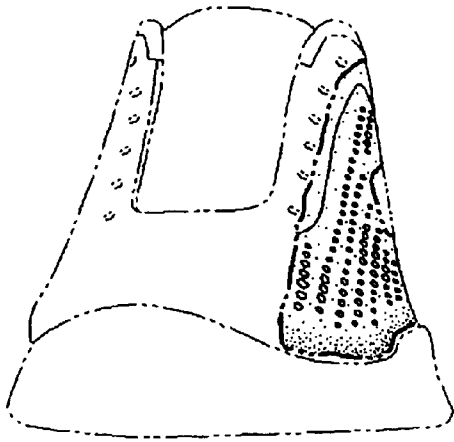

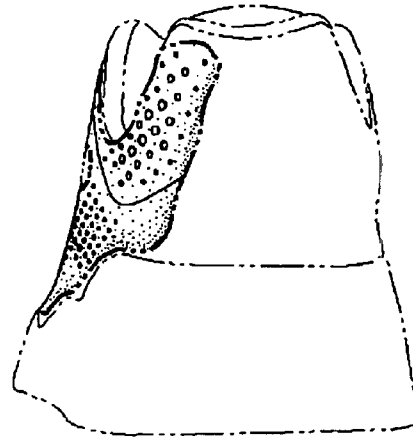

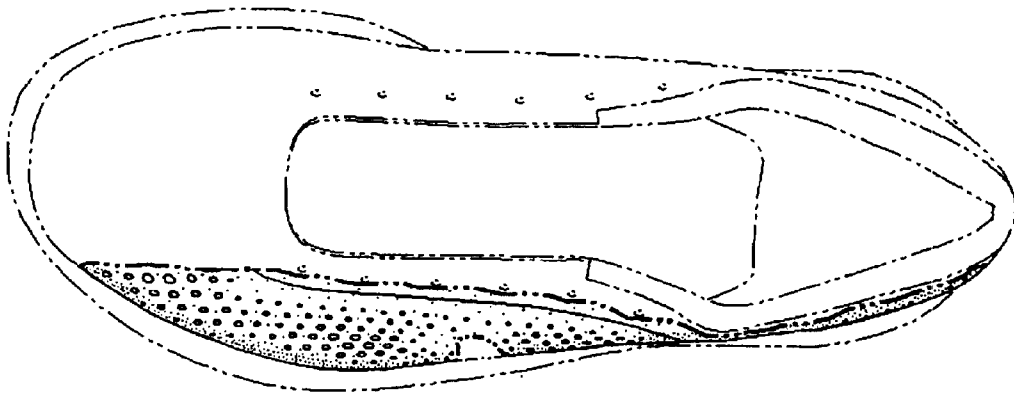
