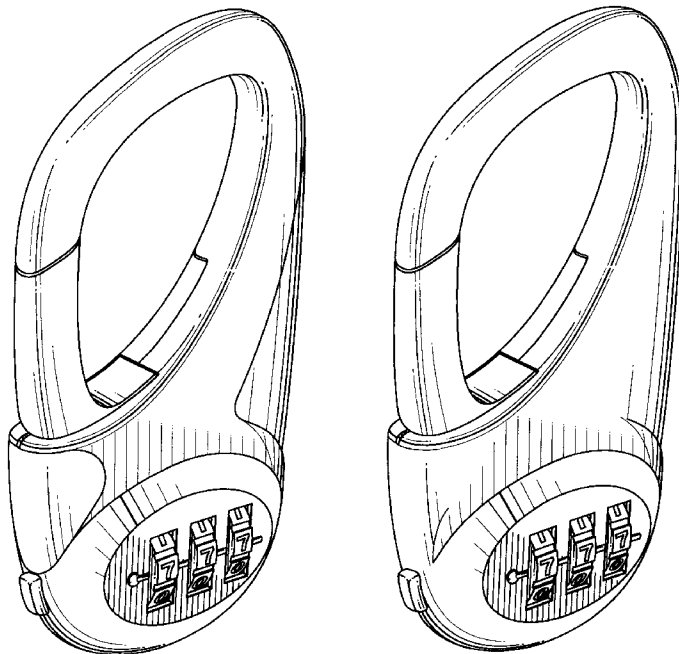

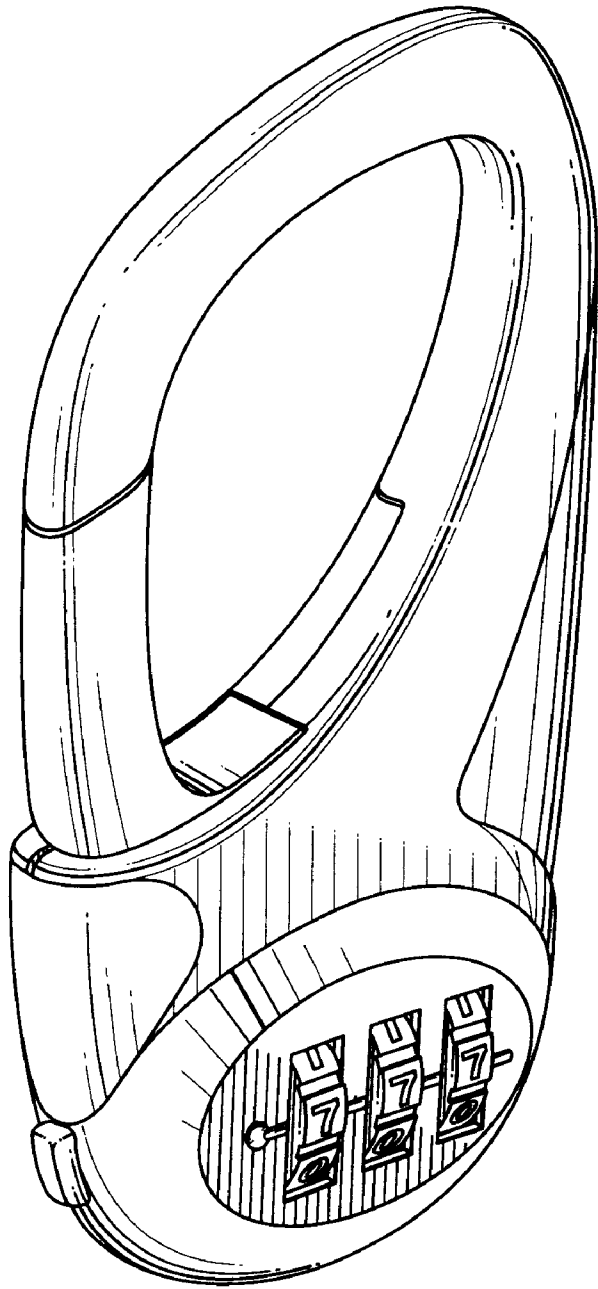
(57) **CLAIM**

I claim the ornamental design for the combination padlock, as shown and described.

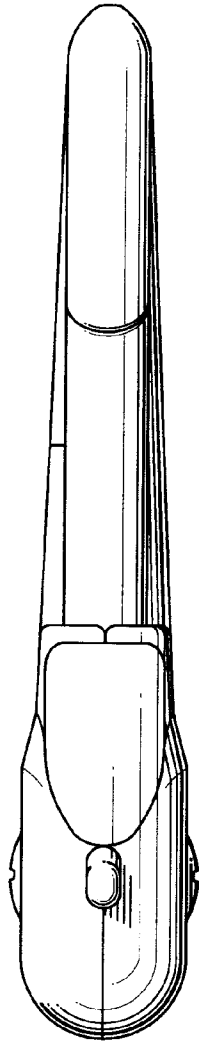

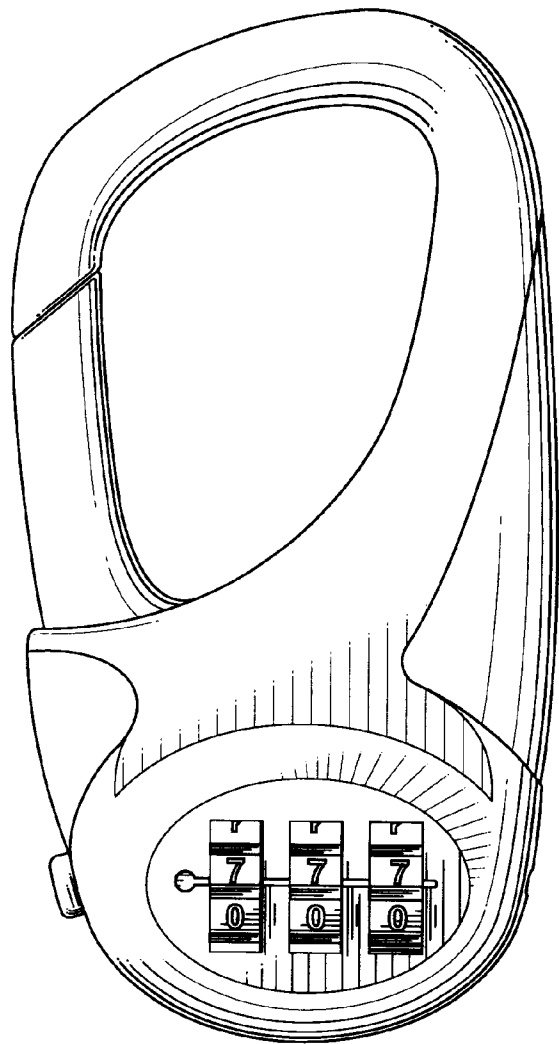




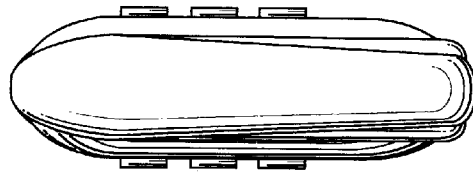

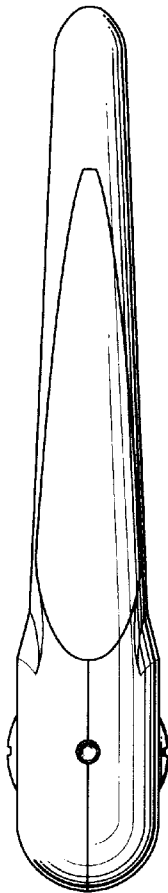

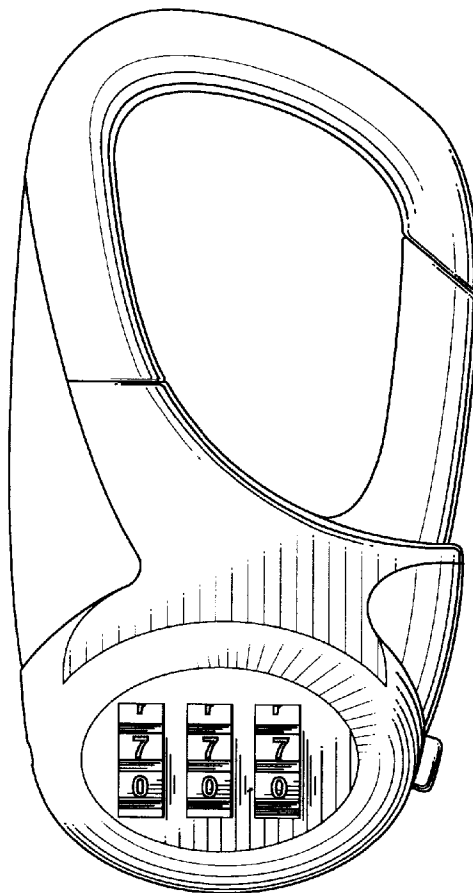

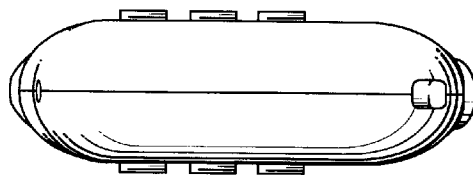

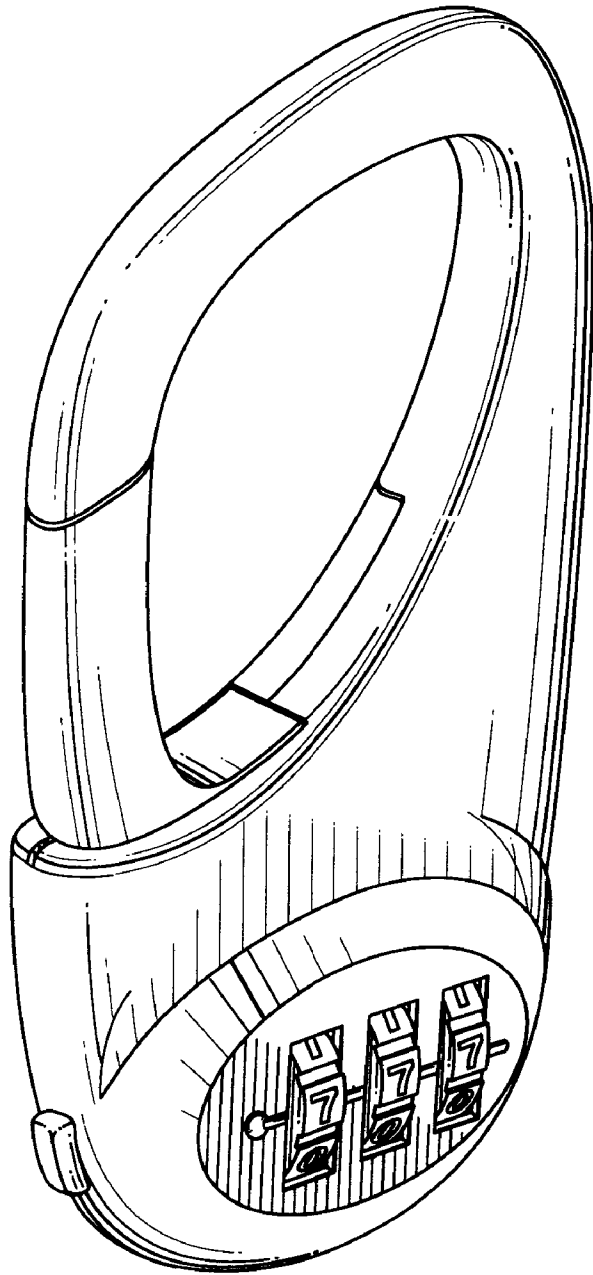

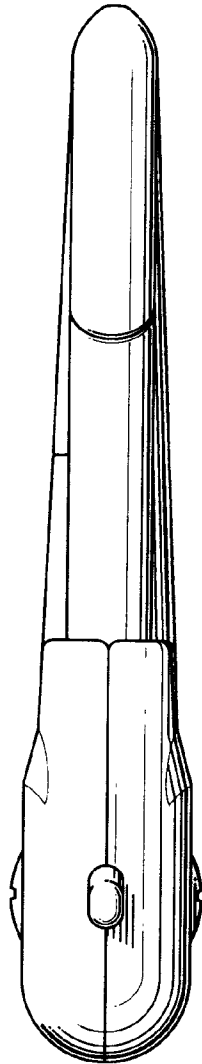

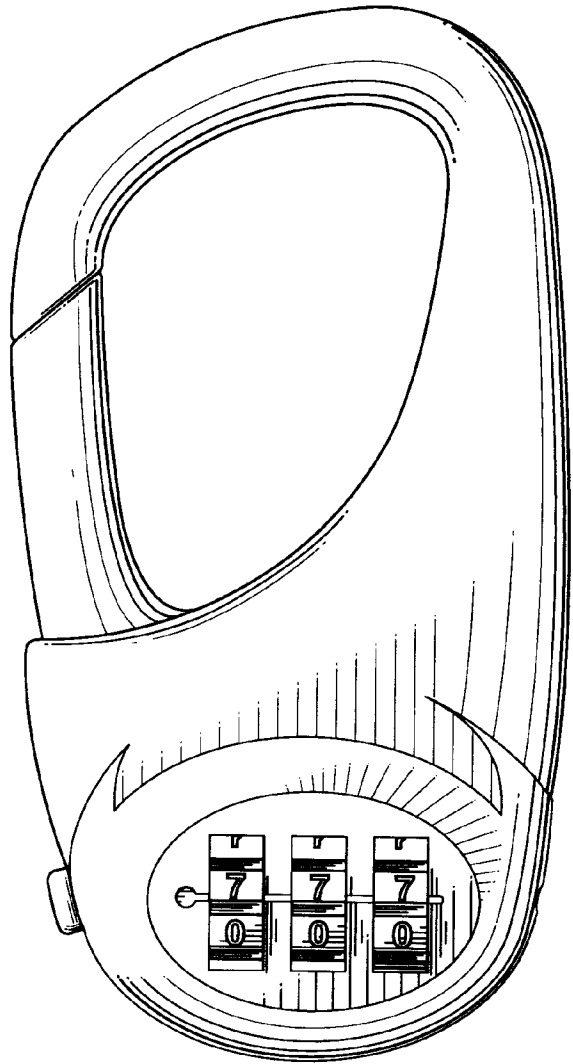

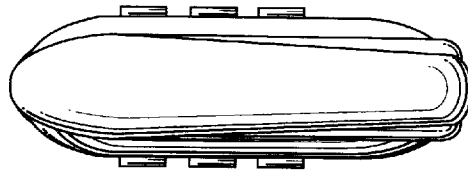

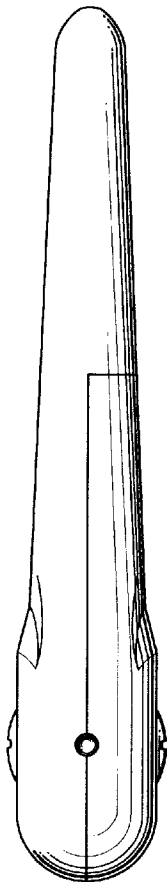

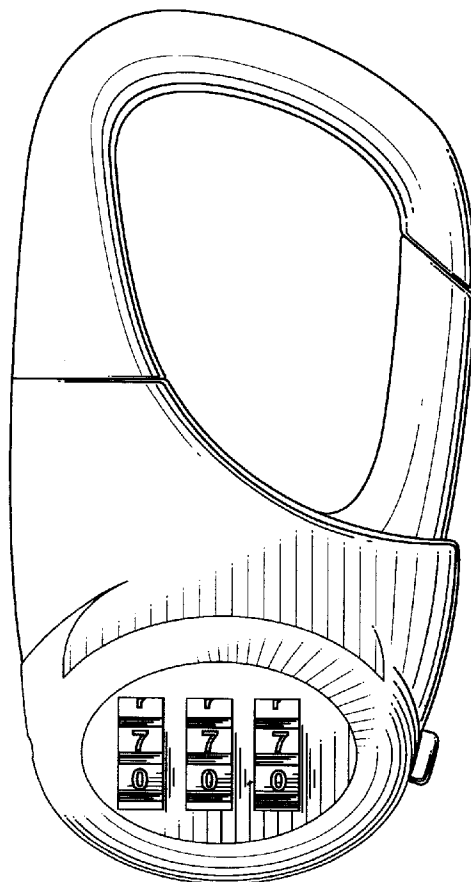

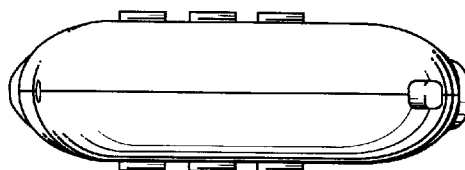
