The ornamental design for a sign support structure, as shown and described.

# DESCRIPTION

FIG. 1 is a front, perspective view of a sign support structure showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a right side view thereof, the left side view being a mirror image of the right side view;




FIG. 5 is a cross-sectional view taken along the line 5-5 in

FIG. 24 is a right side view thereof, the left side view being a mirror image of the right side view;


FIG. 25 is a top view thereof; and


FIG. 26 is a bottom view; and,


























