DESCRIPTION

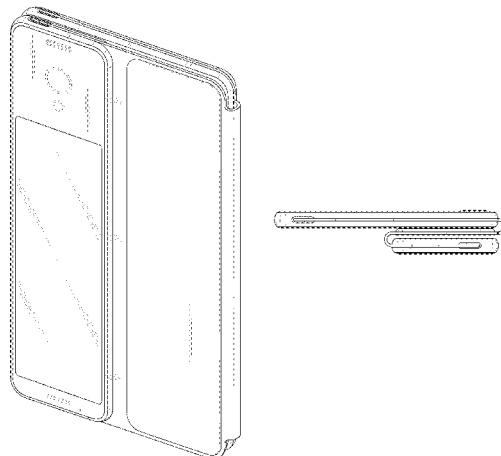


FIG. 11 is a top plan view of the electronic device in a fourth folded position.

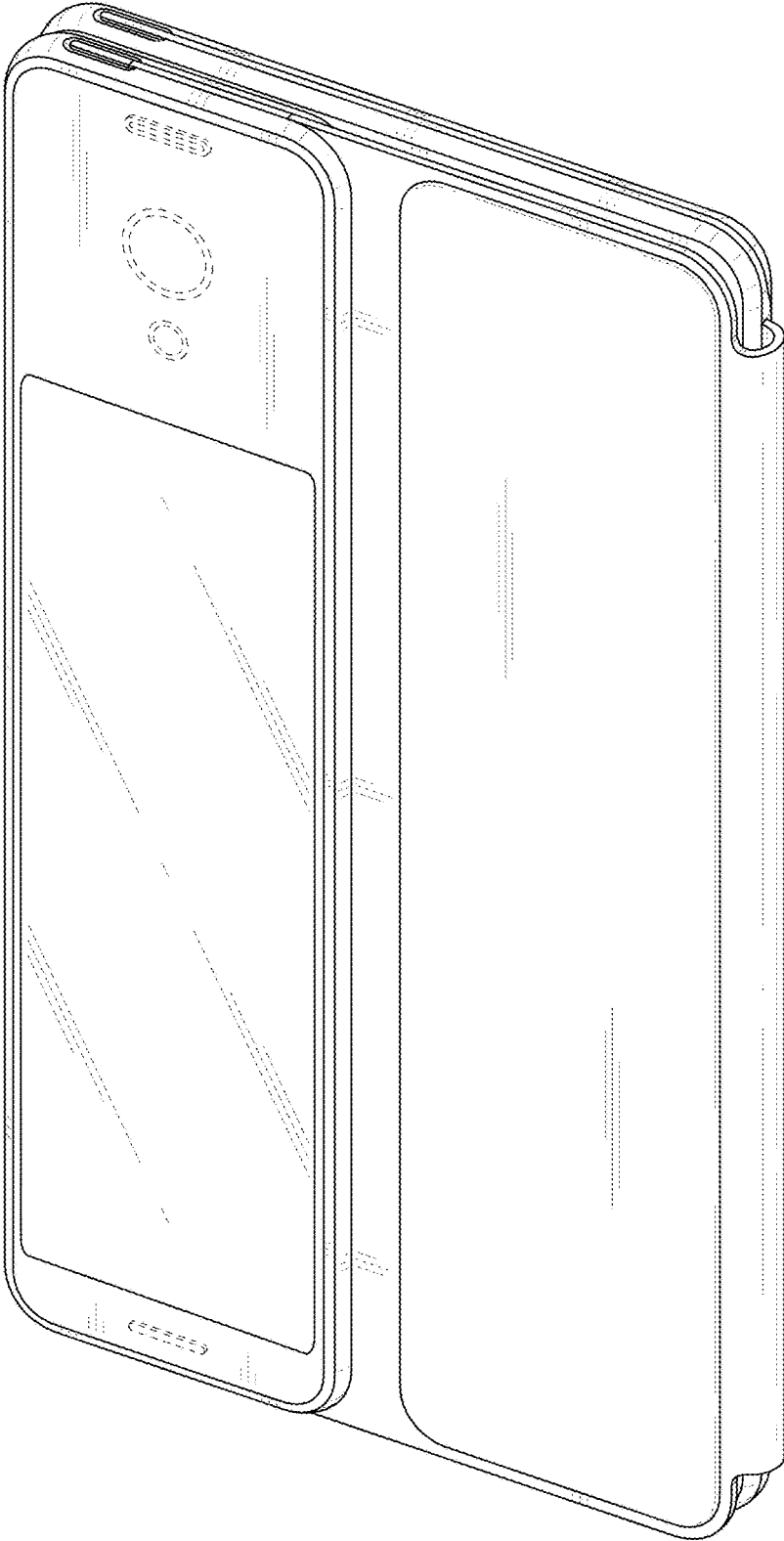

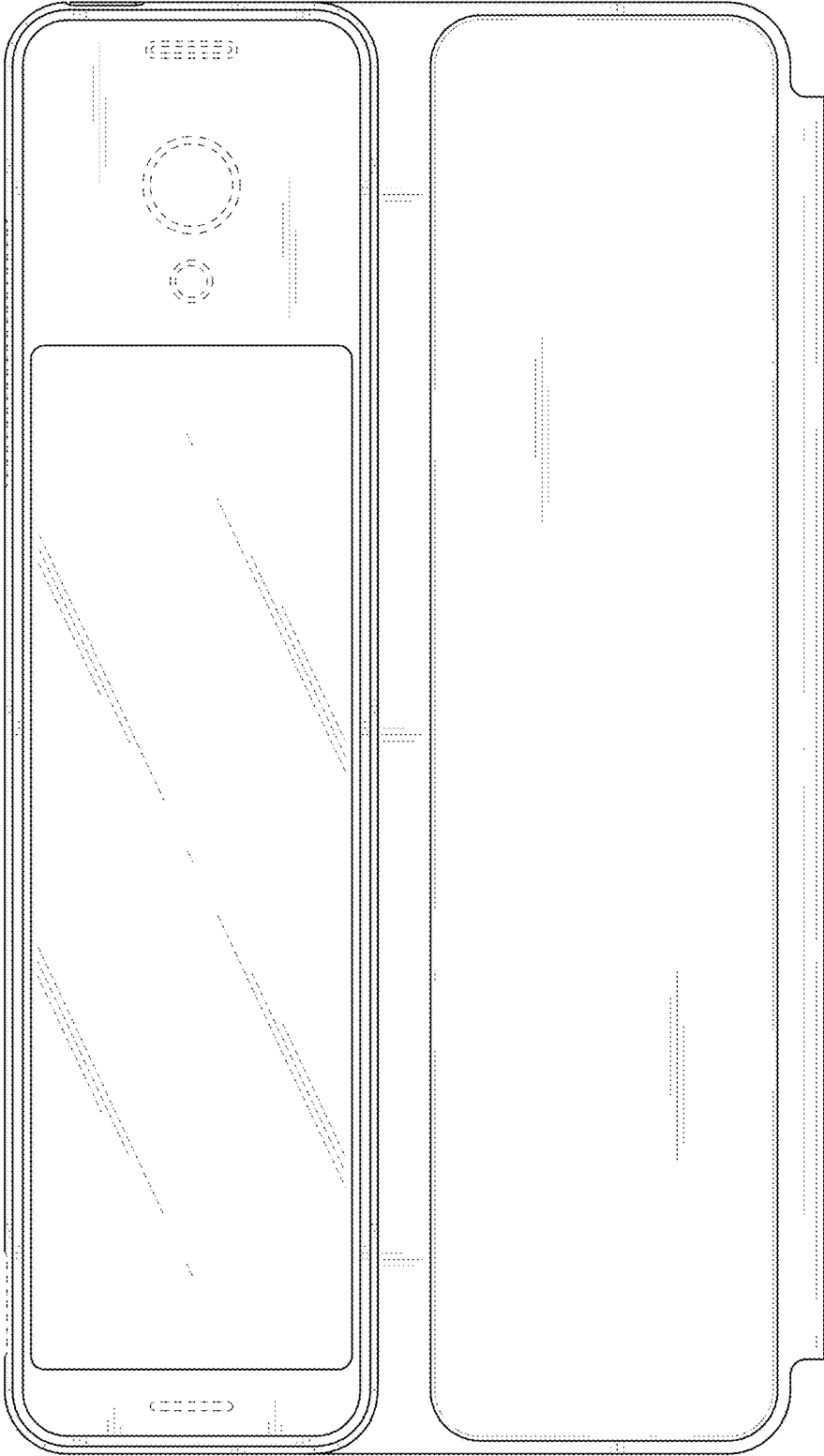

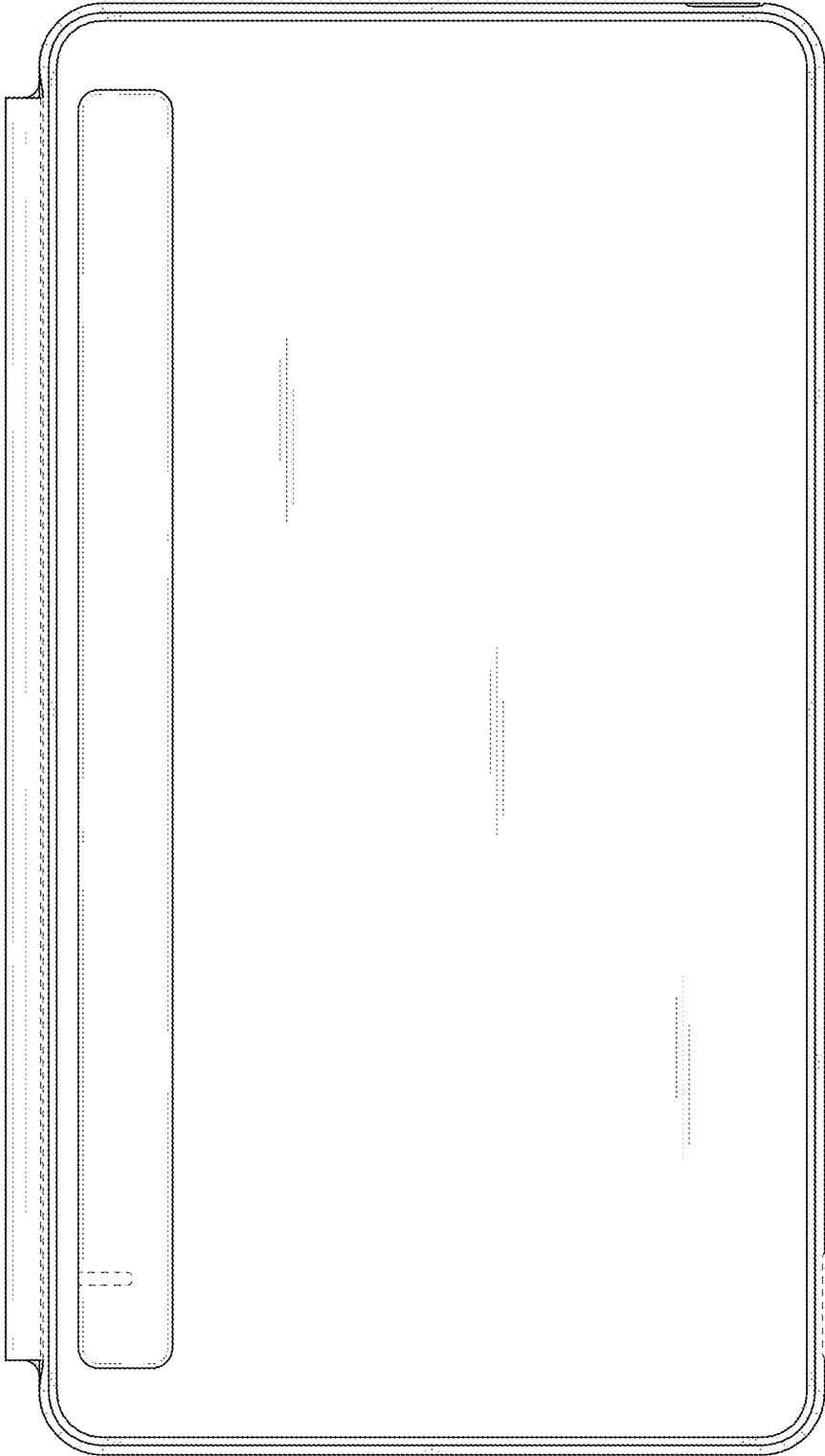

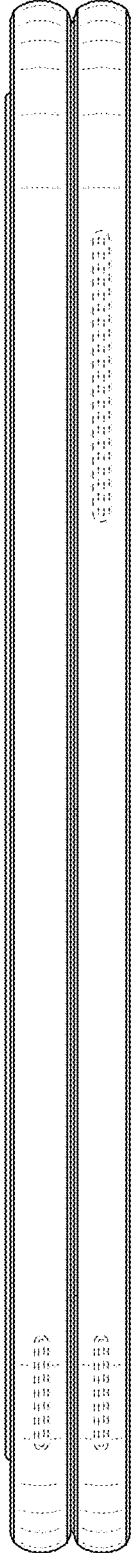

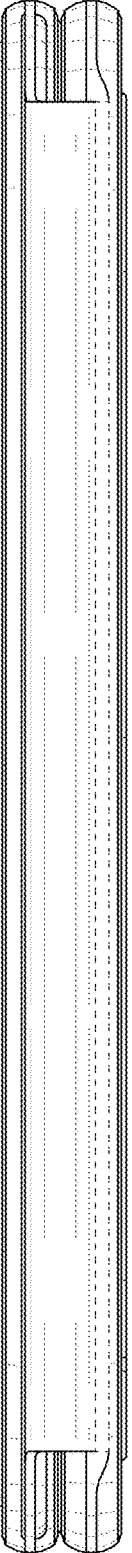

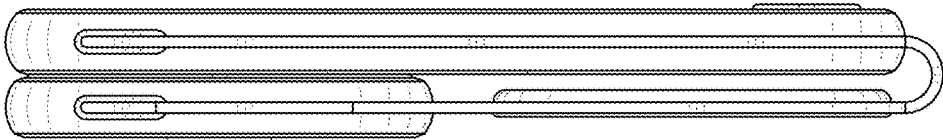

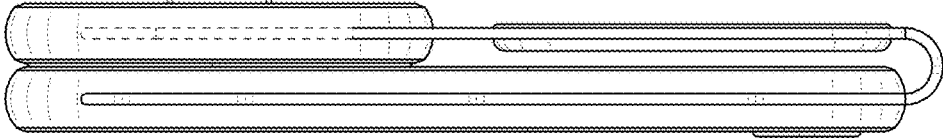

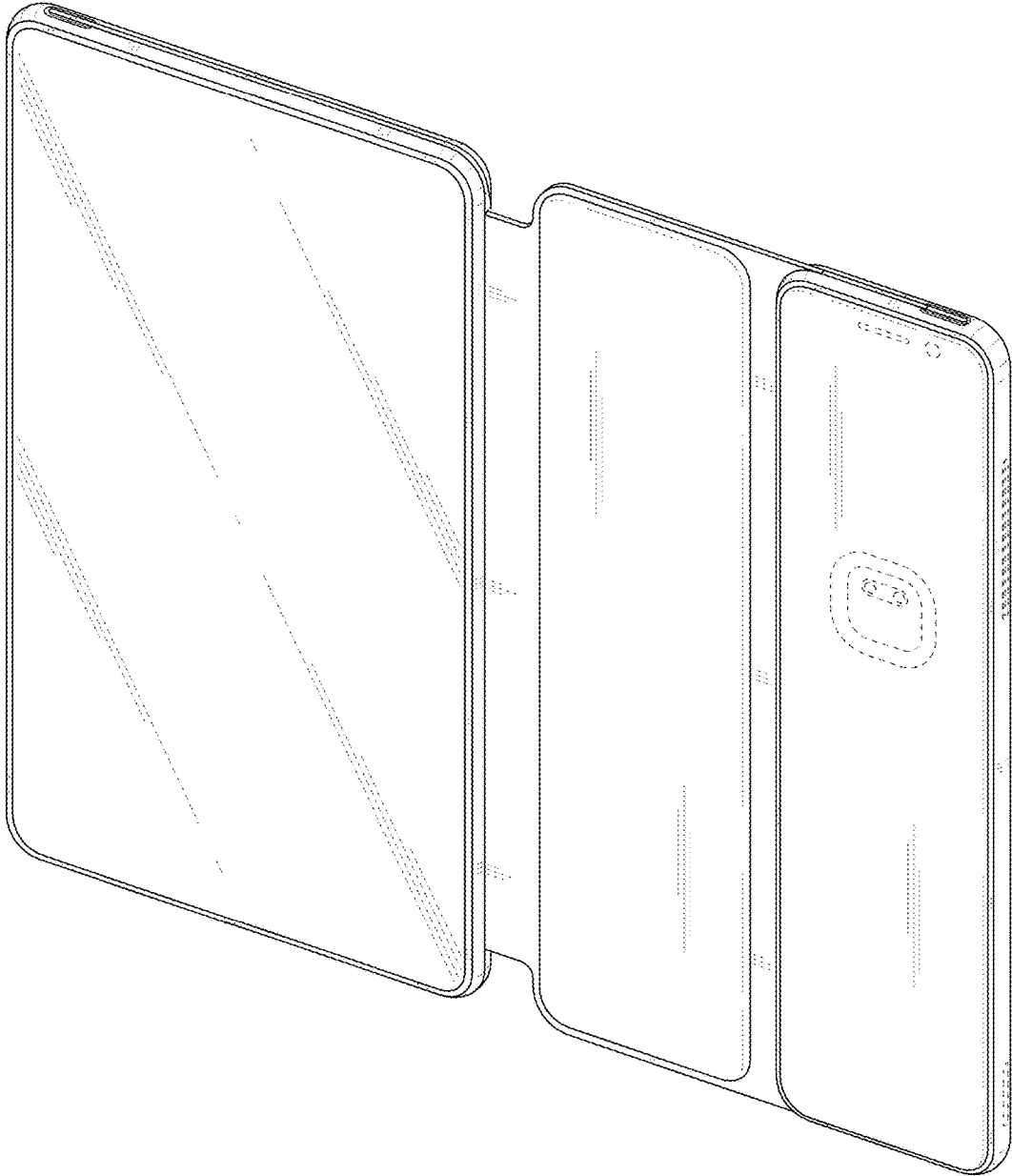

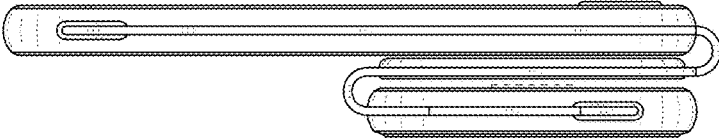

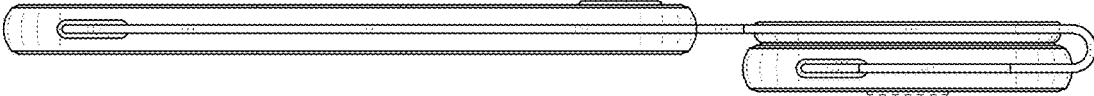
