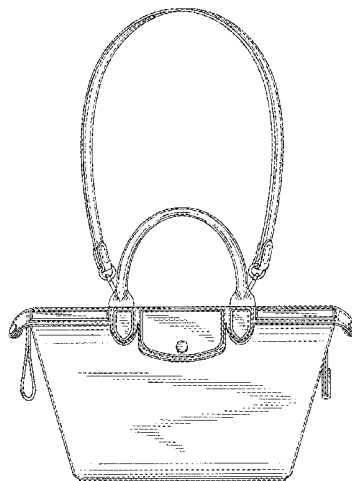

**DESCRIPTION**

FIG. 1 is a front elevational view of the handbag showing our new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a right side elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a rear elevational view thereof; and,  
FIG. 6 is a bottom plan view thereof.

The broken line showing of supporting legs at the bottom of the handbag and clip connections at the handles represent unclaimed subject matter and form no part of the claimed design. The remaining broken lines represent stitching, and form part of the claimed design.

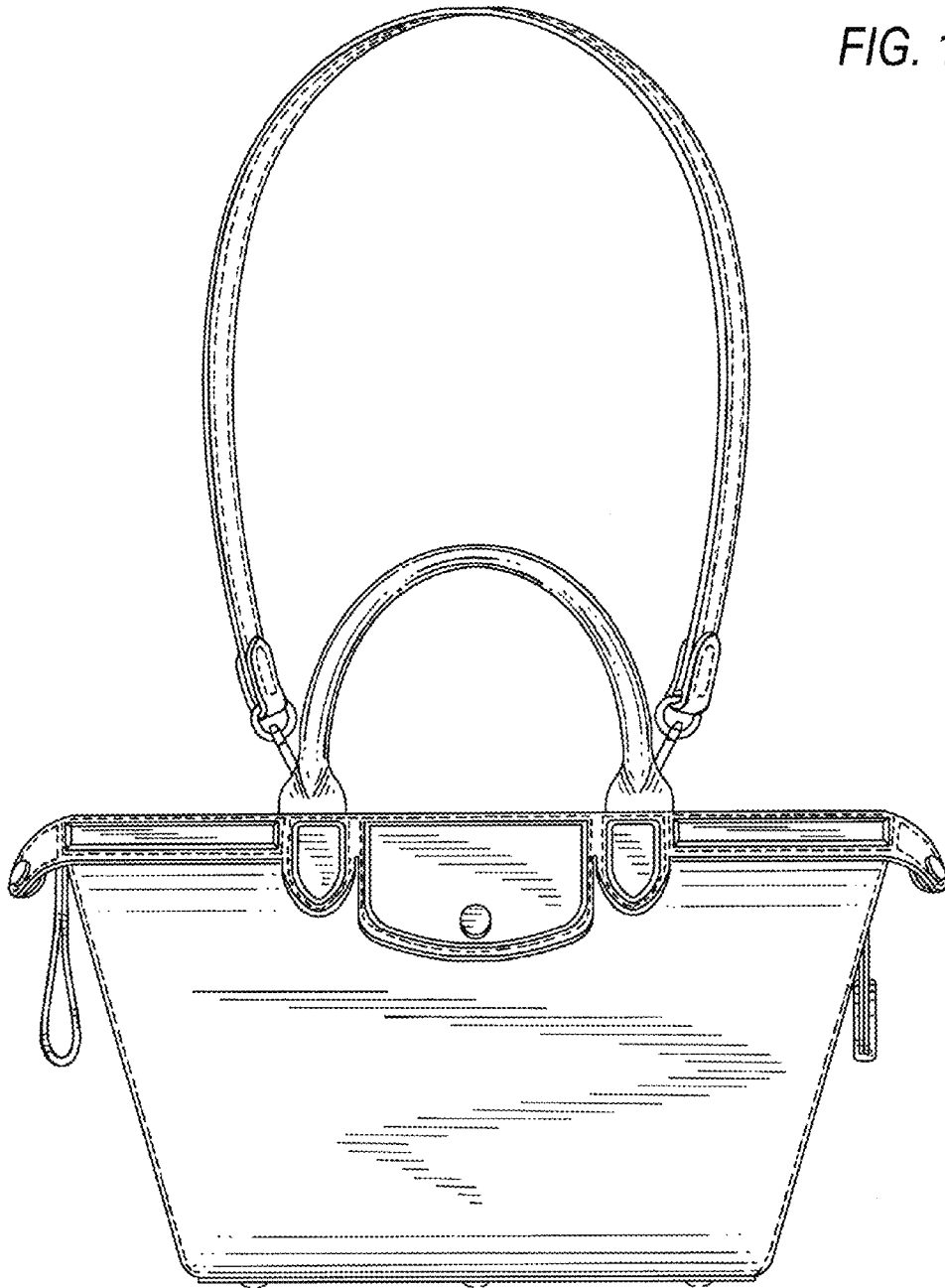

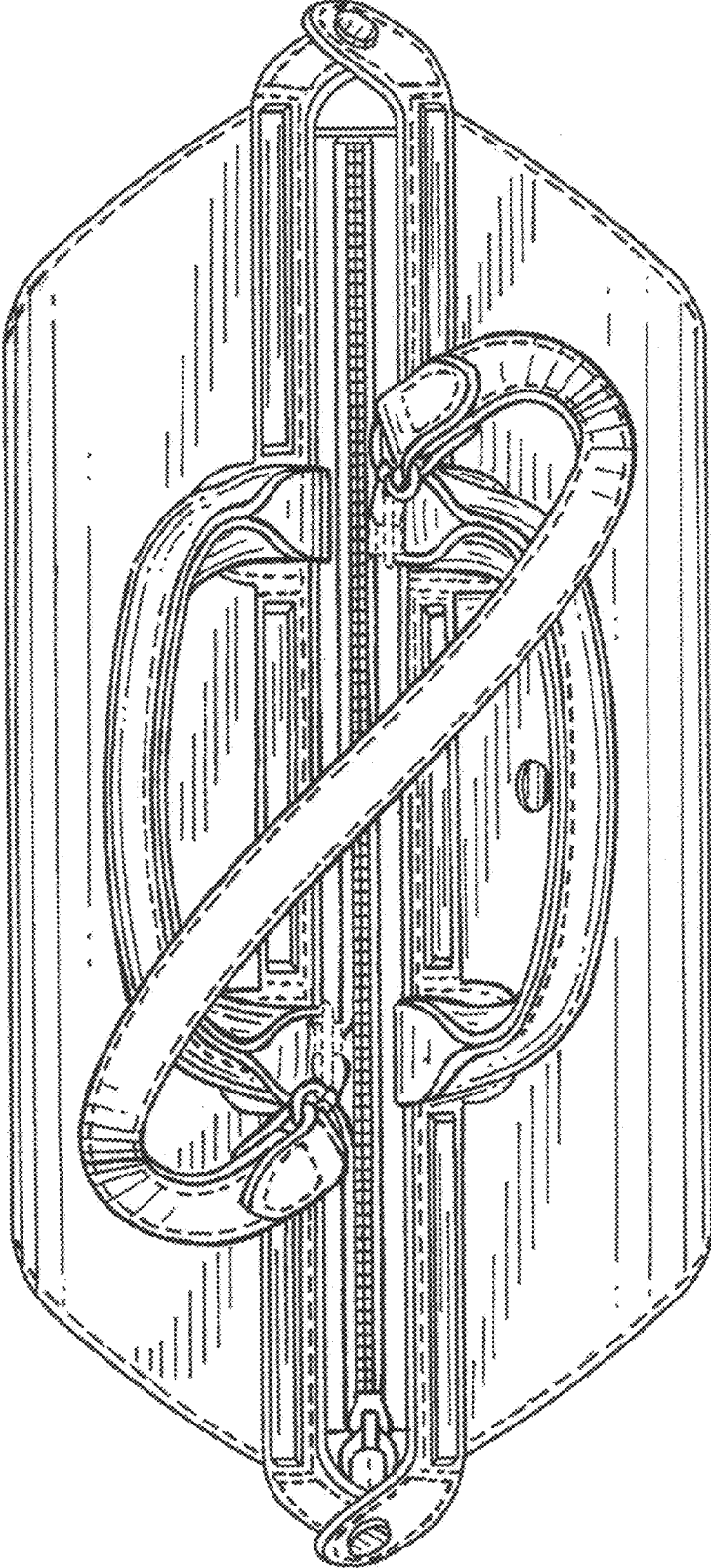

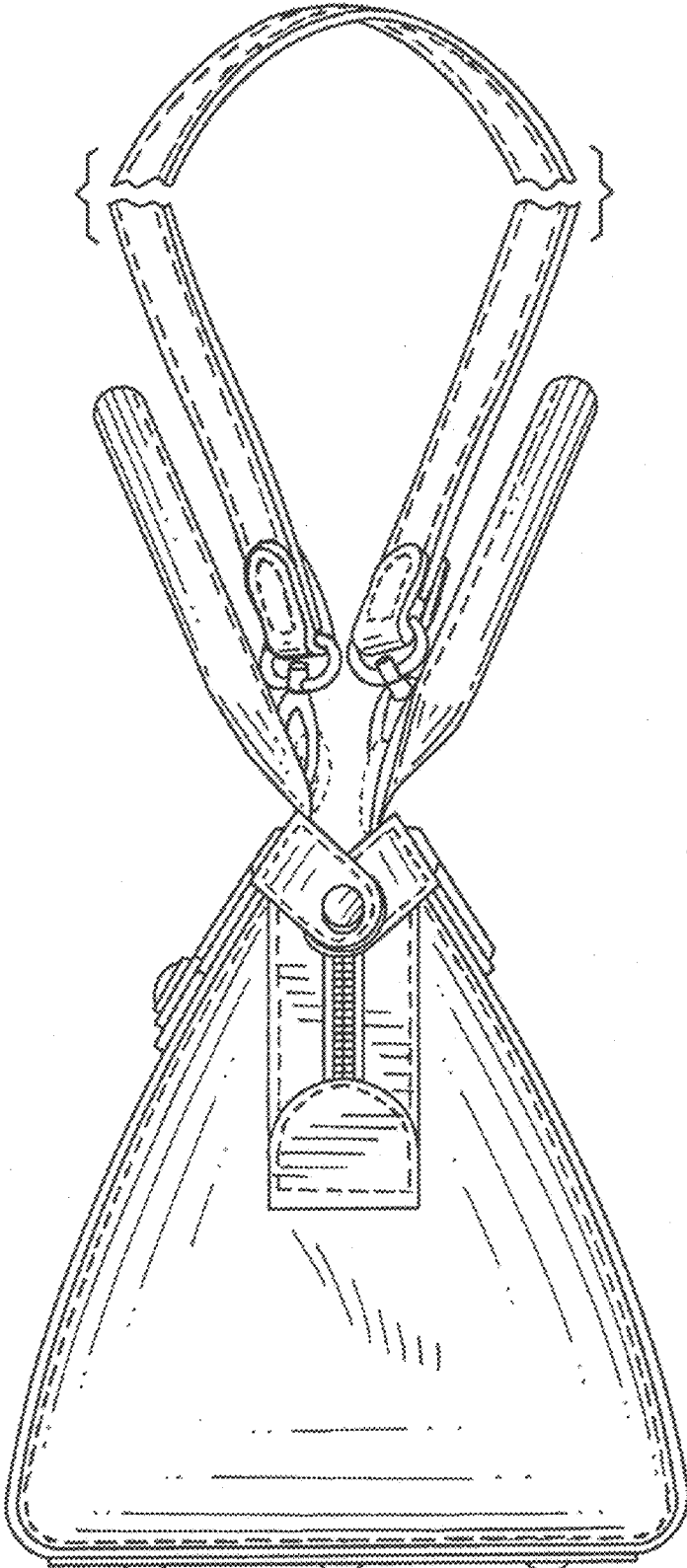

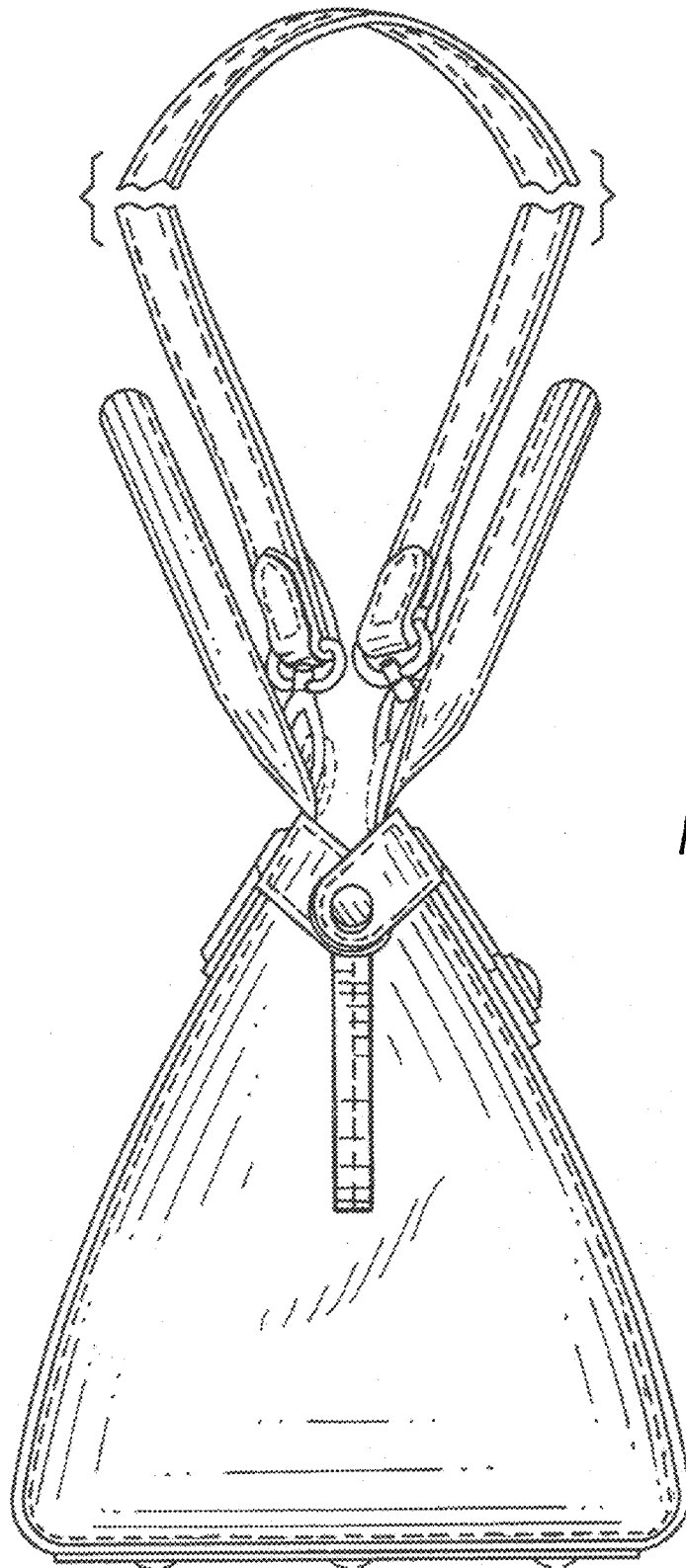
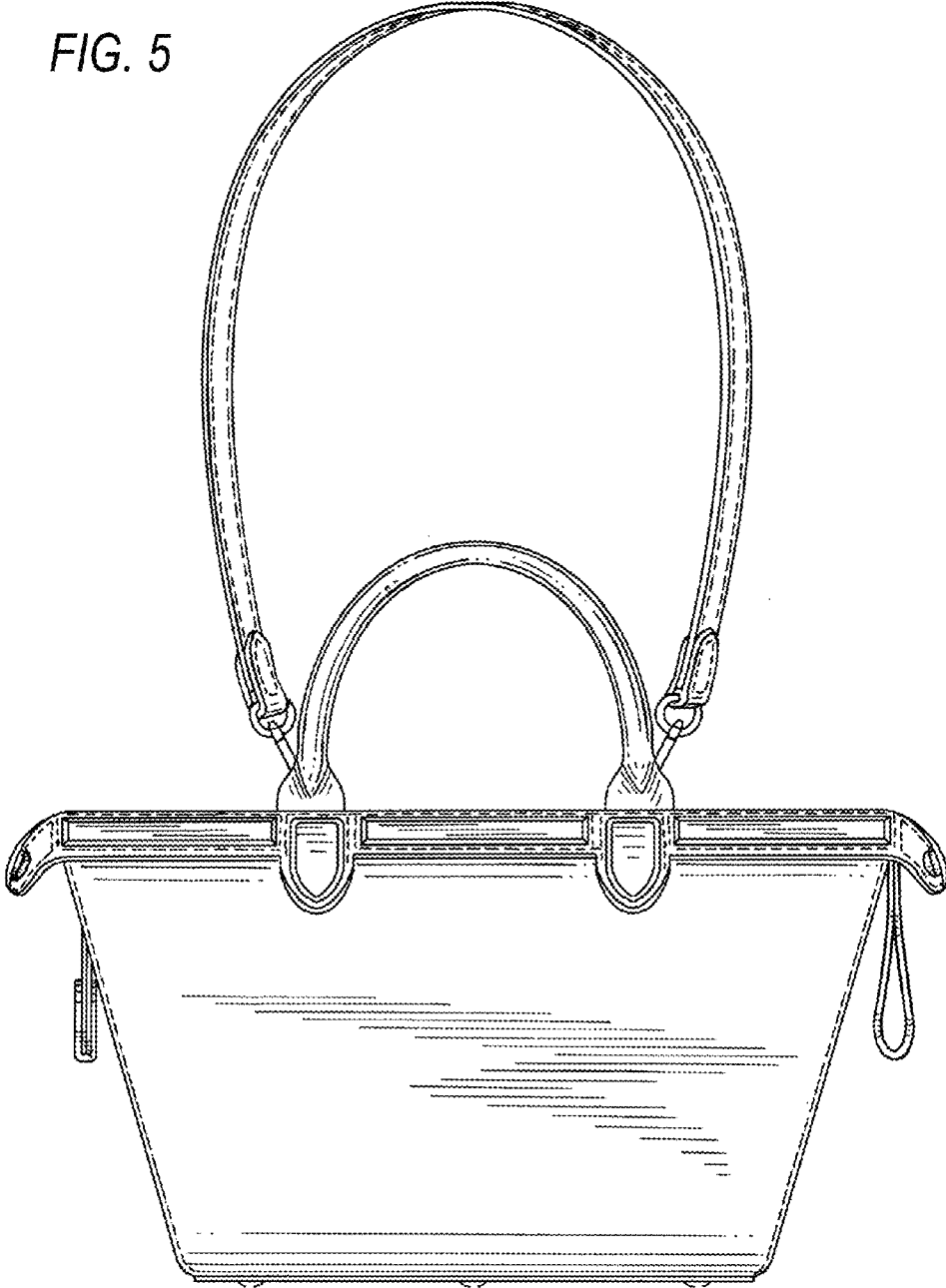

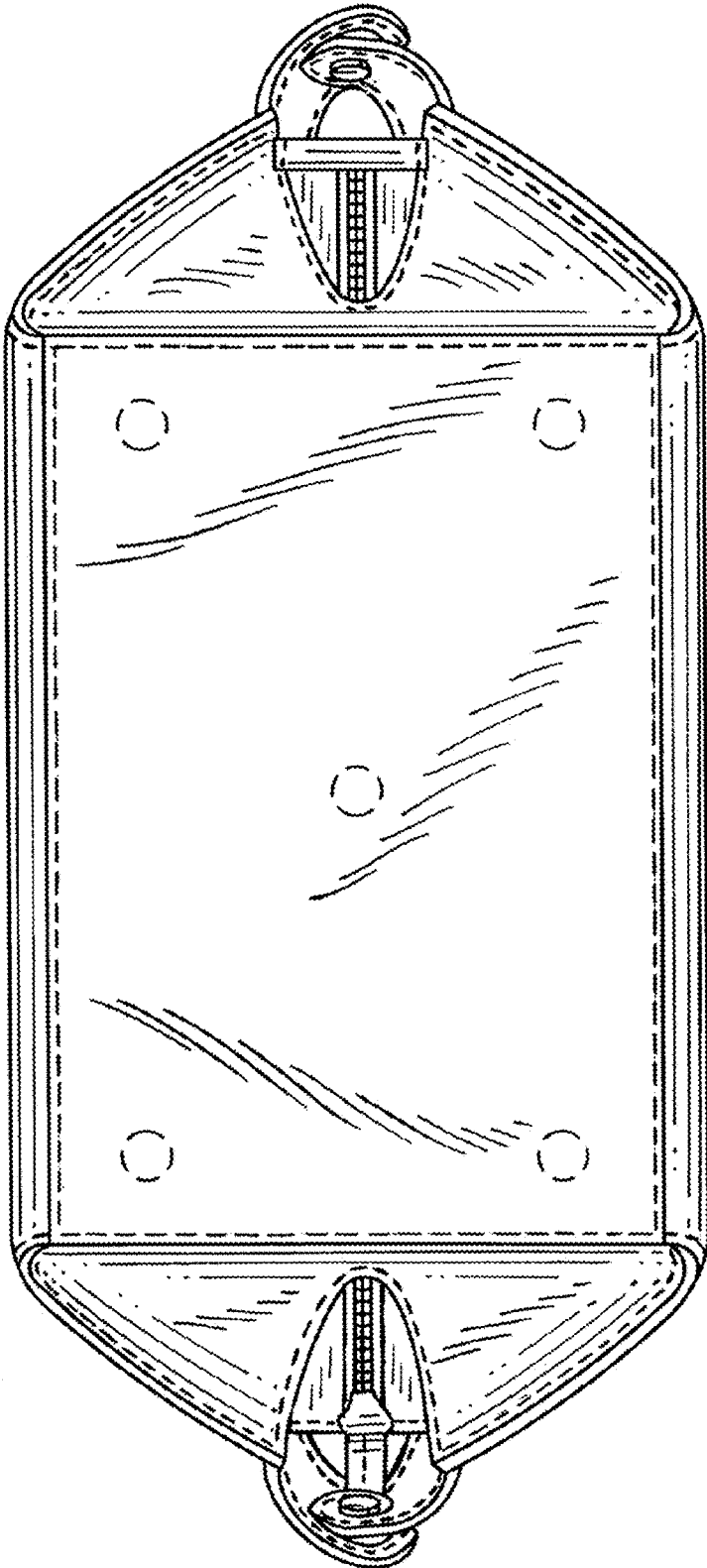
