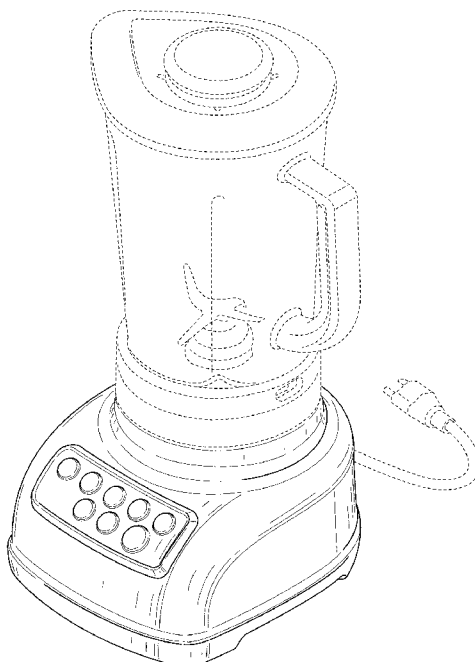
(57) **CLAIM**

We claim the ornamental design for a blender base, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a blender base showing our new design;
FIG. 2 is a front elevational view of the blender base of FIG. 1;
FIG. 3 is a rear elevational view of the blender base of FIG. 1;
FIG. 4 is a first side elevational view of the blender base of FIG. 1;
FIG. 5 is a second side elevational view of the blender base of FIG. 1;
FIG. 6 is a top plan view of the blender base of FIG. 1; and,
FIG. 7 is a bottom plan view of the blender base of FIG. 1.

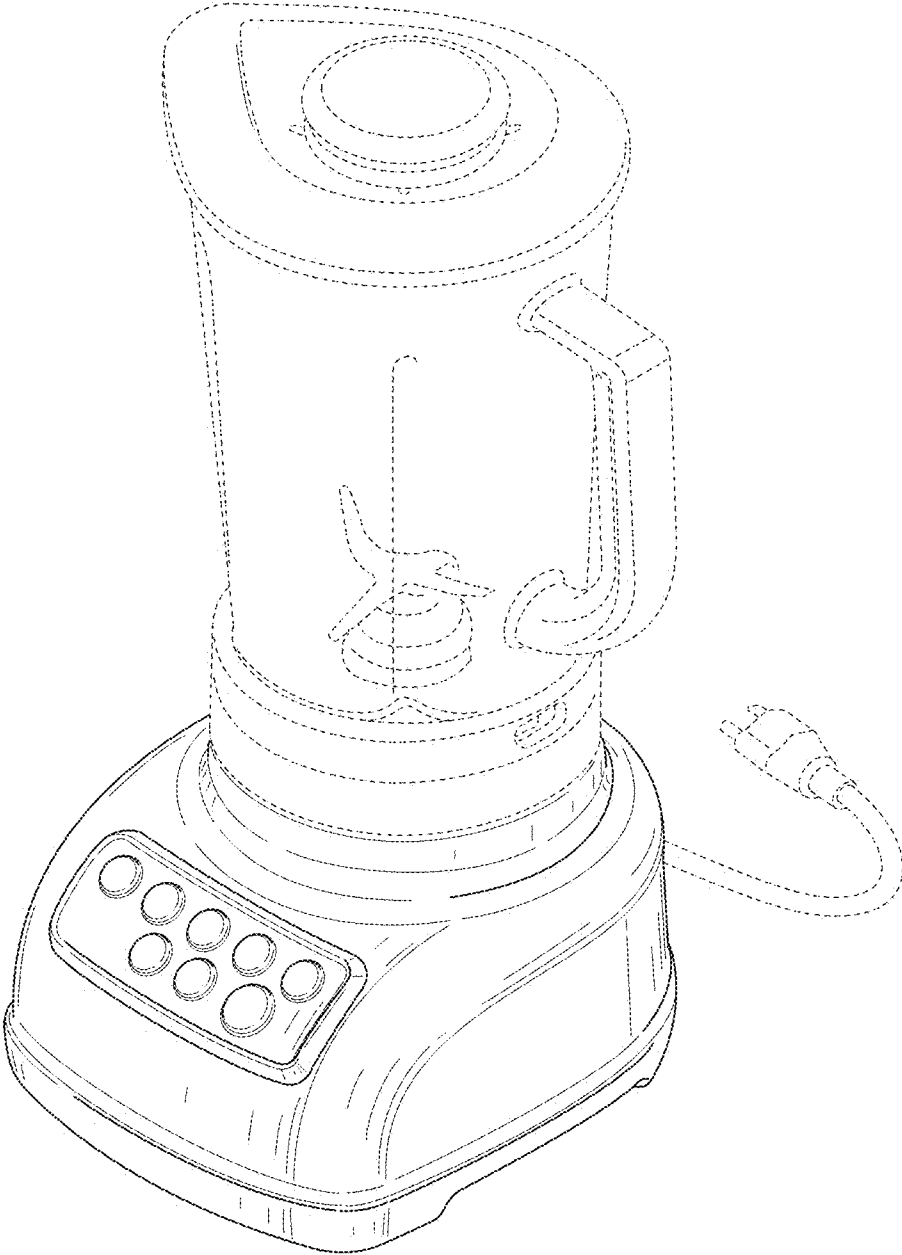

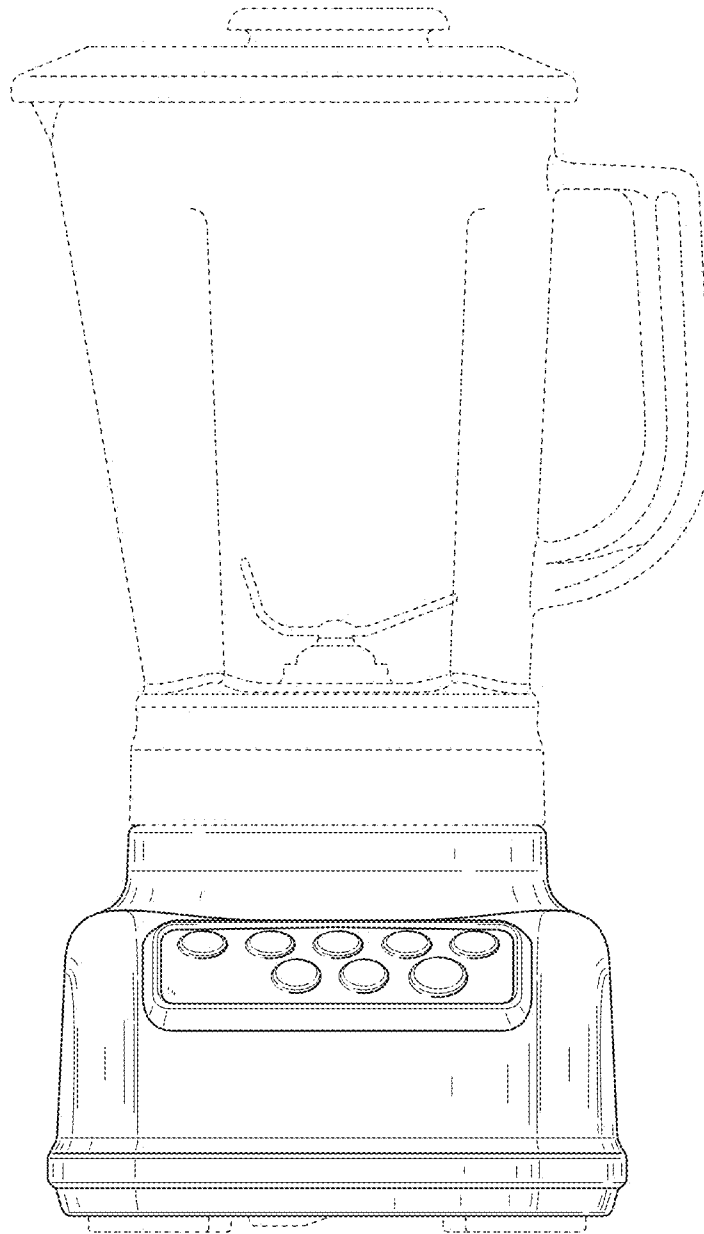

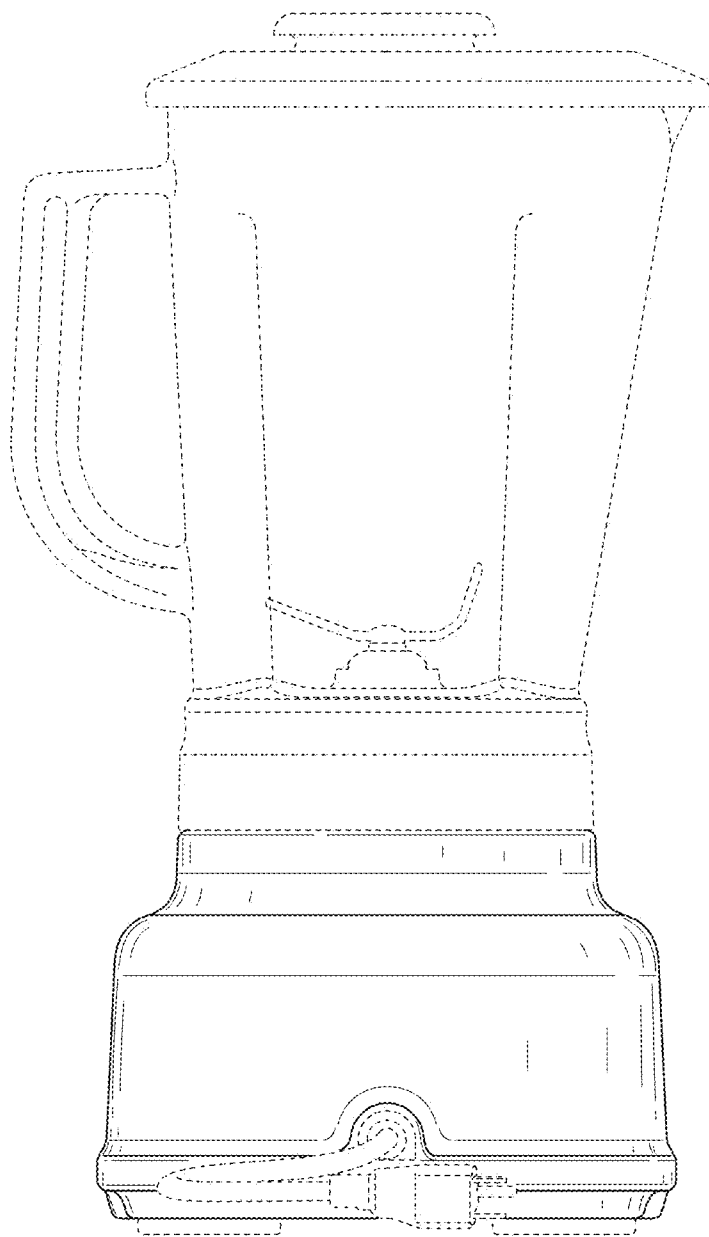

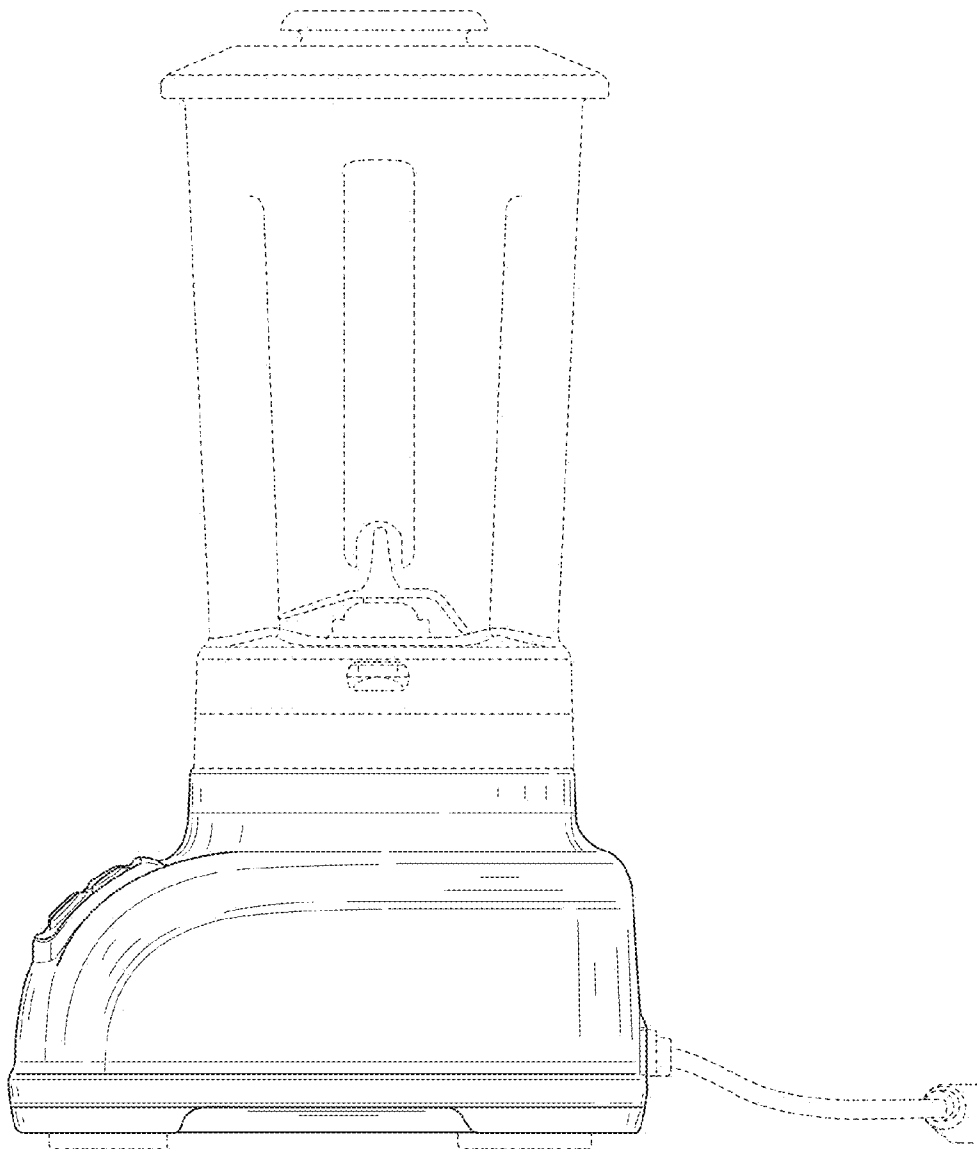

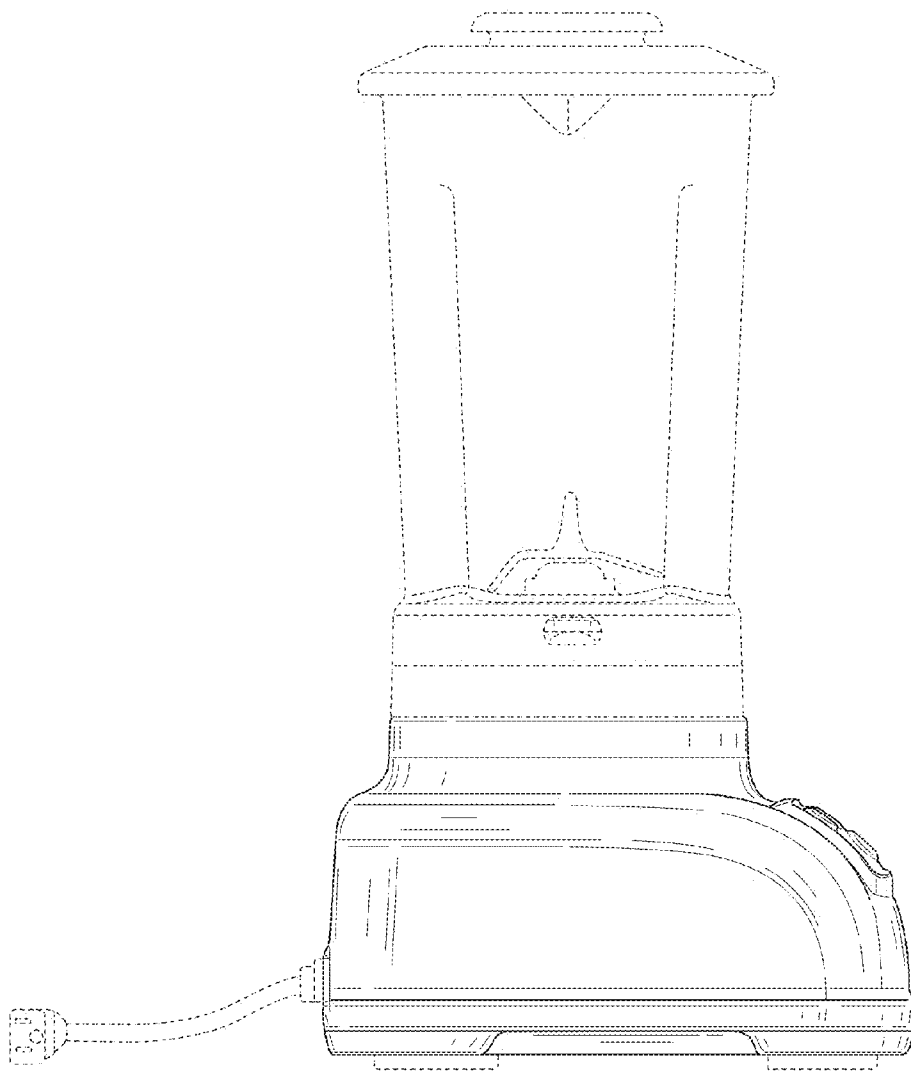

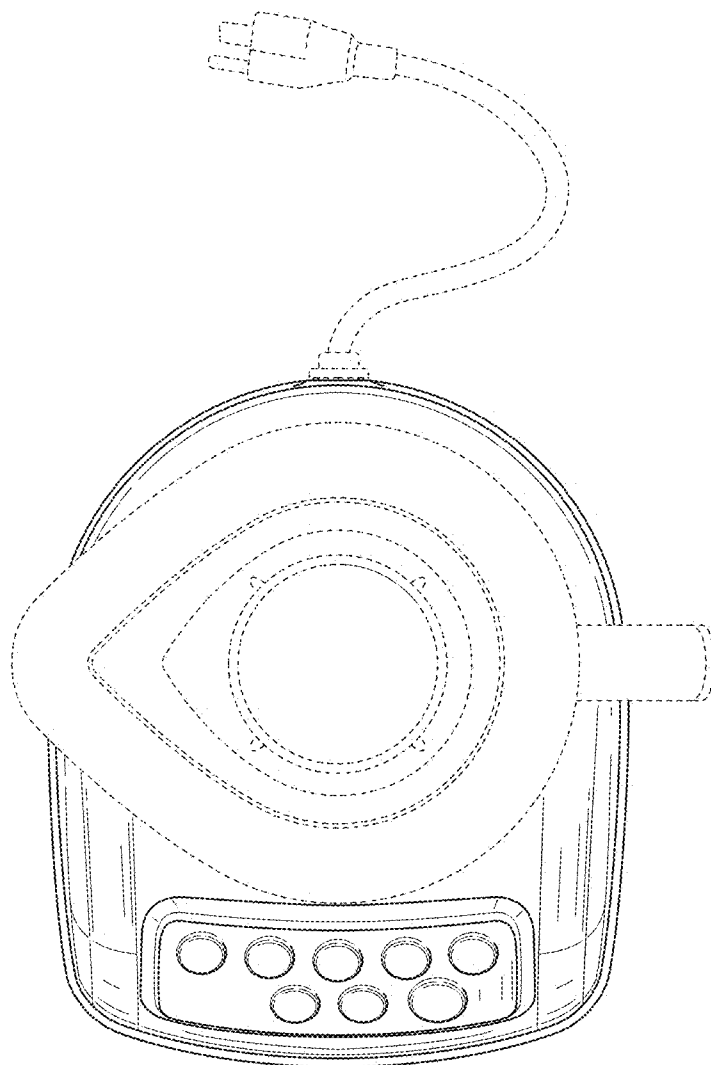

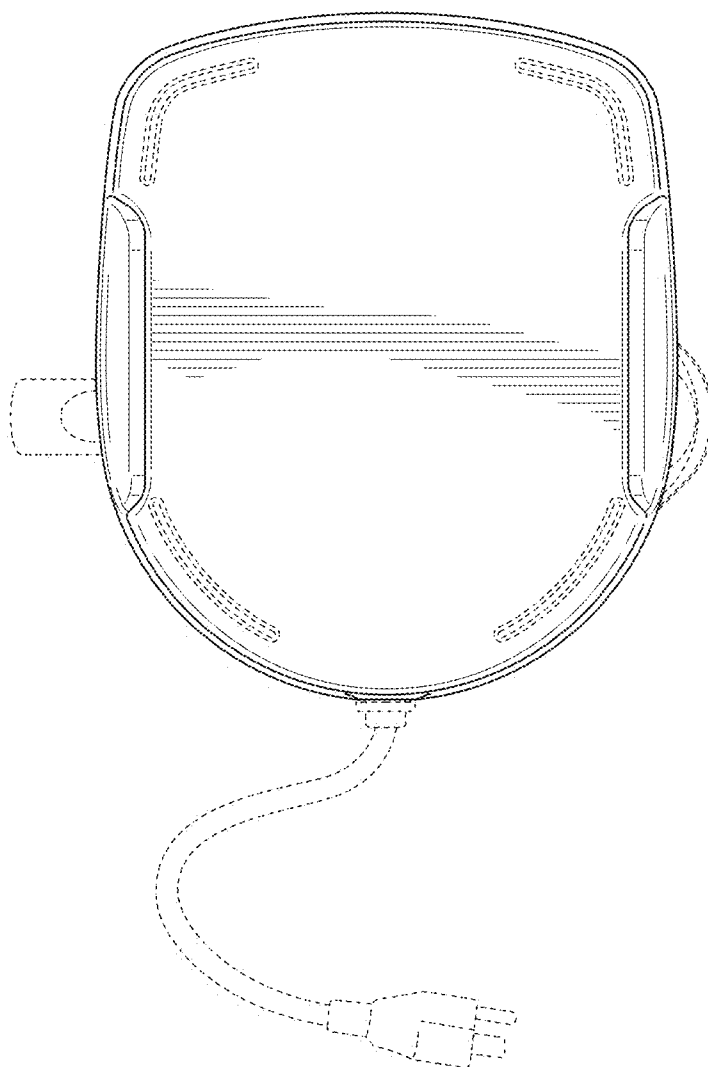
