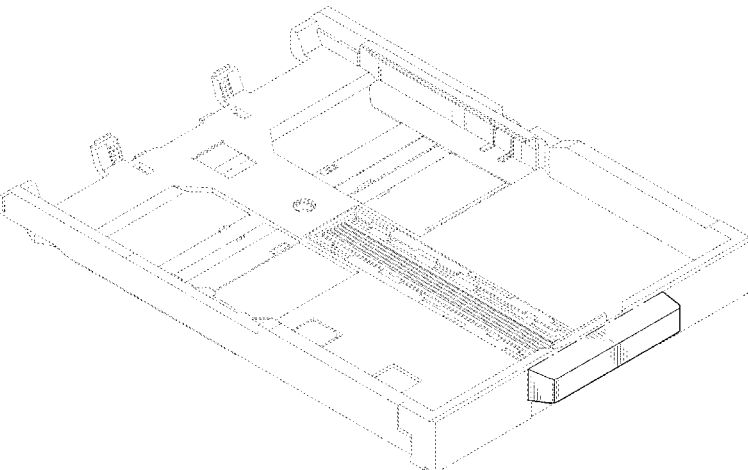

(57) **CLAIM**

The ornamental design for a paper tray for printer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a paper tray for printer showing the new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a left-side elevational view thereof;
FIG. 5 is a right-side elevational view thereof;
FIG. 6 is a rear elevational view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a perspective view thereof in a state of use.
The evenly spaced broken line showing of a printer in FIG. 8 depicts environmental subject matter that forms no part of the claimed design. All other evenly spaced broken lines depict portions of the paper tray for printer that form no part of the claimed design. The dot-dash chain lines depict a boundary of the claimed subject matter and form no part of the claimed design.

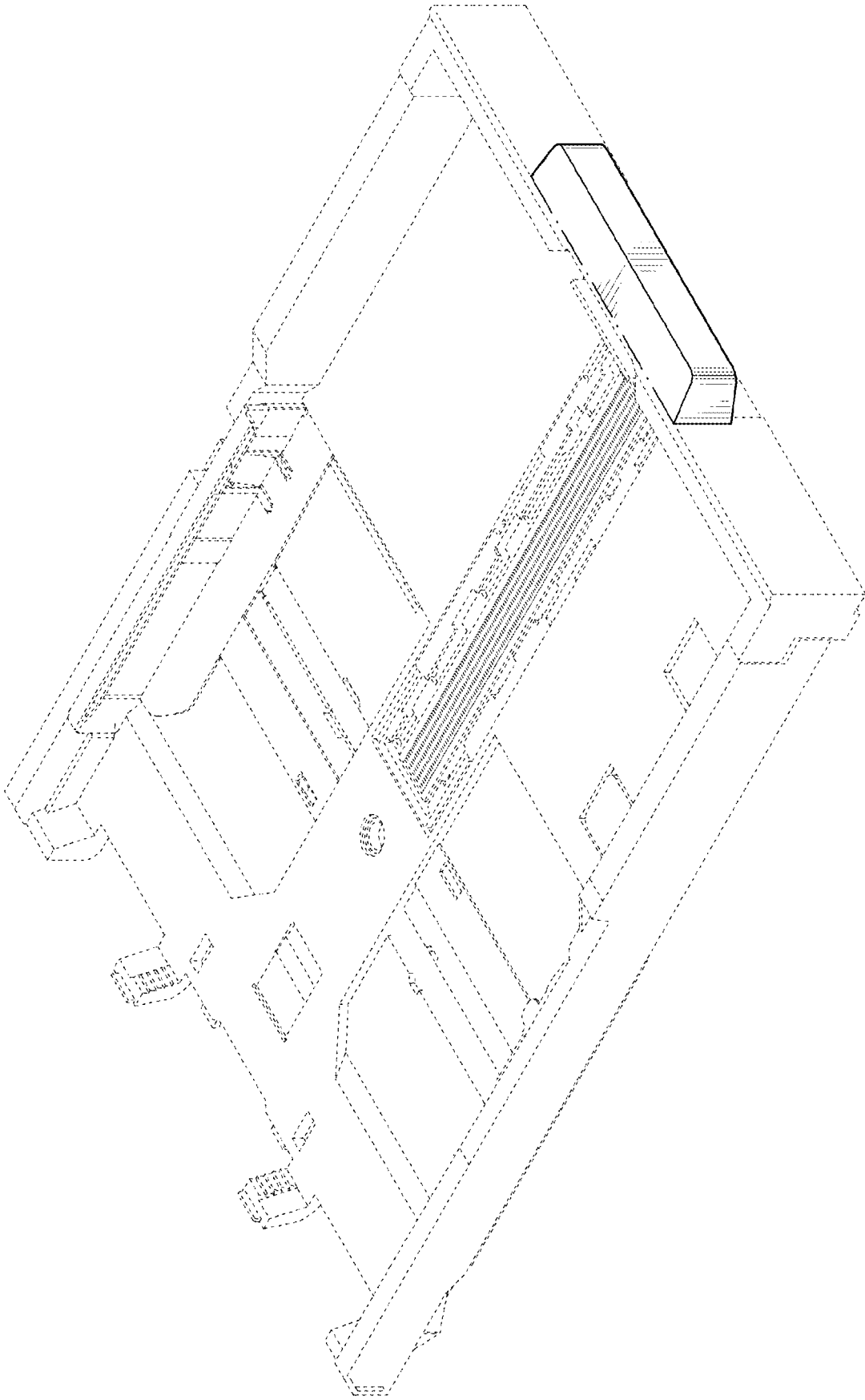

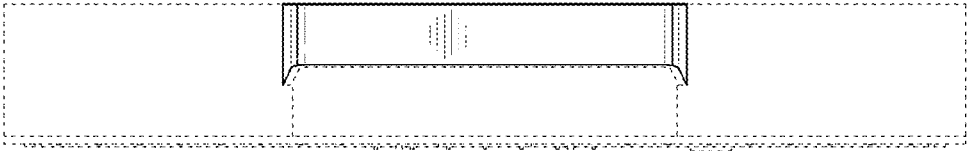

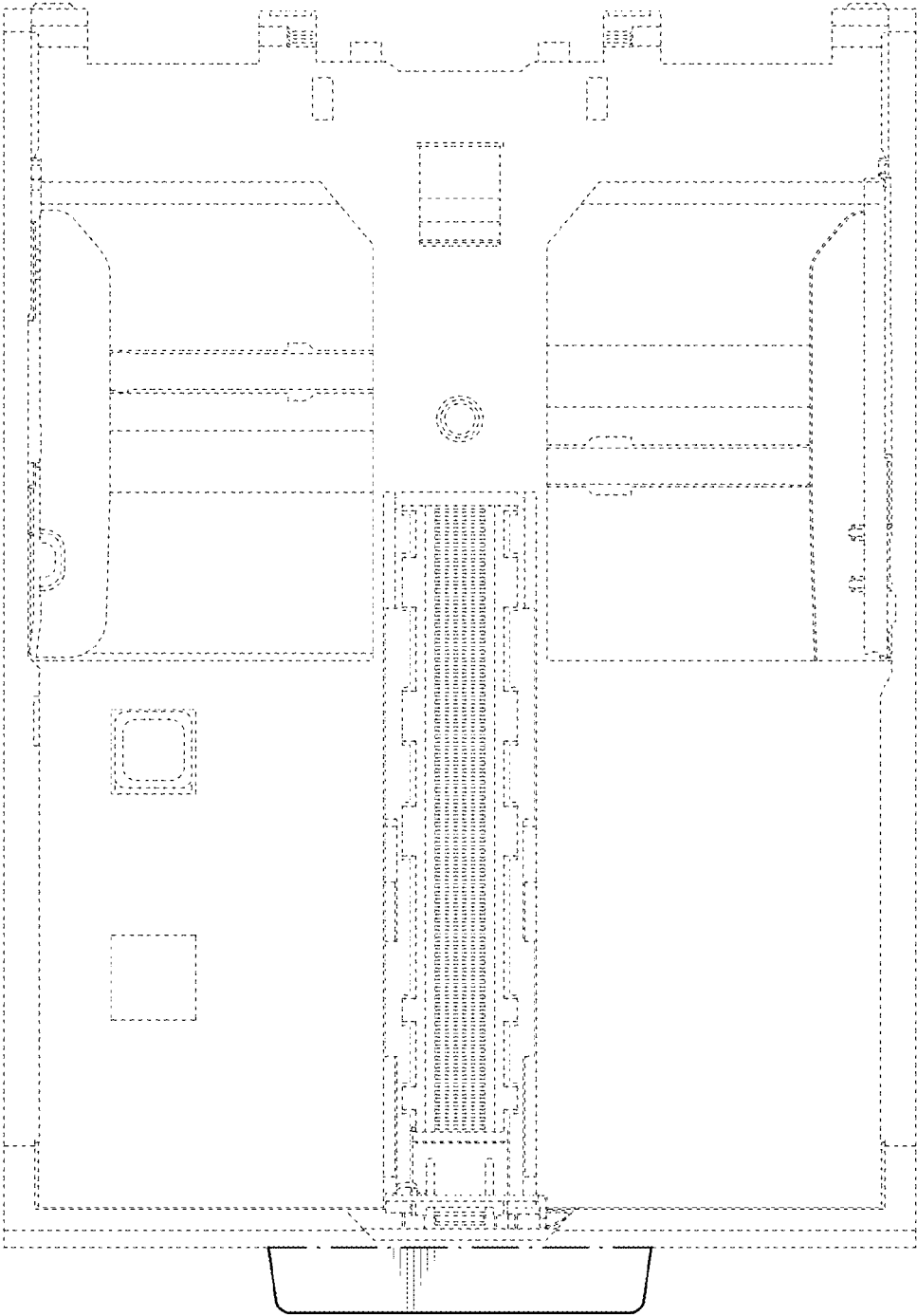

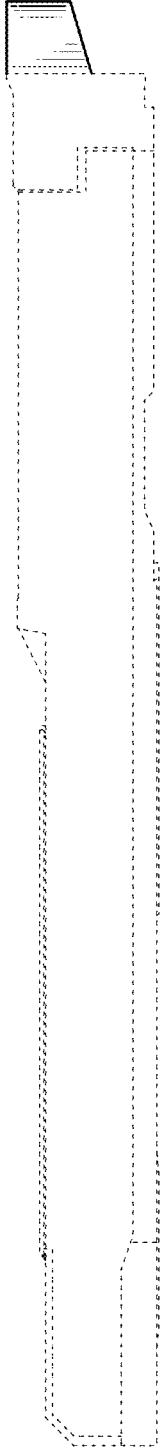

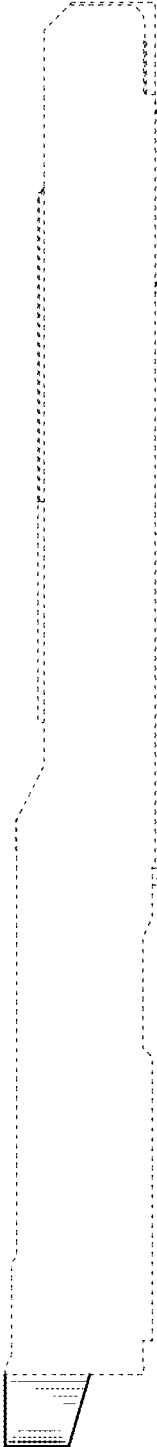

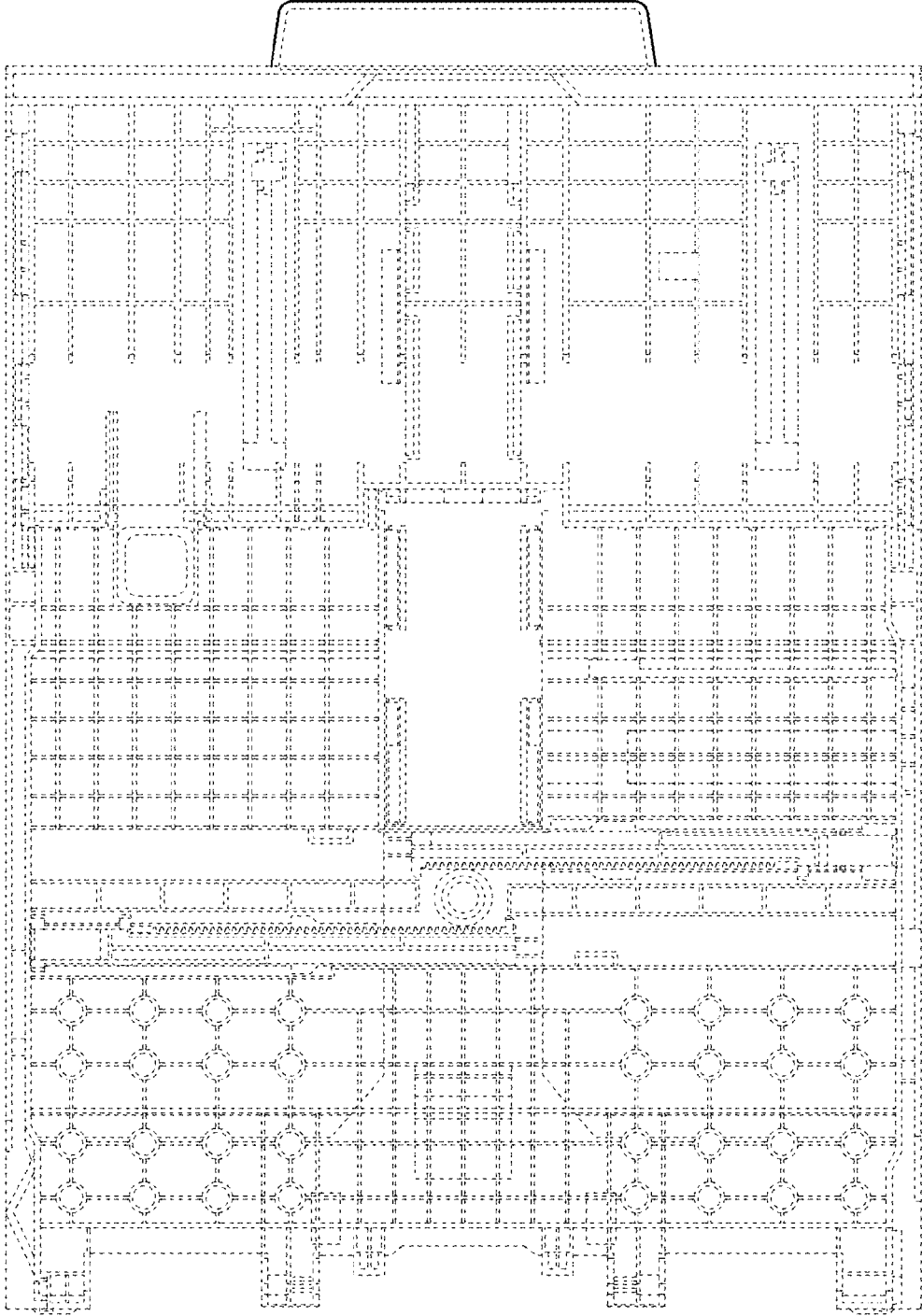

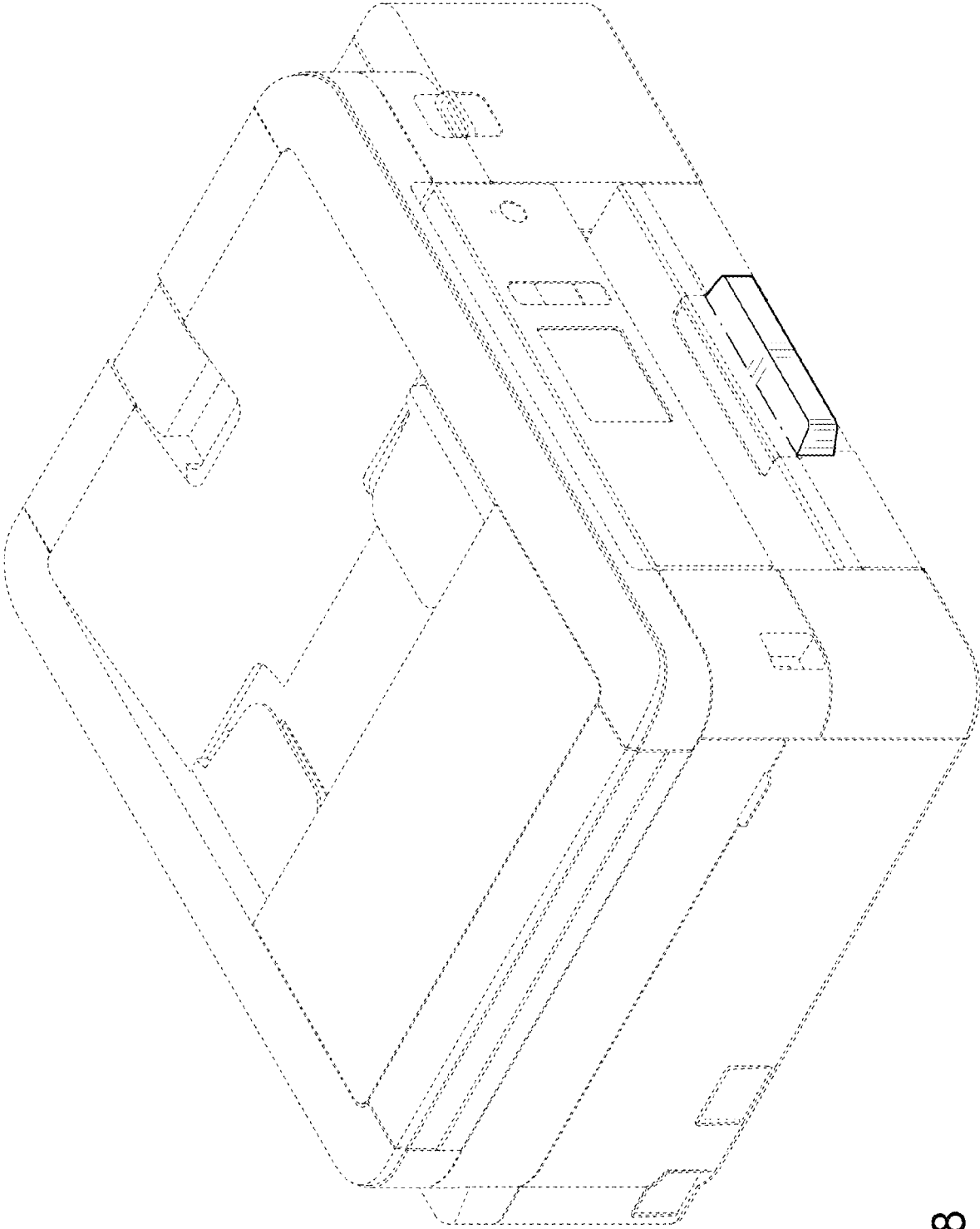
