(57) **CLAIM**

The ornamental design for a display screen portion with animated graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a first image of a first embodiment of a display screen portion with animated graphical user interface showing my new design;

FIG. 2 is a front view of a second image thereof;

FIG. 3 is a front view of a third image thereof;

FIG. 4 is a front view of a fourth image thereof;

FIG. 5 is a front view of a first image of a second embodiment of a display screen portion with animated graphical user interface showing my new design;

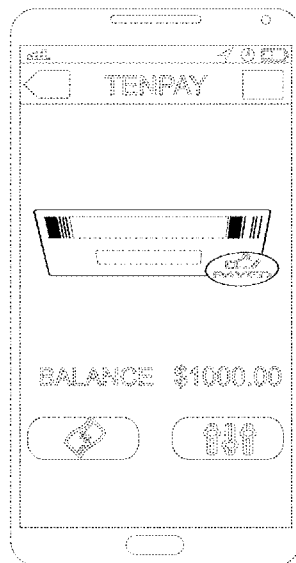
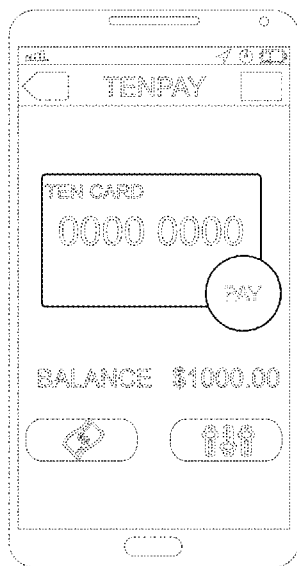
FIG. 6 is a front view of a second image thereof;

The broken line showing of a display screen and remainder of the graphical user interface forms no part of the claimed design.

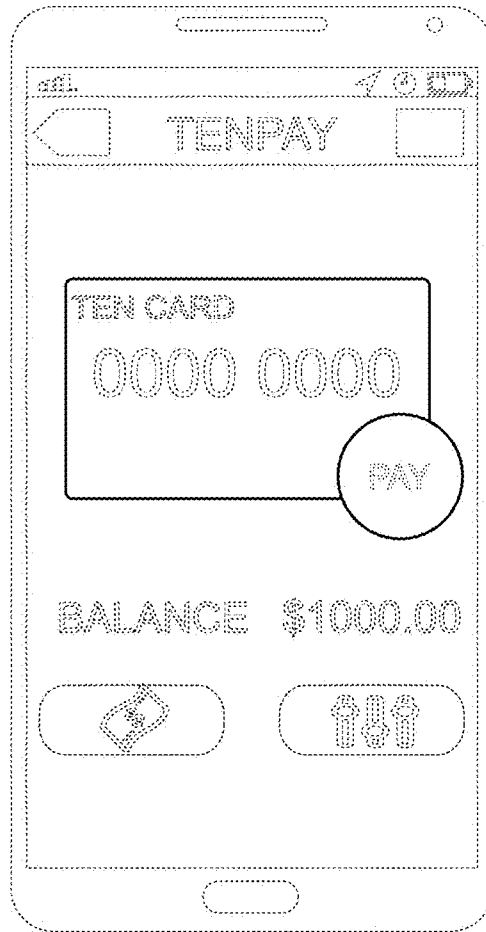

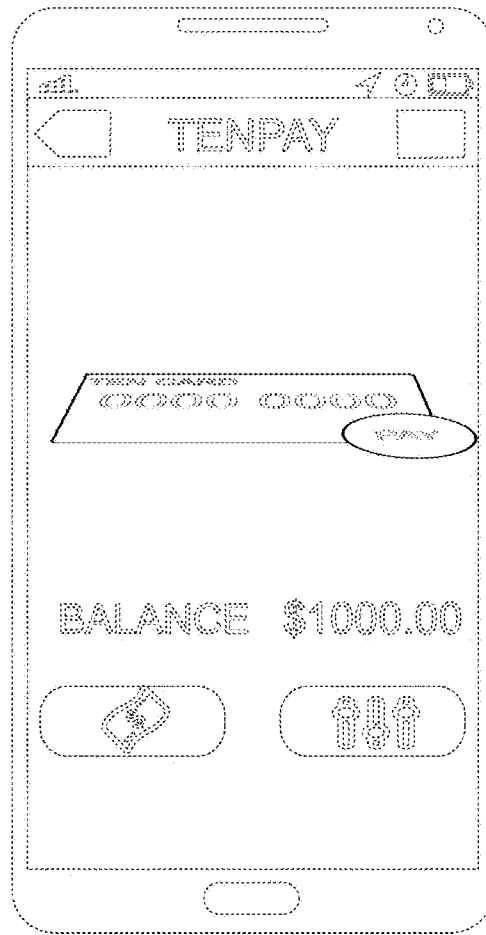

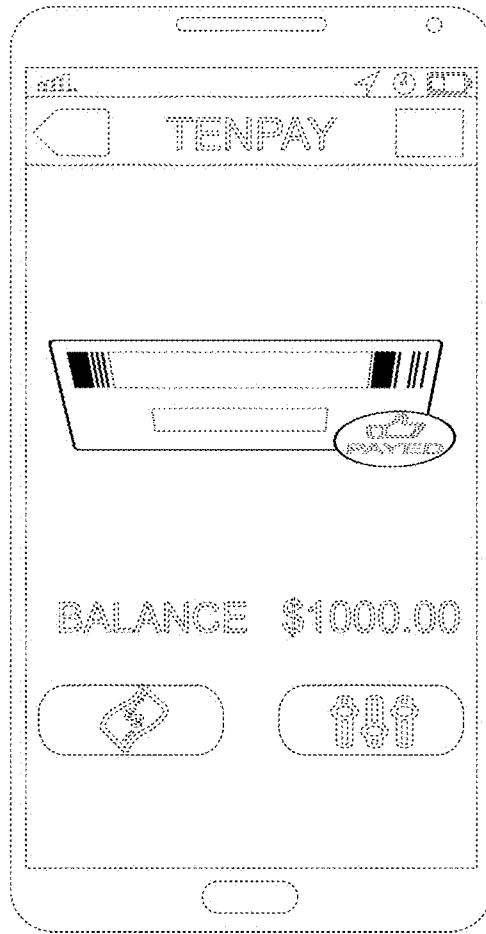

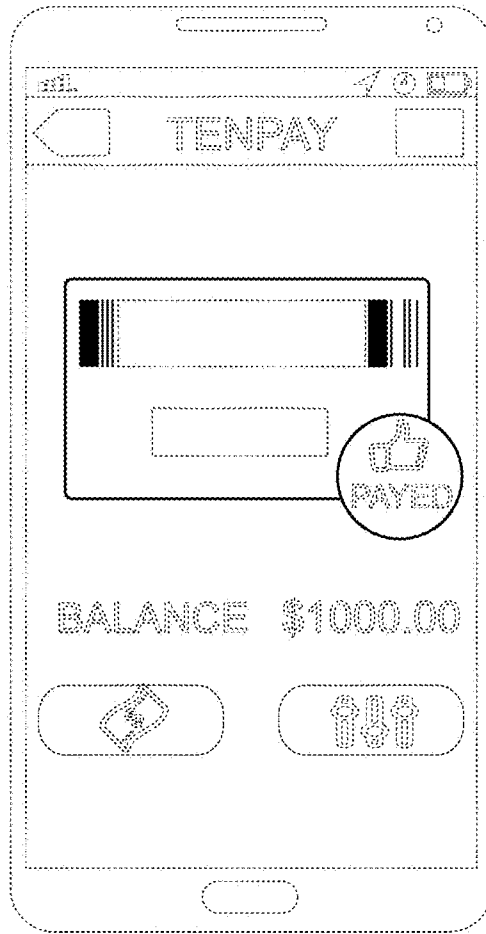

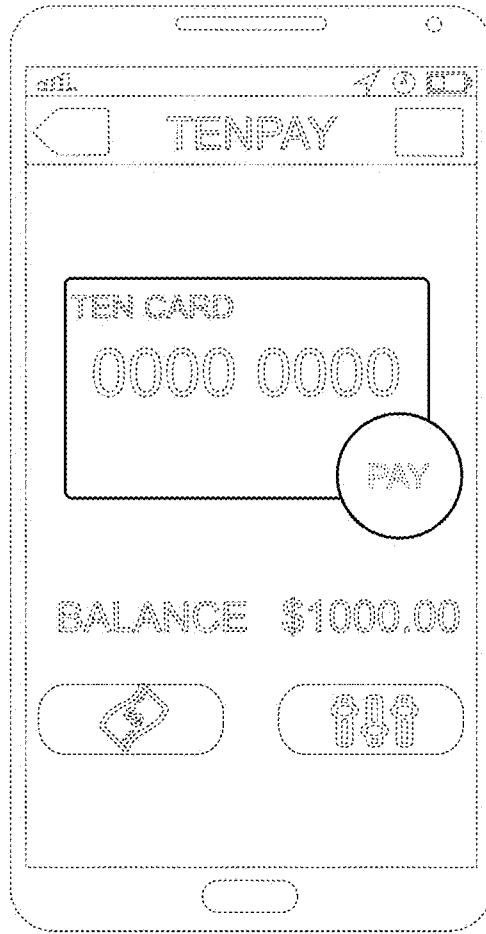

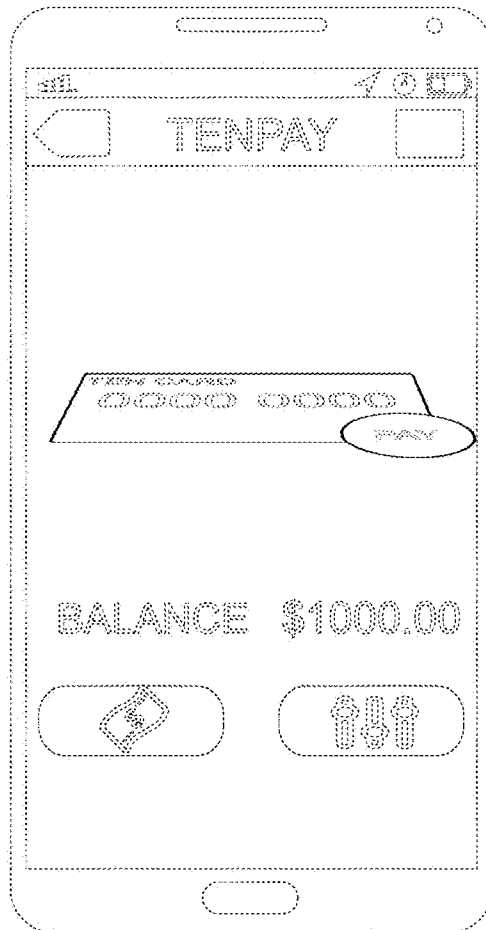

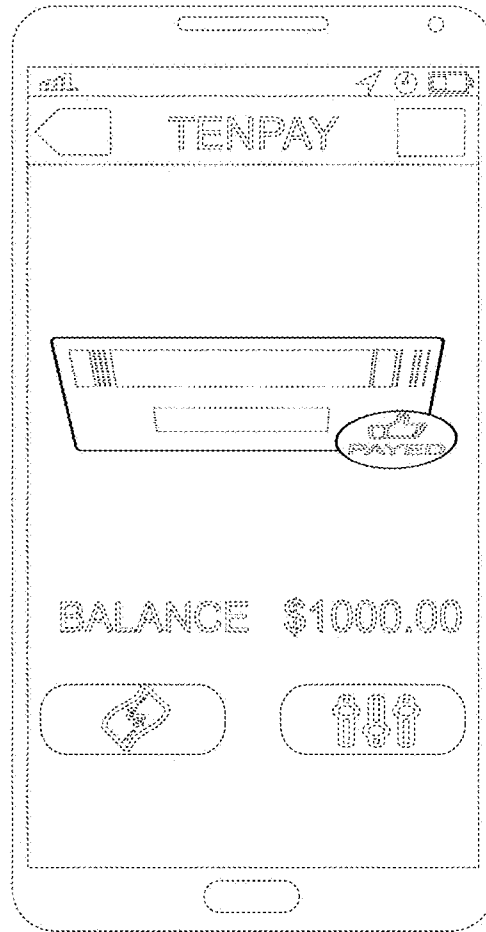

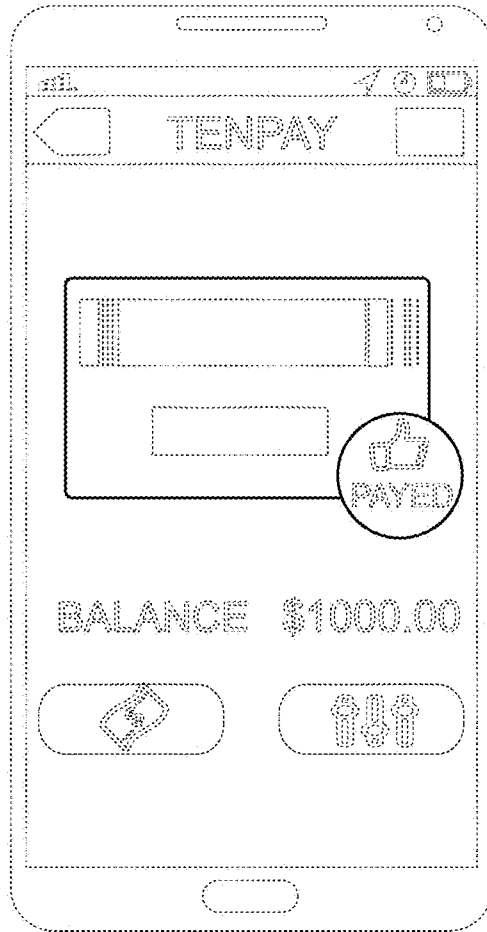
