FIG. 10 is a top plan view thereof;

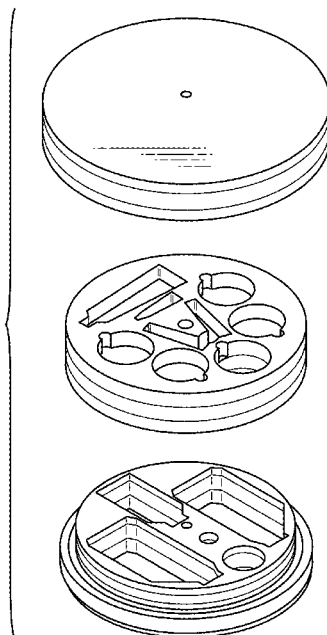
FIG. 11 is a left side sectional view taken along lines 11-11

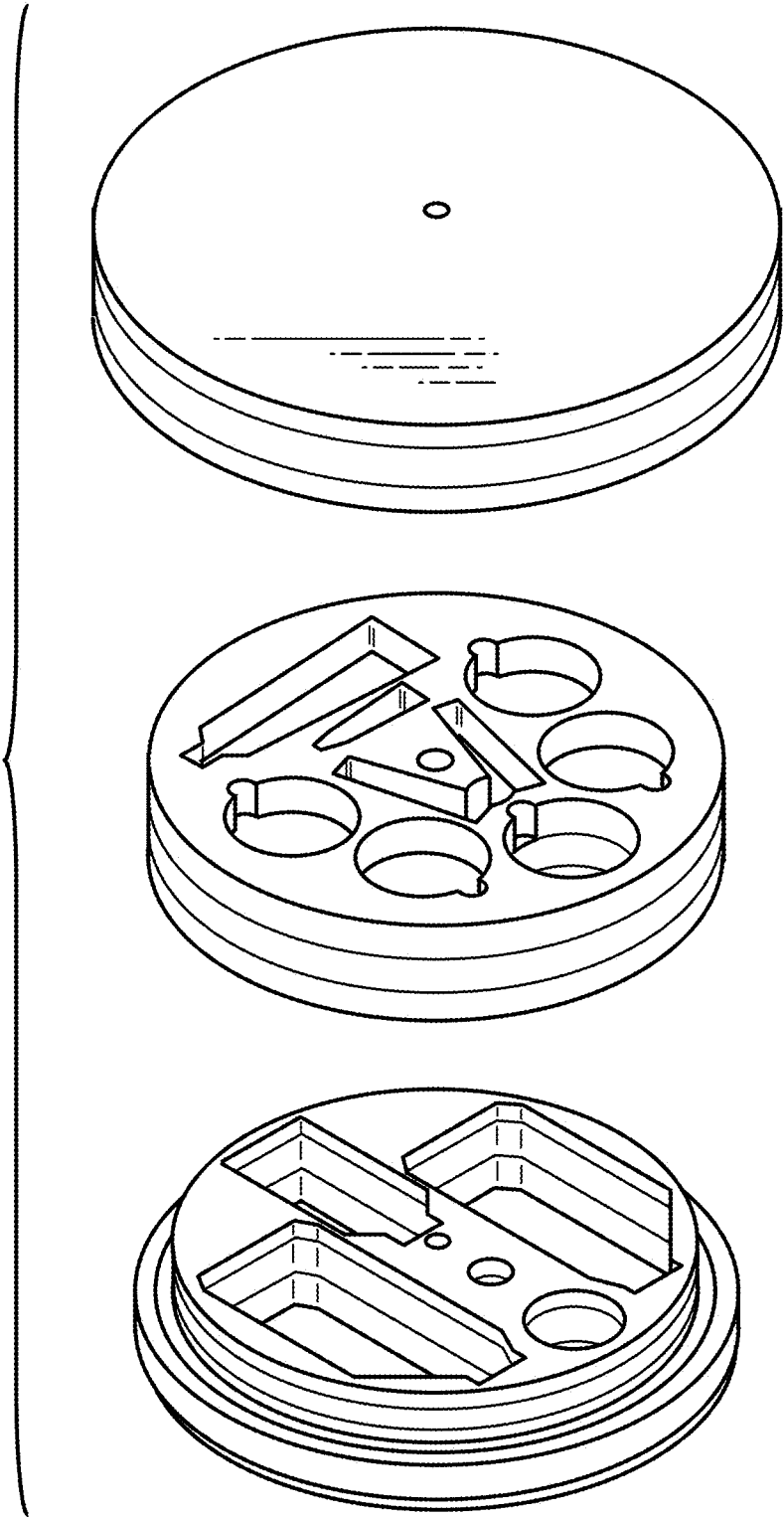

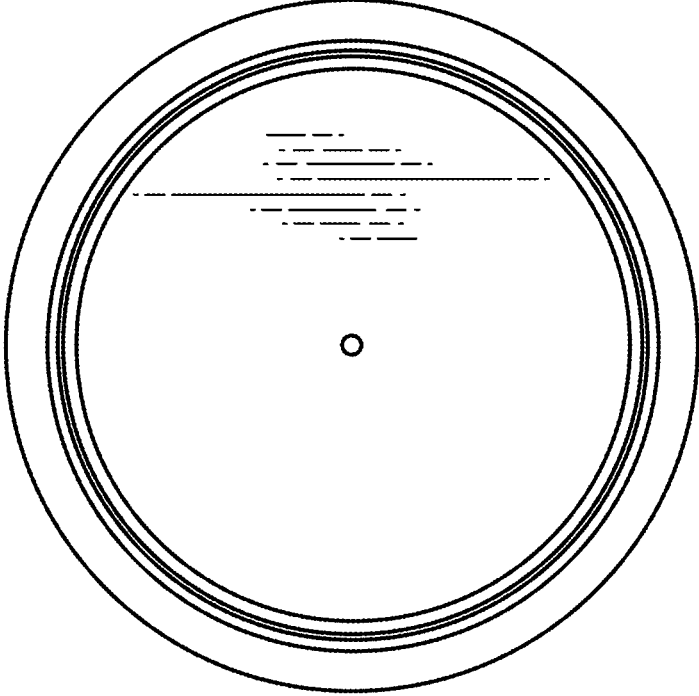

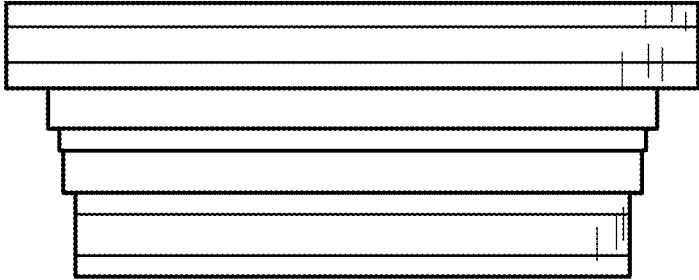

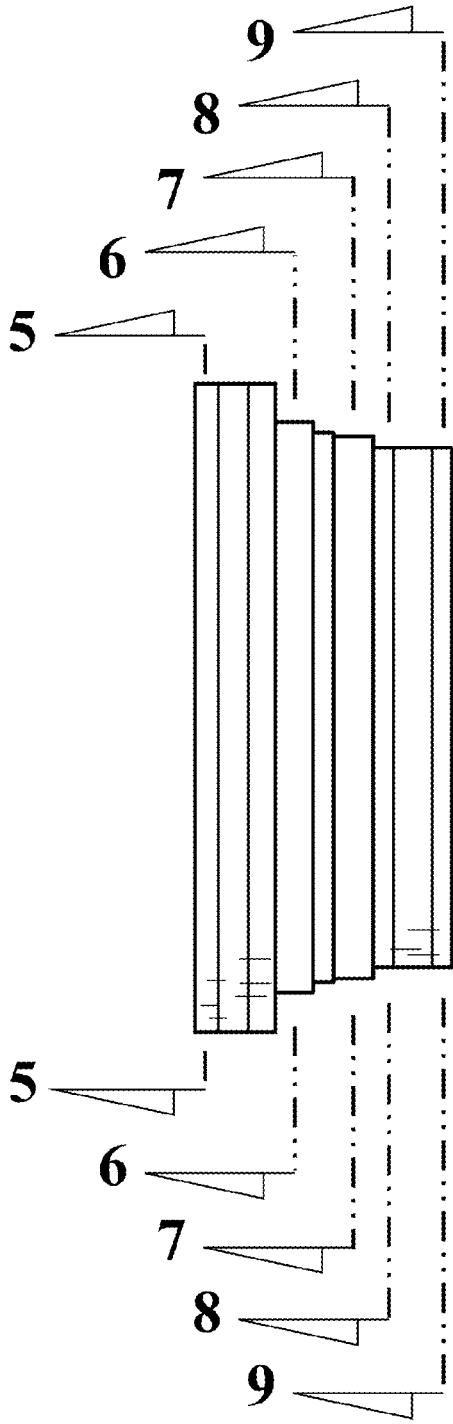

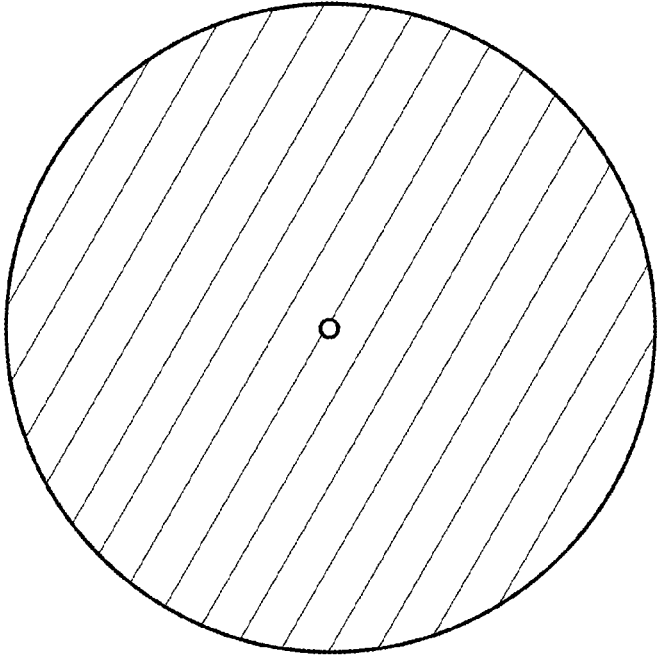

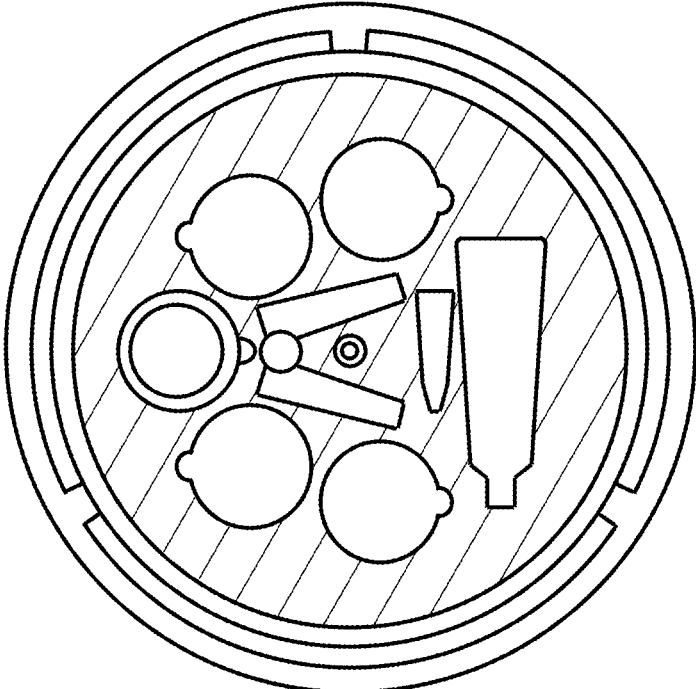

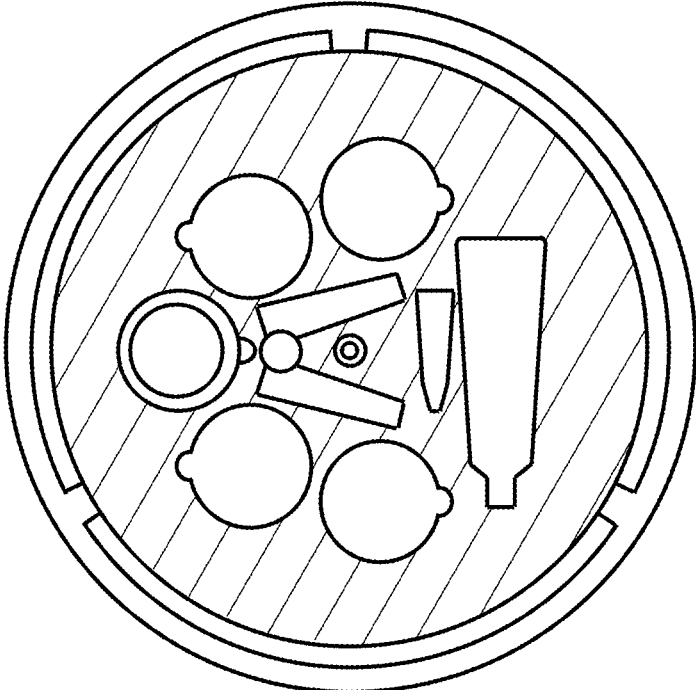

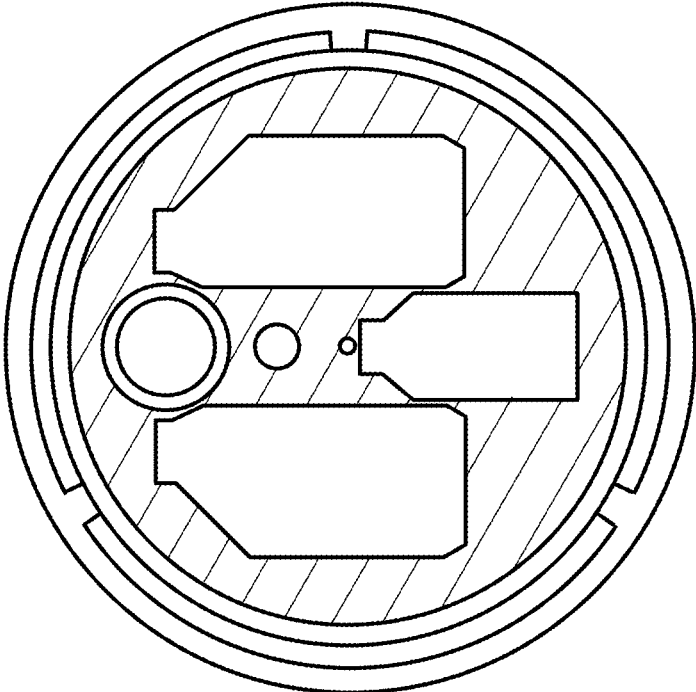

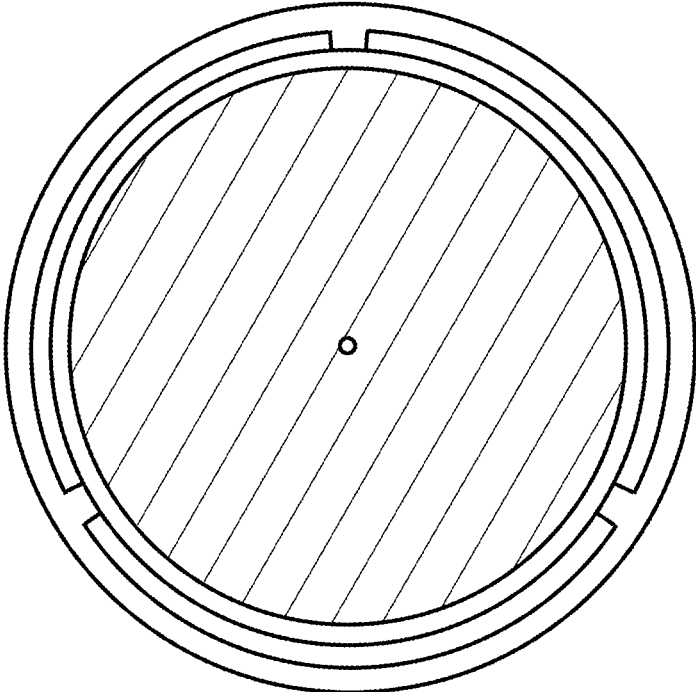

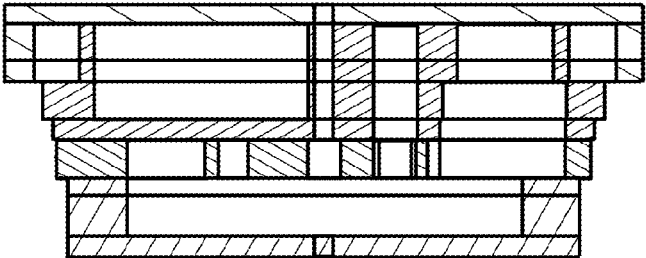
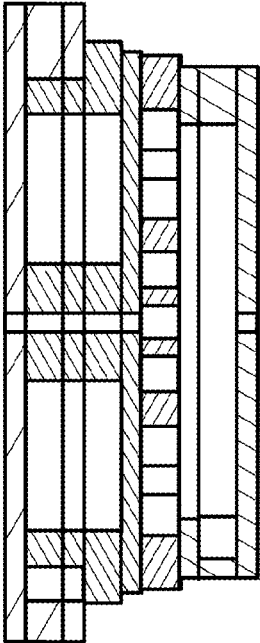
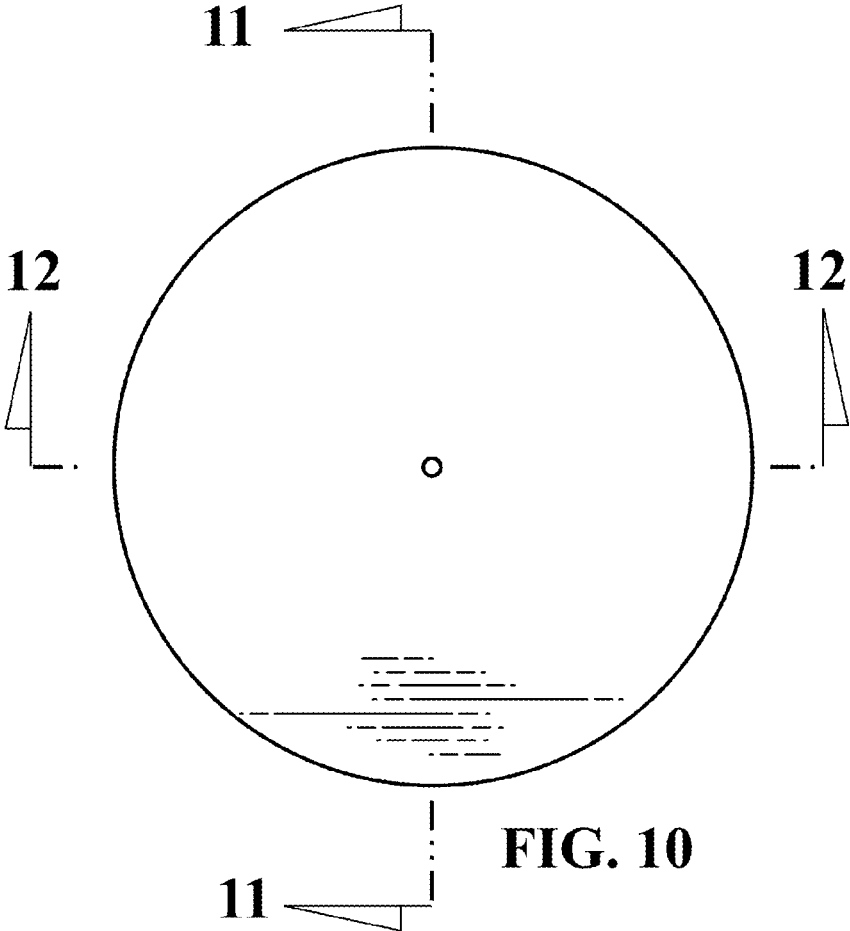

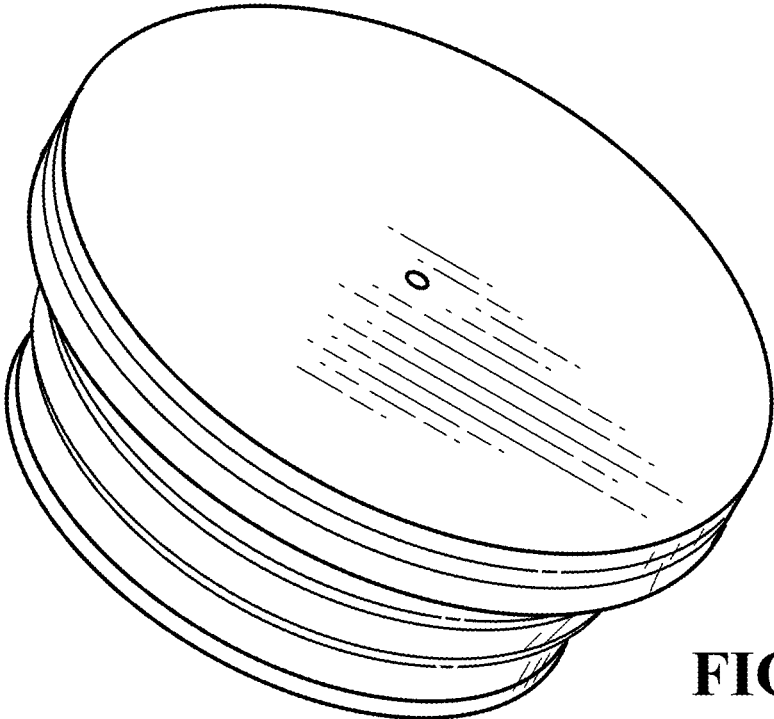

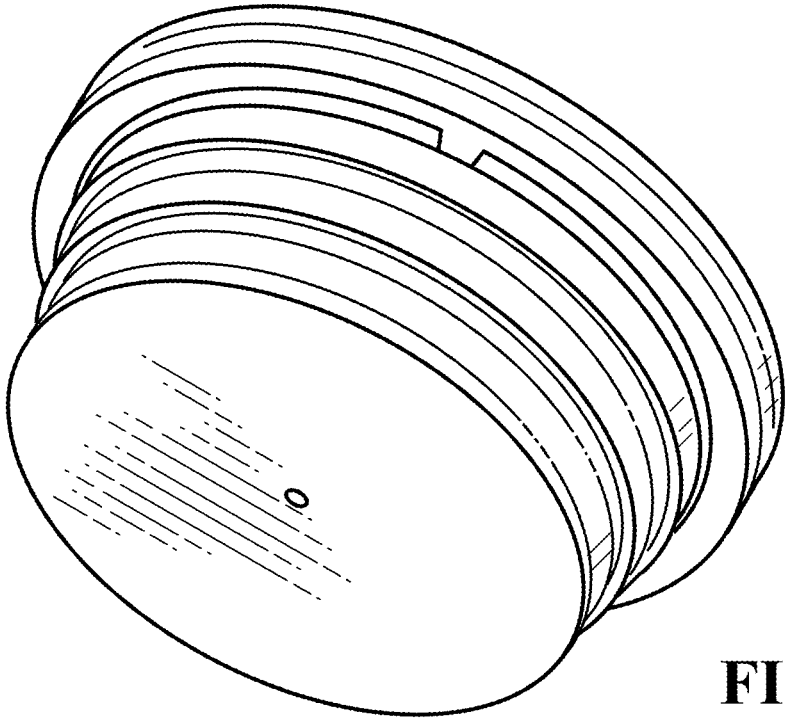
