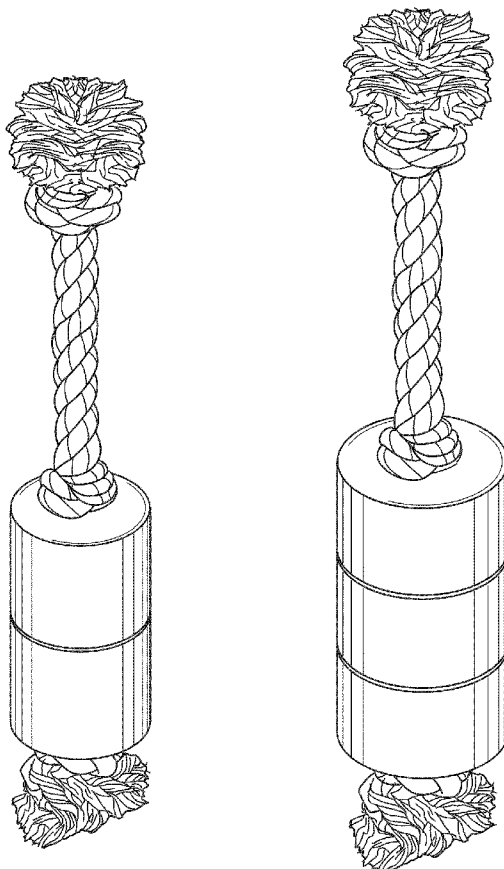
(57) **CLAIM**

The ornamental design for a pet throw/chew toy, as shown and described.

**DESCRIPTION**

FIG. 1 is a top and side perspective view of a pet throw/chew toy embodying my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a right-side elevational view thereof;

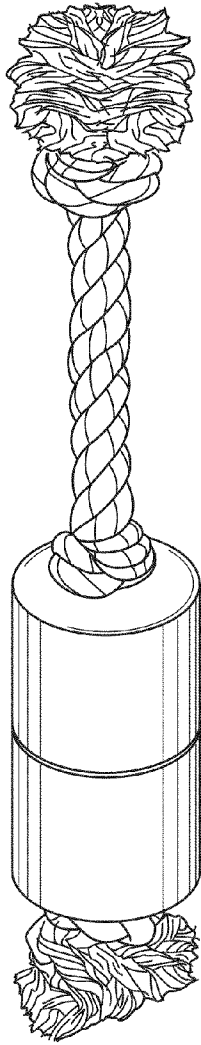

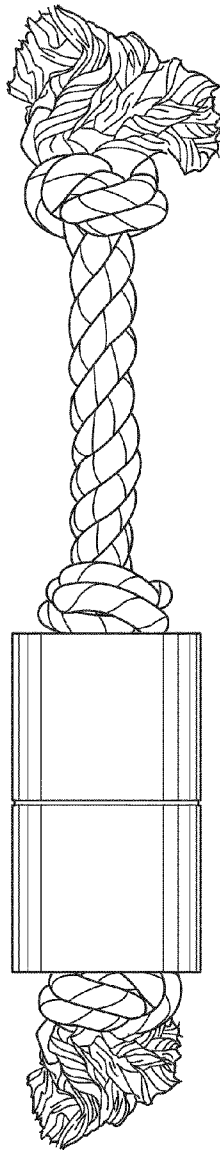

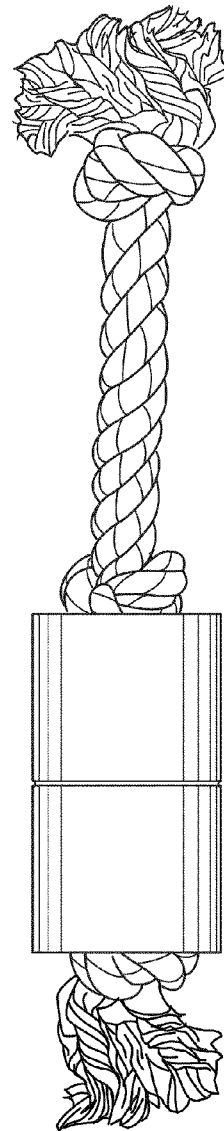

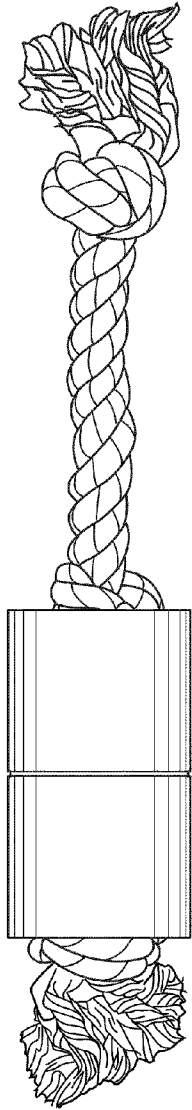

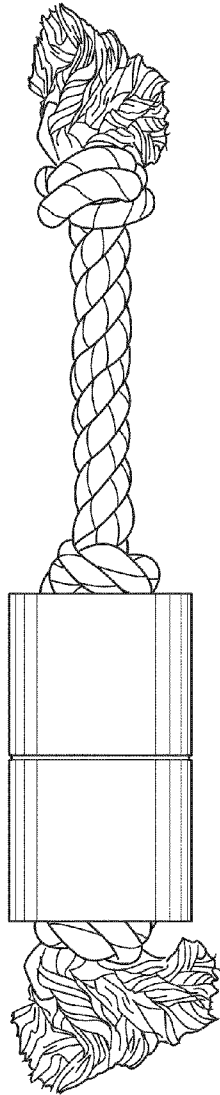

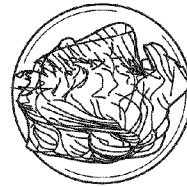

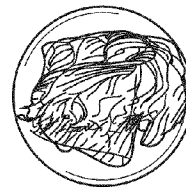

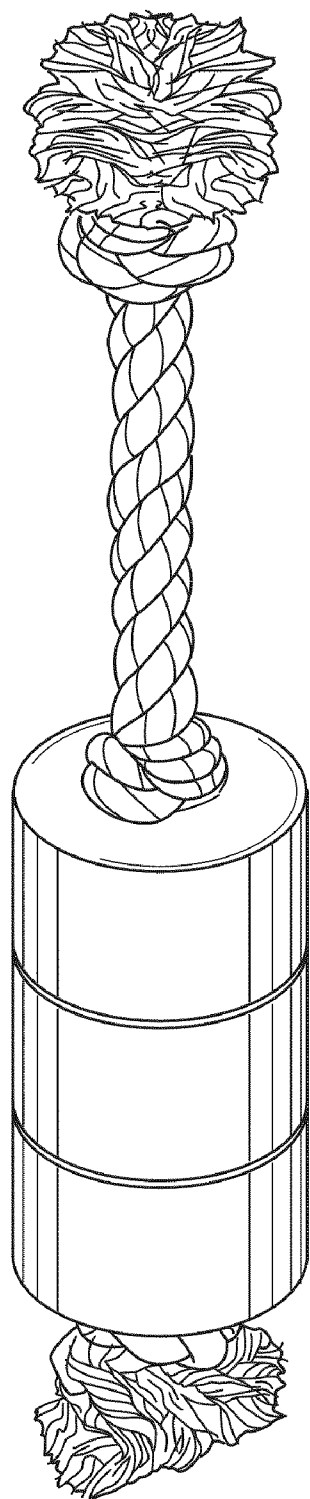
