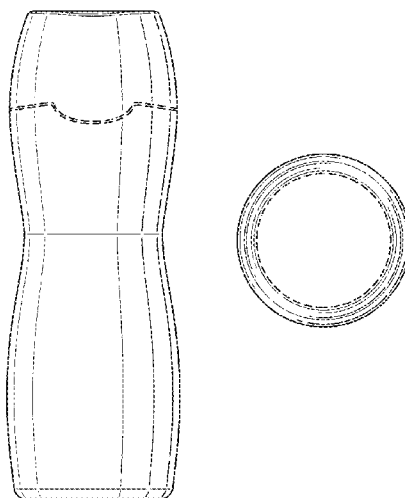
**CLAIM**

What is claimed is the ornamental design for a bottle, as  
shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a bottle;  
FIG. 2 is a top plan view of the bottle of FIG. 1;  
FIG. 3 is a front elevation view of the bottle of FIG. 1, the rear  
elevation view being identical; and,  
FIG. 4 is a bottom plan view thereof.  
The broken lines in FIGS. 1 & 3 showing the junction  
between the cap and the body of the bottle are represent  
unclaimed lines on a claimed surface. The broken line in FIG.  
4 defines the bounds of the claim. That circular broken line  
and the area within forms no part of the claim.

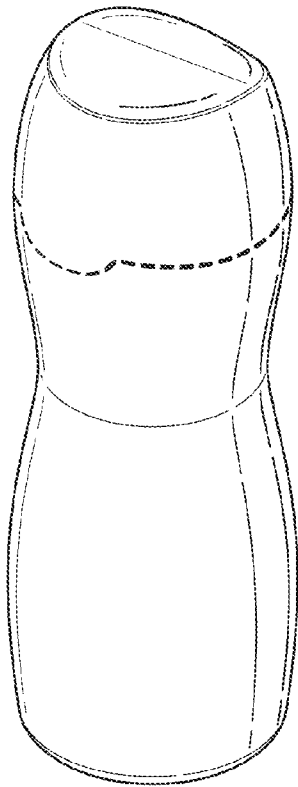

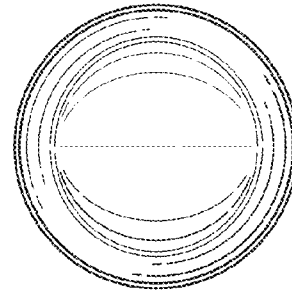

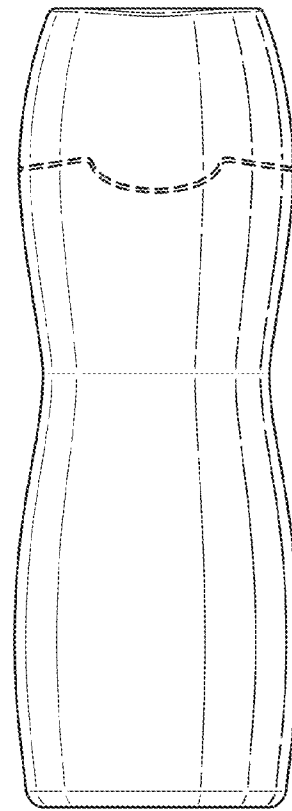

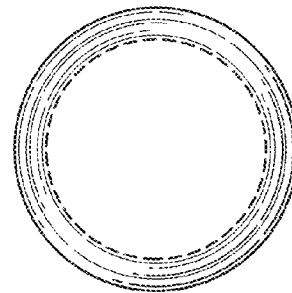
