(57) **CLAIM**

We claim the ornamental design for a hand held stapler, as shown and described.

DESCRIPTION

FIG. 1 is a first side, top, and rear perspective view of a hand held stapler showing our new design;

FIG. 2 is a first side, bottom, and front perspective view of the hand held stapler showing our new design;

FIG. 3 is a first side elevational view of the hand held stapler showing our new design;

FIG. 4 is a bottom plan view of the hand held stapler showing our new design;

FIG. 5 is a front elevational view of the hand held stapler showing our new design;

FIG. 6 is a first side elevational view of the hand held stapler, in a track-open position, showing our new design; and,

FIG. 7 is a top, first side perspective view of a hand held stapler, in a track-open position, showing our new design.

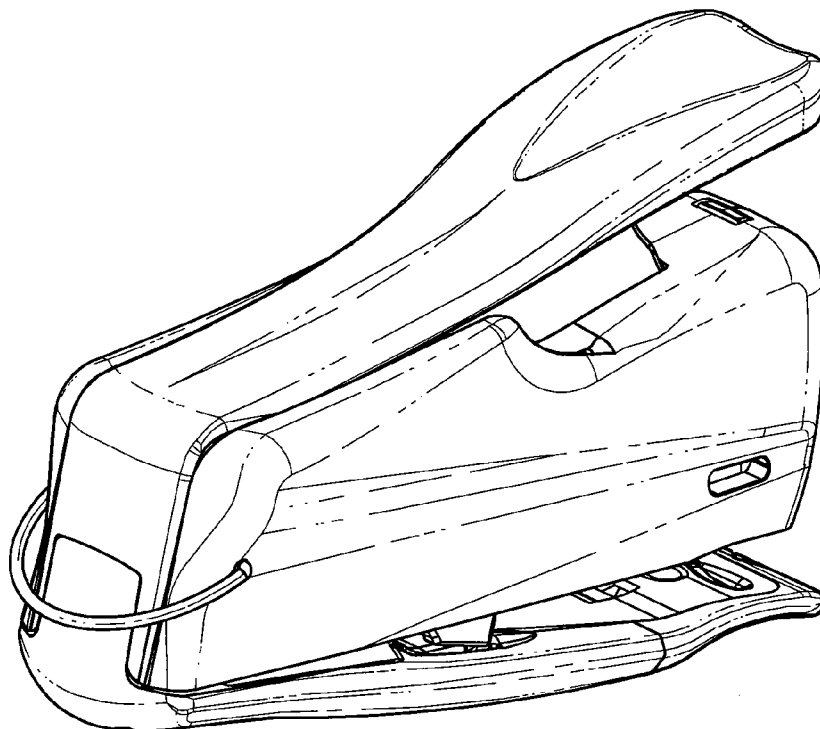

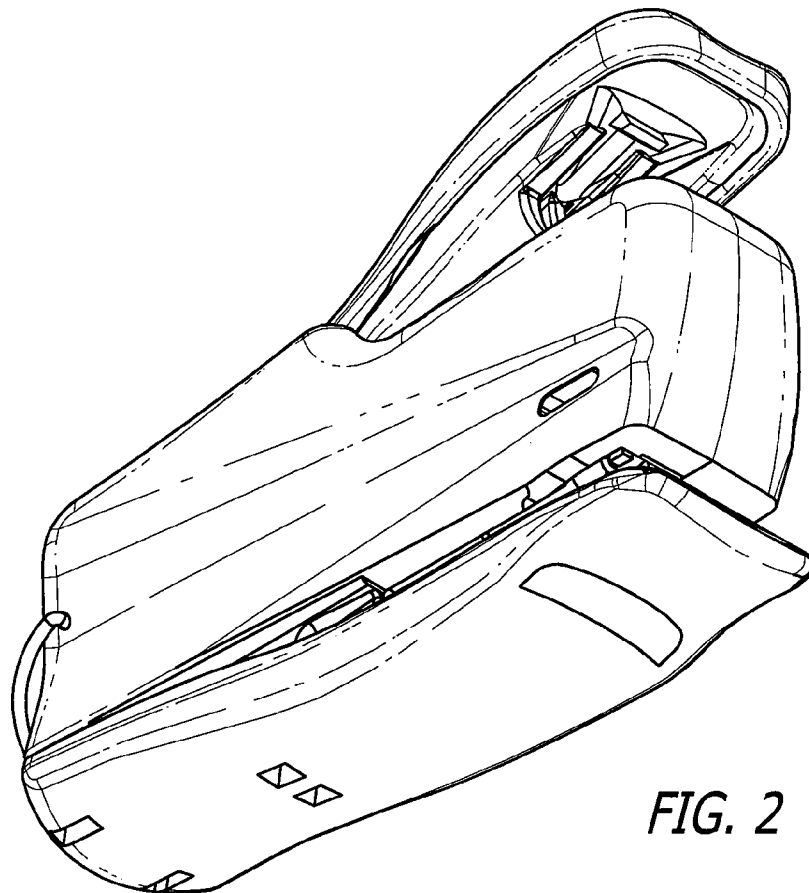
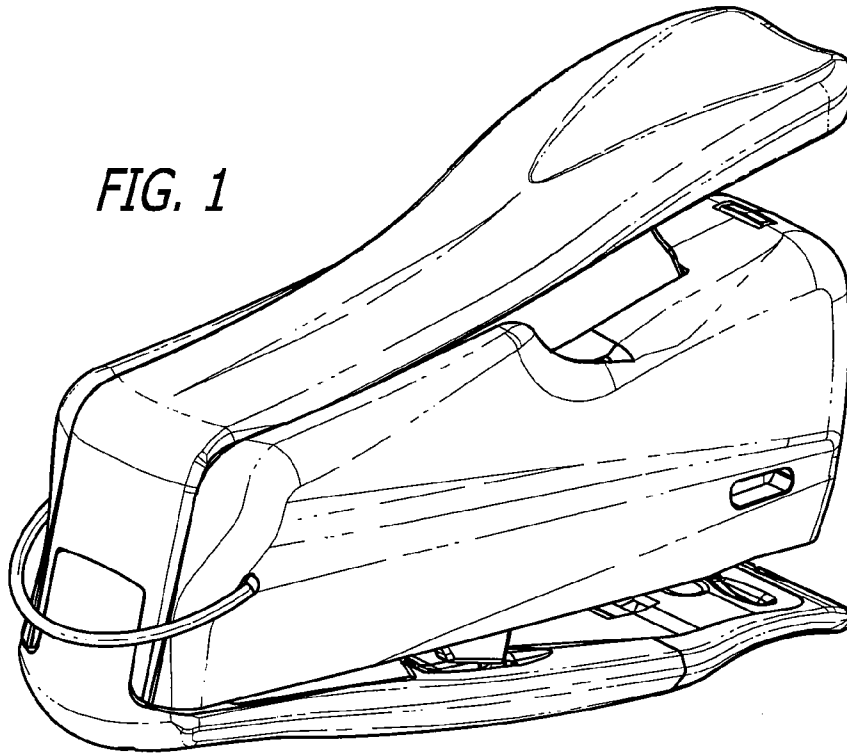

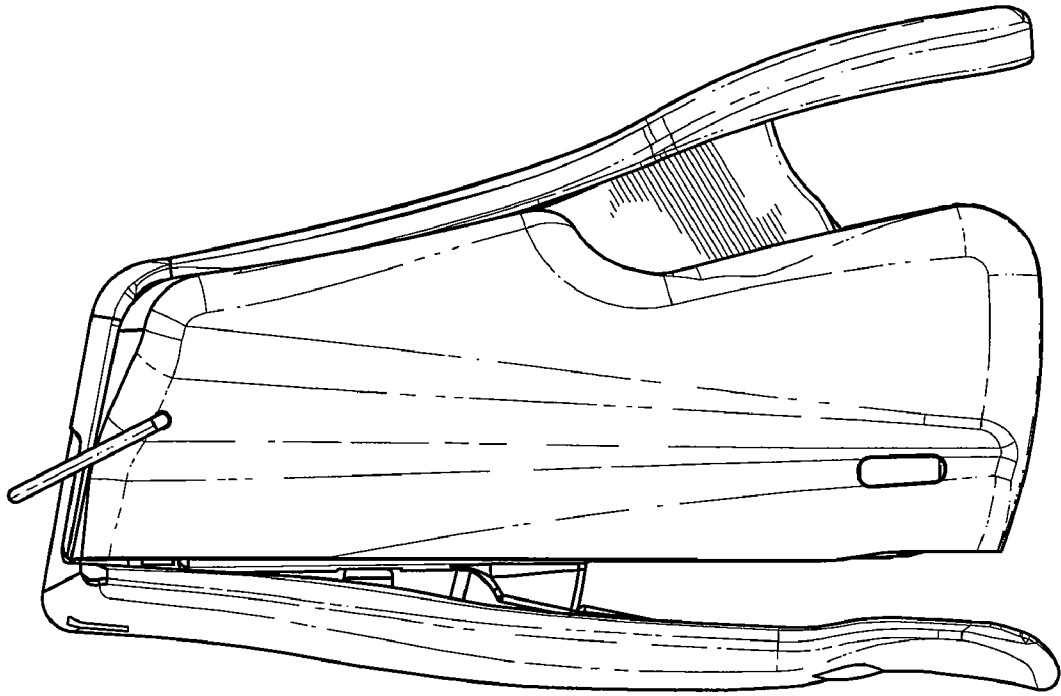

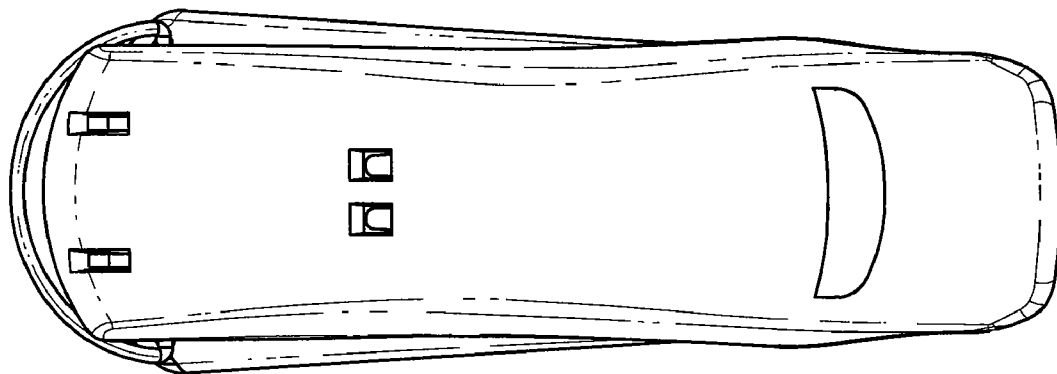

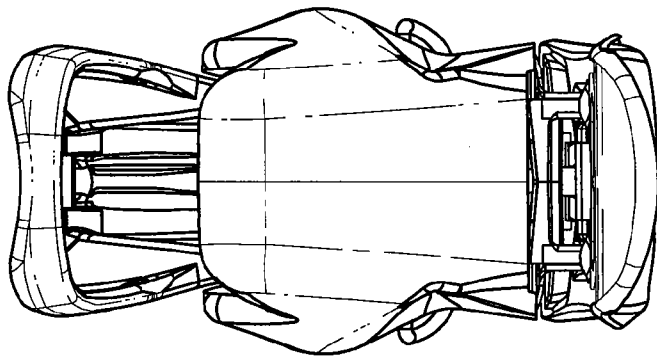

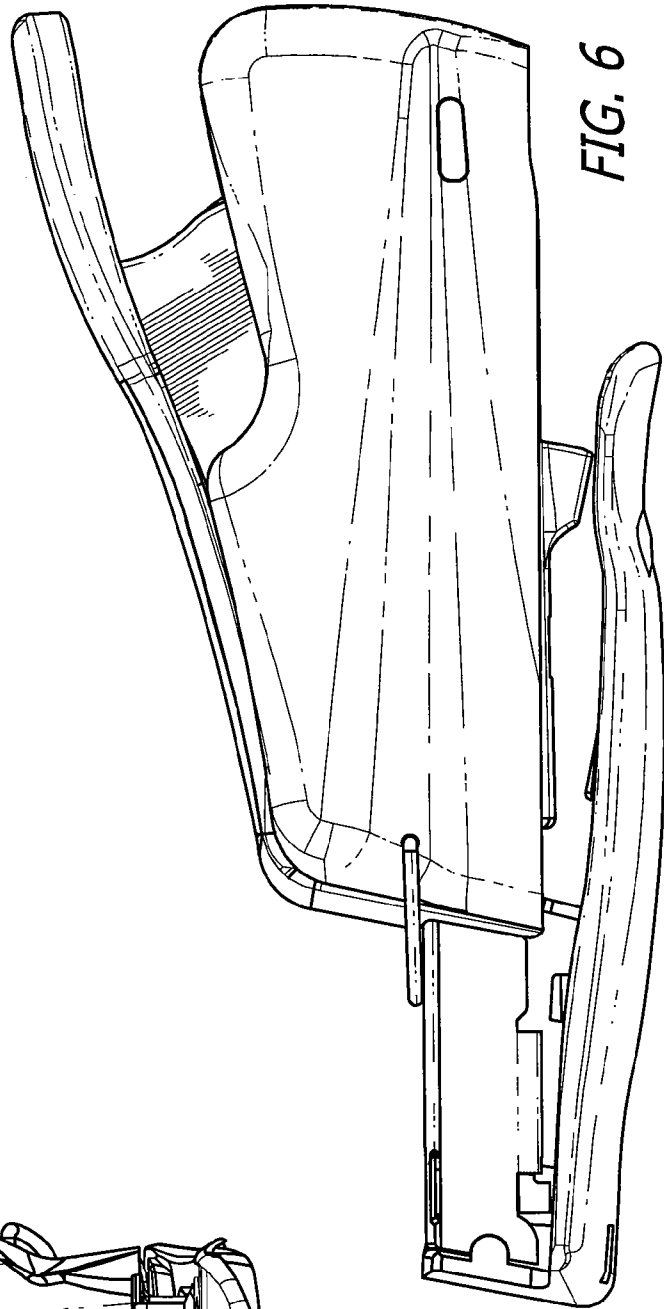

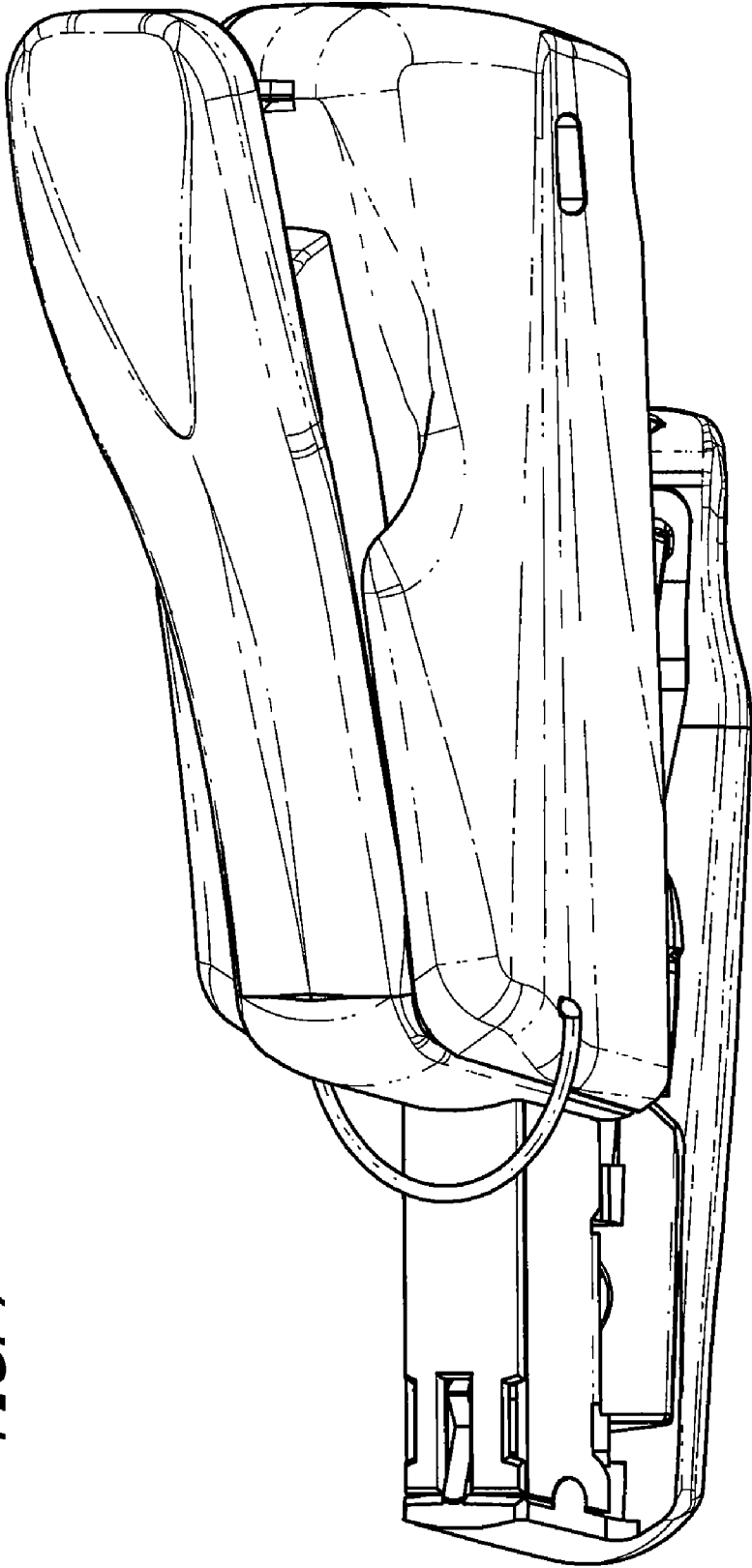
